Subject: Details of students admitted for Postgraduate medical courses in India for the Academic Year 2024-25 - validity thereof.

The Postgraduate Medical Education Regulation, 2023 prescribes conditions and modalities for admission to Post Graduate Level Medical Education through common counseling. Accordingly, after completion of the counseling period, the Post-Graduation Medical Education Board (PGMEB), through Public Notice dated 25.03.2025, and 30.03.2025, had requested all the Medical Colleges to upload the details of students admitted for Post Graduate Medical Education for the Academic Year 2024-25, latest by 07.04.2025. Further, extension of the date was published on 22.05.2025 up to 10.06.2025.

2. Some of the colleges have not uploaded the details of the students admitted to Postgraduate courses, while some colleges uploaded incomplete data. Despite issuance of various circulars and public notices, it is found that a total number of 47,164 students have been admitted for the Academic Year 2024-25, and whose details have been uploaded on the NMC Portal.

3. All the students studying for Postgraduate Course (MD/MS/Diploma) Broad Specialty and who have got admission for the Academic Year 2024-25 are requested to go through the uploaded list, which is available on the website of the NMC, with the following link to ensure that their names are reflected in the list.
