**Subject:Details of students admitted for MBBS course in India for the Academic Year 2024-25 validity thereof.**

Graduate Medical Education Regulation, 2023 prescribes conditions and modalities for admission at Graduate Level Medical Education (UGMEB) through common counseling. Accordingly, after completion of the counseling period, UGMEB through Circular dated 30<sup>th</sup>October, 2024 requested all the Medical Colleges to upload the details of students admitted for Graduate Level Medical Education for the Academic Year 2024-25 latest by 08/11/2024. Further,extension the date was publish on 08/11/2024 to 23/11/2024 for uploading the details of 1<sup>st</sup> year MBBS students for the academic year 2024-25. Due to further extension in counseling by Hon'ble Supreme Court of India, anotherPublic Notice was issued to upload the details of admitted students for the Academic Year 2024-25 latest by 10/12/2024.

2. Some of the colleges did not upload the details of the students admitted in MBBS Course and some colleges uploaded the incomplete data. Despite issuance of various circular and public notice, it has been found that total number of 1,15,250 students admitted for the Academic Year 2024-25 andhave been uploaded details on the NMC Portal. It is informed

that students whose details have been uploaded on the portal shall be eligible for registration to practice Modern Medicine/ Allopath in India.

3. All students studying for MBBS Course and got admission at Graduate Level Medical Education for the Academic Year 2024-25 must go through the uploaded list the same is available on the website of the Commission with the following link to ensure that their names are reflected in the list.
