2.1 New Applications received from Govt. Medical Colleges for enhancement of MBBS seats :

In terms of the Notification dated 8.7.2013 (published in the Gazette on 16.7.2013, for enhancement of annual intake capacity in Undergraduate course in Medical Colleges for the Academic Session 2013-14, as a one time measure, which was

further modified with the permission of the Central Government with regard to time schedule and confining this Regulation at present to Government Colleges for the current Academic Year, 43 Applications were received and their status was placed before the Board of Governors. The BOGs examined the documents of each Medical College submitted by the concerned State authorities, in terms of the conditions such as (1) Current seat capacity; (2) No. of Seats to be enhanced; (3) Year of LOP issued; (4) Applications forwarding authority; (5) Consent of Affiliation; (6) Fees; (7) Undertaking; (8) Legal clearance; (9) Vigilance Clearance and the provisions of the Regulations notified. After detailed discussions, the BOGs approved the enhancement of intake capacity of MBBS seats in 32 Medical Colleges as mentioned in Annexure-A

2.2 Consideration of grant of registration to the candidates of University of Perpetual Help Rizal, Jonelta Foundation School of Medicine, Lasw Pinas City, Phillipines :

The Board of Governors considered the letter received from Shri K.A. Georgekutty, Second Secretary, Embassy of India, Manila, in response to the Council's correspondence seeking confirmation of recognition of Medical qualification awarded by the University of Perpetual Help Rizal, Jonelta Foundation School of Medicine, Las Pinas City, Philippines for enrollment as medical practitioner in Philippines and the authenticity of the medical degree certificate awarded to applicants seeking registration with MCI. It was noted that the Embassy of India clarified that UPHR-JFSM is also a recognized High Education Institution offering the Doctor of Medicine Programme recognized by Commission on Higher Education, Philippines. No. F.9-31/2006-U3(A) dated 30.5.2008. Sri Siddhartha Medical College, Tumkur is a constituent the above University. The request of the College was considered by the Board of Governors and it has been decided to approve change of the affiliating University from Rajiv Gandhi University of Health Sciences, Bangalore to Sri Siddhartha University, Tumkur, in respect of the students being trained at Sri Siddhartha Medical College, Tumkur.

2.5 Suggestion received from Chairman, Planning, Coordination & Monitoring, Board of Minorities regarding increase of seats in PG Courses :

The BOGs noted that the GOI as a one time grant issued letter of permission for increase of PG seats in Govt. medical colleges based on the available faculty in 2009...?

Further, to enhance the seats in PG courses, teacher-student ratio was from 1:1 to 1:2 and in some selected course, as per the country's need, the ratio was increased to 1:3 by means of notification. The BOGs perused the request of from Chairman, Planning, Coordination & Monitoring, Board of Minorities and in the light of above relaxation decided to maintain status quo in order that the quality of PG medical education training in the country is not compromised.

2.8 Consideration of proposal of National Commission for Scheduled Caste received through MoH&FW for relaxation of qualifying percentile for SC/ST/OBC candidates for admission to postgraduate courses :

The Board of Governors perused the letter of Central Govt dated May 31, 2013, carefully examined the reasons recorded therein; taken note of the consent given by Chairperson to the proposal of Central Government to reduce the marks so as ensure that postgraduate seats should not go waste and also taken note of various materials including representations in this regard and decided to ratify the decision of Council communicated earlier. However, percentile so reduced shall not be less than percentage as provided in unamended Postgraduate Medical Education Regulation relating to admission to postgraduate medical courses for general category of SC/ST and physically handicapped persons. Decision of the Board of Governors be communicated to the Central Govt forthwith.

decided that the State Medical Councils be requested to provide required information in a prescribed format (to be developed by Dr. Manoj K. Singh, Member, BOG) so that the information so received could be analyzed for a proper presentation in the forthcoming SEARMCM.

Further, the State Medical Councils may be categorized into Group Councils, region-wise, so that each Member of BOGs, may be made in-charge of a particular Group for the purpose of direct interaction with the Group of Councils of their respective region. In all, there are 25 State Medical Councils and these could be divided into 5 Groups as under :

- 1) Southern Region;
- 2) Eastern Region;
- 3) Western Region;
- 4) Central Region;
- 5) Northern Region;

After the SEARMCM, a meeting of the various Regional Councils would be organized so that proper implementation of the recommendations made at the SEARMCM are successfully implemented.

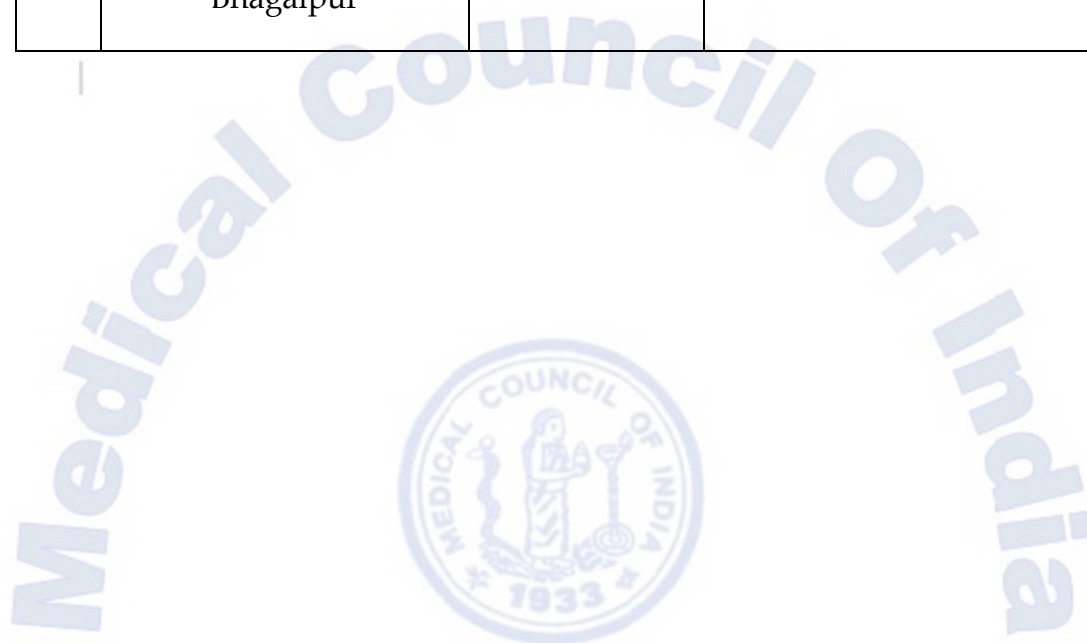
