The Executive Committee of the Council confirmed the minutes of the last meeting held on 14/03/2014 & 27/03/2014.

2. <u>Minutes of the last meeting of the Executive Committee – Action taken</u> thereon.

Read: the action taken on the minutes of the Executive Committee Meeting held on 14/03/2014 & 27/03/2014.

The Executive Committee of the Council noted the action taken on the minutes of the Executive Committee meeting held on 14/03/2014 & 27/03/2014.

The Committee decided that from now onwards minutes of the meeting should be placed on the Council website only after their confirmation.

The Committee pointed out that in Item No. 2 (31) of minutes of Executive Committee meeting dt.14.03.2014, the TEQ Regulations quoted with regard to the posts of Professor / Associate Professor were not the amended regulations as notified vide amendment dated 21/07/2009 and therefore directed the Council office to make the necessary corrections in the minutes as well as on the Council Website. They also directed the office to issue corrigendum to all the concerned State authorities incorporating the amendment dated 21/07/2009 in this regard which reads as under:

"4. The Teaching / Research experience requirements in all the subjects of Broad Specialities shown in Table I shall be substituted as under:

- (A) Professor: (i) As Associate Professor in the subject concerned for three years in the recognized medical college.
 - (ii) Minimum of four research publications in indexed / national journals.
- (B) Associate Professor: (i) As Assistant Professor in the subject concerned for four years in the recognized medical college.
- (ii) Minimum of two research publications in indexed / national journals. "

Note: There is no change in respect of the post of Assistant Professor.

The Executive Committee further decided that the Equivalence of DNB qualifications as well as foreign degrees recognized by the Central Govt., Ministry of Health & F.W. with Indian degrees (MD/MS) should be reviewed and be referred to academic committee.

3. <u>Pending Items arising out of the decisions taken by the Executive</u> <u>Committee.</u>

Read: the pending items arising out of the decisions taken by the Executive Committee.

The Executive Committee noted the pending items arising out of the decisions taken by the Executive Committee.

Item No.3(1) Legal opinion may be taken on whether postgraduate recognition assessment of various courses run by Aarupadai Veedu Medical College & Hospital, Puducherry where request has been received u/s 11(2) from the college authorities and forwarded by Central Govt. should be conducted or not in view of the pending CBI inquiry as well as decision of the Ethics Committee in this regard.

Bankura Sammilani Medical College, Bankura - renewal of permission for admission of 2nd batch of MBBS students against the increased intake i.e. from 100 to 150.

Read: the matter with regard to Bankura Sammilani Medical College, Bankura - renewal of permission for admission of 2nd batch of MBBS students against the increased intake i.e. from 100 to 150.

The Executive Committee considered the Council Assessor report (5th & 6th March,2014) and noted the following:-

- 1. Deficiency of faculty is (a) Professor: 5 out of 24 & (b) Asso. Prof.: 5 out of 40 as detailed in report.
- 2. No information about citizen charter on Website.
- 3. No workshops have been conducted by MEU during the year.
- 4. There is no lecture theater in hospital building.
- 5. Central photographic unit is not available.

- 6. In OPD, Speech Therapy is not available. Paediatrics OPD does not have Child Guidance Clinic & Immunization Clinic. Child rehabilitation clinic is not available.
- 7. MRD is not computerized. ICD X classification is not available.
- 8. Resuscitation equipment like defibrillator, ventilator, etc. are not available in central Casualty.
- 9. RICU is not available. Occupancy in MICU is 40 % on day of assessment.
- 10. Only 2 mobile X-ray Units are available against requirement of 6.
- 11. Dietician is not available.
- 12. In Anatomy museum, MRI/CT films are not available. Lockers are inadequate. Dissection hall is small and has only 13 tables.
- 13. Other deficiencies as pointed out in the inspection report.

In view of the above, the Executive Committee of the Council decided to recommend to the Central Govt. not to renew the permission for admission of 2nd batch of MBBS students against the increased intake from 100 to 150 at Bankura Sammilani Medical College, Bankura for the academic year 2014-15.

5. <u>Prathima Institute of Medical Sciences (PIMS), Karimnagar - increase in</u> MBBS seats from 150 to 250 for academic year 2014-15.

Read: the matter with regard to Prathima Institute of Medical Sciences (PIMS), Karimnagar- increase in MBBS seats from 150 to 250 for the academic year 2014-15.

The Executive Committee considered the Council Assessor report (5th & 6th March,2014) and noted the following:-

- 1. Daily average OPD attendance is 2374. On the day of assessment, it was 2301; hence qualifying criteria 6 (ii) as prescribed under Opening of new or Higher Course or Increase in Admission Capacity Regulations requiring minimum OPD attendance of 3,000 is not fulfilled.
- 2. Number of quarters available for non-teaching staff is only 16 against requirement of 36 as per Regulations.
- 3. Equipment in Physiology, Biochemistry, Pathology department is inadequate as detailed in the report.
- 4. Other deficiencies as pointed out in the inspection report.

In view of the above, the executive committee decided to recommend to the Central Government to disapprove the scheme submitted by the institute for increase in admission capacity from 150 to 250 and return the application of the institute for the academic year 2014-15 as the eligibility criteria prescribed in Opening new or higher course or increase of admission capacity Regulations as amended are not fulfilled.

6. <u>Dr. Somervell Memorial C.S.I. Medical College & Hospital, Karakonam,</u> <u>Thiruvananthpuram Dist</u> - increase in MBBS seats from 100 to 150 for academic year 2014-15 and also continuance of recognition of the college for the award of M.B.B.S. degree(100 seats).

Read: the matter with regard to Dr. Somervell Memorial C.S.I. Medical College & Hospital, Karakonam, Thiruvanthapuram Dist - increase in MBBS seats from 100 to 150 for academic year 2014-15 and also continuance of recognition of the college for the award of M.B.B.S. degree (100 seats).

The Executive Committee considered the Council Assessor report (10th & 11th March,2014) and noted the following:-

- Only 8 quarters for non-teaching staff are available against requirement of 36. Bachelor's accommodation in a 4 seater room cannot be accepted as quarters.
- 2. Radio-diagnosis Department: Workload of Plain X-rays, special investigations, C.T. scan & MRI is inadequate.
- 3. Number of normal delivery & CS on the day of inspection is only 1 each.
- 4. ICUs: Attendance in RICU is 40 % on day of assessment.
- 5. Other deficiencies as pointed out in the inspection report.

In view of the above, the Executive Committee of the Council decided

(1) to recommend to the Central Govt. not to grant letter of Permission for increase in MBBS seats from 150 to 250 for the academic year 2014-15 at Dr. Somervell Memorial C.S.I. Medical College & Hospital, Karakonam, Thiruvananthapuram Dist., 2) not to recommend continuance of recognition of MBBS degree granted by **Kerala University** of Health Sciences, Trissur in respect of students being trained at Dr. Somervell Memorial C.S.I. Medical College & Hospital, Karakonam, Thiruvanthapuram Dist and further decided that the institute be asked to submit the compliance for rectification of the above deficiencies within 3 months.

7. Assessment of the physical and other teaching facilities available for renewal of permission for MBBS course for 5th batch (150 seats) of Sri Muthukumaran Medical College, Hospital & Research Institute, Chennai under the Tamilnadu Dr. M.G.R. The Executive Committee considered the Council Assessor report (5th & 6th March,2014) and noted the following:-

- 1. Seven out of nine Senior residents in General Surgery have not been considered as their names were not found in any OT list of previous months after their appointment and they had no residence proof as per MCI requirement. Four of them were absent at 11 a.m. attendance also.
- 2. Resultantly, there is shortage of Residents as 8.4 % (i.e. 17 out of 143) as detailed in report.
- 3. Planning permission application is still under consideration of Chennai Metropolitan Development Authority and is not yet approved.
- 4. Clinical material is inadequate on the day of assessment. OPD attendance was 620 and bed occupancy was 60 %.
- 5. Histopathological & Cytopathological workload are inadequate.
- 6. On the day of assessment, there were only 2 patients each in SICU & RICU. There was no patient in PICU.
- 7. Other deficiencies as pointed out in the inspection report.

In view of the above, the Executive Committee of the Council decided to recommend to the Central Govt. not to renew the permission for admission of 5th batch (150 seats) of Sri Muthukumaran Medical College, Hospital & Research Institute, Chennai under the Tamilnadu Dr. M.G.R. Medical University, Chennai u/s 10A of the IMC Act, 1956 for the academic year 2014-2015.

8. <u>Assessment of the physical and other teaching facilities available for</u> renewal of permission for MBBS course for 4th batch (100 seats) of Indira Gandhi Institute of Medical Sciences, Sheikhpura, Patna under the Indira Gandhi Institute of Medical Sciences, Patna (Deemed University) u/s 10A of the IMC Act, 1956 for the academic year 2014-2015.

Read: the matter with regard to assessment of the physical and other teaching facilities available for renewal of permission for MBBS course for 4th batch (100 seats) of Indira Gandhi Institute of Medical Sciences, Sheikhpura, Patna under the Indira Gandhi Institute of Medical Sciences, Patna(Deemed University) u/s 10A of the IMC Act, 1956 for the academic year 2014-2015.

The Executive Committee considered the Council Assessor report (6th & 7th March,2014) and noted the following:-

- 1. Shortage of Residents is 17.48 % as detailed in the report.
- 2. There are no deliveries conducted in the hospital. Labour room has been made functional only on 06/01/2014 but no labour is conducted there.
- 3. Both the existing lecture theaters in the college & one in the hospital are not of gallery type which is not as per Regulations.

- 4. Area of Central Library is 900 sq.m. approximately which is inadequate against requirement of 1,600 sq.m.
- 5. Common room for boys does not have attached toilets.
- 6. Hostel accommodation is available for 272 students against requirement of 300 as per Regulations.
- 7. MRD is no computerized. ICD X classification for indexing is not available.
- 8. Some OTs have more than 1 table each which is not as per MCI norms.
- 9. Equipment in CSSD is inadequate. There are no bowl sterilizers and instrument washing machine.
- 10. Anatomy department: There are no lockers for students.
- 11. Students are not posted at RHTC / UHC. Residential accommodation is not available at RHTC. Mess is not available at RHTC. Paramedical staff is not available at RHTC / UHC.
- 12. Other deficiencies as pointed out in the inspection report.

In view of the above, the Executive Committee of the Council decided to recommend to the Central Govt. not to renew the permission for admission of 4th batch (100 seats) of Indira Gandhi Institute of Medical Sciences, Sheikhpura, Patna under the Indira Gandhi Institute of Medical Sciences, Patna (Deemed University) u/s 10A of the IMC Act, 1956 for the academic year 2014-2015.

9. <u>Assessment of the physical and other teaching facilities available for</u> renewal of permission for MBBS course for 5th batch (100 seats) of Jawaharlal Nehru Institute of Medical Sciences, Porompet, Imphal, Manipur under the Manipur University, Manipur u/s 10A of the IMC Act, 1956 for the academic year 2014-2015.

Read: the matter with regard to assessment of the physical and other teaching facilities available for renewal of permission for MBBS course for 4th batch (150

seats) of Madha Medical College & Hospital, Thandalam, Chennai under the Tamilnadu Dr. M.G.R. Medical University, Chennai u/s 10A of the IMC Act, 1956 for the academic year 2014-2015.

The Executive Committee considered the Council Assessor report (10th & 11th March,2014) and noted the following:-

- 1. Shortage of Residents is 18.75 % (i.e. 24 out of 128) as under:
 - (a) Senior Residents: 10 (General Medicine: 2, Paediatrics: 2, Tb & Chest: 2, Skin & VD: 1, General Surgery: 2, O.G.: 1)
 - (b) Junior Resident: 14 (Paediatrics:1, Tb & Chest: 3, Skin & VD: 1, Psychiatry: 2, General surgery: 6, Ophthalmology:1).
- Clinical material is not of good quality. Surgery department had 10 postoperative cases. Admitted cases were mostly of pain in abdomen and vomiting. None were having I.V. fluids, etc. running. Orthopaedics ward had mostly Osteoarthritis cases with very few post-operative cases. Basic surgical procedures were being performed in OTs.
- 3. There was no normal delivery & only 1 Caesarean section on the day of assessment. The number of deliveries is very less (only 10 20 / month, incl. caesarean section).
- 4. There was no patient in NICU on day of assessment.
- 5. Accommodation for students is available for 330 students only against 452 students as per Regulations.
- 6. Quarters for non-teaching staff available are only 26 against requirement of 36 as per Regulations.
- 7. Lecture theater in the hospital is not of gallery type.
- 8. RHTC & UHC are located in leased accommodation for 11 months. Residential accommodation is not available at RHTC.
- 9. Other deficiencies as pointed out in the inspection report.

In view of the above, the Executive Committee of the Council decided to recommend to the Central Govt. not to renew the permission for admission of 4th batch (150 seats) of Madha Medical College & Hospital, Thandalam, Chennai under the Tamilnadu Dr. M.G.R. Medical University, Chennai u/s 10A of the IMC Act, 1956 for the academic year 2014-2015.

The Executive Committee considered the Council Assessor report (21st & 22nd March,2014) and noted the following:-

- 1. Deficiency of faculty is 13.8 % (i.e. 19 out of 137).
- 2. Shortage of Residents is 45. 83 % (i.e. 66 out of 144).
- 3. Clinical material is inadequate. Average bed occupancy is 50 %; on the day of assessment, it was 40 %.
- 4. Daily average OPD attendance is only 130. On day of assessment, it was 110.
- 5. Radiological and laboratory workload are grossly inadequate as detailed in the report.
- 6. Histopathological & Cytopathological workload is NIL.
- 7. ICD X classification is not followed for indexing.
- 8. Records are not properly maintained in Central Casualty.
- 9. Special casualty for O.G.: No Beds are available.
- 10. Technical staff is inadequate in Central Clinical Laboratory.
- 11. ICUs: There was no patient in ICCU, MICU, NICU / PICU & RICU. There was only 1 patient in SICU.
- 12. There was no blood unit stored in blood bank on the day of assessment.
- 13. Intercom is not available.
- 14. Results of examination are not displayed on website of the college.
- 15. Toilet facilities are inadequate in Residents' hostel.
- 16. Nurses' accommodation is available outside the campus.
- 17.OPD: Child guidance clinic & child rehabilitation clinic are not available in Paediatrics OPD. Cancer detection clinic is not available in O.G. O.P.D.
- 18. Anatomy Department: Washroom for embody is not available. No wet gross section is available.
- 19. Pathology Department: Audiovisual aids are not available in 1 demonstration room & seminar room.
- 20. Forensic Medicine Department: Facilities are inadequate in museum.
- 21. Community Medicine Department: There is no seminar room. There are no audiovisual aids.
- 22. RHTC & UHC are under the control of Government of Punjab. Residential accommodation is not available at RHTC. Students are not posted at RHTC.
- 23. Residential quarters for teaching and non-teaching staff no information has been given in the assessment report or by the Institution .
- 24. Other deficiencies as pointed out in the inspection report.

(c) Asst. Prof.: 5 (Community Medicine: 2, General Medicine: 2, General Surgery: 1)

(d) Tutor: 2 (Anatomy: 1, Biochemistry: 1)

2. Shortage of Residents is 32 % (i.e. 21 out of 64) as under:

(a) Senior Resident: 13 (Ophthalmology: 2, Orthopaedics: 1, General Medicine: 3, General Surgery: 3, Radiodiagnosis: 3, Dentistry: 1)

- (b) Junior Resident: 8 (ENT: 1, Ophthalmology: 2, General Medicine: 2, O.G.: 2, Psychiatry: 1)
- 3. Radiodiagnosis: Special investigations are not performed.
- 4. Cytopathological investigations are not performed.
- 5. Pharmaco-vigilance committee is non-existent.
- 6. Residents' accommodation is available for only 8 Residents against requirement of 35 as per Regulations.
- 7. Recreational facilities are not available.
- 8. Speech Therapy is not available.
- 9. Paramedical staff is inadequate in Forensic Medicine, Community Medicine, Pharmacy.
- 10. Child rehabilitation clinic & Cancer detection clinic are not available.
- 11. ICD X classification is not followed for indexing.
- 12. There is a combined ICU block. Separate MICU, SICU & RICU are not available.
- 13. Eclampsia room is not available in Labour Room.

- 14. Anatomy Department: Students' lockers, Band saw & Embalming machine are not available.
- 15. Physiology Department: Research laboratory & Mammalian laboratory are not available.
- 16. Biochemistry Department: Practical Laboratory & library are not available.
- 17. Pathology Department: catalogues are not available in museum.
- 18. Microbiology Department: Practical laboratory, Museum & Demonstration room are not available. Only 5 service laboratories are available against requirement of 7.
- 19. Pharmacology Department: Both practical laboratories, Departmental library, Research laboratory & Museum are not available. Demonstration room is not furnished.
- 20. Forensic Medicine Department: Demonstration room, Departmental library, Research laboratory & Practical laboratory are not available. Museum facilities are inadequate.
- 22. Community Medicine Department: Museum is not prepared. Practical laboratory & Research laboratory are not available.
- 23. Common rooms for Boys & girls are not available.
- 24. Hostel accommodation is available for only 68 against requirement of 75 as per Regulations.
- 25. MEU: Medical education technology workshops have not been conducted in the last year.
- 26. Other deficiencies as pointed out in the inspection report.

- 10. Most of the admitted patients were of minor vague ailments not requiring admission and not related with the department where admitted.
- 11. There was no patient in labour room on day of assessment. No normal delivery was conducted on day of assessment.
- 12. Radiological investigation workload is inadequate.
- 13. There is no flow meter and suction in central casualty. Resuscitation equipment is grossly inadequate. Emergency O.T. is not available.
- 14. ICU: Room designated as NICU / PICU is used by a super specialist. Occupancy is less in ICCU & SICU.
- 15. Rooms for septic cases & Eclampsia cases are not available in Labour room.
- 16. Residential accommodation is not available at RHTC Ramnagara.
- 17. Other deficiencies as pointed out in the inspection report.

In view of the above, the Executive Committee of the Council decided to recommend to the Central Govt. not to renew the permission for admission of 2nd batch (150 seats) of BGS Global Institute of Medical Sciences, Bangalore, Karnataka under the Rajiv Gandhi University of Health Sciences, Bangalore, Karnataka u/s 10A of the IMC Act, 1956 for the academic year 2014-2015.

28. <u>Bangalore Medical College & Research Institute, Bangalore – Renewal of</u> <u>Permission for admission of 4th Batch of MBBS students against the</u> <u>increased intake i.e. from 150 to 250 for the academic session 2014-15.</u>

Read: the matter with regard to Bangalore Medical College & Research Institute, Bangalore - Renewal of Permission for admission of 4th Batch of MBBS students against the increased intake i.e. from 150 to 250 for the academic session 2014-15.

The Executive Committee considered the Council Assessor report (11th & 12th March, 2014) and noted the following:-

- 1. There are only 4 lecture theaters of capacity 300 against requirement of 6 as per Regulations. Lecture Theater of 650 capacity is not available.
- 2. Hostels: Accommodation available for students is 746 against requirement of 950 as per Regulations. None of the hostels has recreational rooms, visitors' room, etc. Some hostels in boys' hostels do not have required furniture.
- 3. Only 56 quarters are available for both teaching & non-teaching staff against requirement of 42 for teaching & 36 for non-teaching staff as per Regulations.
- 4. O.T.s have more than 1 table which is not as per norms.
- 5. Space for faculty is inadequate in Physiology department.
- 6. Only 2 demonstration rooms are available in Microbiology department; both these rooms are having lesser capacity than required as per Regulations.
- 7. Other deficiencies as pointed out in the inspection report.

In view of the above, the Executive Committee of the Council decided to recommend to the Central Govt. not to renew the permission for admission of 4th Batch of MBBS students against the increased intake from 150 to 250 for the academic session 2014-15 at Bangalore Medical College & Research Institute, Bangalore.

Government Medical College, Kozhikode - Renewal of Permission for 29. admission of 4th Batch of MBBS students against the increased intake i.e. from 200 to 250 for the academic session 2014-15.

Read: the matter with regard to Government Medical College, Kozhikode -Renewal of Permission for admission of 4th Batch of MBBS students against the increased intake i.e. from 200 to 250 for the academic session 2014-15.

The Executive Committee considered the Council Assessor report (13th & 14th March, 2014) and noted the following:-

- 1. Daily average OPD attendance is 2,188 and on the day of assessment is 2,803 which is less than 3000 required as per eligibility criterion 6 (ii); hence eligibility criteria are not fulfilled.
- 2. Shortage of Residents is 24.72 % (i.e. 44 out of 178) as under:
 - 42 (a) Senior Resident: (General Medicine: 6, Paediatrics: 8, Anaesthesiology: 9, General Surgery: 12, Orthopaedics: 3, O.G.: 4)
 - (b) Junior Resident: 2 (Ophthalmology: 2)

- 3. Lecture Theaters: Available lecture theaters are 7 of 250 capacity & 2 of 150 capacity against requirement of 6 of 300 & 1 of 650 as per Regulations. Out of these, 5 lecture theaters of 250 capacity & 2 of 150 capacity are not of gallery type which is not as per Regulations.
- 4. Central Library: Area is 2,600 sq.m. only against requirement of 4,000 sq.m. as per Regulations. Foreign journals are not available in physical form.
- 5. Common room for boys is not available.
- 6. Central Laboratory: ABG Analyzer is not available.
- 7. Residential accommodation is not available at RHTC. Mess is not available.
- 8. Paramedical staff like Medical Social Worker, Health Inspector, et al. are not available.
- 9. Other deficiencies as pointed out in the inspection report.

In view of the above, the Executive Committee of the Council decided to recommend to the Central Govt. not to renew the permission for admission of 4th Batch of MBBS students against the increased intake from 200 to 250 for the academic session 2014-15 at Government Medical College, Kozhikode.

30. <u>Govt. Medical College, Jammu – Renewal of Permission for admission of</u> 2nd Batch of MBBS students against the increased intake i.e. from 100 to 150 for the academic session 2014-15.

Read: the matter with regard to Govt. Medical College, Jammu – Renewal of Permission for admission of 2nd Batch of MBBS students against the increased intake i.e. from 100 to 150 for the academic session 2014-15.

The Executive Committee considered the Council Assessor report (21st & 22nd March,2014) and noted the following:-

- 1. Capacity of 2 lecture theaters is 160 each against requirement of 180 each as per Regulations.
- 2. Central Library: Area is 1500 sq.m. approximately against requirement of 2400 sq.m. as per Regulations.
- 3. Hostels: Accommodation is available for 195 students only against requirement of 412 at this stage as per Regulations.
- 4. Interns' Hostel has capacity of only 32 against requirement of 100 at this stage.
- 5. Residents / P.G. Hostel has capacity of only 32 against requirement of 85.
- 6. OPD attendance is only 650.
- 7. Radiodiagnosis department: Special investigations are not performed.
- 8. MRD is partly computerized.
- 9. Anatomy Department: MRI / CT films are not available in museum. Number of articulated skeletons are less.
- 10. Biochemistry Department: Equipment like Ultraviolet Lamp & Electrophoresis Apparatus are not available.

- 11. Pathology Department: Equipment like Histokinette, Paraffin Embedding Bath, Demonstration Eye Piece, Magnifying Glass, Liver Biopsy needle, X-ray View Box, Drill, Blow Pieces, U.V. lamp, Stopwatch, etc. are not available.
- 12. Microbiology Department: Equipment like B.O.D. Incubator, Dark Ground Microscope, Arnold's Sterilizer, Serum Inspissator & Electrophoresis Set are not available.
- 13. Pharmacology Department: Equipment like Spectrophotometer, Flame Photometer, Ultra Centrifuge, Vacuum Dessicator, etc. are not available.
- 14. Forensic Medicine Department: Equipment like Hacksaw, Weighing Scale for Dead Body, Anthropometric Set, Automatic Tissue Processor, Hot Plate, etc. are not available.
- 15. Community Medicine Department: Equipment like Dissecting Microscopes, Electric Sterilizer are not available.
- 16. RHTC is under control of BMO and not under Dean.
- 17. Other deficiencies as pointed out in the inspection report.

In view of the above, the Executive Committee of the Council decided to recommend to the Central Govt. not to renew the permission for admission of 2nd Batch of MBBS students against the increased intake i.e. from 100 to 150 for the academic session 2014-15 at Govt. Medical College, Jammu.

31. <u>Gandhi Medical College, Secunderabad – Renewal of Permission for</u> <u>admission of 2nd Batch of MBBS students against the increased intake i.e.</u> <u>from 150 to 200 for the academic session 2014-15.</u>

The Executive Committee considered the Council Assessor report (21st & 22nd March,2014) and noted the following:-

- 1. Lecture theater in hospital is of capacity of 150 against requirement of 240. Some lecture theaters are not air-conditioned.
- 2. Hostels for Students: Accommodation is available for 602 students against requirement of 750.
- 3. Interns' Hostel: Accommodation is available for 114 interns against requirement of 150.
- 4. Residents' Hostel: Accommodation is available for 135 Residents against requirement of 148.
- 5. Quarters: Only 3 quarters are available for teaching faculty against requirement of 36 & 10 quarters are available against requirement of 36 for non-teaching staff.
- 6. MRD is not computerized.
- 7. CSSD: Bowl sterilizer & Instrument Washing Machine are not available.
- 8. Other deficiencies as pointed out in the inspection report.

In view of the above, the Executive Committee of the Council decided to recommend to the Central Govt. not to renew the permission for admission of 2nd Batch of MBBS students against the increased intake from 150 to 200 for the academic session 2014-15 at Gandhi Medical College, Secunderabad.

32. <u>Increase in MBBS seats from 100 to 150 at Saraswati Institute of Medical</u> <u>Sciences, Hapur.</u>

Read: the matter with regard to increase in MBBS seats from 100 to 150 at Saraswati Institute of Medical Sciences, Hapur.

The Executive Committee considered the matter with regard to the application for increase in MBBS seats from 100 to 150 at Saraswati Institute of Medical Sciences, Hapur and observed that the Essentiality Certificate submitted by the college was of the year 2007 when they had applied for starting of the college. The committee also observed that along with the application for increase of seats from 100 to 150 no fresh essentiality certificate or Permission Letter for increase of seats from 100 to 150 issued by the State Govt. of U.P. was submitted by the college.

It also observed that Section 3 (2) of (Qualifying Criteria) of Part II of Opening of New or Higher Course of Study and Increase in Admission Capacity in any Course of Study, etc. Regulations, 2000 reads as under:

"3

(2) The Permission Letter regarding desirability and feasibility of having an increase of seats in the existing medical college / institution for aforesaid courses has been obtained by the applicant from the respective State Government or the Union Territory Administration."

As the institute has failed to submit the Statutory / Mandatory Permission Letter/Essentiality Certificate as required under Section 3 (2) of (Qualifying Criteria) of Part II of Opening of New or Higher Course of Study and Increase in Admission Capacity in any Course of Study, etc. Regulations, 2000, the Executive Committee decided to return the application to the Central Government recommending disapproval of the scheme.

33. <u>Recognition/Approval of L.N. Medical College, Bhopal u/s 11(2) of the I.M.C.</u> <u>Act, 1956 and Complaint received from Hon'ble M.P. (Lok Sabha) Sh.</u> <u>Premchand Guddu, regarding irregularities in faculty / admission at L.N.</u> <u>Medical College, Bhopal.</u>

Read: the matter with regard to Recognition/Approval of L.N. Medical College, Bhopal u/s 11(2) of the I.M.C. Act, 1956 and Complaint received from Hon'ble M.P. (Lok Sabha) Sh. Premchand Guddu, regarding irregularities in faculty / admission at L.N. Medical College, Bhopal. The Executive Committee considered the matter with regard to Recognition/approval of L.N. Medical College, Bhopal for the award of MBBS degree for 150 seats granted by Barkatulla University, Bhopal and decided to recommend to the Central Government for approval u/s 11(2) of the IMC Act, 1956 from 2014.

The Executive Committee further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16^{th} April 2010 and act accordingly at appropriate time, which reads as under:-

8 (3) ...

(2) The recognition so granted to an Undergraduate Course for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.

(3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.

(4) Failure to seek timely renewal of recognition as required in sub-clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute."

34. Complaint against Travancore Medical College, Kollam – Regarding.

The Executive Committee considered the matter with regard to complaint against Travancore Medical College, Kollam and decided to defer the matter till the request u/s 11(2) is received from the Central Govt. and the fresh assessment is carried out.

The matter was considered along with item No.76 since they were of similar nature.

36. <u>Minutes of the Two Ethics Committee meeting held on 4th January, 2014</u> and 21st & 22nd February, 2014, for approval.

Read: the matter with regard to minutes of the two Ethics Committee meeting held on 4th January, 2014 and 21st & 22nd February, 2014 for approval.

The Executive Committee approved the Minutes of Ethics Committee meeting dt. 04/01/2014.

With regard to minutes of 21/22 February, 2014, the Executive Committee observed the following:

<u>Item # 12.:</u> The following part of decision is not in accordance with IMC Act, 1956 as in accordance with Section 27 of the IMC Act, 1956, a doctor borne on Indian Medical Register can practice anywhere in India and therefore be deleted:

(I) (b) He is practicing in Delhi and West Bengal without any permission or registration with the respective State Medical Councils.

<u>Item # 14.</u>: The precise Regulation said to have been violated has not been mentioned by the Ethics Committee. Further, perusal of available records show that this seems to be a case of misrepresentation and / or fraud of having obtained M.D. (General Medicine) from Calcutta University for which a police complaint has already been lodged. As he is being sentenced *in absentia*, it would be essential to obtain the latest status of the complaint from the police authorities. In this view of the matter, it be remanded back to Ethics Committee for appropriate decision.

<u>Item # 23:</u> Ethics Committee meeting dt. 27 & 28/09/2013 and 18/10/2013. Detailed Minutes are not enclosed. Refer back to Ethics Committee.

<u>Item # 25.</u>: The last sentence in the earlier decision seems to be incomplete. Also, the decision itself is not clear. The contentions of the petition were to be treated as representation and therefore should be included in the present decision. Hence the matter is remanded back to Ethics Committee for appropriate decision.

- 11. Serology and Cytopathology investigations are not performed.
- 12. ICD X classification is not followed for indexing.
- 13. Resuscitation equipment is inadequate in O.T.s.
- 14. SICU, PICU / NICU are not available.
- 15. CSSD: Equipment & staff are inadequate.
- 16. Residential accommodation is non-functional at RHTC.
- 17. Details of website are not available in the report.
- 18. Other deficiencies as pointed out in the inspection report.

In view of the above, the Executive Committee of the Council decided to recommend to the Central Govt. not to renew the permission for admission of 2nd Batch of MBBS students against the increased intake from 50 to 100 for the academic session 2014-15 and also not approved for continuance of recognition of 50 MBBS seats.

- 9. CSSD: Receiving and Distribution points are not separate. Instrument washing machine & ETO Sterilizer are not available.
- 10. Intercom: It is installed partially.
- 11. Physiology Department: There are no beds in Clinical Physiology laboratory.
- 12. Biochemistry Department: There is no Demonstration Room having capacity of 75.
- 13. Pathology Department: There is no Demonstration Room having capacity of 75. Offices for faculty are inadequate.
- 14. Microbiology Department: There is no Demonstration Room having capacity of 75. Offices for faculty are inadequate.
- 15. Pharmacology Department: Offices for faculty are inadequate.
- 16. Other deficiencies as pointed out in the inspection report.

In view of the above, the Executive Committee of the Council decided to recommend to the Central Govt. not to renew the permission for admission of 2nd Batch of MBBS students against the increased intake i.e. from 100 to 150 for the academic session 2014-15 at Patna Medical College, Patna.

- 15. RHTC is not under direct administrative control of Dean.
- 16. Institute is running DNB course in Orthopaedics.
- 17. Generator capacity is 440 kW; hence it is inadequate.
- 18. There is no separate casualty for O.G.
- 19. Blood component separation facility is not available.
- 20. Other deficiencies as pointed out in the inspection report.

In view of the above, the Executive Committee of the Council decided to recommend to the Central Govt. not to renew the permission for admission of 2nd batch of MBBS students against the increased intake from 100 to 150 for the academic session 2014-15 at Shri Vasantrao Naik Govt. Medical College, Yavatmal.

The Executive Committee further decided not to recommend continuance of recognition of MBBS (100 seats) granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at Shri Vasantrao Naik Govt. Medical College, Yavatmal.

The Executive Committee considered the matter with regard to NOC for undergoing Compulsory rotating internship training for 09 months in United States of America and decided to approve the same.

68. <u>Increase in MBBS seats from 75 to 100 at Christian Medical College,</u> <u>Ludhiana, Punjab.</u>

Read: the matter with regard to increase in MBBS seats from 75 to 100 at Christian Medical College, Ludhiana, Punjab.

The Executive Committee noted that the matter with regard to renewal of permission for admission for 4th batch of MBBS students against increased intake

i.e. from 50 to 75 at Christian Medical College, Ludhiana is already in consideration of the Medical Council of India and the file has been sent to assessment cell for carrying out the assessment for the same.

The Executive Committee also noted decision taken at its meeting held on 14th March 2013 which reads as under:

The Executive Committee further decided that no college should be considered for further increase of seats unless it is recognized for the existing number of seats."

In view of above, it was decided to carry out the assessment for 4th batch of 75 MBBS seats. With regard to increase from 75to 100 MBBS seats, it was decided to return the application to the Central Govt. recommending disapproval of the scheme.

The Executive Committee noted that the Council vide letter dated 17.02.2014, has returned application of VSS Medical College, Burla, Orissa for increase in MBBS seats from 150 to 250 for the academic year 2014-15 to the Central Government, Ministry of Health & Family Welfare with recommendation to disapprove it, as the application was found deficient in terms of the following:-

- o "Consent of Affiliation is not in prescribed format.
- Required bed strength is 1200.
- Required OPD is 3000."

It also noted that the Central Govt., Ministry of Health & FW has forwarded the letter of Principal and Dean, VSS Medical College, Burla, Orissa vide No. Edn/MBBS/MCI/5944MC dated 24.02.2014, enclosing therewith a copy of the Consent of Affiliation and Essentiality Certificate, but these certificates have been issued after the cut-off date for receipt of applications –i.e. 30/09/2013.

In view of above, the Executive Committee decided to reiterate the decision of the Committee taken at its meeting held on 10.02.2014 and communicated to Central Govt. vide Council letter dated 17.02.2014 to recommend the Central Government to disapprove the scheme since the essential documents had been submitted after the cut-off date of 30.9.2013.

In view of above, it was decided to return the application to the Central Government recommending disapproval of the scheme.

The Executive Committee noted that the Law Officer in his opinion dated 26/03/2014 has opined as under:-

"I have perused the clarification dated 25/03/2014 issued by the Tahsildar, Devanhalli, Taluk, Devanhalli, Karnataka and it is in order as Tahsildar has clearly certified that total land owned by applicant Trust is 26 acres 11 Guntas and is owned by it(registered in its name). Further, the land is single contiguous piece of land. Building plan has also approval of Town Municipal Council of Devanhalli. Hence, the file may be further may be processed." In view of above, it was decided to process the application and send the file to Assessment Cell for further necessary action. As regards the unsigned and unnamed complaint received in office of MCI on 27/03/2014, it was decided to hand over the complaint to the Assessors with a request to verify the veracity of allegations contained therein and submit a report on it.

- 5. In Eye & ENT wards, male and female patients are kept in the same wards.
- 6. Lecture Theaters are not air-conditioned. There is no facility for E class.
- 7. Hostels for Students: Accommodation is available only for 336 students against requirement of 375 at this stage. This is further reduced by allocation of rooms to Residents as shown in (1) above.
- 8. OPD: Registration counters are not computerized.
- 9. Bed occupancy, number of major & minor operations and number of plain X-rays are inadequate on day of assessment.
- 10. Special investigations are not performed in Radiodiagnosis department.
- 11. Histopathology & Cytopathology workload is grossly inadequate.
- 12. 800 mA X-ray machine is not installed.
- 13. Research laboratory in Physiology is not adequately equipped.
- 14. Forensic Medicine Museum: Specimens are inadequate.
- 15. Residential accommodation at RHTC, Maddipaddu is not available.
- 16. UHC, Balajinagar is not fully under control of dean.
- 17. Other deficiencies as pointed out in the inspection report.

In view of the above, the Executive Committee of the Council decided to recommend to the Central Govt. not to renew the permission for admission of 4th batch (100 seats) of Rajiv Gandhi Institute of Medical Sciences, Ongole, Andhra Pradesh under Dr. N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 for the academic year 2014-2015.

75. <u>Assessment of the physical and other teaching facilities available for</u> renewal of permission for MBBS course for 4th batch (150 seats) of Srinivas Institute of Medical Sciences & Research Centre, Srinivasnagar, Mangalore, Karnataka under Rajiv Gandhi University of Health Sciences, Bangalore, Karnataka u/s 10A of the IMC Act, 1956 for the academic year 2014-2015.

Read: the matter with regard to assessment of the physical and other teaching facilities available for renewal of permission for MBBS course for 4th batch (150 seats) of Srinivas Institute of Medical Sciences & Research Centre, Srinivasnagar, Mangalore, Karnataka under Rajiv Gandhi University of Health Sciences, Bangalore, Karnataka u/s 10A of the IMC Act, 1956 for the academic year 2014-2015.

The Executive Committee considered the Council Assessor report (28th & 29th March,2014) and noted the following:-

- 1. Dr. K.R. Bhat, Professor & HOD of O.G. is not possessing requisite academic qualification for the post. He possesses qualification from USA which is not equated with M.D. (O.G.) qualification prescribed by MCI.
- 2. Lecture Theaters are not air-conditioned.
- 3. No quarters are available for non-teaching staff.
- 4. OPD: Plaster room is not available. Separate record for patients in Tb & Chest is not available.
- 5. Clinical material is grossly inadequate on day of assessment. OPD attendance is only 318 upto 2 p.m. against requirement of 750. Bed occupancy is 51 %. No normal deliveries was conducted. Operative workload of major & minor operations is inadequate. X-ray investigations are inadequate. Special investigations are not performed. Laboratory investigative workload is much less as detailed in the report.
- 6. ICCU is not available. There were only 3 patients in combined MICU / SICU.
- 7. Blood Bank: As per records, 50 60 % of consumption is in private hospitals and not in medical college.
- 8. CSSD: Bowl sterilizer is not available.
- 9. Pathology Department: Audiovisual aids are available only in 1 Demonstration room.
- 10. Microbiology Department: All service laboratories are ill equipped and nonfunctional. Audiovisual aids are available only in 1 Demonstration room. Media preparation facility, etc. are ill equipped.
- 11. Pharmacology Department: Audiovisual aids are available only in 1 Demonstration room.
- 12. Forensic Medicine Department: Audiovisual aids are available only in 1 Demonstration room.
- 13. Community Medicine Department: Audiovisual aids are available only in 1 Demonstration room.
- 14. Residential accommodation is not available at RHTC.

- 15. UHC: Students are not posted. Specialists' visits are not arranged.
- 16. Other deficiencies as pointed out in the inspection report.

In view of the above, the Executive Committee of the Council decided to recommend to the Central Govt. not to renew the permission for admission of 4th batch (150 seats) of Srinivas Institute of Medical Sciences & Research Centre, Srinivasnagar, Mangalore, Karnataka under Rajiv Gandhi University of Health Sciences, Bangalore, Karnataka u/s 10A of the IMC Act, 1956 for the academic year 2014-2015.

76. <u>Grant of Provisional/Permanent/Additional Qualification registration</u> <u>certificate who possess basic medical qualification/postgraduate medical</u> <u>qualification from medical institutions and/or abroad and Amendment in</u> <u>clause 11 of the Screening Test Regulations, 2002 – consideration of.</u>

Read: the matter with regard to grant of Provisional/Permanent/Additional Qualification registration certificate to those who possess basic medical qualification/postgraduate medical qualification from medical institutions and/or abroad and Amendment in clause 11 of the Screening Test Regulations, 2002.

The Executive Committee noted that in the second last para of the agenda note it was stated that the said matter was discussed in the Executive Committee meeting dated 27.3.2014. This has however been wrongly mentioned as this item was never included in the agenda.

The Committee decided that all the pending applications for provisional registration / permanent registration of foreign graduates (i.e. # 2 & 4 in the table below) and applications for provisional registrations of Indian graduates (i.e. # 1 in the table below) be returned to the applicants along with the fees paid by them with advise to apply to the respective State Medical Councils and all concerned be informed accordingly vide public notice to the required effect:-

77. <u>Change of affiliating University in respect of Rama Medical College,</u> <u>Hospital & Research Centre, Kanpur from Dr. Bhim Rao Ambedkar</u> <u>University, Agra to the Rama University, Kanpur (U.P.).</u>

Read: the matter with regard to change of affiliating University in respect of Rama Medical College, Hospital & Research Centre, Kanpur from Dr. Bhim Rao Ambedkar University, Agra to the Rama University, Kanpur (U.P.).

The Executive Committee decided that the institute be asked to submit the certificate / approval from University Grants Commission with regard to formation of Rama University, Kanpur. It was further decided that it may be advised to the Institution to apply to the Central Government when the first batch admitted under Rama University, Kanpur appears for the III M.B;B.S. Part II examination for recognition u/s 11 (2) of IMC Act, 1956.

78. <u>Change of affiliating University in respect of Rama Medical College,</u> <u>Hospital & Research Centre, Hapur from Chaudhary Charan Singh</u> <u>University, Meerut to the Rama University Uttar Pradesh, Kanpur (U.P.).</u>

Read: the matter with regard to change of affiliating University in respect of Rama Medical College, Hospital & Research Centre, Hapur from Chaudhary Charan Singh University, Meerut to the Rama University Uttar Pradesh, Kanpur (U.P.).

The Executive Committee decided that the institute be asked to submit the certificate / approval from University Grants Commission with regard to formation of Rama University, Kanpur. It was further decided that it may be advised to the Institution to apply to the Central Government when the first batch admitted under Rama University, Kanpur appears for the III M.B;B.S. Part II examination for recognition u/s 11 (2) of IMC Act, 1956.

79. <u>Establishment of New Medical College at Saharsa, Bihar by Sri Narayan</u> <u>Foundation Trust, Saharsa, Bihar u/s 10A of the IMC Act, 1956 for the</u> <u>academic year 2014-15.</u>

Read: the matter with regard to establishment of New Medical College at Saharsa, Bihar by Sri Narayan Foundation Trust, Saharsa, Bihar u/s 10A of the IMC Act, 1956 for the academic year 2014-15.

The members of the Executive Committee perused the letter dt. 11/04/2014 received from the applicant college and observed that as on date, the applicant is not in a position to submit the Essentiality Certificate in the prescribed format of MCI in spite of repeated time granted by the Council.

In view of above, it was decided to recommend o Central Govt. to disapprove the scheme and return the application to the applicant. as Qualifying Criteria 2 (3) of Establishment of Medical College Regulations, 1999 is not fulfilled by the applicant trust.

80. <u>Establishment of New Medical College at Bareilly, Uttar Pradesh by</u> <u>Rajshree Educational Trust, Bareilly, Uttar Pradesh /s 10A of the IMC Act,</u> <u>1956 for the academic year 2014-15.</u>

Read: the matter with regard to establishment of New Medical College at Bareilly, Uttar Pradesh by Rajshree Educational Trust, Bareilly, Uttar Pradesh /s 10A of the IMC Act, 1956 for the academic year 2014-15.

The members of the Executive Committee observed that the note of the Law Officer dt. 09/04/2014 reads as under:

"The documents received is in accordance with Council's letter dated 28/03/2014"

In view of above, it was decided to send the file to the Assessment Cell for further processing and to carry out assessment. It was further decided that the Assessors should also be given the copies of the complaint dated 11/03/2014 & 14/03/2014 and to verify the veracity of the complaints, particularly with regard to availability of land to the extent of minimum 20 Acres of land in a single plot of land and whether it is separated by Chuk Road and also with regard to access roads for the college and hospital.

81. <u>Establishment of New Medical College at Deoghar, Jharkhand by Paritran</u> <u>Trust, Deoghar, Jharkhand u/s 10A of the IMC Act, 1956 for the academic</u> <u>year 2014-15.</u>

Read: the matter with regard to establishment of New Medical College at Deoghar, Jharkhand by Paritran Trust, Deoghar, Jharkhand u/s 10A of the IMC Act, 1956 for the academic year 2014-15.

<u>The members of the Executive Committee observed that</u> the Council Office has not yet received any documents/clarification/information regarding submission of land documents in original from the applicant in spite of repeated reminders.

In view of above, it was decided to recommend o Central Govt. to disapprove the scheme and return the application to the applicant as Qualifying Criteria 2 (2) of Establishment of Medical College Regulations, 1999 is not fulfilled by the applicant trust.

82. <u>Establishment of New Medical College at Tirupati, Andhra Pradesh by Sri</u> <u>Venkateswara Institute of Medical Sciences, Tirupati, Andhra Pradesh u/s</u> <u>10A of the IMC Act, 1956 for the academic year 2014-15.</u>

Read: the matter with regard to establishment of New Medical College at Tirupati, Andhra Pradesh by Sri Venkateswara Institute of Medical Sciences, Tirupati, Andhra Pradesh u/s 10A of the IMC Act, 1956 for the academic year 2014-15.

The Executive Committee considered the matter with regard to establishment of New Medical College at Tirupati, Andhra Pradesh by Sri Venkateswara Institute of Medical Sciences, Tirupati, Andhra Pradesh and noted that requisite documents had been received from the applicant college vide letter dated 12.4.2014 and as per legal opinion the 'clarification submitted is acceptable'. The Committee therefore decided to process the application for assessment.

83.

Establishment of New Medical College at Palakkad, Kerala

Read: the matter with regard to establishment of New Medical College at Palakkad, Kerala Pradesh by Kerala State Scheduled Caste and Scheduled Tribe Residential Educational Society, Trivandrum, Kerala u/s 10A of the IMC Act, 1956 for the academic year 2014-15.

The Executive Committee perused letter dt. 18/03/2014 from the Special Officer, Palakkad Medical College and decided that the Council can only accept those teaching faculty who are full time employees of the college. The Council cannot accept any faculty who is on deputation. The office is accordingly directed to communicate the decision of the Executive Committee to the institute immediately.

84. <u>Consideration of application for establishment of medical colleges u/s 10A</u> of the IMC Act, 1956 – non receipt of documents/C.D./D.V.D. – Regarding.

Read: the matter with regard to consideration of application for establishment of medical colleges u/s 10A of the IMC Act, 1956 – non receipt of documents/C.D./DV.D.

The Executive Committee considered the matter with regard to consideration of applications for establishment of medical colleges u/s 10A of the IMC Act, 1956 non receipt of documents/C.D./D.V.D and noted that of the 18 cases mentioned in the agenda item wherein the CD/DVD had not been received from the applicant colleges in spite of repeated reminders decided to send the files of all the colleges shown in the table to the assessment cell for further processing except that of # 12 .- Establishment of new medical college at Jupudi, Krishna Dist., Andhra Pradesh by Nimra Educational Society, Hyderabad – wherein the Council has received a letter dated 15.04.2014 from the applicant informing therein that due to sudden death of the Chairman of the Society, the targets of fulfilling the construction of the ancillary buildings have lagged, and the same shall be achieved in another maximum three months. This delay of complying with the requirements of MCI norms in terms of infrastructure of residential buildings demands, that the Society shall postpone the establishment of this new medical college by a year and hence has requested the Council to consider their proposal for the establishment of new medical college for the academic year 2015-2016.

As there is no provision in the Regulations to keep the applications pending, it was decided to return this application for the establishment of new medical college by Nimra Educational Society to the Central Govt. recommending disapproval of the scheme.

85. <u>Appointment of Secretary/Registrar in the office of Council.</u>

Read: the matter with regard to appointment of Secretary/Registrar in the office of the Council.

The Executive Committee considered the matter with regard to issue of appointment of Secretary / Registrar of the MCI, letters dated 23.12.13 and 19.02.14, had been received from the Ministry of Health & Family Welfare. In this behalf, Amendment Notification dt. 17.05.13 was also to be referred to. These

aspects had been considered by the President of the Council. Having regard to the significance of this important issue, it was decided by her that it would be appropriate and necessary that this matter is considered by the Executive Committee of the Council. She had, thus, directed that this matter be placed for consideration and decision by the Executive Committee of the Council.

As per the direction, the matter was placed before the Executive Committee of the Council in its meeting held on 16.04.14. The following was deliberated and decided by the Executive Committee:-

"This issue had required a closer look – on the one hand, at the scheme of the Indian Medical Council Act, 1956 for discharging statutory functions by the Council and on the other hand, the specific provision relating to the appointment of the Secretary of the Council and also the practical aspects in that behalf. It had also become necessary and appropriate to undertake such an exercise collectively viz. by the Executive Committee of the Council.

Accordingly, this matter was placed before the Executive Committee of the Council held on 16.04.2014. Besides the general scheme of the Act, provision of Section 9 and the other relevant provisions of the Act and the Regulations were also considered by the Committee. The provision of Section 9 of the Act requires / empowers the Council to appoint the Registrar / Secretary.

In this regard it was observed that under the scheme of the Indian Medical Council Act, 1956, it gets emphasized by the Parliament that the Council shall be constituted in a manner that approximately 2/3rd of its members are through the route of election and approximately 1/3rd gets nominated by the Central Govt. and State Govts. This scheme has been incorporated in this Act of 1956, ostensibly for the reason that the Legislature had intended the maintenance of representative character of the MCI on the one hand, and for extending autonomy in its functioning on the other. It was intended that the MCI is not made to discharge its functions as a Department of the Govt. of India and it can maintain its independence from the Govt. of India and when the Central Govt. gets duly represented in the constitution of the MCI along with the nominations from the State Govt.

It may be seen that under the provisions of Section 3 of the Act, the provision of Section 3(1)(a) and Section 3(1)(c) dealing with nomination of the members by the respective State Govts. and 8 members to be nominated by the Central Govt. Under the provisions of Section 3(1)(b) of the Act, each University having a Medical Faculty, can elect one of its members of its Senate and/or Court for membership of the MCI. Similarly, the provision of Section 3(1)(c) of the Act provides for election of one registered medical professional from each of the State from the group of Registered Medical Practitioners in each of the State. The constituency of Section 3(1)(d) is almost non-functional and does not send any further member to be elected under that provision.

With reference to the records of the MCI, it can further be seen that, generally, the MCI used to have approximately 130 memberships in all the 5 constituencies under Section 3(1) of the Act and out of which 2/3rd members were through the route of election and 1/3rd of the membership were through the route of nomination. However, the underlying principle was to give / extend representation to almost all the quarters of medical professionals in the constitution of the Council. The scheme of the Act ensures that all sections in the field of Medicine have a say in the highest body, i.e., MCI which is required to regulate the medical profession in the country. Under the scheme of the Act, it has been endeavored to ensure the representative character of the Council. The Legislative intent in the statutory scheme of the Act is that the number of elected members is to be more than the double the nominated members.

The working of the scheme of the Act has never envisaged the decisionmaking process including on the policy decisions by a category of only nominated members and that too who have retired from the Govt. services and were nominated only by the Central Govt. While proceeding further in the background of the event of taking over of the MCI by an Ordinance dated 15.05.2010 and for providing for a Board of Governors of 7 nominated doctors, either retired from the services and/or working in the private sector, was only as a temporary transit period mechanism, was that the day-to-day functioning of the MCI does not come to a grinding halt.

In other words, the basic legislative intent incorporated in the scheme of the Act is to the effect that –

- (i) The constitution of the MCI should always maintain a representative character, that is to say that every section of medicine is duly represented in the constitution of the MCI.
- (ii) The number of elected members of the MCI is to be more than double the number of members.

Contrary to the above-mentioned fundamental ingredients of the scheme of the Act, the Board of Governors nominated by the Central Govt. under the provisions of the Ordinance of 15.05.2010, had consisted of 5 – 7 doctors, either from the private sector or retired from the Govt. services and were not in conformity with the basic intent / scheme of the Act. It was totally in conflict with the basic intent that elected members ought to be more than double of the nominated members. Under these circumstances, it was expected that such a Board of Governors, during the short transit period, ought to have had discharged only day-to-day functions of the Council and had not involved /

engaged themselves in taking policy decisions. All such policy decisions which have been taken during the period from 15.05.2010 to 05.11.2013 which are not in conformity with the letter and spirits of the Act, would deserve to be re-visited with a view to bring them in conformity with the scheme of the Act. In any case, all those policy decisions which are in conflict with the provisions of the Indian Medical Council Act, 1956 and / or the scheme of the Act, would be void and are unenforceable.

After the Council gets constituted by giving due representation to all sections in the field of medicine thereby maintaining the representative character of the Council, the Govt. can frame the regulations only when the proposals emanate from the Council. Needless to reiterate that in all such proposals relating to policy decisions etc. which emanate from the Council, is only after due representation/participation of not only of the Central Govt. but also of the State Govt., Universities etc., before they are sent to the Central Govt. for grant of approval under Section 33 of the Act.

The scheme of the Act further makes it abundantly clear that the regulations to be framed under the Act for discharging functions of the Council, have to be framed by the Council, however, the implementation and enforcement thereof is on the approval of the Central Govt. Under the scheme of the Act, there is no permissibility whatsoever, for the Central Govt. to frame any regulations on its own and send it to the MCI. Such a course is neither permissible nor available to the Govt. of India.

Similarly, it is not envisaged under the Act that the Central Govt. would be in a position to frame regulations through the recommendations made in the name of MCI by 5 - 7 members nominated by the Central Govt. itself and the Central Govt. grants approval on the proposal sent by those 5 - 7 nominated doctors. In other words, this scheme of the Act, even when it extends representation of the views of the Central Govt. in the decision-making process by the MCI for framing of regulations etc. by nominating 8 members, the scheme of the Act does not permit that under any mechanism - if the Central Govt. gets enabled to get 5 - 7 of its members who are to work as Council, the Central Govt. will obtain the proposals from them even on major policy decisions and grant the approval by itself to such proposals by 5 - 7nominated members, who are nominated by the Central Govt. and then claim of having framed the regulations in the letter and spirit of the Indian Medical Council Act, 1956.

Coming to the aspect of the appointment of the Secretary of the Council, it was observed by the Committee that the appointment of the Registrar / Secretary of the MCI, the specific provisions in this behalf as well as the

scheme of the Act is abundantly clear. The entire jurisdiction / authority to appoint the Registrar / Secretary of the Council has been given by the Parliament to the Council itself. It is not given to the Central Govt. The provision of Section 9 makes it abundantly clear that it is the Council which shall appoint its Registrar / Secretary. The applicable norms under the Regulations for the appointment of the Secretary are framed under Section 33 of the Act with the approval of the Central Govt. The proposal for any amendment / modification to the applicable norms for appointment of the Secretary emanates from the MCI.

It is an admitted position on record that the norms / conditions / requirements for appointment of the Secretary and also all other employees of the MCI including the Registrar / Secretary thereof are required to and have been made by the MCI partaking the form of regulations under Section 33 of the Act upon the approval of the Central Govt.

That having regard to the nature of the functions and duties to be performed by the Registrar / Secretary of the MCI, it is absolutely essential that the person concerned must be from the field of Medicine having the background as a Medical Teacher. It is clear that most of the functions of the Council are discharged through its Executive Committee, PG Committee, Ethics Committee, Sub Committee on Teachers Eligibility Qualifications and General Body of the Council. Almost all policy decisions of the MCI are in relation to the field of Medicine including for laying down of standards etc. for Graduate Medical Education, Postgraduate Medical Education, General Postgraduate Medical Qualifications and Super-Specialty Medical Qualifications etc. The Registrar / Secretary of the MCI is the Secretary to all such Committees. He is required to attend all the meetings of all such Committees, participate in the deliberations for assisting the Committees including the Executive Body and General Body of the Council with regard to various aspects and the records of the MCI etc. and also to record minutes of meetings in relation to all such decisions which are taken by those Committees.

The Office of the Registrar / Secretary of the Council is also pivotal with regard to other significant functions to be discharged by the Council for conduct of inspections, grant of permission / recognition of various medical colleges / institutions imparting medical education. Even when the decisions are required to be taken by the Executive Committee / General Body of the Council, as the case may be, the entire coordination and carrying out of each of the job / assignment by the office of the Registrar / Secretary of the Council.

In other words, it can never be imagined that a person of non-medical background / qualifications can occupy the office of the Registrar / Secretary of the Council. It would be entirely irrational and impractical to even argue that with a view to widen the choice of selection and attract best officers that even persons who have no background in the field of Medicine and Medical Education that the rules had been amended thereby permitting persons from the background of Arts and Commerce as well to be considered and selected as the Registrar / Secretary of the Council.

None of the provisions of the Act permit the Ministry of Health & Family Welfare, Govt. of India to assume the onus / responsibility of filling-up of the post of Registrar / Secretary of the MCI. On the contrary, the provisions of the Act and the scheme mandated by Parliament, obliges the Council to select and appoint a Registrar / Secretary and who cannot be from any other field, other than the field of Medicine / Medical Education. The Parliament has put that responsibility / jurisdiction with the MCI.

On the basis of the records available in the MCI, it has also been informed by the office that the proposal for amendment of the norms / conditions for appointment of the Secretary of the Council [which otherwise also ought not to have been sent by the nominated Board of 5-7 doctors during the transition period] - was never a decision by the Board of Governors also. There was never any agenda item for this purpose. This issue was never placed in any meeting of the Board of Governors. There was never any resolution / decision in this behalf and it has emerged on record that except for the signatures of the then Chairman, there is no other approval / consensus by other members of the Board of Governors in seeking to modify / amend the applicable norms / conditions for appointment of the Secretary / Registrar of the Council. This would demonstrate that the entire exercise is contrary to the legal requirement and the entire decision / amendment would be void. In fact, it is quite inexplicable that when there was no decision / resolution by the Board of Governors, there was never any occasion for the Government to proceed to grant approval on such a vital issue under the Act. In fact and even otherwise, this amendment dated 17.05.13 being in direct conflict with the provisions of Section 9 of the Act, would also have no existence / recognition in the eyes of law and would be void ab initio.

It is in this background that the entire jurisdiction / responsibility, as mandated by the Parliament for appointing the Registrar / Secretary of the Council has been given to the Medical Council of India. Even when this amendment dated 17.05.13 would have no existence in the eyes of law, for keeping the record straight and for eliminating any possibility of any ambiguity or confusion in this behalf - it was also resolved to communicate to the Central Govt. to take the formal step for recall / annulment of the amendment dated 17.05.2013, regarding norms and conditions for appointment of the Secretary, MCI.

It would, however, deserve to be reiterated that :-

- (i) No amendment to the applicable norms / conditions for appointment of the Registrar / Secretary of the MCI would be legal and valid if it is contrary to the provisions and the scheme of the Act. Any such amendment would be void *ab initio*.
- (ii) In any case, from the records of the MCI, it has emerged that the recommendation for amendment dt. 17.05.2013 was only sent by the then Chairman of the BOG. There was no decision by the BOG on this subject. There was no agenda item. There was no resolution on this subject for making any recommendation to the Central Government for amendment. Even on this ground, the amendment dt. 17.05.13, would not be a legal and valid amendment. It would have no existence in the eyes of law.

In the light of the above, during the detailed deliberations held by the Executive Committee of the Council, it had clearly emerged on record that the amendment to the Recruitment norms, besides being ultra vires and void, it is entirely irrational, illegal and not sustainable in law and is not in conformity with the letter and spirit of the Act. In this regard, it would also be useful to refer to the following contents of a communication dated 30.10.2013 which had been addressed by the then Chairperson of the Board of Governors nominated by the Govt. of India and he has expressed the views on behalf of the MCI in the following terms : -

".....This is to bring to your kind attention that the Indian Medical Association (IMA) has filed a writ petition in the Hon'ble High Court of Delhi wherein challenge has been made to the constitutional and statutory validity of notification no.MCI-154(3)/2013-Estt./6576 dated 09.05.2013 published in the official Gazette of India on 17.05.2013. By the said notification the Recruitment Rules for the post of Secretary, MCI were amended.

The IMA has in its Petition, in which the Union of India through the Secretary, Ministry of Health and Family

Welfare and Medical Council of India re respondents, has *inter alia* alleged that the said notification:

- (a) Removed the essential requirement that the candidate for the post of Secretary/ Registrar should possess postgraduate medical qualification.
- (b) Taken away the power of recruitment from the Council which is provided by Section 9 of the Indian Medical Council Act, 1956.

The on-going proceedings in the Court case were subject matter of deliberations in the meeting of Board of Governors, and the Board of Governors, request your goodself to kindly consider:

First, that the revised Recruitment Rule envisages that any person with a postgraduate degree from a recognized University including MD/MS/DM/MCh is entitled to be appointed as Secretary. The role and responsibilities entrusted upon the Secretary/Registrar under the IMC Act, 1956 requires the incumbent to be well-versed in matters relating to medical education and professional conduct of medical practitioners. The requirement of regulating medical education/medical profession makes it imperative that a person who has vast and rich experience in medical education /medical profession should be holding the post of Secretary, MCI. The Secretary has not only to assist the Board/Council in laying down the minimum standards of medical education, but also to ensure the compliance of these norms in the Medical Colleges are best understood by a person from medical fraternity. Further, with the escalating number of issues relating to ethical concerns in the medical profession, such as medical malpractices, negligence, clinical trial, prescription of generic drugs etc., that are required to be dealt with on continuous basis by the



MCI it is essential that only a medical professional having recognized postgraduate qualifications is appointed to the post of the Secretary, MCI. It is imperative that the Secretary of the Council who is the custodian of the statutory duties entrusted upon the Council should be a person having postgraduate medical qualification and with rich and vast experience in handling matters relating to medical education/medical profession that is well-defined in the Recruitment Rules.

Second, under the statutory scheme envisaged under the Indian Medical Council Act, 1956 the Council shall appoint a Registrar who shall act as Secretary. The revised Recruitment Rule virtually takes away this power from the Council and confers it upon the Government of India as the notification provides that the appointment of Secretary is to be done through search-cum-selection Committee constituted by your esteemed Ministry with the concurrence of Department of Personnel and Training. Such a provision in the Recruitment Rules appears to be provisions of the IMC Act.

I would also like to take this opportunity to apprise you that the MCI was required to place before the Hon'ble High Court of Delhi its submissions regarding the petition filed by IMA. The issue was deliberated in the meeting of Board of Governor and after such deliberations; it was felt that the issue required revisit. Accordingly, on 03.09.2013, it was submitted to the Hon'ble High Court that the Council was revisiting the entire. The case is now adjourned till 31.03.2013. Further, another matter is pending in the Hon'ble Central Administrative Tribunal [OA No.1256/2012], New Delhi wherein although the Hon'ble Tribunal has not granted any stay of the advertisement for the post of Secretary or the recruitment process, however it has made any appointment that is to be made shall be subject to the outcome of OA.

Having regard to the above-mentioned crucial legal and factual aspects, the Executive Committee decided to require the office of the Council to issue an appropriate communication responding to the above-mentioned letters from the Ministry and incorporate the deliberation of the Executive Committee of the Council, therein. The above-mentioned deliberations of the Executive Committee be also included in the counter affidavit, which is to be filed on behalf of the MCI in the proceedings in the writ petition filed by Indian Medical Association challenging the validity of the amendment dt. 17.05.13 before the Hon'ble Delhi High Court. "
