1. <u>Minutes of the Executive Committee Meeting held on 31st Jan, 2015 – Confirmation of.</u>

The Executive Committee of the Council while confirming the minutes of the meeting held on 31st Jan, 2015 decided to include the following paragraph as a part of the decision in item nos.71, 72 & 74 of minutes dated 13.01.2015:-

71. <u>Sree Gokulam Medical College & Research Foundation, Trivandrum, Kerala – Renewal of Permission for admission of 5th Batch of MBBS students against the increased intake i.e. from 50 to 150 for the academic session 2015-16.</u>

The Executive Committee of the Council further noted that the Institute has admitted students for 2014-2015 pursuant to order of Hon'ble Supreme Court after filing undertaking dated nil in the name of Dr. A.M. Gopalan and Dr. K.K. Manojan which states as under:

".....We hereby solemnly affirm that the defects which had been recorded at the time of last inspection by the representative of the Medical Council of India has been duly rectified and at present the defects pointed out in the report do not exist. If the statement made in the undertaking is found to be incorrect at the time of next inspection, we understand that our Bank Guarantee deposited with Medical Council of India for renewal of seats from 50 to 150 will be forfeited by way of penalty".

In view of the deficiencies listed above, it is amply evident that the institute has failed to rectify previous deficiencies which are still persisting.

The Executive Committee of the Council also perused the order of Hon'ble Apex Court dt. 18/09/2014 & 25/092014, the operative part of which reads as under:

"The relevant portion of the order dated 18.09.2014 passed in W.P. (C) No. 469/2014 by the Hon'ble Supreme Court is reproduced hereunder:-

" Heard the learned senior counsel appearing for both the sides.

Looking at the peculiar facts and circumstances of the case and, especially, when several seats for medical admission are likely to remain vacant for the academic year 2014-15, we are of the view that these matters require urgent consideration and we are giving these interim directions under the provisions of Article 142 of the Constitution of India.

There is one more reason for passing this interim order. We are conscious of the fact that number of physicians in our country is much less than what is required and because of non-renewal of recognition of several medical colleges, our citizens would be deprived of a good number of physicians and therefore, we are constrained to pass this order, whereby at least there would be some increase in the number of physicians after five years. We are running against time because the last date for giving admissions to MBBS Course for the academic year 2014-15 is 30th September, 2014.

We also desire to reconsider the directions given by this Court in the judgment of Priya Gupta v. State of Chhattisgarh [(2012) 7 SCC 433], but at this juncture, as we do not have sufficient time to decide all these petitions finally, we are passing this interim order and the matter with regard to reconsideration of the aforestated judgment would be considered while finally disposing of this group of petitions.

It has been submitted on behalf of the learned senior counsel appearing for all the petitioners/ respondents, who are managing medical colleges, that the defects which had been recorded at the time of the last inspection by the representatives of the Medical Council of India have been duly rectified and at present, the defects pointed out in the reports do not exist. The said fact can be ascertained only by having a fresh Compliance Verification/Inspection. However, the stand taken by the Central Government and the Medical Council of India is to the effect that no such inspection can be undertaken in the present academic session because of paucity of time and it would violate the time schedule laid down by this Court in the case of Priya Gupta (supra).

The learned senior counsel appearing for the Medical Council of India has also submitted that the petitioners do not have any legal right for getting renewal of the recognition, especially in view of the fact that the Verification/Inspection Reports are not available for the period in question. The learned senior counsel has relied upon some of the Judgments to substantiate his case and according to him, it would not be just and proper to permit the said medical colleges to take fresh batch of students.

Looking at the peculiar facts of the case and the circumstances stated hereinabove, we direct the petitioners to file undertakings by President/Chairman and Secretary of the petitioners' institutions running medical colleges within 10 days from today, to the effect that there is no defect in the medical colleges run by them and they would also state that their deposit with the MCI, which is around Rs.10 Crores, be forfeited by way of penalty if the statement made in the undertaking is found to be incorrect at the time of the next inspection. A draft undertaking has been given to this Court. A copy of the undertaking, which might be filed by the institutions, shall be served upon the office of the Medical Council of India as well as to the Ministry of Health and Family Welfare, Govt. of India, New Delhi.

We also record the fact that in the recent past, the Medical Council of India has renewed recognition of Government Medical Colleges on the basis of undertakings and therefore, we see no reason not to permit the private colleges to admit students on the basis of undertakings given by their office bearer as a special case.

Notwithstanding any direction given in the case of Priya Gupta (supra), if undertakings as stated hereinabove are filed by the institutions managing medical colleges for the academic year 2014-15, admissions shall be given to the students from the merit list prepared by the States and they shall be charged fees prescribed by the Government Medical Colleges of their respective States. The State Authorities, i.e., the Directorate of Medical Education & Research, of the respective States shall send students, in order of their merit, to the medical colleges run by the petitioners, which are situated within their States, within one week from the date of receipt of a copy of this order and the said students shall be admitted to the MBBS Course in accordance with the rules and regulations of the MCI and also regulations dated 16.04.2010 framed by the Medical Council of India, provided undertakings as mentioned above are filed on behalf of the concerned institutions.

It is also clarified that there would be no further counseling in respect of the students who are to be given admission, even if it might result into some heartburning among other students, but in the peculiar facts of the case, we give this direction.

In no case, the admission shall be given after 30thSeptember, 2014. This order shall also apply to all the institutions which had filed their petitions earlier for renewal of their recognition for the academic year2014-15, but their petitions were rejected or withdrawn for whatever reason, provided undertakings as stated hereinabove are filed by President/Chairman and the Secretary of those institutions. All those petitions shall be deemed to have been revived and this order shall be deemed to have been passed in those cases also. This order shall only be in respect of renewal of recognition and not for creation of additional seats or for new colleges.

We also record that the Union of India has supported the petitioners in the interest of students. We also direct the Union of India to give wide publicity to this order in print as well as electronic media in the interest of the concerned students.

It is directed that the list of students getting admission I pursuance of this order shall be placed on record of this Court by 1st October, 2014 by the concerned institutions and a copy thereof shall also be sent to the MCI.

These matters shall be treated as part-heard and shall be notified for further hearing in the month of December. 2014."

The Hon'ble Supreme Court thereafter vide its order dated 25.09.2014 issued certain clarification in respect to the order dated 18.09.2014 in W.P. (C) No. 469/2014, which are reproduced hereunder:-

"After hearing the learned counsel for the parties we deem it appropriate to issue following clarifications with regard to our earlier order dated 18th September, 2014. These clarifications shall be read into the said order as if they were always part thereof:-

- 1. The order dated 18th September, 2014 shall also apply to cases where colleges or institutions were seeking increase in intake capacity and in the current year have been denied permission to admit students after first or second or third or fourth renewal/inspection. In our view such institutions where Renewal/Inspection with respect to increase in capacity were conducted in the present academic year are also entitled to the benefit under the order dated 18th September, 2014.
- 2. We also clarify that fees chargeable from the students admitted pursuant to our order dated 18th September, 2014 shall be at the same rates as applicable to the students in Government medical colleges in respective States and such fees shall be at the same levels as that of the Government medical colleges till the students so admitted pass out from the private medical colleges or institutions.
- 3. Our order shall also apply to all similarly situated institutions irrespective of the fact whether any petitions were or are pending in this Court or in any of the High Courts or even if they had not approached any court at all. This order shall also apply even in cases where there were orders of stay in favour of the Medical Council of India restraining the colleges from admitting students for the current academic session.
- 4. The order shall not apply to colleges or institutions which have been disqualified by the Medical Council of India and/or the Central Government and have been prohibited from making any admissions for the current academic year 2014-15.
- 5. In cases where two separate lists are prepared and sent by the State agencies one relating to State quota and the other relating to management quota in private institutions, we clarify that for the current academic year there shall be only one list and that shall be the "State quota" alone. There shall not be any management quota list to be sent to the private colleges or institutions taking the benefit under our order dated 18th September, 2014. The Management quota shall also be filled through the State list and the fees chargeable for the management quota shall also be charged at the same levels and rates as applicable to State quota list.
- 6. We further clarify that private institutions taking benefit under our order dated 18th September, 2014 shall have to take students only from the State agencies and at fees chargeable for students in Government medical colleges as stated above, regardless of their status or claim as Minority Institutions or Deemed Universities."

The Executive Committee of the Council further decided to invoke/forfeit the Bank Guarantees submitted by the Institute and directed the Institute to submit fresh bank guarantees within 2 weeks.

72. <u>Al-Ameen Medical College & Hospital, Bijapur – Renewal of Permission for admission of 3rd Batch of MBBS students against the increased intake i.e. from 100-150 for the academic session 2015-16.</u>

The Executive Committee of the Council further noted that the Institute has admitted students for 2014-2015 pursuant to order of Hon'ble Supreme Court after filing undertaking dated 26.09.2014 in the name of Mr. Ziaulla Shariff and Dr. B.S. Patil which states as under:

- 1. "I state that I am giving this undertaking in view of the order dt. 18.9.2014, passed by the Hon'ble Supreme Court in WP © No. 469/2014 and other connected matters.
- 2. I say that Al-Ameen Medical College & Hospital, Bijapur (Medical College for short) is owned, run and managed by Al-Ameen Charitable Fund Trust, Bangalore. The Medical College is seeking permission for its 1st renewal (2nd batch) of its increased intake capacity from 100 to 150 seats, i.e. an increase of 50 seats. The Medical College has rectified all the deficiencies vide compliance report dt. 18.7.2014 pointed out by the Medical Council of India vide letter dt. 15.6.2014 bearing No. MCI-34(41)(UG)/2014-Med./Kar/14866.
- 3. I say that in the event the Medical College, for any reason whatsoever, does not comply with this Undertaking, the Hon'ble Supreme Court, if it so chooses, direct that the Bank Guarantee/Security furnished by this Medical College to the MCI be forfeited.
- 4. I say that the admissions to the academic year 2014-15 with respect to the seats to be filled will be in accordance with the norms of the MCI and the candidates will be admitted from the merit list prepared and sent by the Directorate of Medical Education, Govt. of Karnataka and the fees to be charged from the students admitted through this process will be in accordance with the fees prescribed by the State Govt."

"After hearing the learned counsel for the parties we deem it appropriate to issue following clarifications with regard to our earlier order dated 18th September, 2014. These clarifications shall be read into the said order as if they were always part thereof:-

- 1. The order dated 18th September, 2014 shall also apply to cases where colleges or institutions were seeking increase in intake capacity and in the current year have been denied permission to admit students after first or second or third or fourth renewal/inspection. In our view such institutions where Renewal/Inspection with respect to increase in capacity were conducted in the present academic year are also entitled to the benefit under the order dated 18th September, 2014.
- 2. We also clarify that fees chargeable from the students admitted pursuant to our order dated 18th September, 2014 shall be at the same rates as applicable to the students in Government medical colleges in respective States and such fees shall be at the same levels as that of the Government medical colleges till the students so admitted pass out from the private medical colleges or institutions.
- 3. Our order shall also apply to all similarly situated institutions irrespective of the fact whether any petitions were or are pending in this Court or in any of the High Courts or even if they had not approached any court at all. This order shall also apply even in cases where there were orders of stay in favour of the Medical Council of India restraining the colleges from admitting students for the current academic session.
- 4. The order shall not apply to colleges or institutions which have been disqualified by the Medical Council of India and/or the Central Government and have been prohibited from making any admissions for the current academic year 2014-15.
- 5. In cases where two separate lists are prepared and sent by the State agencies one relating to State quota and the other relating to management quota in private institutions, we clarify that for the current academic year there shall be only one list and that shall be the "State quota" alone. There shall not be any management quota list to be sent to the private colleges or institutions taking the benefit under our order dated 18th September, 2014. The Management quota shall also be filled through the State list and the fees chargeable for the management quota shall also be charged at the same levels and rates as applicable to State quota list.
- 6. We further clarify that private institutions taking benefit under our order dated 18th September, 2014 shall have to take students only from the State agencies and at fees chargeable for students in Government medical colleges as stated above, regardless of their status or claim as Minority Institutions or Deemed Universities."

The Executive Committee of the Council further decided to invoke/forfeit the Bank Guarantees submitted by the Institute and directed the Institute to submit fresh bank guarantees within 2 weeks.

The Executive Committee of the Council considered the Council Assessors report (6th & 7th January, 2015) and noted the following:-

- 1. Deficiency of faculty is 10 % as detailed in report.
- 2. Shortage of Residents is 24.24 % as detailed in report.
- 3. Only 2 mobile X-ray machines are available against requirement of 4.
- 4. Only 2 static X-ray machines are available against requirement of 5.
- 5. There was no occupancy in Casualty on day of assessment.
- 6. Lecture Theaters: Facility for E class is available in one lecture theater only. Hospital lecture theater is not available.
- 7. Central Library: Available area is 1,060 sq.m. against requirement of 1,600 sq.m. Students' reading room (outside) is not available. Only 60 journals are available against requirement of 100. Only 4 Internet nodes are available against requirement of 25.
- 8. OPD: Registration counters are partly computerized. Minor O.T. is not available. Dressing room is common for males & females. Separate plaster cutting room is not available.
- 9. Speech Therapy is not available.
- 10. Labour Room: Doctors' duty room is not available in labour room complex.
- 11. Common Rooms for Boys & Girls & Cafeteria for students are not available.
- 12. Dean's office in the hospital is smaller than required.
- 13. MRD: It is computerized but it was not functioning on day of assessment. ICD X classification of diseases is not followed for indexing.
- 14. Casualty: Available beds are 18 against requirement of 20.
- 15. Pathology department: Histopathology laboratory is not available.
- 16. Pharmacology department: Demonstration room is smaller than required. Research laboratory is not well equipped.
- 17. Forensic Medicine department: No separate Demonstration Room is available.
- 18. RHTC: It is actually a PHC under Public Health department and not under the Dean. Residential accommodation is not available. There is no transport facility. Office for staff is not available.
- 19. UHC: There is no daily OPD. Immunization & Family Welfare services are not available. Specialists' visits are not organized. There is no bathroom or toilet for patients or for staff.
- 20. Other deficiencies as pointed out in the assessment report.

In view of the above, the Executive Committee of the Council decided to recommend to the Central Govt. not to renew the permission for admission of 3rd Batch of MBBS students against the increased intake i.e. from 50-100 of Swami Ramanand Teerth Rural Govt. Medical College, Ambejogai under Maharashtra University of Health Sciences, Nashik u/s 10A of the IMC Act, 1956 for the academic year 2015-2016.

5. Rajashree Chatrapati Shahu Maharaj Govt. Medical College, Kolhapur – Renewal of Permission for admission of 3rd Batch of MBBS students against the increased intake i.e. from 100-150 for the academic session 2015-16.

Read: the matter with regard to Rajashree Chatrapati Shahu Maharaj Govt. Medical College, Kolhapur – Renewal of Permission for admission of 3rd Batch of MBBS students against the increased intake i.e. from 100-150 for the academic session 2015-16.

The Executive Committee of the Council considered the Council Assessors report (6th & 7th January, 2015) and noted the following:-

- 4. Dr. Rahul bade, shown as medical Superintendent is not qualified to hold the post as he does not possess required administrative experience for the post.
- 5. Wards: Separate wards for Psychiatry & Skin & VD are not available.
- 6. O.T.s: All O.T.s have 2 tables which is not as per norms. Infusion Pumps are not available.
- 7. OPD: Registration counters are not computerized. IPD counter is in same female counter. Waiting area is inadequate. Only 3 examination rooms are available in Surgery & O.G. Seating capacity of teaching areas is less. Minor O.T. is not sterile. Plaster room & Plaster cutting room are in the same room.
- 8. Speech therapy is not available.
- 9. MRD: It is manual. ICD X classification is not followed for indexing. Statistician is not available.
- 10. Casualty: Disaster Trolley & Crash cart are not available. Ventilator is not available.
- 11. Labour Room: There is no dark room for Eclampsia patients.
- 12. AERB approval is not available.
- 13. Lecture Theaters: Out of 2 available, one lecture hall in the college is not of gallery type. Facility for E class is not available in both.
- 14. Central Library: available area is 1,600 sq.m. against requirement of 2,400 sq.m. as per Regulations. Staff reading room is for only 25 persons. Available Internet nodes are only 24 against 50 required. Librarian is not available.
- 15. Nurses' Hostel: Not available.
- 16. Boys' & Girls' common rooms are smaller than required.
- 17. Residents' Hostel: Accommodation is available for only 90 Residents against requirement of 113.
- 18. Intercom is not available.
- 19. Website: Information regarding admitted students, members of anti ragging committee, Toll free number to report ragging is not available.
- 20. Anatomy department: Lockers are less by 50.
- 21. Biochemistry department: Capacity of Practical Laboratory is less by 15.
- 22. Pharmacology department: Only 1 Demonstration Room is available against requirement of 2.
- 23. Forensic Medicine department: Demonstration rooms are smaller than required.
- 24. Other deficiencies as pointed out in the assessment report.

- 3. OPD: Registration counters are not computerized. Four examination rooms as required for all departments are not available. Injection room for males & females is common. Minor O.T. is not available in OPD. Separate plaster cutting room is not available. Teaching area is grossly inadequate.
- 4. Audiometry & Speech therapy are not available.
- 5. Casualty: Separate casualty for O.G. is not available. Disaster Trolley & Crash cart are not available. Ventilator is not available.
- 6. O.T.: Some O.T.s have more than 1 table which is not as per norms. O.T. is under renovation; hence Orthopaedics department is working in Surgery O.T.
- 7. ICUs: MICU, SICU, RICU are not available.
- 8. Only 4 static X-ray machines are available against requirement of 5.
- 9. CSSD is nonfunctional.
- 10. MRD: It is manual.
- 11. Examination Hall cum Auditorium: Available area is 400 sq.m. against requirement of 500 sq.m.
- 12. Lecture Theaters: lecture theater of capacity 150 is not available. Only 1 theater is of gallery type. Facility for E class is not available. There is no lecture theater in the hospital.
- 13. Central Library: Details of available area, reading rooms, internet nodes are not provided. Posts of Librarian & Deputy Librarian are vacant.
- 14. Common Rooms for Boys & Girls are smaller than required. There is no attached toilet in Boys' common room.
- 15. Interns' Hostel: Accommodation available is only for 15 Interns against requirement of 50.
- 16. Residents' Hostel: Accommodation available is for 16 Residents against requirement of 71. Mess is not available.
- 17. Medical Superintendent's office is smaller than required. Dean's office in hospital is not available.
- 18. Anatomy department: Museum is in lobby. Lockers available are only 30 against requirement of 100.
- 19. Biochemistry department: There is no seminar room.
- 20. Pathology department: There are no catalogues in the museum.
- 21. Microbiology department: Capacity of demonstration room is smaller than required.
- 22. Pharmacology department: There are 2 demonstration rooms but the capacity of both is smaller than required.
- 23. RHTC: It is under joint control of DHS & Dean which is not permissible as per Regulations. The distance is > 45 kms. Audiovisual aids are not available.

- 24. UHC: Specialists' visits are not organized.
- 25. Proper Nursing station & duty rooms are not available in wards.
- 24. Other deficiencies as pointed out in the assessment report.

In view of the above, the Executive Committee of the Council decided to recommend to the Central Govt. not to renew the permission for admission of 3rd Batch of MBBS students against the increased intake i.e. from 50-100 of Sri Bhausaheb Hire Govt. Medical College, Dhule under Maharashtra University of Health Sciences, Nashik u/s 10A of the IMC Act, 1956 for the academic year 2015-2016.

8. <u>Govt. Medical College, Akola – Renewal of Permission for admission of 3rd Batch of MBBS students against the increased intake i.e. from 100-150 for the academic session 2015-16.</u>

Read: the matter with regard to Govt. Medical College, Akola – Renewal of Permission for admission of 3rd Batch of MBBS students against the increased intake i.e. from 100-150 for the academic session 2015-16.

The Executive Committee of the Council considered the Council Assessors report (5th & 6th January, 2015) and noted the following:-

- 1. Deficiency of faculty is 13.6 % as detailed in report.
- 2. Shortage of Residents is 60 % as detailed in report.
- 3. Only 5 mobile X-ray machines are available against requirement of 6 as per Regulations.
- 4. Only 4 static X-ray machines are available against requirement of 5 as per Regulations.
- 5. Pharmaco Vigilance Committee: No meeting has been held in the previous year.
- 6. Central Library: Available area is 1,600 sq.m. against requirement of 2,400 sq.m. Internet nodes are only 20.
- 7. Speech therapy is not available.
- 8. Workload of special Radiological investigations like Ba, IVP was NIL on day of assessment.
- 9. O.T.: Most of the O.T.s have 2 tables each which is not as per norms.
- 10. ETO sterilizer is not available.
- 11. Anatomy department: Mounted specimens are only 109.
- 12. Website: Citizens' charter is not uploaded. Toll free number to report ragging is not provided.
- 13. Other deficiencies as pointed out in the assessment report.

In view of the above, the Executive Committee of the Council decided to recommend to the Central Govt. not to renew the permission for admission of 3rd Batch of MBBS students against the increased intake i.e. from 100-150 of Govt. Medical College, Akola under Maharashtra University of Health Sciences, Nashik u/s 10A of the IMC Act, 1956 for the academic year 2015-2016.

9. <u>Maharashtra Institute of Medical Sciences & Research, Pune – Renewal of Permission for admission of 2nd Batch of MBBS students against the increased intake i.e. from 100-150 for the academic session 2015-16.</u>

In view of the above, the Executive Committee of the Council decided to recommend to the Central Govt. not to renew the permission for admission of 2nd Batch of MBBS students against the increased intake i.e. from 100-150 of Maharashtra Institute of Medical Sciences & Research, Pune under Maharashtra University of Health Sciences, Nashik u/s 10A of the IMC Act, 1956 for the academic year 2015-2016.

10. <u>Dr. Shankarrao Chavan Govt. Medical College, Nanded – Renewal of Permission for admission of 3rd Batch of MBBS students against the increased intake i.e. from 50-100 for the academic session 2015-16.</u>

Read: the matter with regard to Dr. Shankarrao Chavan Govt. Medical College, Nanded – Renewal of Permission for admission of 3rd Batch of MBBS students against the increased intake i.e. from 50-100 for the academic session 2015-16.

- 3. Casualty: Separate casualty for Obstetrics is not available.
- 4. Radiodiagnosis department: Only 2 mobile X-ray machines are available against requirement of 6. AERB approval is not available. IITV/Fluoroscopy is not in working order.
- 5. Blood component separation facility is not available.
- 6. ETO Sterilizer is not available.
- 7. Speech Therapy is not available.
- 8. MRD: It is manual. ICD X classification for indexing of diseases is not followed at GMCH, Miraj.
- 9. Lecture Theaters: No lecture theater has capacity of 180 against requirement of 2 of capacity 180. Facility for E class is not available. Lecture hall of capacity 250 and Hospital lecture Hall are not of gallery type.
- 10. Central Library: It is not air-conditioned. There is no Students' Reading room (Outside). Capacity of staff reading room is only 20.
- 11. OPD: Registration counters are not computerized.

- 12. Website: Citizens' charter is not uploaded. Information provided is not complete.
- 13. Biochemistry department: There is only 1 Demonstration Room against requirement of 2.
- 14. Other deficiencies as pointed out in the assessment report.

In view of the above, the Executive Committee of the Council decided to recommend to the Central Govt. not to renew the permission for admission of 3rd Batch of MBBS students against the increased intake i.e. from 100-150 of Govt. Medical College, Miraj under Maharashtra University of Health Sciences, Nashik u/s 10A of the IMC Act, 1956 for the academic year 2015-2016.

12. <u>Guru Gobind Singh Memorial Medical College, Faridkot – Renewal of Permission for admission of 3rd Batch of MBBS students against the increased intake i.e. from 50-100 for the academic session 2015-16.</u>

- 2. Lecture Theaters: Facility for E class is not available.
- 3. ICUs: There were only 2 patients in SICU on day of assessment.
- 4. Other deficiencies as pointed out in the assessment report.

In view of the above, the Executive Committee of the Council decided to recommend to the Central Govt. not to renew the permission for admission of 4th Batch of MBBS students against the increased intake i.e. from 100-150 of Navodya Medical College, Raichur under Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act, 1956 for the academic year 2015-2016 and further decided to apply clauses 8(3)(1)(c) of Establishment of Medical College Regulation (Amendment),2010(Part II), dated 16th April, 2010 which reads as under:-

"8(3)(1).....

(c) <u>Colleges which are already recognized for award of MBBS degree</u> and/or running postgraduate courses If it is observed during any regular inspection of the institute that the deficiency of teaching faculty and/or Residents is more than 10% and/or bed occupancy is <80%, such an institute will not be considered for processing applications for postgraduate courses in the Academic year and will be issued show cause notices as to why the recommendation for withdrawal of recognition of the courses run by that institute should not be made for undergraduate and postgraduate courses which are recognized u/s 11(2) of the IMC Act, 1956 alongwith direction of stoppage of admissions in permitted postgraduate courses."

In view of above, it was decided not to consider the Institute for processing applications for postgraduate courses in the Academic year (2016-17) and to issue show cause notice as to why the recommendation for withdrawal of recognition of the courses run by that institute should not be made for undergraduate and postgraduate courses which are recognized u/s 11(2) of the IMC Act,1956 alongwith direction of stoppage of admissions in permitted postgraduate courses.

The Executive Committee of the Council further decided to intimate the Postgraduate Section of application of clause 8(3)(1)(c) for this Institute for information and further necessary action.

14. <u>Jawaharlal Nehru Medical College, Ajmer– Renewal of Permission for admission of 3rd Batch of MBBS students against the increased intake i.e. from 100-150 for the academic session 2015-16.</u>

Read: the matter with regard to Jawaharlal Nehru Medical College, Ajmer–Renewal of Permission for admission of 3rd Batch of MBBS students against the increased intake i.e. from 100-150 for the academic session 2015-16.

The Executive Committee of the Council decided to defer the consideration of the matter.

The Executive Committee of the Council considered the Council Assessors report (22nd & 23rd January, 2015) and noted the following:-

- Though this is I renewal for increase from 100 to 150, the beds in General Medicine, Paediatrics, General Surgery, Orthopaedics, O.G. have not been increased proportionately from those required for college with 100 intake.
- 2. Residential Quarters: Only 16 quarters are available for non-teaching staff against requirement of 36 as per Regulations.
- 3. Number of major operations on day of assessment is only 7 on day of assessment.
- 4. Forensic Medicine department: Only 1 Demonstration Room is available against requirement of 2 as per Regulations.
- 5. Other deficiencies as pointed out in the assessment report.

In view of above, the Executive Committee of the Council decided to recommend to the Central Govt. not to renew the permission for admission of 2^{nd} Batch of MBBS students against the increased intake i.e. from 100-150 u/s 10A

of the IMC Act, 1956 in respect of Pondicherry Institute of Medical Sciences, Pondicherry under Pondicherry University, Pondicherry for the academic year 2015-16.

16. MGM Medical College, Indore – Renewal of Permission for admission of 3rd Batch of MBBS students against the increased intake i.e. from 140-150 for the academic session 2015-16.

Read: the matter with regard to MGM Medical College, Indore – Renewal of Permission for admission of 3rd Batch of MBBS students against the increased intake i.e. from 140-150 for the academic session 2015-16.

The Executive Committee of the Council considered the Council Assessors report (22nd & 23rd January, 2015) and noted the following:-

- 1. Shortage of Senior Residents is 15.82 % as detailed in report.
- 2. Some of the departments have more postgraduate students & residents than permitted under MCI Regulations as detailed in the report.
- 3. Casualty: On day of assessment, there was no equipment in Casualty. It was under renovation and shifting.
- 4. ICUs: RICU is not available.
- 5. CT scan is available under PPP mode with SRL lbs. Nature & mode of PPP have not been specified; hence it cannot be verified whether it is available for training of students & Residents or not.
- 6. ETO Sterilizer is not available.
- 7. Examination Hall cum Auditorium: Area available is less and is divided into 3 halls.
- 8. Lecture Theater: There is no lecture theater of 350 capacity required as per Regulations. Facility for E class is not available in any lecture theater. Hospital lecture theater is not of gallery type.
- 9. Central Library: Available area is 864 sq.m. against requirement of 2,400 sq.m. as per regulations. Students' Reading room (inside) is divided into 3 halls with total capacity of 106 against requirement of 150. Capacity of staff reading room is only 10. Internet Nodes are 21 against 40 required.
- 10. Students' Hostels: Available accommodation is 446 against requirement of 540.
- 11. Residential Quarters: Only 21 quarters are available against requirement of 30 as per Regulations.
- 12. Paramedical staff: It is short by 8. (174 available against 182 required.)
- 13. Anatomy department: Dissection tables available are 16 against requirement of 20. Cooling chambers is available only for 4 bodies. Capacity of Demonstration Rooms is less (65 against requirement of 75).

- 6. Number of major Surgical operations is only 10 for the whole hospital.
- 7. Casualty: Number of Medical officers is less. Disaster Trolley, Crash Cart, Defibrillator, Ventilator are not available.
- 8. O.T.: Each O.T. has more than 1 table which is not as per norms. Monitoring & Resuscitation equipment are inadequate.
- 9. ICUs: RICU is not available. There were only 2 patients in ICCU, MICU, SICU on day of assessment.
- CSSD: Receiving & Distribution points are not separate. ETO Sterilizer is not available.
- 11. Pharmaco Vigilance Committee: No meeting has been held during the year.
- 12. Examination Hall cum Auditorium: Area available is 475 sq.m. against requirement of 500 sq.m.
- 13. Lecture Theaters: Capacity of both lecture theaters is 100 against requirement of 120. Hospital lecture theater is not of gallery type. Facility for E class is not available.
- 14. Central library: Area available is only 495 sq.m. against requirement of 1,600 sq.m. as per Regulations. Only 71 journals are available against requirement of 100.
- 15. Central Photography Unit: No staff is available.
- 16. Residential Quarters: Only 14 quarters are available against requirement of 23 as per Regulations.
- 17. MRD: It is partly computerized. ICD X classification of diseases is not used for indexing of diseases. Statistician is not available.

- 22. Website: Very little information is provided. It needs to be updated.

- 14. Pathology department: Demonstration room is not available. Specimens are only 20. Practical laboratories are shared with Anatomy & Physiology departments.
- 15. Forensic Medicine department: Demonstration room is not available. Museum facilities are inadequate.
- 16. Community Medicine department: Museum is not available. Practical laboratory is shared with Biochemistry department. In departmental library, no recent books are available.
- 17. Other deficiencies as pointed out in the assessment report.

In view of the above, the Executive Committee of the Council decided to recommend to the Central Govt. not to renew the permission for admission of 5th batch of 100 seats of Indira Gandhi Institute of Medical Sciences, Sheikhpura, Patna under the Indira Gandhi Institute of Medical Sciences, Patna (Deemed University) u/s 10A of the IMC Act, 1956 for the academic year 2015-2016.

- 11. There is only 1 Demonstration room each in the departments of Biochemistry, Pathology, Pharmacology departments against requirement of 2 demonstration rooms each as per Regulations.
- 12. Pathology department: There is only one laboratory available against requirement of 2 laboratories.
- 13. Common Rooms for Boys & Girls: Capacity is inadequate.
- 14. Pharmacology department: There is no research laboratory.
- 15. Community Medicine department: There are no catalogues in the museum.
- 16. RHTC: It is under the control of Govt. of Karnataka and not under the control of Dean.
- 17. UHC: It is under control of a NGO and not under Dean.
- 18. Other deficiencies as pointed out in the inspection report.

- 12. Other deficiencies as pointed out in the inspection report.

In view of above, the Executive Committee of the Council decided to recommend to the Central Govt. not to renew the permission for admission of 3rd batch of MBBS students against the increased intake i.e. from 150 to 200 u/s 10A of the IMC Act, 1956 in respect of Kakatiya Medical College, Warangal

under Dr. NTR University of Health Sciences, Vijayawada for the academic year 2015-16.

- 6. Lecture Theaters: Facility for E class is not available.

- 12. Forensic Medicine department: Audiovisual aids are not available in the demonstration room. There are no charts, prototype firearms, slides, poisons in the museum. Specimens & Photographs are inadequate.
- 13. RHTC: It is under control of CMO, Meerut which is not as per Regulations. Attendance register of students & interns is not maintained. There are no separate blocks for boys & girls in the hostel. Mess is not available. Specialists' visits are not organized.
- 14. UHC: MCH activities are not carried out. Specialists' visits are not organized.
- 15. MEU: No workshops in Medical Education technology have been conducted by the institute during the year.
- 16. Website: Toll free number to report ragging is not provided.
- 17. Other deficiencies as pointed out in the assessment report.

- 4. O.T.: There are 22 tables in 17 O.T.s indicating more than 1 table in several O.T.s which is not as per norms.
- 5. ICUs: PICU does not have any major equipment & requires infrastructural improvements. Only 1 patient was admitted in RICU on day of assessment.
- 6. Nursing staff: Only 141 Nurses are available against requirement of 247.

- 7. Central Library: 96 journals are available against requirement of 100 as per Regulations. 20 Internet nodes are available against requirement of 40.
- 8. Casualty: Ventilators are not available.
- 9. CSSD: Receiving & distribution points are not separate. ETO sterilizer is not in use.

4. "The Postgraduate diplomas invoked in various medical colleges may be converted to Postgraduate degree so that the postgraduate teacher against whom the diploma is invoked is available for the purposes of postgraduate degree in the concerned medical college."

Reasons: 1. A PG Diploma holder in Psychiatry is also a Consultant Psychiatrist and can practice as a Psychiatrist. Hence automatically converting Diploma seats into Degree seats would not lead to any increase in manpower as such.

2.PG Diploma seats have been notified in the Gazette of India and the prescribed procedure under the regulations for converting them into Degree seats should be followed.

13. "Starting MD (Psychiatry) may be permitted in medical colleges without recognition for their MBBS degree on par with the scheme for starting PG courses in pre- and para -clinical disciplines (at the time of 4th renewal) subject to fulfillment of the prescribed requirements."

Reason: Psychiatry is a clinical discipline and PG can only be started after PrePG assessment to ascertain facilities as required for UG intake are adequately available. Hence this recommendation is against the provisions of existing Regulations.

In view of above, the Executive Committee of the Council decided to refer the matter back to the Academic Committee.

- 4. Workload of Radiological investigations is grossly inadequate on day of assessment. There is no USG performed on day of assessment.
- 5. Laboratory workload is grossly inadequate on day of assessment.
- 6. Histopathology & Cytopathology workload is NIL on day of assessment.
- 7. ICUs: There was no patient in MICU & only 1 patient each in SICU and PICU/NICU on day of assessment.
- 8. Labour Room: There was no woman in Labour Room on day of assessment.
- 9. Radiodiagnosis department: There was no faculty or Resident in the department at the time of assessment.
- 10. Nursing Staff: Only 87 Nurses are available against requirement of 175 as per Regulations.

- 5. Workload of plain X-rays was grossly inadequate and that of USG was NIL on day of assessment.
- 6. Laboratory Investigations workload was grossly inadequate on day of assessment.
- 7. Cytopathology workload was NIL on day of assessment.

- 6. OPD: Only 1 Examination room is available for each department against requirement of 4 rooms for each department. Teaching areas in individual OPDs are not available. There is only 1 common teaching area which is not as per Regulations. Dressing room for male/female is not available. Facilities are inadequate in Paediatrics & O.G. OPD.
- 7. Audiometry & Speech therapy are not available.
- 8. Wards: Distance between 2 beds is < 1.5 m. There is no separate ward for Tb & Chest. Ophthalmology ward is common for male/female patients. Nursing station is common between many wards. Pantry is not available. Duty room & Demonstration room are shared between many wards.
- 9. Bed occupancy is only 45 % on day of assessment.

curtain. ECG room is not available. Dressing room is common for males/females. Plaster room & Plaster cutting room are common. In Ophthalmology OPD, there is no separate dark room.

- 4. MRD: It is partly computerized. Medical Records Officer / Statistician are not available.

- 20. Website: Information is sketchy and not updated. Citizens' charter is not uploaded.

- 4. HOD Pathology is discharging his duties as HOD Microbiology which is not as per Regulations.
- 5. There are only 3 Units in General Medicine against requirement of 4. Department of Skin & VD is headed by Asst. Prof. which is not as per Regulations.
- 6. OPD on day of assessment is 825 against requirement of 1,100.

- 7. Casualty: Separate casualty for O.G. is not available. Defibrillator & Ventilator are not available.
- 8. O.T.: 6 O.T.s are available against requirement of 7 as per Regulations. There are more than 1 table in each O.T. which is not as per norms. Infusion Pumps & Defibrillators are not available.
- 9. ICUs: SICU & RICU are not available.
- 10. Radiodiagnosis department: Only 3 mobile X-ray machines are available against requirement of 6 as per Regulations. Only 3 static X-ray machines are available against requirement of 5 as per Regulations. CT Scan is not available.
- 11. OPD: Registration counters are not computerized. Plaster room & Plaster cutting room are common.
- 12. Wards: Pantry is not available.
- 13. MRD: There is no MRD as such. ICD X classification is not available for indexing of diseases. MRO & Statistician are not available.
- 14. Examination Hall cum Auditorium: Available area is 320 sq.m. Examination Hall & Auditorium are separate with capacity of 160 & 480 respectively which is inadequate.
- 15. Central Library: Available area is 1,261 sq.m. against requirement of 2,400 sq.m. as per Regulations. - 25. Community Medicine department: Only 1 Demonstration Room is available against requirement of 2 as per Regulations.

- 6. Central Library: Area of central library is not provided. Sitting room capacity available is only 150 against requirement of 200. It is not airconditioned.

The Executive Committee of the Council noted that an application dated 26.08.2014 submitted by the Under Secretary, to Govt. of Mizoram, Health & Family Welfare for establishment of New Medical College at Falkawn, District Aizawl, Mizoram by Government of Mizoram u/s 10A of the IMC Act, 1956 for the academic year 2015-16 was received through the Central Govt., Ministry of Health & Family Welfare, New Delhi vide letter dated 23.09.2014 and while scrutiny of the application, it was noted that the application is deficient in terms of the following:-

"Consent of Affiliation is not enclosed with the proposal."

The Committee further noted the Council vide its letter dated 10.11.2014 returned the application of the applicant to the Central Govt. recommending disapproval of scheme for establishment of new medical college at Falkawn, Aizawl, Mizoram by Govt. of Mizoram u/s 10A of the IMC Act, 1956 for the academic year 2015-2016.

The Council office received a letter dated 24.11.2014 from the Central Govt. addressed to the Under Secretary, Health & Family Welfare, Govt. of Mizoram, Aizwal, Mizoram and copy to this Council enclosing therewith a copy of Council's letter dated 10.11.2014 inter-alia recommending that the application/proposal is disapproved for want of consent of affiliation with the proposal. The Central Govt. in the above letter also requested the Council to return the original proposal to the Govt. of Mizoram directly as the same was not received alongwith MCI letter quoted above. Accordingly, the Council vide its letter dated 18.12.2014 also returned the original application to the applicant.

The Executive Committee of the Council further noted the letter dated 07/01/2015 of the Principal Secretary to the Govt. of Mizoram, Health & Family Welfare Department stating therein as under:-

"With reference to the above subject, please find enclosed, urgent letter from Mizoram University granting affiliation to the proposed Mizoram Institute of Medical Education and Research(MIMER).

The delay is regretted and was due to non-receipt of the consent letter in proper format from the University of Mizoram.

In this regard, I would request you to be considerate and grant approval, Medical Council of India to start MIMER at Falkawn, Aizawl District, as this will be the first Medical College in the State of Mizoram."

The matter was considered by the competent authority in the Council Office and as per directions, the Council office vide its letter dated 28/01/2015 has informed the applicant as under:-

"....the Consent of Affiliation dated 07/01/2015 issued by the Registrar, Mizoram University, Aizawl has been issued after the cut off date of submission of application to the Central Govt. i.e. 31/08/2014, therefore the same cannot be considered by the Council at this stage.

In view of above, the Council Office has decided to reiterate its earlier decision which has already been communicated to the Central Govt. vide this office letter No.MCI-34(41)(E-62)/2014-Med./140225, dated 10/11/2014."

The Council Office has received a letter dated 31/01/2015 from the Central Govt., Ministry of Health & Family Welfare, New Delhi stating therein that as per the proviso under Section10(A)(4) of IMC Act, 1956, a Committee has been constituted for granting opportunity of personal hearing the Ministry in case of disapproval/ non-renewal recommendation of the Council in case of UG courses for the year 2015-16. The Committee has given personal hearing to the authorised representatives of the medical colleges/applicants on 19th, 20th & 21st January, 2015. Based on the compliance submitted by the colleges concerned in support of their claim , the committee has recommended for review/assessment of the schemes by the MCI.

In view of above, the Central Govt. has forwarded the representations/compliance submitted by the Principal Secretary to the Govt. of Mizoram, Health & Family Welfare Department, Mizoram enclosing therewith a copy of Consent of Affiliation dated 07/01/2015 issued by Registrar, Mizoram University, which reads as under-

"On the basis of the recommendation of the inspection team and as per recommendation of the Affiliation Committee, and resolution of the Academic Council, No.AC:27: 4(5)(4), dated 21st November, 2014, Mizoram University has agreed, in principle, to affiliate the proposed college, namely Mizoram Institute of Medical Education and Research (MIMER), to be established by Department of Health & Family Welfare, Govt. of Mizoram w.e.f. academic year 2015-16 onwards, subject to grant of permission by the Government of India, Ministry of Health and Family Welfare, New Delhi under section 10(A) of the India Medical Council Act, 1956(102 of 1956)."

In view of above, the Executive Committee of the Council decided to reiterate its earlier decision which has already been communicated to the Central Government vide Council letter dated 10.11.2014 as the Consent of Affiliation dated 07/01/2015 issued by the Registrar, Mizoram University, Aizawl has been issued after the cut off date of submission of application to the Central Govt. i.e. 31/08/2014.

Assessment of the physical and other teaching facilities available for renewal of permission for MBBS course of 3rd batch (150 seats) of DM Wayanad Institute of Medical Sciences, Wayanad, Kerala under the Kerala University of Health & Allied Sciences, Kerala u/s 10A of the IMC Act, 1956 for the academic year 2015-2016.

Read: the matter with regard to assessment of the physical and other teaching facilities available for renewal of permission for MBBS course of 3rd batch (150 seats) of DM Wayanad Institute of Medical Sciences, Wayanad, Kerala under the Kerala University of Health & Allied Sciences, Kerala u/s 10A of the IMC Act, 1956 for the academic year 2015-2016.

The Executive Committee of the Council considered the Council Assessors report (12th & 13th December, 2014) and surprise assessment report (6th and 7th February,2015) and noted the following:-

- 1. Deficiency of faculty is 41% as detailed in report.
- 2. Shortage of Residents is 63% as detailed in the report.
- 3. Bed occupancy is 33% on day of assessment which is grossly inadequate.
- 4. Casualty attendance on day of assessment is only 10 for 24 hours which is grossly inadequate.
- 5. There are only 7 Major and 2 Minor operations for the whole hospital on day of assessment which is inadequate.
- 6. ETO sterilizer is not available.
- 7. Anatomy department: Capacity of cold storage is 4 bodies against requirement of 8 as per Regulations.
- 8. Microbiology Department: There are only 3 service laboratories available against requirement of 7 as per Regulations.
- Porensic Medicine department: In museum, there are inadequate number of specimens and there are no charts, prototype firearms, photographs. There are no catalogues.
- 10. Other deficiencies as pointed out in the assessment report.

In view of above, the Executive Committee of the Council decided to recommend to the Central Govt. not to renew the permission for admission of 3rd batch (150 seats) of DM Wayanad Institute of Medical Sciences, Wayanad, Kerala under the Kerala University of Health & Allied Sciences, Kerala u/s 10A of the IMC Act, 1956 for the academic year 2015-2016. It was further decided to apply clause 8(3)(1)(a) of Establishment of Medical College Regulation (Amendment),2010(Part II), dated 16th April, 2010 which read as under:-

"8(3)(1).....

(a) Colleges in the stage upto II renewal (i.e. Admission of third batch)

If it is observed during any regular inspection of the institute that the deficiency of teaching faculty and/or Residents is more than 30% and/or bed occupancy is <60%, such an institute will not be considered for renewal of permission in that Academic Year."
