#### 1. Minutes of the last meeting of the Postgraduate Committee - confirmation of.

The minutes of the Postgraduate Committee meeting held on 20.1.2003 were confirmed.

#### 2. <u>Minutes of the last meeting of the Postgraduate Committee – Action taken thereon.</u>

The Postgraduate Committee approved the action taken on the minutes of the meeting of the Postgraduate Committee held on 20.1.2003.

## 3. <u>Starting of M.D.(Radio-Diagnosis) course at Siddhartha Medical College, Vijayawada affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956.</u>

Read: - the Council Inspector's report (April, 2002) on the physical and other teaching facilities available at Siddhartha Medical College, Vijayawada for starting of M.D.(Radio-Diagnosis) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (April, 2002) and decided to recommend to the Central Government not to issue Letter of Intent for starting of M.D. (Radio-Diagnosis) course at Siddhartha Medical College, Vijaywada affiliated to NTR University of Health Sciences, Vijayawada u/s 10 A of the IMC Act, 1956 because –

- i) The HOD does not possess requisite recognised postgraduate qualification
- ii) Required equipment in the department is inadequate
- iii) No CT Scan has been provided which is essential for imparting the training to students undergoing MD (Radio-Diagnosis) course
- iv) Other observations /deficiencies pointed out in the inspection report.

### 4. <u>Starting of M.Ch.(Endocrine Surgery) course at Sanjay Gandhi Postgraduate</u> <u>Institute of Medical Sciences, Lucknow affiliated to Sanjay Gandhi Postgraduate</u> <u>Institute of Medical Sciences (Deemed University) u/s 10A of the IMC Act, 1956.</u>

Read: the Council Inspector's report (January, 2003) on the physical and other teaching facilities available at Sanjay Gandhi Postgraduate Institute of Medical Sciences, Lucknow for consideration of starting of M.Ch.(Endocrine Surgery) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (Jan.2003) and noted that the inspection report is very sketchy and does not provide complete information with regard to teaching faculty in the department, availability of beds and also whether the department is functioning as a separate independent department or functioning as a unit in the department of Surgery.

The Committee decided to defer the consideration of the matter till the clarifications are received and the matter is brought back to the Postgraduate Committee for its consideration.

## 5. <u>Starting of M.D.(Obst. & Gynae.) & D.G.O. courses at Dr.D.Y.Patil Pratishtan's Medical College for Women, Pune affiliated to Pune University u/s 10A of the I.M.C. Act, 1956 –consideration of compliance verification regarding.</u>

Read: the compliance verification report (February, 2003) togetherwith compliance and Council Inspector's report (April, 2002) on the physical and other teaching facilities available at Dr.D.Y.Patil Pratishtan's Medical College for Women, Pune for starting of M.D.(Obst. & Gynae.) & D.G.O. courses u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance verification report (February, 2003) together with compliance and Council Inspector's report (April, 2002) and decided to recommend to the Central Government to issue Letter of Permission for starting of M.D. (Obst. & Gynae) & DGO courses at Dr. D.Y. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11 (2) of the Act, 1956.

# 6. Starting of D.M.(Nephrology) course at Sri Venkateswara Institute of Medical Sciences, Tirupati affiliated to Sri Venkateswara Institute of Medical Sciences (Deemed University) u/s 10A of the IMC Act, 1956 – consideration of compliance regarding.

Read: the compliance togetherwith Council Inspector's report (May, 2002) on the physical and other teaching facilities available at Sri Venkateswara Institute of Medical Sciences, Tirupati for starting of D.M.(Nephrology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance together with the Council Inspector's report (May 2002) and decided to recommend to the Central Government to issue Letter of Permission for starting of D.M. (Nephrology) course at Sri Venkateswara Institute of Medical Sciences, Tirupati (Deemed University) u/s 10 A of the IMC Act, 1956 prospectively restricting the number of admission to 1(one) student per year till the first batch admitted appears in the final examination of the said course. Read: the Council Inspector's report (October, 2002) on the physical and other teaching facilities available at Andhra Medical College, Visakhapatnam for consideration of increase of seats in M.D.(Paediatrics) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (October, 2002) and decided to recommend to Central Government to issue Letter of Permission for increase of seats in M.D. (Paediatrics) course at Andhra Medical College, Visakhapatnam affiliated to NTR University of Health Sciences, Vijayawada from 3 (three) to 6(six) in M.D.(Paediatrics) per year prospectively u/s. 10A of the IMC Act, 1956 till the first batch admitted against the increased number appears for the final examination of the said course.

#### 9. <u>Starting of M.S.(Ophthalmology) & D.O. courses at Coimbatore Medical College, Coimbatore affiliated to The Tamilnadu Dr.M.G.R.Medical University u/s 10A of the IMC Act, 1956 – consideration of compliance regarding.</u>

Read: the compliance togetherwith Council Inspector's report (May, 2002) on the physical and other teaching facilities available at Coimbatore Medical College, Coimbatore for starting of M.S.(Ophthalmology) & D.O. courses u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance together with the Council Inspector's report (May 2002) and decided to recommend to the Central Government to issue Letter of Permission for starting of M.S. (Ophthalmology) & DO courses at Coimbatore Medical College, Coimbatore affiliated to the Tamilnadu Dr. MGR Medical University u/s 10 A of the IMC Act, 1956 prospectively restricting the number of admissions to 2(two) students for MS (Ophthalmology) and 1(one) for DO course per year till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11 (2) of the Act, 1956.

## 10. <u>Starting of M.D.(Microbiology) course at Govt. Medical College, Rajkot affiliated to Saurashtra University u/s 10A of the I.M.C. Act, 1956 – consideration of compliance verification regarding.</u>

## 11. <u>Starting of M.D.(Paediatrics) course at Govt. Medical College, Rajkot affiliated to Saurashtra University u/s 10A of the I.M.C. Act, 1956 – consideration of compliance verification regarding.</u>

Read: the compliance verification report (November, 2002) togetherwith compliance and Council Inspector's report (April, 2001) on the physical and other teaching facilities available at Govt. Medical College, Rajkot for starting of M.D.(Paediatrics) course u/s 10A of the IMC Act, 1956.

- (ii) Appoint a Child Psychologist and Medical Social Worker
- (iii) Upgrade emergency services.

# 12. <u>Starting of M.D.(Pharmacology) course at Sher-I-Kashmir Institute of Medical Sciences, Srinagar affiliated to Sher-I-Kashmir Instt. of Medical Sciences, Srinagar (Deemed University) u/s 10A of the IMC Act, 1956 – consideration of compliance regarding.</u>

Read: the compliance togetherwith Council Inspector's report (July, 2002) on the physical and other teaching facilities available at Sher-I-Kashmir Institute of Medical Sciences, Srinagar for starting of M.D.(Pharmacology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance together with Council Inspector's report (July, 2002) and noted that the following deficiencies which were taken into consideration while deciding the matter earlier at its meeting held on 26.9.2002 still exist:-

- i) The HOD does not possess requisite recognised postgraduate qualification.
- ii) The present teaching faculty in the deptt. of Pharmacology is not sufficient even for the annual intake of undergraduate students for which the institution is recognised.
- iii) Other observations /deficiencies pointed out in the inspection report.

In view of above, the Committee decided to recommend to Central Government not to issue Letter of Intent for starting of M.D.(Pharmacology) course at Sher-I-Kashmir Institute of Medical Sciences, Srinagar affiliated to Sher-I-Kashmir Institute of Medical Sciences, Srinagar (Deemed University) u/s 10A of the IMC Act, 1956.

The Committee further decided to recommend that the Govt. may consider disapproving the proposal for starting of MD (Pharmacology) course. However, the institution is free to apply afresh after rectification of the deficiencies, in accordance with the Council's Regulation on Postgraduate Medical Education, 2000.

#### 13. <u>Starting of D.O. courses at L.T.M. Medical College, Mumbai affiliated to Mumbai University u/s 10A of the IMC Act, 1956 – consideration of compliance regarding.</u>

Read: the compliance togetherwith Council Inspector's report (November, 2002) on the physical and other teaching facilities available at L.T.M. Medical College, Mumbai for starting of D.O. course u/s 10A of the IMC Act, 1956.

Noting the above facts, the Committee decided to recommend to the Central Government to issue Letter of Permission for starting of D.O course at LTM Medical College, Mumbai affiliated to Mumbai University u/s 10 A of the IMC Act, 1956 prospectively restricting the number of admission to 1(one) student per year till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11 (2) of the Act, 1956.

### 14. <u>Starting of M.D.(Anatomy) course at Deccan College of Medical Sciences, Hyderabad affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956- Consideration of compliance regarding.</u>

Read: the compliance togetherwith Council Inspector's report (April, 2002) on the physical and other teaching facilities available at Deccan College of Medical Sciences, Hyderabad for starting of M.D.(Anatomy) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance verification report (February, 2003) together with compliance and Council Inspector's report (May, 2002) and decided to recommend to the Central Government to issue Letter of Permission for starting of M.D. (General Medicine) course at Dr. D.Y. Patil Pratishtan's Medical College for Women, Pune affiliated to Pune University u/s 10 A of the IMC Act, 1956 prospectively restricting the number of admissions to 4(four) students per year till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11 (2) of the Act, 1956.

- (ii) Whether the teachers designated to the department of Neuro-Radiology are also working in the deptt. of Radio-Diagnosis.
- (iii) Complete faculty list of the deptt. of Radio-Diagnosis and deptt. of Neuro-Radiology be obtained.

The Postgraduate Committee considered the Council Inspector's report (January, 2003) and decided to recommend to Central Government to issue Letter of Permission for increase of seats in M.S. (Orthopaedics) course at Andhra Medical College, Visakhapatnam affiliated to NTR University of Health Sciences, Vijayawada from 2 (two) to 4(four) students per year prospectively u/s. 10A of the IMC Act, 1956 till the first batch admitted against the increased number appears for the final examination of the said course.

## 47. <u>Increase of seats in M.D.(Pathology) course at Al-Ameen Medical College, Bijapur affiliated to Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act, 1956.</u>

Read: the Council Inspector's report(Jan., 2003) on the physical and other teaching facilities available at Al-Ameen Medical College, Bijapur for consideration of increase of seats in M.D.(Pathology) course u/s 10A of the I.M.C. Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (January, 2003) and decided to recommend to Central Government to issue Letter of Permission for increase of seats in M.D. (Pathology) course at Al-Ameen Medical College, Bijapur affiliated to Rajiv Gandhi University of Health Sciences, Bangalore from 1 (one) to 2(two) students per year prospectively u/s. 10A of the IMC Act, 1956 till the first batch admitted against the increased number appears for the final examination of the said course.

## 48. <u>Starting of M.S.(Orthopaedics) course at Thanjavur Medical College, Thanjavur affiliated to The Tamilnadu Dr.M.G.R.Medical University u/s 10A of the IMC Act, 1956 – Consideration of compliance regarding.</u>

Read: the compliance together with the Council Inspector's report(June, 2002) on the physical and other teaching facilities available at Thanjavur Medical College, Thanjavur for consideration of starting of M.S.(Orthopaedics) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance together with Council Inspector's report (June, 2002) and noted that the previous HOD who was not having a recognised qualification has been replaced with a person having requisite recognised qualification and experience, but other deficiencies still persist. The Committee noted i) total bed strength in the Deptt. of Orthopaedics is only 60 in two units whereas for 150 admissions capacity for which the institution is recognised, the institution need to have 90 beds in three units and ii) many of the teaching faculty members possess MS(General Surgery) qualification; and therefore decided to recommend to the Central Government not to issue Letter of Intent for starting of M.S. (Orthopaedics) course at Thanjavur Medical College, Thanjavur affiliated to The Tamilnadu Dr.M.G.R.Medical University u/s 10 A of the IMC Act, 1956.

#### 49. Rajiv Gandhi University of Health Sciences, Bangalore – Approval of M.S. Ramaiah MedicalCollege, Bangalore for the award of M.D.(Pharmacology).

Read: the Council Inspector report's (Oct., 2002) on the standard of examination and other teaching facilities available at M.S. Ramaiah Medical College, Bangalore for purpose of approval of the college for the award of M.D. (Pharmacology) qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Committee considered the Council Inspector's report (October, 2002) and decided to recommend that M.S. Ramaiah Medical College, Bangalore be approved for the award of MD (Pharmacology) qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore restricting the number of admissions to 2(two) students per year.

#### 50. <u>University of Bombay/Mumbai and Maharashtra University of Health Sciences, Nasik – Approval of Seth G.S.Medical College, Mumbai for the award of D.P.H. qualification- Consideration of compliance verification regarding.</u>

Read: the compliance verification report(Feb., 2003) together with compliance and Council Inspector's report(March, 2001) on the standard of examination and other teaching facilities available at Seth G.S. Medical College, Mumbai for purpose of approval of the college for the award of D.P.H. qualification granted by University of Bombay/Mumbai and Maharashtra University of Health Sciences, Nasik.

The Postgraduate Committee considered the compliance verification report (Feb.2003) together with compliance and Council Inspector's report (March, 2001) and decided to recommend that Seth G.S. Medical College, Mumbai be approved for the award of DPH qualification granted by University of Bombay, Maharashtra University of Health Sciences, Nasik and now by University of Mumbai restricting the number of admissions to 2(two) students per year.

The Committee further decided to direct the authorities of the university and institution to strictly follow the Council Regulations on Postgraduate Medical Education, 2000 with regard to duration i.e. two years for diploma course. The college authorities and the university be directed to provide an undertaking to adhere to the duration of the course.

#### 51. <u>Maharishi Dayanand University, Rohtak - Recognition of M.D.(Forensic Medicine)</u> qualification in respect of students being trained at Pt. B.D. Sharma Postgraduate Institute of Medical Sciences, Rohtak - Consideration of compliance regarding.

Read: the compliance together with Council Inspector's report(July, 2002) on the standard of examination and other teaching facilities available at Pt. B.D. Sharma Postgraduate Institute of Medical Sciences, Rohtak for purpose of recognition of M.D.(Forensic Medicine) qualification granted by Maharishi Dayanand University.

The Postgraduate Committee considered the compliance together with Council Inspector's report(July, 2002) and noted that the postmortem training which is essential component of postgraduate teaching for MD Forensic Medicine course is not available. The Committee therefore decided to direct the college authorities to comply with the above requirement and send compliance to that effect which be verified by way of an inspection for further consideration.

#### 52. <u>University of Bombay/Mumbai – Approval of Institute of Naval Medicine, INHS, Asvini, Mumbai for the award of M.D.(Obst. & Gyane.).</u>

The Postgraduate Committee considered the Council Inspector report's(Jan., 2003) and decided not to approve Institute of Naval Medicine, INHS, Asvini for the award of M.D.(Obst. & Gyane.) qualification granted by University of Bombay/Mumbai because the composition of unit is not complete in terms of beds strength and teaching faculty as per MCI norms.

#### 53. <u>Gujarat University – Approval of Smt. N.H.L. Municipal Medical College,</u> Ahemdabad for the award of MD (Pharmacology).

Read: the Council Inspector's report (Dec., 2002) on the standard of examination and other teaching facilities available at Smt. N.H.L. Municipal Medical College, Ahemadabad for purpose of the approval of the college for the award of MD (Pharmacology) qualification granted by Gujarat University.

The Postgraduate Committee considered the Council Inspector's report (December, 2002) and decided to recommend that Smt. NHL Municipal Medical College, Ahmedabad be approved for the award of M.D. (Pharmacology) qualification granted by Gujarat University restricting the number of admissions to 3(three) students per year.

## 54. <u>Increase of seats in M.D.(Anatomy) course at Gandhi Medical College, Hyderabad affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956- Consideration of compliance regarding.</u>

Read: the compliance together with the Council Inspector's report(Sept., 2002) on the physical and other teaching facilities available at Gandhi Medical College, Hyderabad for increase of seats in M.D.(Anatomy) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance together with the Council Inspector's report (September, 2002) and decided to recommend to Central Government to issue Letter of Permission for increase of seats in M.D. (Anatomy) course at Gandhi Medical College, Hyderabad affiliated to NTR University of Health Sciences, Vijayawada from 2 (two) to 4(four) students per year prospectively u/s. 10A of the IMC Act, 1956 till the first batch admitted against the increased number appears for the final examination of the said course.

## 55. Increase of seats in M.D.(Pharmacology) course at Gandhi Medical College, Hyderabad affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956- Consideration of compliance regarding.

Read: the compliance together with the Council Inspector's report(Sept., 2002) on the physical and other teaching facilities available at Gandhi Medical College, Hyderabad for increase of seats in M.D.(Pharmacology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance together with the Council Inspector's report (September, 2002) and decided to recommend to Central Government to issue Letter of Permission for increase of seats in M.D. (Pharmacology) course at Gandhi Medical College, Hyderabad affiliated to NTR University of Health Sciences, Vijayawada from 2 (two) to 4(four) students per year prospectively u/s. 10A of the IMC Act, 1956 till the first batch admitted against the increased number appears for the final examination of the said course.

# 56. <u>Increase of seats in M.S.(Orthopaedics) course at Nizam's Institute of Medical Sciences, Hyderabad affiliated to Nizam's Institute of Medical Sciences, Hyderabad (Deemed University) u/s 10A of the IMC Act, 1956 – Consideration of compliance regarding.</u>

Read: the compliance together with the Council Inspector's report(May, 2002) on the physical and other teaching facilities available at Nizam's Institute of Medical Sciences, Hyderabad for increase of seats in M.S.(Orthopaedics) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance together with the Council Inspector's report (May, 2002) and reiterated its earlier decision taken at its meeting held on 24.12.2002 recommending to Central Government not to issue Letter of Intent for increase of seats in M.S.(Orthopaedics) course at Nizam's Institute of Medical Sciences, Hyderabad (Deemed University) u/s 10A of the IMC Act, 1956 because the following deficiencies still exist::-

- i) The Professor & HOD neither possesses requisite recognised postgraduate qualification nor his promotion to the post of Professor has been made as per MCI norms
- ii) The composition of units in the department of Orthopaedics in terms of teaching faculty is not as per MCI norms i.e. each unit having a minimum of 3 faculty members.
- iii) Clinical material, in terms of OPD patient strength and operative figures, is inadequate to permit any increase in the intake capacity
- iv) Other deficiencies/observation as pointed out in the inspection report.
- 57. i) Andhra University Recognition of MD (Anaesthesia) qualification in respect of students being trained at Rangaraya Medical College, Kakinada and also approval of the college for the award of DA qualification.

# ii) Andhra Pradesh University of Health Sciences, Vijayawada and N.T.R. University of Health Sciences, Vijayawada - Approval Rangaraya Medical College, Kakinada for the award of M.D.(Anaesthesia) & DA qualifications- Consideration of compliance verification regarding.

Read: the compliance verification report(Nov., 2002) togetherwith compliance and Council Inspector's report(May, 2001) on the standard of examination and other teaching facilities available at Rangaraya Medical College, Kakinada for i) recognition of MD(Anaesthesia) qualification granted by Andhra University and also approval of the college for the award of DA qualification and ii) approval of the college for the award of M.D.(Anaesthesia) & DA qualifications granted by Andhra Pradesh University of Health Sciences, Vijayawada & NTR University of Health Sciences, Vijayawada.

Read: the compliance verification report(Feb., 2003) together with the compliance and Council Inspector's report(June, 2002) on the physical and other teaching facilities available at M.G.M.Medical College, Navi Mumbai for consideration of starting of MD (Anaesthesia) & DA course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance verification report (February, 2003) together with compliance and Council Inspector's report (June, 2002) and decided to recommend to the Central Government to issue Letter of Permission for starting of M.D. (Anaesthesia) & DA courses at MGM Medical College, Navi Mumbai affiliated to Mumbai University u/s 10 A of the IMC Act, 1956 prospectively restricting the number of admissions to 2(two) for MD (Anaesthesia) & 2(two) for DA courses per year till the first batch admitted appears in the final examination of the said courses. The institution be advised to apply for recognition of the qualifications at the time of first available examination as per the provision of Section 11 (2) of the Act, 1956.

Office Note: The Committee further decided that the above recommendations be sent to the Govt. only once an undertaking from the authorities of the institution to the effect that DNB candidates would not be admitted in the department is obtained.

The Postgraduate Committee considered the compliance verification report (Feb.2003) together with the compliance and Council Inspector's report (May, 2002) and noted that the composition of Unit-I is not complete in terms of teaching faculty and decided to advise the institution authorities to re-organise the units as per MCI norms.

The Committee further decided to defer the consideration till the information is received.

#### 62. <u>Increase of seats in M.S.(E.N.T.)</u> course at <u>Himalayan Institute of Medical Sciences, Dehradun affiliated to H.N.B. Garhwal University u/s 10A of the I.M.C. Act, 1956.</u>

Read: the Council Inspector's report(Feb., 2003) on the physical and other teaching facilities available at Himalayan Institute of Medical Sciences, Dehradun for consideration of increase of seats in M.S.(E.N.T.) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (February, 2003) and decided to recommend to Central Government to issue Letter of Permission for increase of seats in M.S. (ENT) course at Himalayan Institute of Medical Sciences, Dehradun affiliated to HNB Garhwal University from 1(one) to 2(two) students per year prospectively u/s. 10A of the IMC Act, 1956 till the first batch admitted against the increased number appears for the final examination of the said course.

### 63. <u>Increase of seats in M.D.(General Medicine) course at Guntur Medical College, Guntur affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956.</u>

Read: the Council Inspector's report (Oct., 2002) on the physical and other teaching facilities available at Guntur Medical College, Guntur for consideration of increase of seats in M.D.(General Medicine) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (October, 2002) and decided to recommend to Central Government to issue Letter of Permission for increase of seats in M.D. (General Medicine) course at Guntur Medical College, Guntur affiliated to NTR University of Health Sciences, Vijayawada from 5 (five) to 6(six) students per year prospectively u/s. 10A of the IMC Act, 1956 till the first batch admitted against the increased number appears for the final examination of the said course.

#### 64. <u>Increase of seats in M.D.(Pharmacology) course at Kakatiya Medical College, Warangal affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956.</u>

Read: the Council Inspector's report(Sept., 2002) on the physical and other teaching facilities available at Kakatiya Medical College, Warangal for consideration of increase of seats in M.D.(Pharmacology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (September, 2002) and decided to recommend to Central Government to issue Letter of Permission for increase of seats in M.D. (Pharmacology) course at Kakatiya Medical College, Warangal, affiliated to NTR University of Health Sciences, Vijayawada from 1 (one) to 3(three) students per year prospectively u/s. 10A of the IMC Act, 1956 till the first batch admitted against the increased number appears for the final examination of the said course.

#### 66. Nagpur University – Recognition of M.D.(T.B.& Chest Diseases) qualification in respect of students being trained at Govt. Medical College, Nagpur- Consideration of clarification regarding.

Read: the Council Inspector's report(Dec., 2002) on the standard of examination and other teaching facilities available at Govt. Medical College, Nagpur together with the

clarification for purpose of recognition of M.D.(T.B. & Chest Diseases) qualification granted by Nagpur University.

The Postgraduate Committee considered the Council Inspector's report (December, 2002) and decided to recommend that M.D.(T.B. & Chest Diseases) qualification granted by Nagpur University in respect of students being trained at Govt. Medical College, Nagpur be recognised and included in the Ist Schedule to the Indian Medical Council Act, 1956. However, the authorities of the institution are directed to prospectively restrict the number of admissions to 1(one) student per year in consonance with the Council Regulations on Postgraduate Medical Education, 2000.

#### 67. <u>Holding of a single entrance test for Undergraduate and Postgraduate admission in the country- Letter regarding.</u>

Read: the letter dated 25.2.2003 from Dr. Ved Prakash Mishra, Dr. D.K. Sharma, Dr. D.J.Bora, Dr. L.S. Chawla, Dr. Indrajit Ray, Dr. B.P. Dubey, Dr. S.K. Pathank and Dr. A.C. Borah for Holding of a single entrance test for Undergraduate and Postgraduate admission in the country.

The Postgraduate Committee deliberated on the suggestion of the members for holding a single entrance test for undergraduate and postgraduate admissions made in various medical colleges of the country. The Committee agreed with the suggestions and decided to recommend to General Body that a single entrance test be held at the national level cumulatively each for admissions to undergraduate and postgraduate respectively in a centralized manner.

#### 68. Consideration of matters u/s 10A of the IMC Act, 1956 – Matter regarding.

Read: the matter in respect of some of the institutions who at the initial stage, had applied u/s 10A; are not ready/in position to arrange for inspections at reasonable time.

The Postgraduate Committee considered the matter and decided to constitute a Sub-Committee consisting of the following members to deliberate in the matter:
