Apology for absence was received from Dr. S.R. Maralihalli and Dr. N.B. Singh.

The Postgraduate Committee noted that the Ministry vide its letter No.U.12012/60/2002-ME (P-II), dated 27th June, 2003 has granted Letter of Permission to Dr. DY Patil Pratishtan's Medical College for Women, Pune for starting of MS (Ophthalmology) and DO courses with an annual intake of 2(two) seats for each course prospectively on the recommendations of the Postgraduate Committee vide its meeting dated 27.2.2003.

The aforesaid decision of the Postgraduate Committee taken in its meeting dated 27.2.2003 was reviewed because as per Postgraduate Regulations the permissible annual intake for Diploma per unit is one seat annually.

Accordingly the Postgraduate Committee decided to recommend to the Central Government to revise Letter of Permission for starting of M.S. (Ophthalmology) & DO courses at Dr. D.Y. Patil Pratishtan's Medical College for Women, Pune affiliated to Pune University u/s 10 A of the IMC Act, 1956 prospectively restricting the number of admissions to 2(two) students for MS (Ophthalmology) course and 1(one) student for Diploma in Ophthalmology per year till the first batches admitted appear in the final examination of the said courses. The institution be advised to apply for recognition of the qualifications at the time of first available examination as per the provision of Section 11 (2) of the Act, 1956.

It was further decided that the recommended change in regard to the intake of Diploma in Ophthalmology (one seat per year) shall be effective from the date of issuance of the revised Letter of Permission from the Government of India.

4. <u>Increase of seats in M.D.(T.B. & Respiratory Diseases) course at Andhra Medical College, Visakhapatnam affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 – compliance regarding.</u>

Read: the Council Inspector's report (July, 2003) on the physical and other teaching facilities available at Andhra Medical College, Visakhapatnam togetherwith compliance for consideration of increase of seats in M.D.(T.B. & Respiratory Diseases) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector report (July,2003) and decided to verify the compliance by way of an inspection.

5. <u>Increase of seats in D.M.(Neurology) course at Osmania Medical College, Hydeabad affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956.</u>

Read: the Council Inspector's report (December, 2003) on the physical and other teaching facilities available at Osmania Medical College, Hyderabad for increase of seats in D.M.(Neurology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (December, 2003) and noted the following deficiencies:-

- (i) Teaching complement is incomplete in all the three units.
- (ii) Promotion of Professor & HOD is not as per MCI norms
- (iii) Other deficiencies/observations as pointed out in the inspection report.

In view of above, the Committee decided to recommend to Central Government not to issue Letter of Intent for increase of seats in DM (Neurology) course at Osmania Medical College, Hyderabad affiliated to NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956.

The Committee further decided to recommend that in view of the above; the Govt. may consider disapproving the proposal for increase of seats in DM (Neurology) course. However, the institution is free to apply afresh after rectification of the deficiencies, in accordance with the Council's Regulations on Postgraduate Medical Education, 2000.

The Committee further decided to direct the institution authorities to henceforth stop admissions in D.M (Neurology) course from the ensuing academic session.

6. <u>Starting of M.Ch.(Surgical Oncology) course at Osmania Medical College, Hydeabad affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956.</u>

Read: the Council Inspector's report (December, 2003) on the physical and other teaching facilities available at Osmania Medical College, Hyderabad for starting of M.Ch.(Surgical Oncology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (December, 2003) and noted the following deficiencies:-

- (i) Teaching complement is incomplete in unit-I as the faculty does not possess requisite qualification.
- (ii) Other deficiencies/observations as pointed out in the inspection report.

In view of above, the Committee decided to recommend to Central Government not to issue Letter of Intent for starting of M.Ch (Surgical Oncology) course at Osmania Medical

College, Hyderabad affiliated to NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956.

The Committee further decided to recommend that in view of the above; the Govt. may consider disapproving the proposal for starting of M.Ch (Surgical Oncology) course. However, the institution is free to apply afresh after rectification of the deficiencies, in accordance with the Council's Regulations on Postgraduate Medical Education, 2000.

7. <u>Increase of seats in M.D.(Microbiology) course at Guntur Medical College, Guntur affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956.</u>

Read: the Council Inspector's report (December, 2003) on the physical and other teaching facilities available at Guntur Medical College, Guntur for consideration of increase of seats in M.D.(Microbiology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (December, 2003) and noted the following deficiencies:-

- (i) Principal is officiating
- (ii) Promotion of Professor & HOD is not as per MCI norms.
- (iii) Other deficiencies/observations as pointed out in the inspection report.

In view of above, the Committee decided to recommend to Central Government not to issue Letter of Intent for increase of seats in M.D (Microbiology) course at Guntur Medical College, Guntur affiliated to NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956.

The Committee further decided to recommend that in view of the above; the Govt. may consider disapproving the proposal for increase of seats in M.D (Microbiology) course. However, the institution is free to apply afresh after rectification of the deficiencies, in accordance with the Council's Regulations on Postgraduate Medical Education, 2000.

8. <u>Increase of seats in M.D.(Dermatology) course at Guntur Medical College, Guntur affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 – compliance verification regarding.</u>

Read: the compliance verification report (December, 2003) togetherwith compliance and Council Inspector's report (August, 2002) on the physical and other teaching facilities available at Guntur Medical College, Guntur for increase of seats in M.D.(Dermatology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance verification report (December, 2003) togetherwith compliance and Council Inspector's report (August, 2002) and noted the following deficiencies:-

- (i) Principal is officiating
- (iii) Promotion of Professor & HOD is not as per MCI norms.
- (ii) Other deficiencies/observations as pointed out in the inspection report.

In view of above, the Committee decided to recommend to Central Government not to issue Letter of Intent for increase of seats in M.D (Dermatology) course at Guntur Medical College, Guntur affiliated to NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956.

The Committee further decided to recommend that in view of the above; the Govt. may consider disapproving the proposal for increase of seats in M.D (Dermatology) course. However, the institution is free to apply afresh after rectification of the deficiencies, in accordance with the Council's Regulations on Postgraduate Medical Education,2000.

9. <u>Starting of M.Ch.(Urology) course at Kakatiya Medical College, Warangal affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 – compliance regarding.</u>

Read: the Council Inspector's report (July, 2003) on the physical and other teaching facilities available at Kakatiya Medical College, Warangal togetherwith compliance for consideration of starting of M.Ch.(Urology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (July, 2003) togetherwith compliance and decided to reiterate its earlier decision taken at its meeting held on 29.7.2003 recommending to the Central Government not to issue Letter of Intent for starting of M.Ch. (Urology) course at Kakatiya Medical College, Warangal u/s 10 A of the IMC Act, 1956 because of the following –

- (i) Teaching complement is incomplete in Unit-I as there is no Associate Professor.
- (ii) Purchase orders have been placed for Dialysis machine which is not an actual compliance.
- (iii) Nephrologist has been appointed but has not joined.
- (iv) ESWL facility till date not provided
- (v) Other deficiencies/observations as pointed out in the inspection report.

The Committee further decided to recommend that in view of the above; the Govt. may consider disapproving the proposal for starting of M.Ch. (Urology) course. However, the institution is free to apply afresh after rectification of the deficiencies, in accordance with the Council's Regulations on Postgraduate Medical Education, 2000.

10. <u>Starting of M.D.(Dermatology, Venereology & Leprosy) course at Shri B.M. Patil Medical College, Bijapur affiliated to Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act, 1956.</u>

Read: the Council Inspector's report (November, 2003) on the physical and other teaching facilities available at Shri B.M.Patil Medical College, Bijapur for consideration of starting of M.D.(Dermatology, Venereology & Leprosy) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (November,2003) and decided to defer the consideration of the matter till a clarification regarding the teaching experience of HOD & Associate Professor alongwith the necessary documentary evidence/s is received.

11. <u>Starting of M.D.(Biochemistry) course at Sri Devraj Urs Medical College, Kolar affiliated to Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act, 1956 – compliance verification regarding issuance of LOP.</u>

Read: the compliance verification report (November, 2003) togetherwith compliance and Council Inspector's report (May, 2002) on the physical and other teaching facilities available at Sri Devraj Urs Medical College, Kolar for starting of M.D.(Biochemistry) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance verification report (November, 2003) togetherwith compliance and Council Inspector report (May, 2002) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of M.D.(Biochemistry) course at Sri Devraj Urs Medical College, Kolar affiliated to Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act, 1956 prospectively restricting the number of admission to 1 (one)student per year till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11 (2) of the Act, 1956.

12. <u>Starting of M.D.(Radio-Diagnosis) course at M.G.M. Medical College, Navi Mumbai affiliated to Mumbai University u/s 10A of the IMC Act, 1956 – consideration of compliance for issuance of LOP.</u>

Read: the compliance verification report (March, 2003) togetherwith further compliance and Council Inspector's report (June, 2002) on the physical and other teaching facilities available at M.G.M.Medical College, Navi Mumbai for starting of M.D.(Radio-Diagnosis) & course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance verification report (March, 2003) togetherwith further compliance and Council Inspector's report (June, 2002) and decided to recommend to the Central Government not to issue Letter of Permission for starting of M.D. (Radio-Diagnosis) course at MGM Medical College, Navi Mumbai u/s 10 A of the IMC Act, 1956 because of the following –

- (i) No MRI machine
- (ii) Instrumentation is inadequate.
- (iii) Other deficiencies/observations as pointed out in the inspection report.

13. <u>Starting of M.D.(Microbiology) course at S.C.B. Medical College, Cuttack affiliated to Utkal University u/s 10A of the IMC Act, 1956 – Consideration of compliance regarding.</u>

Read: consider the Council Inspector's report (July-August, 2002) on the physical and other teaching facilities available at S.C.B. Medical College, Cuttack togetherwith compliance for starting of M.D.(Microbiology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (July-August, 2002) togetherwith compliance and decided to reiterate its earlier decision taken at its meeting held on 26.9.2002 recommending to the Central Government not to issue Letter of Intent for starting of M.D. (Microbiology) course at SCB Medical College, Cuttack u/s 10 A of the IMC Act, 1956 because (i) Professor & Head has not been promoted as per MCI norms i.e. minimum of 4 years experience as Assoc. Prof. for the post of Professor and (ii) Other deficiencies/observations as pointed out in the inspection report.

The Committee further decided to recommend that in view of the above; the Govt. may consider disapproving the proposal for starting of M.D. (Microbiology) course. However, the institution is free to apply afresh after rectification of the deficiencies, in accordance with the Council's Regulations on Postgraduate Medical Education, 2000.

14. <u>Increase of seats in M.D.(Paediatrics) course at Regional Institute of Medical Sciences, Imphal, Manipur affiliated to Manipur University u/s 10A of the IMC Act, 1956 – compliance regarding.</u>

Read: the Council Inspector's report (June, 2003) on the physical and other teaching facilities available at Regional Institute of Medical Sciences, Imphal, Manipur togetherwith compliance for increase of seats in M.D.(Paediatrics) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector report (June, 2003) and decided to verify the compliance by way of an inspection.

15. <u>Starting of M.Ch.(Surgical Gastroenterology) course at Kilpauk Medical College, Kilpauk affiliated to The Tamilnadu Dr.M.G.R.Medical University u/s 10A of the IMC Act, 1956 – compliance verification regarding.</u>

Read: the compliance verification report (November, 2003) togetherwith compliance and the Council Inspector's report (June, 2002) on the physical and other teaching facilities available at Kilpauk Medical College, Kilpauk for starting of M.Ch.(Surgical Gastroenterology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance verification report (November, 2003) togetherwith compliance and Council Inspector's report (June, 2002) and decided to recommend to the Central Government not to issue Letter of Intent for starting of M.Ch. (Surgical Gastroenterology) course at Kilpauk Medical College, Kilpauk u/s 10 A of the IMC Act, 1956 because of the following –

- (i) Clinical material is still inadequate.
- (ii) No improvement in the Intensive Care Unit.
- (iii) There is gross discrepancy between the details of staff provided in Annexure I and II. Many forms are incompletely filled eg Page 21 Posts of Drs. Selvaraj, Padmanabhan, Kopperun Devi are not mentioned; Page 22 Posts of Drs. Anand, Ramu, Ravikanth are not mentioned; Page 33 designations are not mentioned.
- (iv) Other deficiencies/observations as pointed out in the inspection report.

The Committee further decided to recommend that in view of the above; the Govt. may consider disapproving the proposal for starting of M.Ch. (Surgical Gastroenterology) course. However, the institution is free to apply afresh after rectification of the deficiencies, in accordance with the Council's Regulations on Postgraduate Medical Education, 2000.

16. <u>Starting of M.S.(E.N.T.) course at Stanley Medical College, Chennai affiliated to The Tamilnadu Dr.M.G.R.Medical University u/s 10A of the IMC Act, 1956 – consideration of compliance verification regarding.</u>

Read: the compliance verification report (November, 2003) togetherwith compliance and Council Inspector's report (May, 2003) on the physical and other teaching facilities available at Stanley Medical College, Chennai for consideration of starting of M.S.(E.N.T.) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance verification report (November, 2003) togetherwith compliance and Council Inspector report (May, 2003) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of M.S.(ENT) course at Stanley Medical College, Chennai affiliated to the Tamilnadu Dr. MGR Medical University u/s 10A of the IMC Act, 1956 prospectively restricting the number of admissions to 2 (two) students per year till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11 (2) of the Act, 1956.

17. <u>Starting of M.D.(Immuno Haematology & Blood Transfusion) course at Dr.M.G.R. Medical University Campus, Chennai affiliated to The Tamilnadu Dr.M.G.R. Medical University u/s 10A of the IMC Act, 1956 – compliance verification regarding.</u>

Read: the compliance verification report (December, 2003) togetherwith compliance and Council Inspector's report (October, 2002) on the physical and other teaching facilities available at Dr.M.G.R. Medical University Campus, Chennai for consideration of starting of M.D.(Immuno Haematology & Blood Transfusion) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee reviewed its earlier decision taken in its meeting dated 20th January, 2003 to recommend to Central Government to issue Letter of Intent for starting of MD (Immuno Haematology & Blood Transfusion) course at Dr. MGR Medical University Campus Chennai affiliated to The Tamilnadu Dr.M.G.R. Medical University u/s 10A of the IMC Act, 1956 restricting the number of admissions to 2(two) seats per year decided that the applicant not being a college/institution as contemplated in terms of 10A of the Act and also not owning the required hospital hence decided to recommend to the Central Government to withdraw the Letter of Intent for starting of MD (Immuno Haematology & Blood Transfusion) course at Dr. MGR Medical University Campus Chennai affiliated to The Tamilnadu Dr.M.G.R. Medical University u/s 10A of the IMC Act, 1956.

The Committee further decided to recommend that in view of the above, the Govt. may consider disapproving of the proposal for starting of MD (Immuno Haematology & Blood Transfusion) course. However, the institution is free to apply afresh after rectification of the

deficiencies in accordance with the Council Regulations on Postgraduate Medical Education, 2000.

18. <u>Starting of M.D.(Obst. & Gynae.) course at Burdwan Medical College, Burdwan affiliated to Burdwan University u/s 10A of the IMC Act, 1956 – compliance verification regarding.</u>

Read: the compliance verification report (November, 2003) togetherwith compliance and Council Inspector's report (May 2003) on the physical and other teaching facilities available at Burdwan Medical College, Burdwan for consideration of starting of M.D.(Obst. & Gynae.) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance verification report (November, 2003) togetherwith compliance and Council Inspector's report (May, 2003) and decided to reiterate its earlier decision taken at its meeting held on Ist & 2nd July, 2003 recommending to the Central Government not to issue Letter of Intent for starting of M.D. (Obst. & Gynae.) course at Burdwan Medical College, Burdwan affiliated to Burdwan University u/s 10 A of the IMC Act, 1956 because (i) the HOD has not been promoted as per MCI norms i.e. the required minimum experience of 4 years as Assoc.Prof./Reader for promotion as Professor and (ii) Other deficiencies/observations as pointed out in the inspection report.

The Committee further decided to recommend that in view of the above; the Govt. may consider disapproving the proposal for starting of M.D. (Obst. & Gynae.) course. However, the institution is free to apply afresh after rectification of the deficiencies, in accordance with the Council's Regulations on Postgraduate Medical Education, 2000.

19. <u>Starting of M.D.(Microbiology) course at Nizam's Institute of Medical Sciences, Hyderabad affiliated to Nizam's Institute of Medical Sciences, Hyderabad (Deemed University) u/s 10A of the IMC Act, 1956 – compliance regarding.</u>

Read: the Council Inspector's report (August, 2003) on the physical and other teaching facilities available at Nizam's Institute of Medical Sciences, Hyderabad togetherwith compliance for consideration of starting of M.D.(Microbiology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (August, 2003) and decided to reiterate its earlier decision taken at its meeting held on 9.10. 2003 recommending to the Central Government not to issue Letter of Intent for starting of M.D. (Microbiology) course at Nizam Institute of Medical Sciences, Hyderabad u/s 10 A of the IMC Act, 1956 because of the following:-

- (i) Promotion of Prof. & HOD and Assoc. Professor is not as per MCI norms.
- (ii) Other deficiencies/observations as pointed out in the inspection report.

The Committee further decided to recommend that in view of the above; the Govt. may consider disapproving the proposal for starting of M.D. (Microbiology) course. However, the institution is free to apply afresh after rectification of the deficiencies, in accordance with the Council's Regulations on Postgraduate Medical Education, 2000.

20. Rajiv Gandhi University of Health Sciences, Bangalore – Permitting Inatke in M.D.(Skin & V.D.) and D.D.V.L. qualifications in respect of students being trained at Mysore Medical College, Mysore.

Read: the Council Inspector's report (November, 2003) on the standard of examination and other teaching facilities available at Mysore Medical College, Mysroe for purpose of permitting intake in M.D.(Skin & V.D.) and D.D.V.L. qualifications granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Committee considered the Council Inspector's report (November, 2003) and decided to permit the institution to restart the course of MD (Skin & VD) and DDVL qualifications granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Mysore Medical College, Mysore prospectively restricting the number of admission to 1(one) student each for MD (Skin & VD) and DDVL qualifications per year.

21. <u>Shivaji University – Recognition of M.S.(Orthopaedics) & D.Ortho. qualificationsd in respect of P.G. Institute of Swasthiyog Pratisthan, Miraj – reconsideration regarding.</u>

Read: the Council Inspector's report (March, 2003) on the standard of examination and other teaching facilities available at P.G. Institute of Swasthiyog Pratisthan, Miraj togetherwith compliance for purpose of recognition of M.S.(Ortho.) & D.Ortho. qualifications granted by Shivaji University as referred back by the General Body.

The Postgraduate Committee considered the Council Inspector's report (March, 2003) and decided to defer the consideration of the matter for want of clarification on the following:-

- 1. Details of the two faculty members were sketchy.
- 2. Whether the Government Medical College, Miraj has an independent department of Orthopaedic or not.

22. <u>University of Rajasthan – Approval of S.P.Medical College, Bikaner for the award of MS (ENT) qualification - Consideration of compliance regarding .</u>

Read: the Council Inspector's report (July, 2003) on the standard of examination and other teaching facilities available at S.P. Medical College, Bikaner togetherwith compliance for purpose of approval of the college for the award of MS (ENT) qualification granted by University of Rajasthan.

The Postgraduate Committee considered the Council Inspector's report (July,2003) togetherwith compliance and decided to recommend that SP Medical College, Bikaner be approved for the award of MS(ENT) qualification granted by University of Rajasthan restricting the number of admission to 1(one) student per year.

23. <u>University of Rajasthan – Approval of S.P.Medical College, Bikaner for the award of MD(Paediatrics) qualification – Consideration of compliance verification regarding</u>

Read: the compliance verification report (January, 2004) togetherwith compliance and Council inspector's report (August 2003) on standard of examination and other teaching facilities available at S.P. Medical College, Bikaner for purpose of approval of the college for the award of MD (Paediatrics) qualification granted by University of Rajasthan.

The Postgraduate Committee considered the compliance verification report (January, 2004) togetherwith compliance and Council Inspector's report (August, 2003) and decided to recommend that SP Medical College, Bikaner be approved for the award of MD(Paediatrics) qualification granted by University of Rajasthan restricting the number of admissions to 4(four) students per year.

The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the Act,1956.

74. <u>Starting of M.D.(Dermatology, Venereology & Leprsoy) course at Madurai Medical College, Madurai affiliated to The Tamilnadu Dr.M.G.R. Medical University, Chennai u/s 10A of the IMC Act, 1956 – compliance verification regarding.</u>

Read: the compliance verification report (January, 2004) togetherwith compliance and Council Inspector's report (March, 2003) on the physical and other teaching facilities available at Madurai Medical College, Madurai for consideration of starting of M.D.(Dermatology, Venereology & Leprosy) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance verification report (January,2004) togetherwith compliance and Council Inspector's report (March,2003) and decided to recommend to the Central Govt., to issue Letter of Permission for starting of M.D.(Dermatology, Venereology & Leprosy) course at Madurai Medical College, Madurai affiliated to The Tamilnadu Dr.M.G.R. Medical University, Chennai u/s 10A of the IMC Act,1956 prospectively restricting the number of admissions to 2 (two) students per year till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the Act,1956.

75. <u>H.N.B. Garhwal University – Recognition of D.Ortho. qualification in respect of students being trained at Himalayan Institute of Medical Sciences, Dehradun.</u>

Read: the Council Inspector's report (January, 2004) on the standard of examination and other teaching facilities available at Himalayan Institute of Medical Sciences, Dehradun for purpose of recognition of D.Ortho. qualification granted by H.N.B.Garhwal University.

The Postgraduate Committee considered the Council Inspector's report (January,2004) and observed that the incharge of Unit-II does not possess recognised postgraduate medical qualification. As such, Unit-II is not as per MCI norms in terms of teaching faculty. The institution is therefore advised to re-organise the Unit-II as per MCI norms.

The Committee further decided to defer the consideration till the information is received.

76. <u>H.N.B. Garhwal University – Recognition of D.M.R.D. qualification in respect of students being trained at Himalayan Institute of Medical Sciences, Dehradun.</u>

The Postgraduate Committee considered the Council Inspector's report (January,2004) and decided to defer the consideration of the matter till the details of examination is received from the Council Inspector.

The Postgraduate Committee considered the Council Inspector's report (December,2003) and decided to recommend that Sree Siddhartha Medical College, Tumkur be approved for the award of M.D(Pathology) qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore restricting the number of admissions to 1(one) student per year.

78 Sardar Patel University – Recognition of D.M.R.D. qualification in respect of students being trained at Pramukhswami Medical College, Karamsad.

Read: the Council Inspector's report (December, 2003) on the standard of examination and other teaching facilities available at Pramukhswami Medical College, Karamsad for purpose of recognition of D.M.R.D. qualification granted by Sardar Patel University.

The Postgraduate Committee considered the Council Inspector's report (December,2003) and decided to recommend that D.M.R.D. qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore be recognised and included in the first schedule to the IMC Act,1956 restricting the number of admission to 1(one) student per year.

79. <u>Kerala University – Approval of T.D. Medical College, Alappuzha for the award of M.D.(Anaesthesia) & D.A. qualifications.</u>

Read: the Council Inspector's report (December, 2003) on the standard of examination and other teaching facilities available at T.D. Medical College, Alappuzha for the award of M.D.(Anaesthesia) & D.A. qualifications granted by Kerala University.

The Postgraduate Committee considered the Council Inspector's report (December,2003) and decided to recommend that T.D. Medical College, Alappuzha be approved for the award of M.D(Anaesthesia) & D.A. qualifications granted by Kerala University restricting the number of admission to 1(one) student for degree and 2(two) for Diploma per year.

80. <u>Punjab University and Baba Farid University of Health Sciences, Faridkot – Approval of Dayanand Medical College, Ludhiana for the award of D.C.H. qualification.</u>

Read: the Council Inspector's report (January, 2004) on the standard of examination and other teaching facilities available at Dayanand Medical College, Ludhiana for the award of D.C.H. qualification granted by Punjab University and Baba Farid University of Health Sciences, Faridkot.

The Postgraduate Committee considered the Council Inspector's report (January,2004) and decided to recommend that Dayanand Medical College, Ludhiana be approved for the award of D.C.H. qualification granted by Punjab University and Baba Farid University of Health Sciences, Faridkot restricting the number of admission to 2(two) students per year prospectively.

81. <u>Maharishi Dayanand University, Rohtak – Recognition of M.D.(Psychiatry) & D.P.M. qualifications in respect of students being trained at Pt.B.D.Sharma Postgraduate Institute of Medical Sciences, Rohtak.</u>

Read: the Council Inspector's report (December, 2002) on the standard of examination and other teaching facilities available at Pt.B.D.Sharma Postgraduate Institute of Medical Scinces, Rohtak purpose of recognition of M.D.(Psychiatry) & D.P.M. qualifications granted by Maharishi Dayanand University, Rohtak.

The Postgraduate Committee considered the considered the Council Inspector's report (December,2002) and decided to recommend that M.D. (Psychiatry) & D.P.M. qualifications granted by Maharishi Dayanand University, Rohtak be recognised and included in the first schedule to the IMC Act,1956 restricting the number of admission to 2(two) students per year in each course.

82. <u>Poona University – Recognition of D.M.(Cardiology) qualification in respect of students being trained at Armed Forces Medical College, Pune – reconsideration of compliance regarding.</u>

Read: the Council Inspector's report (July, 2001) on the standard of examination and other teaching facilities available at Armed Forces Medical College, Pune togetherwith compliance for purpose of recognition of D.M.(Cardiology) qualification granted by Poona University.

The Postgraduate Committee considered the Council Inspector's report (July,2001) and decided to verify the compliance by way of an inspection.

83. Nagpur University – Approval of J.L.N. Medical College, Swangi, Wardha for the award of M.S.(General Surgery) qualification – consideration of compliance regarding.

Read: the Council Inspector's report (November, 2003) on the standard of examination and other teaching facilities available at J.L.N.Medical College, Swangi, Wardha togetherwith compliance for the award of M.S.(General Surgery) qualification granted by Nagpur University.

The Postgraduate Committee considered the Council Inspector's report (November,2003) and decided to verify the compliance by way of an inspection.

84. The Tamilnadu Dr.M.G.R. Medical University, Chennai – Approval of Institute of Ophthalmology, Joseph Eye Hospital, Tiruchirapalli for the award of M.S.(Ophthalmology) & D.O. qualifications – consideration of compliance regarding.

Read: the Council Inspector's report (April, 2003) on the standard of examination and other teaching facilities available at Institute of Ophthalmology, Joseph Eye Hospital, Tiruchirapalli togetherwith compliance for the award of M.S.(Ophthalmology) & D.O. qualifications granted by the Tamilnadu Dr.M.G.R. Medical University, Chennai.

The Postgraduate Committee considered the Council Inspector's report (April,2003) and decided to recommend that Institute of Ophthalmology, Joseph Eye Hospital, Tiruchirapalli be approved for the award of M.S.(Ophthalmology) & D.O qualifications granted by The Tamil Nadu Dr.M.G.R. Medical University, Chennai prospectively restricting the number of admissions to 2(two) for degree and 3(three) for diploma per year.

85. (i) <u>University of Mumbai/Bombay – Recognition of M.D.(Radio-Diagnosis)</u> <u>qualification in respect of students being trained at L.T.M. Medical College,</u> <u>Mumbai.</u>

(ii) <u>University of Mumbai/Bombay and Maharashtra University of Health Sciences,</u> <u>Nasik – Approval of L.T.M. Medical College, Mumbai for the award of D.M.R.D. qualification – consideration of compliance rgarding.</u>

Read: the Council Inspector's report (March, 2001) on the standard of examination and other teaching facilities available at L.T.M. Medical College, Mumbai for purpose of recognition of M.D.(Radio-Diagnosis) qualification granted by University of Mumbai/Bombay and approval of the college for the award of D.M.R.D. qualification granted by University of Mumbai/Bombay and Maharashtra University of Health Sciences, Nasik.

The Postgraduate Committee considered the Council Inspector's report (March,2001) and decided to recommend that –

- 1. M.D.(Radio-Diagnosis) qualification granted by Bombay University/Mumbai be recognised and included in the first schedule to the IMC Act,1956 prospectively restricting the number of admission to 3(three) students per year.
- 2. LTM Medical College, Mumbai be approved for the award of DMRD qualification granted bly University of Mumbai/Bombay and Maharashtra University of Health Sciences, Nasik prospectively restricting the number of admissions to 3(three) students per year.

86. <u>Calcutta University – Approval of Vivekanand Institute of Medical Sciences, Calcuta for the award of M.D.(Obst. & Gynae.) & D.G.O. qualifications – consideration of compliance regarding.</u>

Read: the Council Inspector's report (April, 2003) on the standard of examination and other teaching facilities available at Vivekanand Institute of Medical Sciences, Calcutta togetherwith compliance for the award of M.D.(Obst. & Gynae.) & D.G.O. qualifications granted by the Calcutta University.

The Postgraduate Committee considered the considered the Council Inspector's report (April,2003) and decided to recommend that Vivekanand Institute of Medical Sciences, Calcutta, be approved for the award of M.D.(Obst. & Gynae.) & DGO qualifications granted by Calcutta University restricting the number of admissions to 3(three) students for degree and 3(three) students for diploma per year.

An undertaking may be procured from the college authorities for stopping admission to DNB courses.

87. <u>Rajasthan University – Approval of R.N.T. Medical College, Udaipur for the award of M.D.(Radio-Diagnosis) qualification.</u>

Read: the Council Inspector's report (December, 2002) on the standard of examination and other teaching facilities available at R.N.T. Medical College, Udaipur for the award of M.D.(Radio-Diagnosis) qualification granted by the Rajasthan University.

The Postgraduate Committee considered the Council Inspector's report (December,2002) and decided not to recommend approval of R.N.T. Medical College, Udaipur for the award of M.D.(Radio-Diagnosis) qualification granted by Rajasthan University because –

- 1. Instrumentation is inadequate.
- 2. Number of journals are inadequate.
- 3. Departmental museum is lacking
- 4. Other deficiencies pointed out in the Inspection report.

88. <u>University of Delhi – Approval of Army Hospital, Delhi Cantt., Delhi for the award of M.D.(Pathology) qualification – consideration of compliance regarding.</u>

Read: the Council Inspector's report (October, 2003) on the standard of examination and other teaching facilities available at Army Hospital, Delhi Cantt., Delhi togetherwith compliance for the award of M.D.(Pathology) qualification granted by the University of Delhi..

The Postgraduate Committee considered the Council Inspector's report (October,2003) and decided to defer the consideration of the matter till the break-up of experience of the faculty in the prescribed performa is received.

89. <u>Nizam's Institute of Medical Sciences, Hyderabad (Deemed University) – Recognition of M.D.(Radio-Diagnosis) & D.M.R.D. qualifications in respect of students being trained at Nizam's Institute of Medical Sciences, Hyderabad – consideration of compliance verification regarding.</u>

Read: the compliance verification reports (December, 2002 & October, 2003) togetherwith compliance and Council Inspector's report (January, 1996) on the standard of examination and other teaching facilities available at Nizam's Institute of Medical Sciences, Hyderabad for purpose of recognition of M.D.(Radio-Diagnosis) & D.M.R.D. qualifications granted by the Institute.

The Postgraduate Committee considered the compliance verification reports (December,2002 & October,2003) togetherwith compliance and Council Inspector's report

(January,1996) and decided to reiterate its earlier decision taken at its meeting held on 15.12.2003 which reads as under:-

"The Postgraduate Committee considered the compliance verification report (December,2002) and decided not to recommend recognition of M.D.(Radio-Diagnosis) & D.M.R.D. qualifications granted by Nizam's Instt. of Medical Sciences, Hyderabad (Deemed University) in respect of students being trained at Nizam's Institute of Medical Sciences, Hyderabad because –

- 1. The promotion of HOD is not as per MCI norms.
- 2. Other deficiencies pointed out in the inspection report have not been complied satisfactorily"

The Committee further decided to direct the institution authorities to henceforth stop admissions in M.D.(Radio-Diagnosis) & DMRD courses from the ensuring academic session.

90. To consider the Inspection report (3rd & 4th November, 2003) of M.L.B. Medical College, Jhansi carried out to assess the undergraduate teaching and training facilities available at the college.

Read: the Inspector report (3rd & 4th November, 2003) of M.L.B. Medical College, Jhansi carried out to assess the undergraduate teaching and training facilities available at the college.

The Postgraduate Committee considered the Inspector report (3rd & 4th November,2003) and decided that the college authorities be directed forthwith to stop the admissions to all the postgraduate degree/diploma courses that are current being run by the said college under intimation to the Registrar of the concerned university and Secretary (Health) of the State of Madhya Pradesh.

91. To consider the Inspection report (28th & 29th November, 2003) of Rajendra Institute of Medical Sciences, Ranchi carried out to assess the undergraduate teaching and training facilities available at the college.

Read: the Inspector report (28th & 29th November, 2003) of Rajendra Institute of Medical Sciences, Ranchi carried out to assess the undergraduate teaching and training facilities available at the college.

The members of the Ad-hoc Committee and of the Executive Committee of the Council considered the inspection report (28th and 29th November, 2003) and noted as under:

- 1. Shortage of teaching staff is as under:
 - (a) Faculty 43.66% (i.e. 62 out of 142)
 - (i) Professors-7
 - (ii) Assoc. Professors-13
 - (iii) Asstt. Professors-32
 - (iv) Tutors-10
- 2. The distribution of units in different departments which have been submitted by the Director of the Institute is not as per the standard requirement of the Council as given in the Postgraduate Medical Education Regulations,2000. The number of postgraduate students admitted in each department is much more than the recognised postgraduate teachers in the department. As per MCI norms the ratio has not been followed. Hence, there is gross anomaly in number of units and faculty members and also postgraduate students.
- 3. Electricity fired incinerator with capacity of 50 kg/hr. is not functional.
- 4. The availability of para medical staff of different categories is not adequate.
- 5. There is no centralized research laboratory for experimental/research work, however different departments have their own research labs.
- 6. No functional linkage is with 3 primary health centres and separate accommodation for boys and girls interns and students be created.

- 7. No central workshop functioning.
- 8. Pharmacy have not been upgraded.
- 9. The laundry be mechanized.
- 10. Incinerator is not functional.
- 11. In the department of Pathology, post of Professor be filed up.
- 12. Every unit in the hospital should have a side pathology laboratory.
- 13. In the deptt. of PSM, deficiency of 2 Asstt. Professors, 1-Epidemio-cum-Lect.,1-Statician-cum-Lect. And 2-Tutors still persist.
- 14. The students go to Ranchi Instt. of Psychiatry and Allied Sciences, Kanke for training in Psychiatry.
- 15. The campus should have complete boundary wall.
- 16. Other deficiencies/remarks are in the report.

In view of the above, the members of the Ad-hoc Committee and of the Executive Committee of the Council decided to issue a show cause notice to the concerned authorities as to why steps should not be initiated to recommend to the Central Government to derecognise the institution for the award of MBBS degree granted by Ranchi University. The Committee further decided to give one month's time to the institution to respond to the show cause notice. If no reply is received within the specified period, action be initiated as decided.

The Committee further decided to send a copy of the letter to the Chief Secretary, Health Secretary and Director Medical Education of the State Govt., Registrar of the concerned university, Health Secretary to Govt. of India and member of the Council representing the State Govt. for information and necessary action.

The Committee further decided to place this decision on the record of the Hon'ble High Court of Jharkhand by filing an affidavit through the Council Advocate. As the institution is also running postgraduate courses, it was also decided that the above mentioned deficiencies/remarks may be placed before the Postgraduate Committee for further action.

Accordingly, the Postgraduate Committee considered the said report and taking note of the deficiencies including therein and the decision of the Executive Committee alongwith the members of the Adhoc Committee appointed by the Hon'ble Supreme Court and decided that the college authorities be directed forthwith to stop the admissions to all the postgraduate degree/diploma courses that are currently being run by the said college under intimation to the Registrar of the concerned University and Secretary (Health) of the State of Bihar.

92. To consider the Inspection report (22th & 23rd December, 2003) of Darbhanga Medical College, Darbhanga carried out to assess the undergraduate teaching and training facilities available at the college.

Read: the Inspector report (22nd & 23rd December, 2003) of Darbhanga Medical College, Darbhanga carried out to assess the undergraduate teaching and training facilities available at the college.

The members of the Ad-hoc Committee and of the Executive Committee of the Council noted that the Executive Committee at its meeting held on 31.10.2002 decided to issue a show cause notice to Darbhanga Medical College, Laheriasarai as to why steps should not be initiated to recommend derecognition of the college for the award of MBBS degree granted by L.N.Mithila University as per provision of Section 19 of the I.M.C. Act,1956 for not submitting the proper compliance on the deficiencies pointed out in the inspection report and further noted that one month time was granted to the institution to respond to the show cause notice.

The Committee further noted that the compliance report received from the Principal, Darbhanga Medical College, Laheriasarai was considered by the Executive Committee at its meeting held on 09.01.2003 wherein it was decided to verify the same by way of an inspection. Accordingly, an inspection to verify the compliance was carried out on 22nd & 23rd December,2003.

The members of the Ad-hoc Committee and of the Executive Committee of the Council considered the inspection report (22nd & 23rd December,2003) and noted that

deficiencies are still persisting as under:-

- 1. Shortage of teaching staff is as under:
 - (a) Faculty 45.3% (i.e. 69 out of 152)
 - (i) Prof. -3 (TB-1, Orth., & Dents.-1
- (ii) Assoc. Prof.: 9 (Anat.-1, Paed.-1, Gen. Sur.-4, Eye-1, ENT-1, Radio.-1)
 - (iii) Asstt.Prof.: 41 (Ant.-4, Bio-Chem.-2, Path.-1, For.Med.-1, Comm.Med.-6(5+1) Gen. Med.-1, Paed.-3, Psy.-1, Gen.Surg.-3, Orth.-2, Eye-3, ENT-2, Obst. & Gynae.-4, Anes.-2, Radio-Diag.-3, Dents.-1, Pharm. Chemist -1, & Lecture in Bio-Phys.-1.)
 - (i) Tutor: 16 (Anat.-2, Phy.-2, Bio-Chem.-3, Pharma.-2, Mico.-1, PSM-3, Radio.-3)
- (b) Sr. Resident 4 (TB & Chest-1, Skin and VD-1, Psy.-1, Surg.-1)
- 1. The following deficiencies are observed in the infrastructure of pre-clinical departments.

Anatomy

- i) The Anatomy Museum needs to be provided with X-ray, CT Scan, MRI for proper display.
- ii) The Lecture theatres have to be provided with OHP and Audio system.
- iii) Thou the department undertakes postgraduate teaching, research facilities are inadequate.

Physiology

- i) The lecture theatres should be provided with audiosystem.
 - ii) There are no student physiographs (required three channel physiograph- 01, single channel physiograph-06)
 - iii) Though the department undertakes postgraduate teaching, research facilities are inadequate.

Biochemistry

- i) Though it is service department yet is not providing any Hospital investigation services.
- ii) The department undertakes postgraduate teaching, research facilities are inadequate.

Pathology

- i) The museum is over-crowded and need to be expanded.
- ii) There is a research laboratory. However, it is not provided with adequate research equipment like inverted microscope trinocular microscope automatic cell counter etc.

Microbiology

- i) Virology, immunology laboratories have to do active work.
- 2. The following deficiencies are observed in the infrastructure of para-clinical departments.

Community Medicine

Health Centres:

- i) No lecturer cum medical officer having M.D. {P.S.M.} is available
- ii) L.M.O. is not available.
- iii) Messing facilities are not available.
- iv) X-ray & ECG are not available.
- v) Staff as prescribed under norms needs to be appointed.

- vi) The residential quarters available in the RTHC have also been occupied by the Police Officials.
- vii) Community based training for students and interns is weak.
- viii) The visits of the faculty of the department of P.S.M are not regular.
- ix) There is no separate vehicle earmarked for visits of the faculty.
- x) Staff as per MCI norms needs to be posted and the primary health centre has to be attached formally with the Medical College, preferably under the administrative and technical control of the Medical College.

<u>U.H.C.</u>:

- i) There is no population attached.
- ii) Duty rosters and records of various activities and investigations are not maintained properly.
- iii) Staff required for urban training health centre as per MCI norms needs to be provided.
- 3. Other deficiencies/remarks in the main report and indicated as under:
 - i) All the Diploma courses being run are un-recognized.
 - ii) The Librarian has qualifications of M.Sc (Maths).
 - iii) No Central Workshop is available.
 - iv) No Gymnasiums facilities are available.
 - v) In CSSD:- there are no separate receiving and distribution points.
 - vi) Distribution of teaching beds in different specialties is not as per Council norms.
 - vii) Bed occupancy was 55%.
 - viii) There is a shortage of nursing staff.
 - ix) The numbers of Indian Journals are 21 and foreign Journals 4, which are less than MCI norms.
 - x) The kitchen is not fully functional and also is not mechanized.
 - xi) Laundry is not mechanized.
 - xii) The number of special radiological investigation was nil.
 - xiii) Blood Bank does not have a valid license.

In view of above, the members of the Ad-hoc Committee and of the Executive Committee of the Council decided to recommend to the Council to withdraw the recognition of MBBS degree granted by L.N.Mithila University in respect of students being trained at Darbhanga Medical College, Laheriasarai u/s 19 of the I.M.C. Act,1956.

The Committee further decided to refer the matter to the Postgraduate Committee regarding the unrecognised postgraduate medical degree/diploma courses being run by the institution.

Accordingly, the Postgraduate Committee considered the said report and taking note of the deficiencies including therein and the decision of the Executive Committee alongwith the members of the Adhoc Committee appointed by the Hon'ble Supreme Court and decided that the college authorities be directed forthwith to stop the admissions to all the postgraduate degree/diploma courses that are currently being run by the said college under intimation to the Registrar of the concerned University and Secretary (Health) of the State of Bihar.

93. <u>Increase of seats in M.D.(General Medicine) course at Al-Ameen Medical College, Bijapur affiliated to Rajiv Gandhi University of Health Sciences, Bangalore u/s</u> 10A of the IMC Act, 1956.

To consider the Council Inspector's report (February, 2004) on the physical and other teaching facilities available at Al-Ameen Medical College, Bijapur for consideration of increase of seats in M.D.(General Medicine) course u/s10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (February,2004) and decided to recommend to Central Govt., to issue Letter of Permission for increase of seats in M.D. (General Medicine) course at Al-Ameen Medical College, Bijapur affiliated to Rajiv Gandhi University of Health Sciences, Bangalore from 1(one) to 4(four) students per year

prospectively u/s 10A of the IMC Act, 1956 till the first batch admitted against the increased number appears for the final examination of the said course.

94. <u>Starting of M.D.(Anaesthesia) course at Deccan College of Medical Sciences, Hyderabad affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act,1956 – Consideration of compliance verification.</u>

Read: the Council Inspector report (April,2002) on the physical and other teaching facilities available at Deccan College of Medical Sciences, Hyderabad for starting of M.D. (Anaesthesia) course u/s 10A of the IMC Act,1956.

The Postgraduate Committee considered the Council Inspector report (April,2002) and decided to recommend to Central Govt., to issue Letter of Permission for starting of M.D. (Anaesthesia) course at Deccan College of Medical Sciences, Hyderabad affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act,1956 to 3(three) students per year till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per provision of Section 11(2) of the IMC Act, 1956.

95. <u>Kempegowda Instt. of Medical Sciences, Bangalore – Continuance of recognition of MBBS degree granted by Rajiv Gandhi University of Health Sciences, Bangalore.</u>

Read: the Council Inspectors report (24th & 25th November,2003) on the standard of examination and other teaching facilities available at Kempegowda Instt. of Medical Sciences, Bangalore for purposes of continuance of recognition of MBBS degree granted by Rajiv Gandhi University of Health Sciences, Bangalore.

-The Postgraduate Committee noted that the Executive Committee and members of the Adhoc Committee considered the Council Inspectors report 24th & 25th November, 2003 pertaining to Kempegowda Instt. of Medical Sciences, Bangalore at its meeting held on 30.12.2003 and observed that there is gross evidence of irregularities in registering the patients in the main register of the hospital. Some of the entries are followed by the blank spaces and not by the entries of the patients. The Dean of the college could not give any explanation. Similar manipulation was also observed in the register of the operation theatre. The Committee also observed gross deficiencies in the clinical material, teaching and non-teaching staff etc.

In view of the gross deficiencies that were observed in the inspection reports, the Adhoc Committee appointed by the Hon'ble Supreme Court and the Executive Committee were clearly of the view that it would be against the interest of innocent students who, if not stopped, will be admitted in these colleges for the academic year 2003-04. Accordingly, it was decided that the State Government be advised not to make admissions in the first year of the MBBS course for the academic year 2003-04 at these three colleges. It was also decided that if the deficiencies are not removed necessary action u/s 19 be considered for recommending to the Central Government for de-recognition.

The Committee also decided to refer the inspection reports to the Postgraduate Committee of the Council for consideration regarding the postgraduate courses.

Accordingly, the Postgraduate Committee considered the said reports and taking note of the deficiencies including therein and the decision of the Executive Committee alongwith the members of the Adhoc Committee appointed by the Hon'ble Supreme Court and decided that the existing facilities at the college required for running various postgraduate degree and diploma courses be evaluated through a suitable inspection forthwith.

96. <u>H.N.B. Garhwal University – Recognition of DCP qualification in respect of students being trained at Himalayan Instt. of Medical Sciences, Dehradun.</u>

Read: the Council Inspector report (5th Jan.,2004)on the standard of examination and other teaching facilities available at Himalayan Instt. of Medical Sciences, Dehradun for purposes of recognition of DCP qualification granted by HNB Garhwal University.

The Postgraduate Committee considered the Council Inspector report (5th Jan.,2004) and decided to recommend that DCP qualification granted by HNB Garhwal University in respect of students being trained at Himalayan Instt. of Medical Sciences, Dehradun be recognised and included in the first schedule to the IMC Act,1956 restricting the number of admissions to 2(two) students per year.

97. <u>Continuance of recognition of qualification granted by College of Physicians and Surgeons, Bombay – letter of the Central Govt., for reconsideration of earlier recommendations of derecognition</u>

Read: the matter with regard to continuance of recognition of qualification granted by College of Physicians and Surgeons, Bombay regarding letter of the Central Govt., for reconsideration of earlier recommendations of derecognition.

The Postgraduate Committee noted the contents in the letter dated 11.10.2003 routed through the Govt. of India from the authorities of College of Physicians & Surgeons, Bombay and decided to reiterate its earlier decision of recommending derecognition of postgraduate qualifications granted by the College of Physicians and Surgeons, Bombay which were duly approved by the General Body of the Council in its meeting held on 23.10.97 and were communicated to the Govt. of India by the Council in its letter dated 16.10.98 to the effect that the recognition given to the postgraduate medical qualifications granted by the College of Physicians and Surgeons, Bombay be withdrawn with effect from 23.10.97.

The Postgraduate Committee also decided to reiterate the decision taken by the PG Committee in its meeting held on 2nd/3rd August,2001 while considering the letter from the Govt. of India dt.29th May,2001 that the recognised medical colleges/institutions where the PG courses permitted/recognised by the Council are being run, be directed to stop the admissions to CPS courses, if any, forthwith.
