Apology for absence was received from Dr. Indrajit Ray, Dr. L.S. Chawla, Dr. V. Kanagaraj & Dr. N.B. Singh and the leave of absence was granted to all the four members by the Committee.

#### 1. Minutes of the last meeting of the Postgraduate Committee – confirmation of.

Minutes of the meeting of the Postgraduate Committee held on 23.9.2004 were confirmed with the following modification/correction in item no.28 & 80 and the same be read as under:-

#### Item No. 28-<u>Increase of seats in M.S.(General Surgery) course at Bharti Vidhyapeeth Medical College, Pune (Deemed University) u/s 10A of the IMC Act, 1956.</u>

"The Postgraduate Committee considered the Council Inspector's report (August, 2004) and decided to recommend to the Central Govt. to issue Letter of Permission for increase of seats in MS (General Surgery) course at Bharti Vidhyapeeth Medical College, Pune (Deemed University) u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2005-2006 restricting the number of admissions from 2(two) to 4(four) students per year till the first batch admitted against the increased number appears for the final examination of the said course."

"The Postgraduate Committee considered the Council Inspector's report (August, 2004) and decided not to recommend to the Central Govt. to issue Letter of Intent for starting of M.D.(Psychiatry) & DPM courses at Sri Ramachandra Instt. of Medical Sciences, Chennai (Deemed University) u/s 10A of the IMC Act,1956 because –

- i) Professor & HOD does not possess requisite recognised PG qualification.
- ii) There is no Assoc. Prof.

- iii) Resultantly teaching complement is incomplete.
- iv) Other deficiencies/observation are in the inspection report."

The Postgraduate Committee noted the work out put report of the requests received u/s 10A of the IMC Act, 1956 for the year 2003 & 2004.

### 4. <u>Increase of seats in M.D.(Microbiology) course at Guntur Medical College, Guntur affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956-Consideration of compliance regarding.</u>

Read: The compliance together with the inspection report (December, 2003) on the physical and other teaching facilities available at Guntur Medical College, Guntur for consideration of increase of seats in M.D.(Microbiology) course.

The Postgraduate Committee considered the compliance together with the inspection report (December, 2003) and noted that i) Promotion of Professor & HOD is not as per MCI norms; ii) Dr. Lalitha is counted as second professor; decided to advise the institution authorities to reorganise the units in terms of teaching faculty as per MCI norms.

The Committee further decided to defer the consideration of the matter till the information is received.

### 5. <u>Starting of M.Ch.(Surgical Gastroenterology) course at Nizam Institute of Medical Sciences, Hyderabad affiliated to Nizam's Institute of Medical Sciences, Hyderabad u/s 10A of the IMC Act, 1956.</u>

Read: The Council Inspector's report (July, 2004) on the physical and other teaching facilities available at Nizam's Institute of Medical Sciences, Hyderabad for consideration of starting of M.Ch.(Surgical Gastroenterology) course.

The Postgraduate Committee considered the Council Inspector's report (July, 2004) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.Ch.(Surgical Gastroenterology) course at Nizam's Institute of Medical Sciences, Hyderabad u/s 10A of the IMC Act, 1956 because of the following:-

- 1. None of the teaching faculty possesses requisite recognized super speciality qualification.
- 2. Prof. & HOD does not possess requisite teaching experience in the super speciality for promotion as Professor.
- 3. Teaching complement is incomplete.
- 4. Other deficiencies/observations as pointed out in the inspection report.

6. Starting of D.M.(Rheumatology) course at Nizam's Institute of Medical Sciences, Hyderabad affiliated to Nizam's Institute of Medical Sciences, Hyderabad (Deemed University) u/s 10A of the IMC Act, 1956 – Consideration of compliance regarding.

Read: The compliance together with the inspection report (October, 2003) on the physical and other teaching facilities available at Nizam's Institute of Medical Sciences, Hyderabad for consideration of starting of D.M.(Rheumatology) course.

The Postgraduate Committee considered the compliance together with the inspection report (October, 2003) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of D.M.(Rheumatology) course at Nizam's Institute of Medical Sciences, Hyderabad affiliated to Nizam's Institute of Medical Sciences, Hyderabad (Deemed University) u/s 10A of the IMC Act, 1956 because –

- 1. Assoc. Prof. & Asstt. Prof. do not possess recognized super-speciality qualification.
- 2. Resultantly teaching complement is incomplete.
- 3. Other deficiencies/observations as pointed out in the inspection report.
- 7. <u>Starting of M.D.(Microbiology) & Diploma in Microbiology courses at Pramukhswami Medical College, Karamsad, Gujarat affiliated to Sardar Patel University u/s 10A of the IMC Act, 1956.</u>

Read: The Council Inspector's report (August, 2004) on the physical and other teaching facilities available at Pramukhswami Medical College, Karamsad, Gujarat affiliated to Sardar Patel University for consideration of starting of M.D.(Microbiology) & Diploma in Microbiology courses.

The Postgraduate Committee considered the Council Inspector's report (August, 2004) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.D.(Microbiology) & Diploma in Microbiology courses at Pramukhswami Medical College, Karamsad, Gujarat affiliated to Sardar Patel University u/s 10 A of the IMC Act, 1956 because –

- 1. HOD is also Dean of the college.
- 2. Addl. staff for teaching complement is not available.
- 3. Promotion of second Professor & Assoc. Professor is not as per MCI norms.
- 4. More than 30% staff is non-medical.
- 5. Other deficiencies/observations as pointed out in the inspection report.
- 8. <u>Starting of D.M.R.D. course at Bharati Vidyapeeth Medical College, Pune affiliated to Bharati Vidyapeeth (Deemed University) u/s 10A of the IMC Act, 1956 compliance verification regarding issuance of LOP.</u>

Read: The compliance verification (September, 2004) together with the compliance and inspection report (October, 2003) on the physical and other teaching facilities available at Bharati Vidyapeeth Medical College, Pune for consideration of starting of D.M.R.D course.

The Postgraduate Committee considered the compliance verification (September, 2004) and noted that the compliance is unsatisfactory & even now MRI & Mammography is in collaboration; decided to recommend to Central Govt. not to issue Letter of Permission for starting of D.M.R.D course at Bharati Vidyapeeth Medical College, Pune u/s 10A of the IMC Act, 1956.

## 9. <u>Starting of M.D.(Dermatology, Venereology and Leprosy) & (D.D.V.L.) courses at J.L.N. Medical College, Swangi, Wardha under Nagpur University u/s 10A of the IMC Act, 1956.</u>

Read: The Council Inspector's report (September, 2004) on the physical and other teaching facilities available at J.L.N. Medical College, Swangi, Wardha under Nagpur University for consideration of starting of M.D. (Dermatology, Venereology and Leprosy) & (D.D.V.L.) courses.

The Postgraduate Committee considered the Council Inspector's report (September, 2004) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of M.D. (Dermatology, Venereology and Leprosy) & (D.D.V.L.) courses at J.L.N. Medical College, Swangi, Wardha affiliated to Nagpur University u/s 10A of the IMC Act, 1956 i.e. from the academic session 2005-2006 restricting the number of admission to 1(one) student per year in each course till the first batch admitted appears in the final examinations of the said courses. The Institution be advised to apply for recognition of the qualifications at the time of first available examinations as per the provisions of Section 11 (2) of the Act, 1956.

#### 10. <u>Starting of M.D.(Anaesthesia) & D.A. courses at Padmashree Dr. D.Y. Patil Medical</u> College, Navi Mumbai (Deemed University) u/s 10A of the IMC Act, 1956.

Read: The Council Inspector's report (August, 2004) on the physical and other teaching facilities available at Padmashree Dr. D.Y. Patil Medical College, Navi Mumbai (Deemed University) for consideration of starting of M.D.(Anaesthesia) & D.A. courses.

The Postgraduate Committee considered the Council Inspector's report (August, 2004) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of M.D.(Anaesthesia) & D.A. courses at Padmashree Dr. D.Y. Patil Medical College, Navi Mumbai (Deemed University) u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2005-2006 restricting the number of admissions to 2 (two) students for degree and 1(one) student for diploma courses per year till the first batch admitted appears in the final examinations of the said courses. The institution be advised to apply for recognition of the qualifications at the time of first available examination as per the provision of Section 11(2) of the Act, 1956.

#### 11 <u>Sardar Patel University – Recognition of M.D.(S.P.M./community Medicine)</u> <u>qualification in respect of students being trained at Pramukhswami Medical</u> <u>College, Karamsad.</u>

Read: The Council Inspector's report (August, 2004) on the standard of examination and other teaching facilities available at Pramukhswami Medical College, Karamsad for purpose of recognition of M.D.(S.P.M./Community Medicine) qualification granted by Sardar Patel University was carried out on behalf of the Council during August, 2004.

The Postgraduate Committee considered the Council Inspector's report (August, 2004) and decided not to recommend recognition of M.D.(S.P.M./Community Medicine) qualification granted by Sardar Patel University in respect of students being trained at Pramukhswami Medical College, Karamsad because –

- 1. Staff is deficient by one Assoc. Prof., one Lecturer-cum-Epidemiologist and one Lady Medical Officer.
- 2. Other deficiencies/observations as pointed out in the inspection report.

### 12. <u>Manipur University- Recogniton of MD (Community Medicine) qualification in respect of students being trained at Regional Institute of Medical Sciences, Imphal granted by Manipur University.</u>

Read: The Council Inspector's report (August, 2004) on the standard of examination and other teaching facilities available at Regional Institute of Medical Sciences, Imphal for purpose of recognition of MD (Community Medicine) qualification in respect of Regional institute of Medical Sciences, Imphal granted by Manipur University.

The Postgraduate Committee considered the Council Inspector's report (August, 2004) and decided to seek clarification from the institution authorities as to why Addl. Professor is shown as HOD?

The Committee further decided to defer the consideration of the matter till the information is received.

### 13 The Tamilnadu Dr. M.G.R. Medical University, Chennai – Approval of P.S.G. Institute of Medical Sciences & Research, Coimbatore for the award of MD (General Medicine) qualification.

Read: The Council Inspector's report (August, 2004) on the standard of examination and other teaching facilities available at P.S.G. Institute of Medical Sciences & Research, Coimbatore for purpose of approval of the college for the award of MD (General Medicine) qualification granted by The Tamilnadu Dr. M.G.R. Medical University, Chennai.

The Postgraduate Committee considered the Council Inspector's report (August, 2004) and decided to recommend that P.S.G. Institute of Medical Sciences & Research, Coimbatore be approved for the award of MD(General Medicine) qualification granted by The Tamilnadu Dr. M.G.R. Medical University, Chennai restricting the number of admissions to 2 (two) students per year.

## 14. <u>Madurai University, Madurai Kamraj University, Madras University and The Tamilnadu Dr. MGR Medical University, Chennai – Approval of Tirunelvelli Medical College, Tirunelvelli for the award of M.D. (Pathology) qualification.</u>

Read: The Council Inspector's report (September, 2004) on the standard of examination and other teaching facilities available at Tirunelvelli Medical College, Tirunelvelli for purpose of approval of the college for the award of M.D. (Pathology) qualification earlier granted by Madurai University, Madurai Kamraj University, Madras and now by The Tamilnadu Dr. M.G.R. Medical University, Chennai.

The Postgraduate Committee considered the Council Inspector's report (September, 2004) and decided not to approve Tirunelvelli Medical College, Tirunelvelli for the award of M.D. (Pathology) qualification because –

- 1. Dean is also shown as Head of the Department.
- 2. There is no other Professor in the Department.
- 3. Other deficiencies/observations as pointed out in the inspection report.

## 15. The Tamilnadu Dr. M.G.R. Medical University, Chennai – recognition of MD (Physiology) qualification in respect of students being trained at P.S.G. Institute of Medical Sciences & Research, Coimbatore.

Read: The Council Inspector's report (August, 2004) on the standard of examination and other teaching facilities available at P.S.G. Institute of Medical Sciences & Research,

Coimbatore for purpose of recognition of MD (Physiology) qualification granted by The Tamilnadu Dr. M.G.R. Medical University, Chennai.

The Postgraduate Committee considered the Council Inspector's report (August, 2004) and decided to recommend that MD (Physiology) qualification granted by The Tamilnadu Dr. M.G.R. Medical University, Chennai in respect of students being trained at P.S.G. Institute of Medical Sciences & Research, Coimbatore be recognized and included in the first schedule to the Indian Medical Council Act, 1956 restricting the number of admission to 1 (one) student per year.

### 16. <u>Madras University and The Tamilnadu Dr. M.G.R. Medical University, Chennai-Recognition of MD(Physiology) qualification in respect of students being trained at Stanley Medical College, Chennai.</u>

Read: The Council Inspector's report (September, 2004) on the standard of examination and other teaching facilities available at Stanley Medical College, Chennai for purpose of recognition of MD (Physiology) qualification earlier granted by Madras University and now by The Tamilnadu Dr. M.G.R. Medical University, Chennai.

The Postgraduate Committee considered the Council Inspector's report (September, 2004) and decided to recommend that MD (Physiology) qualification earlier granted by Madras University and now by The Tamilnadu Dr. M.G.R. Medical University, Chennai in respect of students being trained at Stanley Medical College, Chennai be recognized and included in the first schedule to the Indian Medical Council Act, 1956 restricting the number of admissions to 2 (two) students per year.

#### 17. <u>Annamalai University – Recognition of MD(Physiology) qualification in respect of students being trained at Rajah Muthiah Medical College, Annamalainagar.</u>

Read: The Council Inspector's report (September, 2004) on the standard of examination and other teaching facilities available at Rajah Muthiah Medical College, Annamalainagar for purpose of recognition of MD(Physiology) qualification granted by Annamalai University.

The Postgraduate Committee considered the Council Inspector's report (September, 2004) and decided not to recommend recognition of MD (Physiology) qualification granted by Annamalai University in respect of students being trained at Rajah Muthiah Medical College, Annamalainagar as the non-medical teaching faculty is more than permissible percentage.

#### 18. <u>Rajjiv Gandhi University of Health Sciences, Bangalore – Approval of St. John's Medical College, Bangalore for the award of D.M. (Cardiology) qualification.</u>

Read: The Council Inspector's report (October,2003) along with the compliance on the standard of examination and other teaching facilities available at St.John's Medical College, Bangalore for approval of the college for the award of D.M.(Cardiology) qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Committee considered the Council Inspector's report (October,2003) and noted that the compliance is unsatisfactory; decided to reiterate its earlier decision taken at its meeting held on 4.8.2004 not to approve St. John's Medical College, Bangalore for the award of D.M.(Cardiology) qualification because the deficiencies are still persisting.

The Committee further decided to direct the institution authorities to henceforth stop admissions in D.M (Cardiology) qualification from the ensuing academic session.

## 19. Rajiv Gandhi University of Health Sciences, Bangalore – Approval of M.S. Ramaiah Medical College, Bangalore for the award of D.G.O. qualification in respect of increased intake capacity – compliance regarding.

Read: The Council Inspector's report (May, 2004) along with the compliance on the standard of examination and other teaching facilities available at MS Ramiah Medical College, Bangalore for purpose of approval of the college for the award of DGO qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of increased intake

The Postgraduate Committee considered the Council Inspector's report (May, 2004) along with the compliance and decided to verify the compliance by way of inspection.

#### 20. <u>King George's Medical University, Lucknow (Deemed University) – Continuation of recognition of MD(Obst. & Gynae) & DGO qualifications– Compliance verification regarding.</u>

Read: The compliance verification inspection report (May,2004) togetherwith compliance and Council Inspector's report (May,2003) on the standard of examination and other teaching facilities available at K.G. Medical College, Lucknow for purposes of continuance of recognition of MD(Obst. & Gynae.) & DGO qualifications granted by Lucknow University.

The Postgraduate Committee considered the compliance verification inspection report (May,2004) and decided to recommend that recognition of MD (Obst. & Gynae.) & DGO qualifications granted by Lucknow University in respect of students being trained at K.G. Medical College, Lucknow be continued.

The Committee further decided to direct the institution authorities to prospectively i.e. from the academic session 2005-2006 restrict the number of admissions to 7 (seven) students for degree and 4 (four) students for diploma per year commensurate with available number of postgraduate teachers and the number of teaching units.

### 21. <u>Increase of seats in M.S.(Orthopaedics) & D.Ortho courses at Padamshree Dr. D.Y.Patil Medical College, Pimpri, Pune (Deemed University) u/s 10A of the IMC Act, 1956.</u>

The Postgraduate Committee considered the Council Inspector's report (September, 2004) and decided to recommend to the Central Govt. to issue Letter of Permission for increase of seats in M.S.(Orthopaedics) & D.Ortho courses at Padamshree Dr. D.Y.Patil Medical College, Pimpri, Pune u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2005-2006 restricting the number of admissions from 2 (two) to 3 (three) students per year in each course till the first batch admitted against the increased number appears for the final examination of the said courses.

College, Pimpri, Pune u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2005-2006 restricting the number of admissions from 2 (two) to 3 (three) students per year in each course till the first batch admitted against the increased number appears for the final examination of the said courses.

## 23. <u>Increase of seats in M.D.(Radio-diagnosis) & D.M.R.D. courses at Padamshree Dr. D.Y.Patil Medical College, Pimpri, Pune (Deemed University) u/s 10A of the IMC Act, 1956.</u>

Read: The Council Inspector's report (September, 2004) on the physical and other teaching facilities available at Padamshree Dr. D.Y.Patil Medical College, Pimpri, Pune for consideration of increase of seats in M.D.(Radio-diagnosis) & D.M.R.D. courses.

The Postgraduate Committee considered the Council Inspector's report (September, 2004) and decided to recommend to the Central Govt. to issue Letter of Permission for increase of seats in M.D.(Radio-diagnosis) & D.M.R.D. courses at Padamshree Dr. D.Y.Patil Medical College, Pimpri, Pune u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2005-2006 restricting the number of admissions from 2 (two) to 3 (three) students per year for degree course till the first batch admitted against the increased number appears for the final examination of the said course.

The Committee further decided to recommend to Central Govt. not to issue Letter of Intent for increase of seats in DMRD course at Padamshree Dr. D.Y.Patil Medical College, Pimpri, Pune u/s 10A of the IMC Act, 1956 as there are 5 (five) PG teachers.

#### 24. Rajasthan University – Approval of J.L.N. Medical College, Ajmer for the award of M.D.(Physiology) qualification.

Read: The Council Inspector's report (September, 2004) on the standard of examination and other teaching facilities available at J.L.N. Medical College, Ajmer for purpose of approval of the college for the award of M.D. (Physiology) qualification granted by Rajasthan University was carried out on behalf of the Council during September, 2004.

The Postgraduate Committee considered the Council Inspector's report (September, 2004) and decided not to approve J.L.N. Medical College, Ajmer for the award of M.D. (Physiology) qualification granted by Rajasthan University because –

- 1. Staff is insufficient even for UG.
- 2. Museum is inadequate.
- 3. No separate Clinical Physiology Lab.
- 4. Other deficiencies/observations as pointed out in the inspection report.

The Committee further decided to direct the institution authorities to henceforth stop admissions prospectively in M.D (Physiology) course with immediate effect.

### 25. Letters of Intent/Permission/Disapproval of Scheme issued by Central Govt., Ministry of Health & F.W. for starting /increase of seats of postgraduate courses in various Medical Colleges u/s 10A of the IMC Act, 1956.

Read: The Letters of Intent/Permission/Disapproval of scheme for starting/increase of seats in the postgraduate courses in various Medical colleges issued by Central Govt., Ministry of Health & F.W. u/s 10 A of the IMC Act, 1956.

The Postgraduate Committee noted the Letters of Intent/Permission/Disapproval of scheme for starting/increase of seats in the postgraduate courses in various Medical colleges issued by Central Govt., Ministry of Health & F.W. u/s 10 A of the IMC Act, 1956.

#### 26. Rajasthan University – Approval of S.M.S. Medical College, Jaipur for the award of D.C.H. qualification.

The Postgraduate Committee considered the Council Inspector's report (August, 2004) and decided to advise the institution authorities to re-organise the units in terms of bed strength as per MCI norms.

The Committee further decided to defer the consideration of the matter till the information is received.

## 27. <u>Calcutta University – Approval of Vivekanand Institute of Medical Sciences, Calcutta for the award of M.D. (Paediatrics) & D.C.H. qualifications – Consideration of compliance regarding.</u>

Read: The Council Inspector's report (April, 2003) along with the compliance and compliance verification inspection report on the standard of examination and other teaching facilities available at Vivekanand Institute of Medical Sciences, Calcutta for purpose of approval of the college for the award of M.D. (Paediatrics) & D.C.H. qualifications granted by Calcutta University.

The Postgraduate Committee considered the Council Inspector's report (April, 2003) and noted that all the teachers are observed as full time Honorary teachers and decided to seek clarification as to whether any emoluments in any form are given to the faculty and also the working hours of the teaching faculty?

The Committee further decided to defer the consideration of the matter till the information is received.

# 28. <u>Madurai University, Madurai Kamraj University, Madras University and The Tamilnadu Dr. M.G.R. Medical University, Chennai – Recognition of M.D.(Forensic Medicine) qualification in respect of students being trained at Tirunelveli Medical College, Tirunelveli</u>

Read: The Council Inspector's report (Sept., 2004) on the standard of examination and other teaching facilities available at Tirunelvelli Medical College, Tirunelvelli for purpose of recognition of M.D.(Forensic Medicine) qualification earlier granted by Madurai University, Madurai Kamraj University, Madras University and now by The Tamilnadu Dr. M.G.R. Medical University, Chennai.

The Postgraduate Committee considered the Council Inspector's report (Sept., 2004) and decided not to recommend recognition of M.D.(Forensic Medicine) qualification earlier granted by Madurai University, Madurai Kamraj University, Madras University and now by The Tamilnadu Dr. M.G.R. Medical University, Chennai because –

- 1. All teachers including HOD do not possess requisite recognized postgraduate qualification
- 2. Other deficiencies/observations as pointed out in the inspection report.

The Committee further decided to direct the institution authorities to henceforth stop admissions in M.D.(Forensic Medicine) course from the ensuing academic session i.e. 2005-2006.

### 29. <u>Starting of M.D.(Physiology) course at Pt. Deen Dayal Upadhyay Medical College, Rajkot affiliated to Saurashtra University u/s 10A of the I.M.C. Act, 1956-compliance verification regarding.</u>

Read: The compliance verification report (September, 2004) togetherwith compliance and Council Inspector's report (May,2001) on the physical and other teaching facilities available at Pt. Deen Dayal Upadhyay Medical College, Rajkot for starting of M.D.(Physiology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance verification report (September, 2004) togetherwith compliance and Council Inspector's report (May,2001) and noted that the compliance is unsatisfactory decided to reiterate its earlier decision taken at its meeting held on 12.6.2001 recommending to Central Govt. not to issue Letter of Intent for starting of M.D.(Physiology) course at Pt. Deen Dayal Upadhyay Medical College, Rajkot u/s 10A of the IMC Act, 1956 because –

- i) There is a deficiency of an Assoc. Professor/Reader and Lecturer in the Department to be eligible to start postgraduate course.
- ii) Other deficiencies/observations as pointed out in the inspection report.

The Committee further decided to recommend that in view of the above, the Govt. may consider disapproving the proposal for starting of M.D.(Physiology) course. However, the institution is free to apply afresh after rectification of the deficiencies, in accordance with the Council's Regulations on Postgraduate Medical Education, 2000.

## 30. <u>Starting of MD(Anaesthesia) course at Rajiv Gandhi Medical College, Thane affiliated to University of Mumbai u/s 10A of the IMC Act, 1956– Consideration of compliance regarding.</u>

Read: The compliance along with the Council Inspector's report (April, 2004) on the physical and other teaching facilities available at Rajiv Gandhi Medical College, Thane for consideration of starting of MD(Anaesthesia) course u/s 10A of the I.M.C. Act, 1956.

The Postgraduate Committee considered the compliance along with the Council Inspector's report (April, 2004) and decided to reiterate its earlier decision taken at its meeting held on 22.5.2004 recommending to the Central Government not to issue Letter of Intent for starting of MD (Anaesthesia) course at Rajiv Gandhi Medical College, Thane affiliated to University of Mumbai u/s 10A of the IMC Act,1956 as there is deficiency of teaching staff of two Assistant Professors and one Tutor in the department.

The Committee further decided to recommend that in view of the above, the Govt. may consider disapproving the proposal for starting of MD (Anaesthesia) course. However, the institution is free to apply afresh after rectification of the deficiencies, in accordance with the Council's Regulations on Postgraduate Medical Education, 2000.

## 31. <u>Starting of MD(Preventive & Social Medicine) course at Rajiv Gandhi Medical College, Thane affiliated to University of Mumbai u/s 10A of the IMC Act, 1956—Consideration of compliance regarding.</u>

Read: The compliance along with the Council Inspector's report (April, 2004) on the physical and other teaching facilities available at Rajiv Gandhi Medical College, Thane for consideration of starting of MD (Preventive & Social Medicine) course u/s 10A of the I.M.C. Act, 1956.

The Postgraduate Committee considered the compliance along with the Council Inspector's report (April, 2004) and decided to reiterate its earlier decision taken at its meeting held on 22.5.2004 recommending to the Central Govt. not to issue Letter of Intent for starting of MD (Preventive & Social Medicine) course at Rajiv Gandhi Medical College, Thane affiliated to University of Mumbai u/s 10A of the IMC Act, 1956 because of the following:-

- (i) Promotions of Professor & HOD and Associate Professor are not as per MCI norms.
- (ii) Resultantly there is no postgraduate teacher in the department.
- (iii) Other deficiencies/observations as pointed out in the inspection report.

The Committee further decided to recommend that in view of the above, the Govt. may consider disapproving the proposal for starting of MD (Preventive & Social Medicine) course. However, the institution is free to apply afresh after rectification of the deficiencies, in accordance with the Council's Regulations on Postgraduate Medical Education, 2000.

### 32. <u>Starting of M.D.(Pathology) course at Rajiv Gandhi Medical College, Thane affiliated to University of Mumbai u/s 10A of the IMC Act, 1956– Consideration of compliance regarding.</u>

Read: The compliance along with the Council Inspector's report (May, 2004) on the physical and other teaching facilities available at Rajiv Gandhi Medical College, Thane for consideration of starting of M.D.(Pathology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance along with the Council Inspector's report (May, 2004) and decided to reiterate its earlier decision taken at its meeting held on 30.6.2004 recommending to the Central Government not to issue Letter of Intent for starting of MD (Patology) course at Rajiv Gandhi Medical College, Thane affiliated to University of Mumbai u/s 10A of the IMC Act, 1956 because of the following:-

- (i) There is no regular Dean.
- (ii) Teaching staff is deficient even for UG intake by one Lecturer.
- (iii) Clinical material is inadequate.
- (iv) Investigative facilities are inadequate.
- (v) There is no Autopsy Section.
- (vi) Other deficiencies/observations as pointed out in the inspection report.

The Committee further decided to recommend that in view of the above, the Govt. may consider disapproving the proposal for starting of MD (Pathology) course. However, the institution is free to apply afresh after rectification of the deficiencies, in accordance with the Council's Regulations on Postgraduate Medical Education, 2000.

### 33. <u>Starting of M.D. (Physiology) course at Rajiv Medical College, Thane affiliated to University of Mumbai u/s 10A of the IMC Act, 1956– Consideration of compliance regarding.</u>

Read: The compliance along with the Council Inspector's report (April, 2004) on the physical and other teaching facilities available at Rajiv Medical College, Thane for consideration of starting of M.D.(Physiology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance along with the Council Inspector's report (April, 2004) and decided to reiterate its earlier decision taken at its meeting held on 30.6.2004 recommending to the Central Government not to issue Letter of Intent for starting of MD (Physiology) course at Rajiv Medical College, Thane affiliated to University of Mumbai u/s 10A of the IMC Act,1956 because of the following:-

- (i) There is no regular Dean.
- (ii) Staff is insufficient even for UG intake by one Asstt. Prof.
- (iii) Other than Prof. remaining staff is non-medical which is not as per MCI norms and no teacher has been recognised as PG teacher by the affiliating university.
- (iv) Other deficiencies/observations as pointed out in the inspection report.

The Committee further decided to recommend that in view of the above, the Govt. may consider disapproving the proposal for starting of MD (Physiology) course. However, the institution is free to apply afresh after rectification of the deficiencies, in accordance with the Council's Regulations on Postgraduate Medical Education, 2000.

#### 34. <u>Starting of M.S.(General Surgery) course at Rajiv Gandhi Medical College, Thane affiliated to University of Mumbai u/s 10A of the IMC Act,1956– Consideration of compliance regarding.</u>

Read: The compliance along with the Council Inspector's report (April, 2004) on the physical and other teaching facilities available at Rajiv Gandhi Medical College, Thane for consideration of starting of M.S.(General Surgery) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance along with the Council Inspector's report (April,2004) and decided to reiterate its earlier decision taken at its meeting held on 22.5.2004 recommending to the Central Government not to issue Letter of Intent for starting of M.S.(General Surgery) course at Rajiv Gandhi Medical College, Thane affiliated to Mumbai University u/s 10A of the IMC Act,1956 because of the following:-

- (i) Clinical material is inadequate.
- (ii) Surgical workload is inadequate.
- (iii) Promotion of HOD is not as per MCI norms.
- **(iv)** Teaching complement is incomplete in all three units.
- (v) Other deficiencies/observations as pointed out in the inspection report.

The Committee further decided to recommend that in view of the above, the Govt. may consider disapproving the proposal for starting of MS (General Surgery) course. However, the institution is free to apply afresh after rectification of the deficiencies, in accordance with the Council's Regulations on Postgraduate Medical Education, 2000.

#### 35. <u>Increase of seats in M.D.(General Medicine) course at Padamshree Dr. D.Y.Patil Medical College, Pimpri, Pune (Deemed University).</u>

Read: The Council Inspector's report (Oct., 2004) on the physical and other teaching facilities available at Padamshree Dr. D.Y.Patil Medical College, Pimpri, Pune for consideration of increase of seats in M.D.(General Medicine) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (Oct., 2004) and decided to recommend to the Central Govt. to issue Letter of Permission for increase of seats in MD (General Medicine) course at Padamshree Dr. D.Y. Patil Medical College, Pimpri, Pune (Deemed University) u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2005-2006 restricting the number of admissions from 4(four) to 5(five) students per year against five units fulfilling MCI norms till the first batch admitted against the increased number appears for the final examination of the said course.

#### 36. <u>Increase of seats in M.D.(Pediatrics) & D.C.H. courses at Padamshree Dr. D.Y.Patil</u> Medical College, Pimpri, Pune (Deemed University).

Read: The Council Inspector's report (Oct., 2004) on the physical and other teaching facilities available at Padamshree Dr. D.Y.Patil Medical College, Pimpri, Pune for consideration of increase of seats in M.D.(Pediatrics) & D.C.H. courses u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (October, 2004) and decided to recommend to the Central Govt. not to issue Letter of Intent for increase of seats in M.D. (Pediatrics) & D.C.H. courses at Padamshree Dr. D.Y. Patil Medical College, Pimpri, Pune (Deemed University) u/s 10A of the IMC Act, 1956 because –

- i) Central oxygen and suction is not there in all the Pediatric wards except in Unit III.
- ii) Treatment room in each unit is not provided separately.
- iii) There is no separate new born ward with Level I,2 & 3 care facilities.
- iv) There is no separate Pediatric Intensive Care Unit.
- v) Other deficiencies/observations as pointed out in the inspection report.

#### 37. <u>Starting of M.D.(Psychiatry) course at Dr. S.N.Medical College, Jodhpur, Rajasthan under University of Rajasthan u/s 10A of the IMC Act, 1956.</u>

Read: The Council Inspector's report (Sept., 2004) on the physical and other teaching facilities available at Dr. S.N.Medical College, Jodhpur, Rajasthan under University of Rajasthan for consideration of starting of M.D.(Psychiatry) course.

The Postgraduate Committee considered the Council Inspector's report (September, 2004) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.D (Psychiatry) course at Dr. S.N. Medical College, Jodhpur affiliated with University of Rajasthan u/s 10A of the IMC Act, 1956 because of the following-

- (i) Unit is not as per MCI norms.
- (ii) There is no Associate Professor.
- (iii) Teaching complement is incomplete.
- (iv) Other deficiencies/observations as pointed out in the inspection report.

#### 38. Rajasthan University – Approval of J.L.N. Medical College, Ajmer for the award of M.D.(SPM) qualification.

Read: The Council Inspector's report (Sept./Oct., 2004) on the standard of examination and other teaching facilities available at J.L.N. Medical College, Ajmer for purpose of approval of the college for the award of M.D. (S.P.M.) qualification granted by Rajasthan University u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (Sept/Oct., 2004) and decided not to approve J.L.N. Medical College, Ajmer for the award of M.D.(SPM) qualification granted by Rajasthan University because –

- (i) The department is headed by an Associate Professor.
- (ii) Staff is insufficient for undergraduate teaching.
- (iii) Other deficiencies/observations as pointed out in the inspection report.

The Committee further decided to direct the institution authorities to henceforth stop admissions prospectively in MD (SPM) course from the ensuing academic session.

#### 39. <u>Rajasthan University – Recognition of MD (Microbiology) qualification in respect of students being trained at Dr. S.N. Medical College, Jodhpur.</u>

Read: The Council Inspector's report (September, 2004) on the standard of examination and other teaching facilities available at Dr. S.N. Medical College, Jodhpur for purpose of approval of the college for the award of M.D .(Microbiology) qualification granted by Rajasthan University.

The Postgraduate Committee considered the Council Inspector's report (September, 2004) and decided not to recommend recognition of MD (Microbiology) qualification granted by Rajasthan University in respect of students being trained at Dr. S.N. Medical College, Jodhpur because –

- i) Additional staff for PG in terms of one Associate Professor is deficient.
- ii) Other deficiencies/observations as pointed out in the inspection report.

## 40. <u>Starting of M.D.(Psychiatry) & DPM courses at J.S.S. Medical College, Mysore affiliated to Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act, 1956.</u>

Read: The Council Inspector's report (Sept., 2003) on the physical and other teaching facilities available at J.S.S. Medical College, Mysore affiliated to Rajiv Gandhi University of Health Sciences, Bangalore for consideration of starting of MD(Psychiatry) & DPM courses u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (September, 2003) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of M.D.(Psychiatry) & DPM courses at J.S.S. Medical College, Mysore affiliated to Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act, 1956 prospectively

i.e. from the academic session 2005-2006 restricting the number of admission to 1(one) student per year in each course till the first batch admitted appears in the final examination of the said courses. The institution be advised to apply for recognition of the qualifications at the time of first available examinations as per the provision of Section 11(2) of the Act, 1956.

### 41. <u>Starting of MS (Ophthalmology) course at Rajiv Medical College, Thane affiliated to University of Mumbai u/s 10A of the IMC Act, 1956– Consideration of compliance regarding.</u>

Read: The compliance along with the Council Inspector's report (April, 2004) on the physical and other teaching facilities available at Rajiv Medical College, Thane for consideration of starting of MS(Ophthalmology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance alongwith the Council Inspector's report (April, 2004) and decided to reiterate its earlier decision taken at its meeting held on 22.5.2004 recommending to the Central Govt. not to issue Letter of Intent for starting of MS (Ophthalmology) course at Rajiv Medical College, Thane affiliated to University of Mumbai u/s 10A of the IMC Act, 1956 because of the following –

The Committee further decided to recommend that in view of the above, the Govt. may consider disapproving the proposal for starting of MS (Ophthalmology) course. However, the institution is free to apply afresh after rectification of the deficiencies, in accordance with the Council's Regulations on Postgraduate Medical Education, 2000.

# 42. <u>Starting of M.D. (Radio-Therapy) & D.M.R.T. courses at Govt. Arignar Anna Memorial Cancer Research Institute & Hospital, Karapettai, Kancheepuram affiliated to The Tamilnadu Dr.MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 – consideration of compliance regarding.</u>

Read: The compliance along with the Council Inspector's report (June, 2002) on the physical and other teaching facilities available at Govt. Arignar Anna Memorial Cancer Research Institute & Hospital, Karapettai, Kancheepuram for starting of M.D.(Radio-Therapy) & D.M.R.T. courses u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance along with the Council Inspector's report (June, 2002) and decided to verify the compliance by way of an inspection.

Read: The Central Govt. letter dated 10<sup>th</sup> September, 2004 with regard to postponement of inspections for starting of various postgraduate courses at Santosh Medical College, Ghaziabad u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Central Govt. letter dated 10<sup>th</sup> September, 2004 and decided that the matter may be processed in terms of suitable inspections for further consideration.

#### 44. <u>Starting of M.D.(Psychiatry) & DPM courses at Sri Ramachandra Instt. of Medical Sciences, Chennai (Deemed University) u/s 10A of the IMC Act, 1956.</u>

Read: The matter with regard to starting of M.D. (Psychiatry) and DPM courses at Sri Ramachandra Medical College & Research Institute (Deemed University) u/s 10 A of the IMC Act 1956.

The Postgraduate Committee considered the matter with regard to starting of M.D. (Psychiatry) and DPM courses at Sri Ramachandra Medical College & Research Institute (Deemed University) u/s 10 A of the IMC Act 1956 and decided to recommend to the Central Govt. to issue Letter of Permission for starting of M.D.(Psychiatry) & DPM courses at Sri Ramachandra Instt. of Medical Sciences, Chennai (Deemed University) u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2005-2006 restricting the number of admission to 1(one) student per year in each course till the first batch admitted appears in the final examination of the said courses. Read: The Council Inspector's report (Oct., 2004) on the physical and other teaching facilities available at Maulana Azad Medical College, New Delhi granted by Delhi University for consideration of starting of D.M.(Neonatology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (October, 2004) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of DM (Neonatology) course at Maulana Azad Medical College, New Delhi affiliated to Delhi University u/s 10A of the IMC Act, 1956 because of the following –

- (i) Prof. & HOD and the IInd Asstt. Prof. do not possess requisite recognised superspeciality qualification.
- (ii) Teaching complement is incomplete.
- (iii) There is no Associate Professor.
- (iv) Other deficiencies/observations as pointed out in the inspection report.

## 46. Starting of M.Ch.(Cardio Vascular & Thoracic Surgery) course at Bangalore Medical College, Bangalore affiliated to Rajiv Gandhi University of Health Sciences, Karnataka u/s 10A of the IMC Act, 1956-consideration of compliance regarding.

Read: The compliance along with the Council's inspector report(June,2004) on the physical and other teaching facilities available at Bangalore Medical College, Bangalore affiliated to Rajiv Gandhi University of Health Sciences, Karnataka for starting of M.Ch.(Cardio Vascular & Thoracic Surgery) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance along with the Council's inspector report (June, 2004) and decided to recommend to the Central Government not to issue Letter of Intent for starting of M.Ch. (Cardio Vascular & Thoracic Surgery) course at Bangalore Medical College, Bangalore affiliated to Rajiv Gandhi University of Health Sciences, Karnataka u/s 10A of the IMC Act, 1956 because of the following —

- (i) There is no Associate Professor in the department.
- (ii) One of the Lecturer is deputed for M.Ch.; the second Lecturer does not possess requisite super-speciality qualification; therefore teaching complement is incomplete.
- (iii) Bed strength is not as per MCI norms.
- (iv) There is no facility for Cardiac Surgery & Cardiology.
- (v) Other deficiencies/observations as pointed out in the inspection report.

### 47. <u>Starting of M.D.(General Medicine) at Dr. Panjabrao Alias Bhausaheb Deshmukh Memorial Medical College, Amravati affiliated to Amravati University u/s 10A of the IMC Act, 1956-consideration of compliance regarding.</u>

Read: The compliance along with the Council Inspector's report (May, 2004) on the physical and other teaching facilities available at Dr. Panjabrao Alias Bhausaheb Deshmukh Memorial Medical College, Amravati affiliated to Amravati University for consideration of starting of M.D. (General Medicine) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance alongwith the Council Inspector's report (May, 2004) and noted that the compliance is unsatisfactory; decided to reiterate its earlier decision taken at its meeting held on 4.8.2004 recommending to the Central Govt. not to issue Letter of Intent for starting of M.D. (General Medicine) course at Dr. Panjabrao Alias Bhausaheb Deshmukh Memorial Medical College, Amravati u/s 10A of the IMC Act, 1956 because the following deficiencies are still persisting: -

- (i) Central Oxygen/Nitrous/Suctions are not available in OTs and surgical ICU, ICCU, NICU & PICU.
- (ii) No ventilator is available in the casualty department.
- (iii) Auto-analyzer in Biochemistry laboratory is not available.
- (iv) Facility for medical ICU (MICU) is not available.
- (v) College has only 330 beds of their own, remaining beds are from the District Civil Hospital.
- (vi) Other deficiencies/observations as pointed out in the inspection report.

The Committee further decided to recommend that in view of the above, the Govt. may consider disapproving the proposal for starting of MD (General Medicine) course. However, the institution is free to apply afresh after rectification of the deficiencies, in accordance with the Council's Regulations on Postgraduate Medical Education, 2000.

### 48. <u>Starting of DM(Nephrology) course at T.N. Medical College, Mumbai affiliated to Mumbai University u/s 10A of the IMC Act, 1956- consideration of compliance regarding.</u>

Read: The compliance along with the Council Inspector's report (May,2004) on the physical and other teaching facilities available at T.N. Medical College, Mumbai affiliated to Mumbai University for consideration of starting of DM(Nephrology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance alongwith the Council Inspector's report (May, 2004) and decided to verify the compliance by way of an inspection.

#### 49. <u>Non teaching hospital-Recognition of Central Railway Hospital Varanasi, for Housemanship.</u>

Read: The Council Inspector's report (Oct., 2004) on the physical and other teaching facilities available at Central Railway Hospital Varanasi, for purposes of recognition of the hospital for Housemanship.

The Postgraduate Committee considered the Council Inspector's report (October, 2004) and decided to recommend that Central Railway Hospital, Varanasi be recognised for housemanship in the following subjects with the number of house posts mentioned against each:-

- 1. General Medicine -2(two)
- 2. General Surgery -1(one)
- 3. Paediatrics -1(one)

### 51. <u>Starting of M.S.(General Surgery) course at Padmashree Dr. D.Y. Patil Medical College, Navi Mumbai (Deemed University) u/s 10A of the IMC Act, 1956-consideration of compliance regarding.</u>

Read: The compliance along with the Council Inspector's report (August, 2004) on the physical and other teaching facilities available at Padamashree Dr. D.Y. Patil Medical College, Navi Mumbai (Deemed University) for consideration of starting of M.S.(General Surgery) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance alongwith the Council Inspector's report (August, 2004) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of M.S.(General Surgery) course at Padamashree Dr. D.Y. Patil Medical College, Navi Mumbai (Deemed University) u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2005-2006 restricting the number of admissions to 4(four) students per year against four units till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examinations as per the provision of Section 11(2) of the Act, 1956.

## 52. <u>Starting of M.D.(General Medicine) course at Padamshree Dr. D.Y.Patil Medical College, Navi Mumbai (Deemed University) u/s 10A of the IMC Act, 1956-consideration of compliance regarding.</u>

Read: The compliance along with the Council Inspector's report (August, 2004) on the physical and other teaching facilities available at Padamshree Dr. D.Y.Patil Medical College, Navi Mumbai (Deemed University) for consideration of starting of M.D.(General Medicine) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance alongwith the Council Inspector's report (August, 2004) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of M.D.(General Medicine) course at Padamashree Dr. D.Y. Patil Medical College, Navi Mumbai (Deemed University) u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2005-2006 restricting the number of admissions to 4(four) students per year against four units till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examinations as per the provision of Section 11(2) of the Act, 1956.

#### 53. <u>Starting of D.M.(Child & Adolescent Psychiatry) course at NIMHANS, Bangalore u/s 10A of the IMC Act, 1956- consideration of compliance regarding.</u>

Read: The compliance along with the Council Inspector's report (July, 2004) on the physical and other teaching facilities available at NIMHANS for consideration of starting of D.M.(Child & Adolescent Psychiatry) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance along with the Council's inspector report (July,2004) and decided to recommend to the Central Government not to issue Letter of Intent for starting of D.M. (Child & Adolescent Psychiatry) course at NIMHANS, Bangalore u/s 10A of the IMC Act, 1956 because of the following –

- (i) Compliance states it to be a separate unit headed by Dr. Shobha Srinath who is Professor of Psychiatry.
- (ii) There is no teaching faculty with super-speciality qualification.
- (iii) Other deficiencies/observations as pointed out in the inspection report.

#### 54. <u>Increase of seats in M.S.(General Surgery) course at Bharati Vidyapeeth Medical College, Pune u/s 10A of the I.M.C. Act, 1956.</u>

Read: The Council Inspector's report (Oct., 2004) on the physical and other teaching facilities available at Bharati Vidyapeeth Medical College, Pune for consideration of increase of seats in M.S.(General Surgery) course u/s 10A of the IMC Act, 1956 alongwith the letter dated 29.10.2004 from the college authorities.

The Postgraduate Committee considered the Council Inspector's report (October, 2004) alongwith the letter dated 29.10.2004 from the college authorities and decided to recommend to the Central Govt. to issue Letter of Permission for increase of seats in MS (General Surgery) course at Bharti Vidhyapeeth Medical College, Pune (Deemed University) u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2005-2006 restricting the number of admissions from 2(two) to 5(five) students per year against five units which are as per MCI norms till the first batch admitted against the increased number appears for the final examination of the said course.

## 55. Starting of M.Ch. (Cardio Thoracic & Vascular Surgery) at J.N. Medical College, Belgaum affiliated to Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act, 1956-consideration of compliance regarding.

Read: The compliance along with the Council Inspector's report (May, 2004) on the physical and other teaching facilities available at J.N. Medical College, Belgaum for consideration of starting of M.Ch. (Cardio Thoracic & Vascular Surgery) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance alongwith the Council Inspector's report (May, 2004) and decided to reiterate its earlier decision taken at its meeting held on 30.6.2004 recommending to the Central Govt. not to issue Letter of Intent for starting of M.Ch. (Cardio Thoracic & Vascular Surgery) course at J.N. Medical College, Belgaum affiliated to Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act,1956 because of the following:-

- (i) There are 131 beds against Unit I which is not as per MCI norms.
- (ii) Prof. & HOD does not possess requisite recognised postgraduate qualification.
- (iii) Clinical material is inadequate.
- (iv) 2<sup>nd</sup> Prof. also does not possess requisite postgraduate qualification in the speciality.
- (v) Other deficiencies/observations as pointed out in the inspection report.

The Committee further decided to recommend that in view of the above, the Govt. may consider disapproving the proposal for starting of MCh. (Cardio Thoracic & Vascular Surgery) course. However, the institution is free to apply afresh after rectification of the deficiencies, in accordance with the Council's Regulations on Postgraduate Medical Education, 2000.

## 56. <u>Starting of M.Ch.(Paediatric Surgery) course at Deccan College of Medical Sciences, Hyderabad affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956.</u>

Read: The Council Inspector's report (September, 2004) on the physical and other teaching facilities available at Deccan College of Medical Sciences, Hyderabad affiliated to N.T.R. University of Health Sciences, Vijayawada for consideration of starting of M.Ch.(Paediatric Surgery) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council's inspector report (September,2004) and decided to recommend to the Central Government not to issue Letter of Intent for starting of M.Ch.(Paediatric Surgery) course at Deccan College of Medical Sciences, Hyderabad affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 because of the following –

- (i) No separate section for treating surgical neonates.
- (ii) There are no books in the departmental library.
- (iii) Clinical material is inadequate and quality clinic material.

(iv) Other deficiencies/observations as pointed out in the inspection report.

#### 57. Recognition of Indian Medical Courses in UK – Regarding.

Read: The report of the meeting of the Sub-Committee held on 13.7.2004 as constituted by the P.G. Committee at its meeting held on 22.5.2004 regarding the recognition of the Indian Medical Courses in UK.

The Postgraduate Committee approved the report of the Sub-Committee with regard to recognition of the Indian Medical Courses in UK.

## 58. Rajiv Gandhi University of Health Sciences, Bangalore – Approval of St. John's Medical College, Bangalore for the award of M.D.(General Medicine) qualification in respect of increased intake capacity.

Read: The Council Inspector's report (Oct., 2004) on the standard of examination and other teaching facilities available at St. John's Medical College, Bangalore for purpose of approval of the college for the award of M.D.(General Medicine) qualification in respect of increased intake granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Committee considered the Council Inspector's report (Oct.2004) and decided to recommend that St. John's Medical College, Bangalore be approved for the award of MD (General Medicine) qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore restricting the number of admissions to 5(five) students per year.

#### 59. Restoration of admissions in the I<sup>st</sup> MBBS course for the academic session 2004-05 in the Medical Colleges in Karnataka.

Read: The matter with regard to regularization of admissions in the Ist M.B.B.S. course for the academic session 2004-05 in the Medical Colleges in Karnataka.

The Postgraduate Committee considered the matter and decided that the inspections be caused for restoration of admissions to PG courses in respect of the following medical colleges:-

- 1. M.R. Medical College, Gulbarga
- 2. Adichunchanagiri Instt. of Medical Sciences, Bellur.
- 3. Kempegowda Institute of Medical Sciences, Bangalore

### 60. Recognition of postgraduate medical qualifications granted by Delhi University in respect of various medical colleges (non-teaching hospitals) – consideration of request u/s 11(2) of the IMC Act,1956.

Read: The matter with regard to recognition of postgraduate medical qualifications granted by Delhi University in respect of various medical colleges (non-teaching hospitals) – consideration of request u/s 11(2) of the IMC Act,1956.

The Postgraduate Committee considered the matter and decided to constitute a Sub-Committee with the following members for making appropriate recommendations taking into consideration the various aspects of the issue in a time bound manner:-

- 3. Dr. Ved Prakash Mishra, Chairman as Special Invitee

## 61. Starting of MD (Dermatology, Venereology & Leprosy) course at Shri B.M. Patil Medical College, Bijapur affiliated to Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act,1956 – Consideration of compliance regarding.

Read: The Council Inspector's report (October, 2004) on the physical and other teaching facilities available at Shri B.M. Patil Medical College, Bijapur affiliated to Rajiv Gandhi

University of Health Sciences, Bangalore for consideration of starting of M. D (Dermatology, Venereology & Leprosy) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (October, 2004) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of M. D (Dermatology, Venereology & Leprosy) course at Shri B.M. Patil Medical College, Bijapur affiliated to Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2005-2006 restricting the number of admission to 1(one) student per year till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examinations as per the provision of Section 11(2) of the Act, 1956.

#### 62. <u>Admissions made in various PG courses in violation of the MCI norms in various Medical Colleges in the country-Reg.</u>

Read: the matter with regard to admissions made in various PG courses in violation of the MCI norms in various Medical Colleges in the country.

The Postgraduate Committee considered the matter and decided to issue show cause notice to the all concerned taking into consideration the following:

- (a) Admissions made against sanctioned intake.
- (b) Admissions beyond prescribed cut out date.
- (c) Transgressing the prescribed quota.

It also decided that all such cases be dealt in the aforesaid manner.

## 63. <u>Starting of M.D. (Forensic Medicine) & D.F.M. courses at Padmashree Dr.D.Y.</u> <u>Patil Medical College, Pimpiri Pune (Deemed University) u/s 10A of the IMC Act,</u> <u>1956.</u>

Read: Council Inspector's report (October, 2004) on the physical and other teaching facilities available at Padmashree Dr. D.Y. Patil Medical College, Pimpri, Pune (Deemed University) for consideration of starting of M.D.(Forensic Medicine) & D.F.M. courses u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council's inspector report (October,2004) and decided to recommend to the Central Government not to issue Letter of Intent for starting of M.D.(Forensic Medicine) & D.F.M. courses at Padmashree Dr. D.Y. Patil Medical College, Pimpri, Pune (Deemed University) u/s 10A of the IMC Act, 1956 because of the following –

- (i) Teaching faculty is deficient by two Associate Professors & 3 Lecturers.
- (ii) Staff is insufficient even for undergraduate intake at the college.
- (iii) Other deficiencies/observations as pointed out in the inspection report.
