Apologies for absence were received from Dr. A. Rajasekaran and Dr. (Mrs.) Usha Sharma.

1. Minutes of the last meeting of the Postgraduate Committee – confirmation of.

The Chairman informed the members that a letter was received from Dr. A. Rajasekaran seeking his observations on the minutes of the meeting held on 23.11.2005 of the PG Committee to be incorporated. He also informed that the said letter has been replied by the Secretary of the Council mainly stating that the minutes were a record of discussion taking place in the meeting and none of the observations now put forth by Dr. A. The Postgraduate Committee noted the work output report of the requests received u/s 10A of the IMC Act, 1956 for the year 2004 and 2005.

4. Starting of MD(Microbiology) course at Katihar Medical College, Katihar under B.N. Mandal University, Madhepura, Bihar u/s 10A of the IMC Act, 1956.

Read : The Council Inspector's report (Oct., 2005) on the physical and other teaching facilities available at Katihar Medical College, Katihar under B.N. Mandal University, Madhepura for consideration of starting of MD(Microbiology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (Oct.,2005) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of MD(Microbiology) course at Katihar Medical College, Katihar under B.N. Mandal University, Madhepura, Bihar u/s 10A of the IMC Act, 1956 prospectively i.e.

from the academic session 2006-2007 restricting the number of admission to 2 (two) students per year till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

The Committee further decided to draw the attention of the college authorities to the observations made by the Council Inspector in the inspection report.

5. Starting of MD(Community Medicine) course at Katihar Medical College, Katihar under B.N. Mandal University, Madhepura, Bihar u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (Oct., 2005) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of MD(Community Medicine) course at Katihar Medical College, Katihar under B.N. Mandal University, Madhepura u/s 10A of the IMC Act, 1956 because of the following:-

1. Prof. & HOD and other 3 Professors do not possess recognized postgraduate qualifications.
2. Resultantly teaching complement is incomplete.
3. Other deficiencies as pointed out in the inspection report.

6. Starting of MD(Physiology) course at Narayna Medical College, Nellore under NTR University of Health Sciences, Vijaywada u/s 10A of the IMC Act, 1956.

Read : The Council Inspector's report (Dec., 2005) on the physical and other teaching facilities available at Narayna Medical College, Nellore under NTR University of Health Sciences, Vijaywada for consideration of starting of MD(Physiology) course u/s 10A of the IMC Act, 1956 u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (Dec., 2005) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of MD(Physiology) course at Narayna Medical College, Nellore under N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2006-2007 restricting the number of admission to 3 (three) students per year till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

7. Starting of M.S.(General Surgery) course at Mata Gujri Medical College, Kishanganj under B.N. Mandal University, Bihar u/s 10A of the IMC Act, 1956.

(General Surgery) course at Mata Gujri Medical College, Kishanganj under B.N. Mandal University, Madhepura u/s 10A of the IMC Act, 1956 because of the following:-

1. Promotions of Professor & HOD and Associate Professor in Unit-I are not as per MCI norms.
2. Professor of Unit-III is Gastroenterologist.
3. Resultantly teaching complement is incomplete in Unit-I and Unit-III.
4. Postgraduate Hostels are under construction.
5. Surgical work load is inadequate.
6. Clinical material is inadequate.
7. Investigation facilities are inadequate.
8. Other deficiencies as pointed out in the inspection report.

8. Starting of M.D(Paediatrics) & DCH courses at Mata Gujri Medical College, Kishanganj under B.N. Mandal University, Bihar u/s 10A of the IMC Act, 1956.

Read : The Council Inspector's report (November, 2005) on the physical and other teaching facilities available at Mata Gujri Medical College, Kishanganj under B.N. Mandal University, Bihar for consideration of starting of M.D(Paediatrics) & DCH courses u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (Nov., 2005) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.D. (Paediatrics) and DCH courses at Mata Gujri Medical College, Kishanganj under B.N. Mandal University, Madhepura u/s 10A of the IMC Act, 1956 because of the following:-

1. Professor & HOD & Incharge of Unit-II do not possess recognized postgraduate qualifications.
2. There is no Associate Professor in Unit-I and Lecturer in Unit-II.
3. Resultantly teaching complement is incomplete in both the Units.
4. Postgraduate hostels are under construction.
5. Other deficiencies as pointed out in the inspection report.

9. Starting of M.S.(Ophthalmology) & D.O. courses at Mata Gujri Medical College, Kishanganj under B.N. Mandal University, Bihar u/s 10A of the IMC Act, 1956.

Read : The Council Inspector's report (Nov., 2005) on the physical and other teaching facilities available at Mata Gujri Medical College, Kishanganj under B.N. Mandal University, Bihar for consideration of starting of M.S(Ophthalmology) & D.O. courses u/s 10A of the IMC Act, 1956..

The Postgraduate Committee considered the Council Inspector's report (Nov., 2005) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.S. (Ophthalmology) & D.O. courses at Mata Gujri Medical College, Kishanganj under B.N. Mandal University, Madhepura u/s 10A of the IMC Act, 1956 because of the following:-

1. Equipments available in the department are inadequate.
2. There are no Special clinics in the department.
3. Teaching staff is sufficient for one Unit only.
4. Clinical material is inadequate.
5. Other deficiencies as pointed out in the inspection report.

10. Starting of M.D(Pathology) course at Mata Gujri Medical College, Kishanganj under B.N. Mandal University, Bihar u/s 10A of the IMC Act, 1956.

Read : The Council Inspector's report (November, 2005) on the physical and other teaching facilities available at Mata Gujri Medical College, Kishanganj under B.N. Mandal University, Bihar for consideration of starting of M.D(Pathology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (Nov., 2005) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.D. (Pathology) course at Mata Gujri Medical College, Kishanganj under B.N. Mandal University, Madhepura u/s 10A of the IMC Act, 1956 because of the following:-

1. Clinical material is inadequate.
2. Blood Bank license is not updated.
3. Improper records.
4. Specimens available in the museum are inadequate.
5. Departmental library has no journals.
6. Other deficiencies as pointed out in the inspection report.

11. Starting of D.Ortho. course at Mata Gujri Medical College, Kishanganj under B.N. Mandal University, Bihar u/s 10A of the IMC Act, 1956.

Read : The Council Inspector's report (November, 2005) on the physical and other teaching facilities available at Mata Gujri Medical College, Kishanganj under B.N. Mandal University, Bihar for consideration of starting of D. Ortho. course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (Nov., 2005) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of D.Ortho. course at Mata Gujri Medical College, Kishanganj under B.N. Mandal University, Madhepura u/s 10A of the IMC Act, 1956 because of the following:-

1. Professor and Principal of the college is one and the same person and possessing unrecognized postgraduate qualification.
2. Clinical material is inadequate.
3. Number of operations performed are inadequate.
4. There is no operation theatre for Joint replacement and Spinal surgery.
5. Arthroscopic operations are not done in the department.
6. Special clinic in OPD is not present.
7. Department of Physical Medicine & Rehabilitation is inadequate.
8. CT Scan & MRI facilities are not available.
9. Ultrasonography for orthopaedic patients is not done in the department.
10. There is no research lab.
11. Recent books and Orthopaedic related journals (Indexed) are insufficient in the departmental library.
12. Other deficiencies as pointed out in the inspection report.

12. Starting of M.D(Obst. & Gynae.) & DGO courses at Mata Gujri Medical College, Kishanganj under B.N. Mandal University, Bihar u/s 10A of the IMC Act, 1956.

Read : The Council Inspector's report (November, 2005) on the physical and other teaching facilities available at Mata Gujri Medical College, Kishanganj under B.N. Mandal University, Bihar for consideration of starting of M.D(Obst. & Gynae.) & D.G.O. courses u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (Nov., 2005) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.D. (Obst. & Gynae.) & DGO courses at Mata Gujri Medical College, Kishanganj under B.N. Mandal University, Madhepura u/s 10A of the IMC Act, 1956 because of the following:-

1. Professor & HOD does not possess recognized postgraduate qualification.
2. Clinical material is inadequate.
3. Surgical workload is inadequate.
4. Library facilities are inadequate.
5. Blood bank is not having updated license.
6. Other deficiencies as pointed out in the inspection report.

13. Starting of M.D(Biochemistry) course at Mata Gujri Medical College, Kishanganj under B.N. Mandal University, Bihar u/s 10A of the IMC Act, 1956.

Read : The Council Inspector's report (November, 2005) on the physical and other teaching facilities available at Mata Gujri Medical College, Kishanganj under B.N. Mandal University, Bihar for consideration of starting of M.D(Biochemistry) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (Nov., 2005) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.D. (Biochemistry) course at Mata Gujri Medical College, Kishanganj under B.N. Mandal University, Madhepura u/s 10A of the IMC Act, 1956 because of the following:-

1. Clinical material is inadequate in terms of investigative workload.
2. Facilities are not available for Immunology diagnosis and Molecular Biology.
3. Other deficiencies as pointed out in the inspection report.

14. Starting of M.D(Microbiology) course at Mata Gujri Medical College, Kishanganj under B.N. Mandal University, Bihar u/s 10A of the IMC Act, 1956.

Read : The Council Inspector's report (November, 2005) on the physical and other teaching facilities available at Mata Gujri Medical College, Kishanganj under B.N. Mandal University, Bihar for consideration of starting of M.D(Microbiology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (Nov., 2005) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.D. (Microbiology) course at Mata Gujri Medical College, Kishanganj under B.N. Mandal University, Madhepura u/s 10A of the IMC Act, 1956 because of the following:-

1. Instrumentation is inadequate.
2. Museum needs upgradation.
3. Anaerobic bacteriology and Virology areas need upgradation.
4. Research laboratory requires additional equipments.
5. Other deficiencies as pointed out in the inspection report.

15. Starting of M.D(General Medicine) course at Mata Gujri Medical College, Kishanganj under B.N. Mandal University, Bihar u/s 10A of the IMC Act, 1956.

Read : The Council Inspector's report (Dec., 2005) on the physical and other teaching facilities available at Mata Gujri Medical College, Kishanganj under B.N. Mandal University, Bihar for consideration of starting of M.D.(General Medicine) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (Dec., 2005) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.D. (General Medicine) course at Mata Gujri Medical College, Kishanganj under B.N. Mandal University, Madhepura u/s 10A of the IMC Act, 1956 because of the following:-

1. Clinical material is inadequate.
2. Teaching complement is incomplete in Units I & III as there is no Associate Professor, Lecturer respectively.
3. Instrumentation is inadequate.
4. Other deficiencies as pointed out in the inspection report.

16. **Starting of M.D.(Dermatology, Venereology & Leprosy) course at Mata Gujri Medical College, Kishanganj under B.N. Mandal University, Bihar u/s 10A of the IMC Act, 1956.**

Read : The Council Inspector's report (Nov., 2005) on the physical and other teaching facilities available at Mata Gujri Medical College, Kishanganj under B.N. Mandal University, Bihar for consideration of starting of M.D.(Dermatology, Venereology & Leprosy) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (Nov., 2005) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.D. (Dermatology, Venereology & Leprosy) course at Mata Gujri Medical College, Kishanganj under B.N. Mandal University, Madhepura u/s 10A of the IMC Act, 1956 because of the following:-

1. Unit is deficient in term of bed strength as the Unit has only 20 beds which is not as per MCI norms.
2. Space for departmental library and departmental office is inadequate.
3. Clinical material is inadequate.
4. Library facilities are inadequate in terms of national and international journals.
5. Other deficiencies as pointed out in the inspection report.

17. **Starting of M.D(Anaesthesiology) & D.A. courses at Mata Gujri Medical College, Kishanganj under B.N. Mandal University, Bihar u/s 10A of the IMC Act, 1956.**

Read : The Council Inspector's report (Nov., 2005) on the physical and other teaching facilities available at Mata Gujri Medical College, Kishanganj under B.N. Mandal University, Bihar for consideration of starting of M.D(Anaesthesiology) & D.A. courses u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (Nov., 2005) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.D. (Anaesthesiology) & DA courses at Mata Gujri Medical College, Kishanganj under B.N. Mandal University, Madhepura u/s 10A of the IMC Act, 1956 because of the following:-

1. Instrumentation is inadequate.
2. Professor & HOD does not possess recognized postgraduate qualification.
3. Other deficiencies as pointed out in the inspection report.

18. **Starting of D.M.(Cardiology) course at R.N.T. Medical College, Udaipur affiliated Rajasthan University u/s 10A of the IMC Act, 1956- Consideration of compliance regarding.**

Read : The compliance verification report (Dec.,2005) together with compliance and the Council Inspector's report (March, 2005) on the physical and other teaching facilities available at R.N.T. Medical College, Udaipur for consideration of starting of D.M.(Cardiology) course u/s 10A of the IMC Act, 1956 u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance verification report (Dec.,2005), compliance and Council Inspector's report (March,2005) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of D.M. (Cardiology) course at R.N.T.Medical College, Udaipur under Rajasthan University u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2006-2007 restricting the number of admission to 1 (One) student per year till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the IMC Act,1956.

19. Increase of seats in M.Ch(Urology) course at Armed Forces Medical College, Pune under Pune University u/s 10A of the IMC Act, 1956.

Read : The compliance together with the Council Inspector's report (May, 2005) on the physical and other teaching facilities available at Armed Forces Medical College, Pune under Pune University for consideration of increase of seats in M.Ch(Urology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance together with the Council Inspector's report (May, 2005) and decided to reiterate its earlier decision taken at its meeting held on 07.06.2005 recommending to the Central Govt. not to issue Letter of Intent for increase of seats in M.Ch(Urology) course at Armed Forces Medical College, Pune under Pune University u/s 10A of the IMC Act, 1956 because the following deficiencies are still persisting:-

1. The department is still not being headed by a Professor.
2. Resultantly teaching complement is incomplete.
3. Clinical material is inadequate.
4. Other deficiencies as pointed out in the inspection report.

20. Increase of seats in MD(Obst. & Gynae.) course at Yenepoya Medical College, Mangalore under Rajiv Gandhi University of Health Sciences, Karnataka u/s 10A of the IMC Act, 1956.

Read : The Council Inspector's report (Dec., 2005) on the physical and other teaching facilities available at Yenepoya Medical College, Mangalore under Rajiv Gandhi University of Health Sciences, Karnataka for consideration of increase of seats in MD(Obst. & Gynae.) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (Dec.,2005) and decided to recommend to the Central Govt. to issue Letter of Permission for increase of seats in M.D. (Obst. & Gynae.) course at Yenepoya Medical College, Mangalore under Rajiv Gandhi University of Health Sciences, Karnataka u/s 10A of the I.M.C. Act,1956 prospectively i.e. from the academic session 2006-2007 from 2 (two) to 4 (four) students per year till the first batch admitted against the increased number appears in the final examination of the said course.

21. Starting of MD(Obst. & Gynae.) & D.G.O. courses at Academy of Medical Sciences, Pariyaram, Kannur, Kannur University u/s 10A of the IMC Act, 1956.

Read : The compliance verification report (Nov., 2005) together with the compliance and Council Inspectors report (April, 2004) on the physical and other teaching facilities available at Academy of Medical Sciences, Pariyaram for consideration of starting of M.D. (OBG) & DGO courses u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance verification inspection report (Nov.,2005) together with the compliance and Council Inspectors report (April, 2004) and noted that the compliance is unsatisfactory; decided to reiterate its earlier decision taken at its meeting held on 23.12.2004 recommending to the Central Govt. not to issue Letter of Intent for starting of M.D. (Obst. & Gynae.) & D.G.O. courses at Academy of Medical Sciences, Pariyaram, Kannur affiliated to Kannur University u/s 10A of the IMC Act, 1956 as the following deficiencies are still persisting:-

1. Clinical material is inadequate.
2. Library facilities are inadequate.
3. Teaching complement is incomplete in Unit-I.
4. Other deficiencies/observations as pointed out in the inspection report.

22. Starting of MD (Obst. & Gynae.) & D.G.O course at M.G.M. Medical College, Navi Mumbai affiliated to University of Mumbai u/s 10A of the IMC Act, 1956 – consideration of compliance verification reg.

Read : The compliance verification report (April, 2005) together with compliance and Council Inspectors report (April, 2004) in light of the Central Govt.'s letter dated 28.10.2005 for consideration of starting of MD (Obst. & Gynae.) & D.G.O courses affiliated to Mumbai University u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance verification inspection report (April, 2005) together with compliance and Council Inspector's report (April, 2004) in light of GOI letter dated 28.10.2005 and noted that the clinical material is adequate, the extent of which is as under:

- (a) Average daily deliveries (i) normal 2 to 3 per day (ii) Caesarian 0.5 -1 per day.
- (b) Average daily bed occupancy 82%.
- (c) Average daily OPD 65 per day.
- (d) Average daily IPD 7 to 8 per day.
- (e) Average daily operations 7 to 10 per day.

The Postgraduate Committee also observed that the academic years 2004-05 and 2005-06, in cases of _____ college, considering the following clinical material, it was decided to recommend grant of Letter of Permission for 2(two) seats each in MD and DGO courses. Similarly, in case of _____ college, it was decided to recommend grant of Letter of Permission for 2(two) seats in MD & DGO courses.

It was further decided that GOI may be informed that as per the policy guidelines, inspectors are not required to make any recommendations. As such, the aforesaid decision of the Committee is in conformity with its earlier decisions in respect of clinical material and number of seats recommended for the similar courses for other applicant institutions.

In view of above, the Committee decided to reiterate earlier decision of the Postgraduate Committee taken at its meeting held on 07.06.2005 recommending to the Central Govt. to issue Letter of Permission for starting of M.D.(Obst. & Gynae.) & D.G.O. courses at M.G.M. Medical College, Navi Mumbai affiliated to University of Mumbai u/s 10A of the I.M.C. Act, 1956 prospectively i.e. from the academic session 2006-2007 restricting the number of admission to 2 (two) students for each course per year till the first batch admitted appears for the final examinations of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the I.M.C. Act, 1956.

23. Starting of M.D.(Physical Medicine & Rehabilitation) course at Regional Institute of Medical Sciences, Imphal, Manipur affiliated to Manipur University u/s 10A of the IMC Act, 1956.

Read : The Council Inspector's report (November, 2005) on the physical and other teaching facilities available at Regional Institute of Medical Sciences, Imphal, Manipur for consideration of starting of M.D.(Physical Medicine & Rehabilitation) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (Nov., 2005) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of M.D.(Physical Medicine & Rehabilitation) course at Regional Institute of Medical Sciences, Imphal under Manipur University u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2006-2007 restricting the number of admission to 1 (one) student per year till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

24. Starting of DLO course at Deccan College of Medical Sciences, Hyderabad under NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956.

Read : The Council Inspector's report (April, 2005) together with the compliance on the physical and other teaching facilities available at Deccan College of Medical Sciences, Hyderabad under NTR University of Health Sciences, Vijayawada for consideration of starting of DLO course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (April, 2005) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of D.L.O. course at Deccan College of Medical Sciences, Hyderabad under N.T.R. Kanagaraj (in consultation of experts opinion) for inclusion of DM/PDCC programme in Cardia Anaesthesia at LPS Instt. of Cardiology.

The Postgraduate Committee considered the letter dated 5/9/2005 received from Dr. J.L. Sahni, Professor Director, LPS Instt. of Cardiology, GSVM Medical College, Kanpur together with the detailed observations of Dr. V. Kanagaraj (experts opinion) for

inclusion of DM/PDCC programme in Cardiac Anaesthesia at LPS Instt. of Cardiology which reads as under:-

“Anaesthesia for cardiac surgery requires that the anesthesiologist possess much of the knowledge, conventionally within the domain of the cardiologist and cardiac surgeon.

The cardiac anesthetist must make clinical decisions based on a sound understanding of the cardiovascular pathophysiology present in each patient. This requires familiarity with invasive and non-invasive diagnostic techniques as well as with the proposed surgical procedure. The scope of the sub-speciality of cardiac anaesthesia has become so broad as to prevent its complete coverage in one chapter.

Further, the opinion of the experts in the field of cardiac anaesthesia is as under:-

Anaesthesia for cardiac surgery which involves pre-operative evaluation, monitoring anesthetic technique, cardiovascular pulmonary by-pass and early post-operative I.C.U. Management. Simply speaking it is anesthetic technical sub-speciality pertaining to cardiac surgery. It is like a neuro-anaesthesia, paediatric anaesthesia, ortho/ENT/OBG/GE etc.

But for the careful anesthetic technique and management with monitors there is nothing more in cardiac anaesthesia, Cardiac complications, by-pass managements, pulmonary complications, cardio-pulmonary resuscitations, arrhythmias correction and I.C.U. management, are all the same as to be challenged by an anesthetist with MD Degree.

Moreover all the cardiac cases will be diagnosed, treated and referred to cardiac surgery by the cardiologist.

The role of anesthetist is the anesthetic management of the peri-operative period only (i.e. pre-operative, intra-operative and post-operative management in I.C.U). Even in the post-operative period cardiologist also will look after the case and taken over the follow-up.

The role of anesthetist is in the O.T and I.C.U only. All the anesthetist with MD degree is sufficient, provided they are familiar with cardiac centers for doing cases.

So the cardiac anaesthesia is a sub-speciality with a careful technique of anaesthesia and MD degree is sufficient. But PDCC, course (Post Doctor certificate course) can be recommended in cardiac anaesthesia, which involves teaching and training of the clinical anesthetic technique and short refresher course in cardiology. The DM in cardiac anaesthesia is not necessary.

Conclusion

Cardiac anaesthesia being a sub-speciality of anaesthesia with technical advances, MD (Anaes) with PDCC course is sufficient and DM course is not necessary.

Therefore inclusion of PDCC course is enough, DM is not necessary in cardiac anaesthesia.”

The Committee therefore decided not to agree for inclusion of DM (Cardiac Anaesthesia) in the Postgraduate Regulations, 2000 and further decided for inclusion of PDCC (postgraduate diploma in Cardiac Anaesthesia commencement) course in the said Regulations, 2000.

1. Clinical material is inadequate.
2. There is no central suction & oxygen line in ICU.
3. Workload in ICU is inadequate.
4. Other deficiencies/observations as pointed out in the inspection report.

The Postgraduate Committee considered the compliance verification report (Dec., 2005) together with the compliance and Council Inspectors report (April, 2004) and decided to reiterate its earlier decision taken at its meeting held on 23.12.2004 recommending to the Central Govt. not to issue Letter of Intent for starting of M.D.(Obst. & Gyane.) course at Annasaheb Chavdaman Patil Memorial Medical College, Dhule u/s 10A of the IMC Act,1956 as the compliance is unsatisfactory because :

1. The bed occupancy is less than 45% on the day of inspection.
 2. The department is running Oncology clinic but there is no colpose.
 3. There is no USG in the department.
 4. There is no Cryo machine in the department.
 5. Clinical material is inadequate.
 6. There is no OPD number or IPD number in labour room register which shows that only list is kept to show the statistics.
 7. In the indoor register of gynaecology, patients like ectopic pregnancy, ovarian cyst and fibroid uterus were admitted and discharged without doing any intervention. This also shows that patients were admitted to increase the number.
 8. On verification of register of gynaec OPD, there was average of 6 to 10 patients per day.
 9. Special services like Artificial insemination, Recanalisation of fallopian tubes, Pep smear examination etc. are not available.
 10. In the indoor register of Gynaecology, patients like ectopic, pregnancy, ovarian cyst and fibroid uterous were admitted and discharged without doing any intervention. This also shows that patients were admitted to increase the number.

The Postgraduate Committee considered the compliance verification report (Feb., 2006) together with the compliance and Council Inspector's report (March, 2005) and decided to reiterate its earlier decision taken at its meeting held on 7.6.2005 recommending to the Central Government not to issue Letter of Intent for starting of M.D. (OBG) course at Santosh Medical College, Ghaziabad under Ch. Charan Singh University u/s 10A of the IMC Act, 1956 because the following deficiencies are still persisting:-

- i) Clinical material is inadequate.
- ii) Surgical workload is inadequate.
- iii) Number of deliveries is very less.
- iv) Library facilities are inadequate.
- v) There was discrepancy in the number of deliveries shown in the records submitted in the report and actual number of deliveries taking place in the hospital. There are 6-8 deliveries taking place per month in the hospital.
- vi) The discrepancy was also noted in the number of major & minor surgeries shown in the records and verified on inspection.
- vii) System of unitwise distribution/diplay of beds was not followed.

- (iii) Only two teachers in Unit-II
- (iv) Resultantly, teaching complement is incomplete in both the units.
- (v) Clinical Material is inadequate.
- (vi) Departmental Library needs augmentation.
- (vii) Number of Journals are inadequate.
- (iv) Other deficiencies pointed out in the inspection report.

134. Starting of MD(Pharmacology) course at Katihar Medical College, Katihar under B.N. Mandal University, Madhepura, Bihar u/s 10A of the IMC Act, 1956.

Read: The Council Inspector report (Dec., 2005) on the physical and other teaching facilities available at Katihar Medical College, Katihar under B.N. Mandal University, Madhepura for consideration of starting of MD (Pharmacology) course.

The Postgraduate Committee considered the Council Inspectors report (Dec., 2005) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of MD (Pharmacology) course at Katihar Medical College, Katihar under B.N. Mandal University, Madhepura u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2006-2007 restricting the number of admissions to 3 (three) students per year till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the Act, 1956.

135. Starting of MD(Biochemistry) course at SVS Medical College, Mahboobnagar under NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956.

Read: The Council Inspector report (February, 2006) on the physical and other teaching facilities available at SVS Medical College, Mahboobnagar under NTR University of Health Sciences, Vijayawada for consideration of starting of M.D.(Biochemistry) course.

The Postgraduate Committee considered the Council Inspectors report (February, 2006) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of MD (Biochemistry) course at SVS Medical College, Mehboobnagar under NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2006-2007 restricting the number of admissions to 3 (three) students per year till the first batch admitted appears in the final examination of the said course. The Postgraduate Committee considered the Council Inspector's report (January, 2006) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of MD (Radio-Diag.) & DMRD courses at Narayana Medical College, Nellore under NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2006-2007 restricting the number of admissions to 2 (two) students each for MD (Radio-Diagn.) and DMRD course per year till the first batch admitted appears in the final examination of the said courses. Read: The Council Inspector report (Dec., 2005) on the physical and other teaching facilities available at C.U. Shah Medical College, Surendranagar under Saurashtra University for consideration of starting of M.D.(Radiodiagnosis) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (December, 2005) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of MD(Radio-Diagn.) qualification at C.U. Shah Medical College, Surendranagar under Saurashtra University u/s 10A of the IMC Act, 1956 because of the following:-

1. Instrumentation is inadequate as there is no MRI.
2. Other deficiencies/observations as pointed out in the inspection report.

138. Starting of M.S. (Orthopaedics) course at Dr. D.Y. Patil Medical College, Kolhapur under the Institute (Deemed University) u/s 10A of the IMC Act, 1956.

Read: The Council Inspector report (Feb., 2006) on the physical and other teaching facilities available at Dr. D.Y. Patil Medical College, Kolhapur under the Institute (Deemed University) for consideration of starting of M.S.(Orthopaedics) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (Feb., 2006) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of MS (Orthopaedics) qualification at Dr. D.Y. Patil Medical College, Kolhapur under the Institute (Deemed University) u/s 10A of the IMC Act, 1956 because of the following:-

1. Majority of the patients were those who did not require admission and should have been treated on OPD basis.
2. The spectrum of Orthopaedic diseases seemed to be limited.
3. None of the museum specimens exhibited, were concerning Orthopaedic Surgery.
4. More than 50% of the books in the departmental library were not on the subject of Orthopaedics.
5. On an average only 3 to 4 fracture cases were being attended to per day.
6. Reference books like Chapman's Orthopaedics were not in the central library.
7. Journal of Bone & Joint Surgery was available for the last one year only, no back issues were available.
8. Number of dissected specimens of upper & lower extremities were not of good quality.

The Postgraduate Committee considered the compliance verification report (Feb., 2006) together with the compliance and Council Inspector's report (July, 2003) and decided to recommend to the Central Govt. to issue Letter of Permission for increase of seats in MD (Pathology) course at Regional Institute of Medical Sciences, Imphal under Manipur University u/s 10A of the IMC Act,1956 prospectively i.e. from the academic session 2006-2007 from 2 (two) to 6 (six) students per year till the first batch admitted against increased of seats appears in the final examination of the said course.

140. Starting of MD(Community Medicine) course at Narayana Medical College, Nellore under NTR University of Health Sciences, Vijaywada u/s 10A of the IMC Act, 1956.

Read: The Council Inspector report (Feb., 2006) on the physical and other teaching facilities available at Narayana Medical College, Nellore under NTR University of Health Sciences, Vijaywada for consideration of starting of MD(Community Medicine) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspectors report (February, 2006) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of MD (Community Medicine) course at Naryana Medical College, Nellore under NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act,1956 prospectively i.e. from the academic session 2006-2007 restricting the number of admissions to 3 (three) students per year till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the Act, 1956.

141. Starting of various Postgraduate courses at Dr. Bhausaheb Deshmukh Memorial Medical College, Amravati - Permission of Central Govt. regarding.

Read: The matter regarding starting of various Postgraduate courses at Dr. Bhausaheb Deshmukh Memorial Medical College, Amravati.

The Postgraduate Committee considered the matter in the light of the decision of the Executive Committee taken at its meeting held on 12.11.2005 deciding to initiate action u/s 19 of the Indian Medical Council Act,1956 for withdrawal of recognition of Dr. Panjabrao Alias Bhausaheb Deshmukh Memorial Medical College, Amravati for the

award of MBBS degree granted by Amravati University and, therefore, decided not to entertain the applications received u/s. 10A of the IMC Act, 1956 for starting of following courses at the said college:-

- (i) MD (General Medicine)
- (ii) MS (Orthopaedics)
- (iii) MD (Obst. & Gynae.)

The Postgraduate Committee further decided to return the applications to the Central Government.

142. Increase of seats in M.D.(Obst. & Gynae.) course at Gandhi Medical College, Hyderabad affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956.

Read: The Council Inspector report (Feb., 2006) on the physical and other teaching facilities available at Gandhi Medical College, Hyderabad under N.T.R. University of Health Sciences, Vijayawada for consideration of increase of seats in M.D.(Obst. & Gynae.) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspectors report (Feb., 2006) and decided to recommend to the Central Govt. to issue Letter of Permission for increase of seats in MD (Obst. & Gynae.) course at Gandhi Medical College, Hyderabad under N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2006-2007 from 5 (five) to 10 (ten) students per year till the first batch admitted against increased intake appears in the final examination of the said course.

The Committee further decided to reduce the number of admissions from 10 (ten) to 5(five) for DGO qualification prospectively in conformity with the Regulations on Postgraduate Medical Education, 2000.

143. Rajiv Gandhi University of Health Sciences, Bangalore – Approval of Sree Siddhartha Medical College, Tumkur for the award of M.D.(Microbiology) qualification .

Read: The compliance verification report (February, 2006) together with the compliance and Council Inspector's report (December, 2002) of standard of examination and other teaching facilities available at Sree Siddhartha Medical College, Tumkur for purpose of approval of the college for the award of M.D.(Microbiology) qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Committee considered the compliance verification report (February, 2006) together with the compliance and Council Inspector's report (December, 2002) of standard of examination and decided to recommend that Sree Siddhartha Medical College, Tumkur be approved for the award of MD (Microbiology) qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore restricting the number of admission to 1 (one) student per year.

144. Ranchi University – Recognition of D.L.O. qualification in respect of students being trained at Rajendra Instt. of Medical Sciences, Ranchi.

Read: The compliance verification report (February, 2006) together with the compliance and Council Inspector's report (Jan., 2000) on the standard of examination & other teaching facilities available at Rajendra Medical College, Ranchi for purpose of recognition of D.L.O. qualification granted by Ranchi University.

The Postgraduate Committee considered the compliance verification report (February, 2006) together with the compliance and Council Inspector's report (Jan., 2000) on the standard of examination and decided to advise the institution authorities to re-organise the units in terms of bed strength and teaching faculty as per MCI norms as the present units are not as per MCI norms not under:-

- (i) There are two units having 22 beds each.
- (ii) Unit I does not have Assoc. Prof.
- (iii) Consequentially, teaching faculty complement is incomplete.

The Committee further decided to defer the consideration of the matter till the compliance is received from the institution authorities.

- (ii) to recommend to Central Government to issue Letter of Permission for increase of seats in MD (Anaesthesia.) qualification at Rajah Muthiah Medical College, Annamalai Nagar under Annamalai University u/s 10A of the IMC Act,1956 prospectively i.e. from the academic session 2006-2007 from 6 (six) to 7 (seven) students per year till the first batch admitted against the increased number appears in the final examination of the said course.

At this point, Dr. Ved Prakash Mishra disassociated from the consideration of the next item.

169 Starting of MD (Radio-Diagn.) & DMRD courses at JLN Medical College, Swangi, Wardha, under Nagpur University u/s 10A of the IMC Act, 1956.

Read: The compliance verification report (Feb. 2006) together with compliance and the Council Inspector's report (October, 2003) on the physical and other teaching facilities available at JLN Medical College, Swangi, Wardha, under Nagpur University for consideration of starting of MD (Radio-Diagn.) & DMRD courses u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance verification report (Feb. 2006) together with compliance and the Council Inspector's report (October, 2003) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of MD (Radio-Diagn.) & DMRD courses at JLN Medical College, Swangi, Wardha, under

Nagpur University u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2006-2007 restricting the number of admissions to 2 (two) students each for MD (Radio-Diagn.) & DMRD course per year till the first batch admitted appears in the final examination of the said courses. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the Act, 1956.

Read: The compliance verification report (Jan. 2006) together with compliance and the Council Inspector's report (April, 2005) on the physical and other teaching facilities available at Deccan College of Medical Sciences, Hyderabad under NTR University of Health Sciences, Vijaywada for consideration of starting of DPH courses u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance verification report (Jan. 2006) together with compliance and the Council Inspector's report (April, 2005) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of DPH course at Deccan College of Medical Sciences, Hyderabad under NTR University of Health Sciences, Vijaywada because of the following:-

1. The teaching staff is insufficient by 1- Reader and 6 Lecturers.
2. Urban Health Training Center is functioning in two premises located 100 meters apart. The functioning can be improved by bringing them under one roof.
3. Other deficiencies/remarks in the report.

171. **Starting of DMRD course at Deccan College of Medical Sciences, Hyderabad under NTR University of Health Sciences, Vijaywada u/s 10A of the IMC Act, 1956.**

Read: The compliance verification report (Feb. 2006) together with compliance and the Council Inspector's report (April, 2005) on the physical and other teaching facilities available at Deccan College of Medical Sciences, Hyderabad under NTR University of Health Sciences, Vijaywada for consideration of starting of DMRD courses u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance verification report (Feb. 2006) together with compliance and the Council Inspector's report (April, 2005) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of DMRD course at Deccan College of Medical Sciences, Hyderabad under NTR University of Health Sciences, Vijaywada because of the following:-

1. Instrumentation is inadequate as there are no MRI facilities.
2. Other deficiencies/remarks in the report.

172. **Starting of MD (Psychiatry) course at Command Hospital, Kolkatta under West Bengal University of Health Sciences, Kolkatta u/s 10A of the IMC Act, 1956.**

Read: The Council Inspector report (Feb., 2006) on the physical and other teaching facilities available at Command Hospital, Kolkatta for consideration of starting of M.D.(Psychiatry) course.

The Postgraduate Committee considered the Council Inspectors report (Feb., 2006) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of MD (Psychiatry) course at Command Hospital, Kolkatta u/s 10A of the IMC Act, 1956 because of the following:-

1. The facilities required for basic sciences as per Regulation 8(1)(a) of Postgraduate Medical Education Regulations, 2000 are not available and there is no MoU with a medical college.
2. Bed strength is not as per MCI norms.
3. There is no Lecturer in the department.
4. Resultantly, teaching complement is incomplete.
5. There is no clinical Psychologist.
6. Books & journals are inadequate.
7. Other deficiencies/remarks in the report.
