#### 1. <u>Minutes of the last meeting of the Postgraduate Committee – confirmation of.</u>

The Postgraduate Committee noted the contents of the letter dated 5<sup>th</sup> January, 2008 of Prof. A. Rajasekaran.

The Postgraduate Committee confirmed the minutes of the last meeting of the Postgraduate Committee held on 16.12.2007 with the following corrections/modifications:-

#### Item No. 20: Starting of M.D.(Biochemistry) course at Santosh Medical College, Ghaziabad under Santosh University u/s 10A of the I.M.C. Act,1956.

At point No.2 of the decision of the PG Committee, it was recorded as under:-

2. Teaching faculty is deficient by 2 Asstt. Prof. for total requirement of undergraduate & postgraduate teaching & training.

The decision of the PG Committee at point No.2 be read corrected as follows:-

2. Dr. Reema Sharma, Associate Professor; Dr. Pradeep Kumar, Associate Professor and Dr. Preeti Sharma, Assistant Professor do not possess M.Sc.(Medical Biochemistry) and Ph.D.(Medical Biochemistry) qualifications. Dr. D.K. Srivastava has been appointed as Dean, hence, cannot be considered as teacher in the department. Resultantly, teaching faculty is deficient by 2 Assistant Professors for total requirement of undergraduate & postgraduate teaching & training.

#### <u>Item No. 105.</u> <u>Recognition of various PG courses under Madras University in respect of JIPMER Pondicherry.</u>

The decision of the PG Committee be read corrected as follows:

"The Postgraduate Committee considered the request dated 01.11.2007 received from the Director, JIPMER, Pondicherry and noted that the institute was started in 1956 and was affiliated to Madras University until 1986. The affiliation was changed to Pondicherry University from the year 1986 all the MBBS seats have been affiliated to Pondicherry University and PG degree & diploma and Post Doctoral course in different disciplines of Medical Sciences from the year 2004.

The Committee further noted that earlier the qualifications were granted by Madras University and included in the Schedule & decided to include the said qualifications under Pondicherry University in the governing schedule as recognized postgraduate qualifications."

#### 2. <u>Minutes of the last meeting of the Postgraduate Committee – action taken thereon.</u>

The Postgraduate Committee approved the action taken on the minutes of the meeting of the Postgraduate Committee held on 16.12.2007.

### 3. <u>Starting of DM(Pulmonary & Critical Care Medicine) course at Govt. Medical College, Thiruvananthapuram under Kerala University u/s 10A of the IMC Act, 1956.</u>

Read: The Council Inspector's report (December, 2007) on the physical and other teaching facilities available at Govt. Medical College, Thiruvananthapuram for starting of DM(Pulmonary & Critical Care Medicine) course at Govt. Medical College, Thiruvananthapuram u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (December, 2007) and decided to form a Sub-Committee comprising of Dr. D.G. Mhaisekar & Dr. Rani Bhaskaran, to deliberate upon the matter and to submit its report, at the earliest.

### 4. <u>Starting of MD(Pulmonary Medicine) course at Lala Ram Sarup Instt. of TB & Respiratory Diseases, New Delhi under Guru Gobind Singh Indraprastha University u/s 10A of the IMC Act, 1956.</u>

Read: The Council Inspector's report (November, 2007) on the physical and other teaching facilities available at LRS Institute of TB & Respiratory Diseases, New Delhi for starting of M.D.(Pulmonary Medicine) course at Lala Ram Sarup Institute of TB & Respiratory Diseases, New Delhi u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (November, 2007) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting MD (Pulmonary Medicine) course at Lala Ram Sarup Institute of TB & Respiratory Diseases, New Delhi under Guru Gobind Singh Indraprastha University u/s 10A of the IMC Act, 1956, because of the following:-

- 1. There are 520 beds in 5 Units which is not as per MCI norms.
- 2. None of the specialists shown as teachers possess teaching experience required as per Regulations for the respective posts.
- 3. Dr. Sanjay Singh in Unit I, Dr. Rakesh Agarwal in Unit II & Dr. D. Behera in Unit IV do not possess prescribed academic qualifications.
- 4. Teaching faculty complement is inadequate in all the Units.
- 5. The institute is admitting DNB students also which is not as per the Council norms.
- 6. Other deficiencies as pointed out in the inspection report.

### 5. <u>Starting of M.D. (Radio-Diag.) & DMRD course at Mahatma Gandhi Medical College & Research Instt. Pondicherry under Pondicherry University u/s 10A of the IMC Act, 1956.</u>

Read: The compliance verification report (January, 2007) on the physical and other teaching facilities available at Mahatma Gandhi Medical College & Research Instt., Pondicherry under Pondicherry University for consideration of starting of M.D.(Radio-Diag.) & DMRD courses u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance verification inspection report (January, 2007) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of MD(Radio-Diag.) & DMRD courses at Mahatma Gandhi Medical College & Research Instt. Pondicherry under Pondicherry University u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2008-2009 restricting the number of admission to 2 (two) students for degree and 1(one) student for diploma course per year till the first batch admitted appears in the final examination of the said courses. The institution be advised to apply for recognition of the qualifications at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

#### 6. <u>Starting of MD(Anaesthesia) course at Command Hospital (WC), Chandimandir, Haryana affiliated to Kurukshetra University u/s 10A of the IMC Act,1956.</u>

Read: The compliance verification report (November, 2007) on the physical and other teaching facilities available at Command Hospital (WC), Chandimandir, Haryana for consideration of starting of MD(Anaesthesia) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (November, 2007) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of MD (Anaesthesia) course at Command Hospital (WC), Chandimandir, Haryana under Kurukshetra University u/s 10A of the IMC Act, 1956, because of the following:-

- 1. Brig. V.P. Singh, Professor & HOD, Lt.Col. Nitin Sharma, Asstt. Prof. & Lt.Col. Sanil Mohan, Asstt. Prof. are on leave and could not be verified.
- 2. Promotion of Dr. C.S.Ahluwalia, Assoc. Prof. is not as per Regulations as he possesses experience of only 2 years 9 months as Asstt. Prof. in a recognized medical institution against the requirement of 5 years as per Regulations.
- 3. Resultantly, teaching faculty is deficient by 1 Professor, 2 Assoc. Professors and 3 Sr. Residents.
- 4. Other deficiencies as pointed out in the inspection report.

#### 7. <u>Starting of MD(General Medicine) course at Govt. Medical College, Chandigarh under Panjab University u/s 10A of the IMC Act, 1956.</u>

Read: The Council Inspector's report (December, 2007) on the physical and other teaching facilities available at Govt. Medical College, Chandigarh for starting of M.D.(General Medicine) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (December, 2007) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting MD (General Medicine) course at Govt. Medical College, Chandigarh under Panjab University u/s 10A of the IMC Act, 1956, because of the following:-

- 1. There are only 2 teachers in Unit II & III.
- 2. Promotions of Dr. Atul Sachdeva, Dr. Ram Singh & Dr. S.S. Lehl are not as per Regulations as they do not possess experience of 5 years as Asstt. Professor required as per Regulations for promotion to the post of Assoc. Professor.
- 3. Resultantly, teaching faculty component is inadequate.
- 4. Other deficiencies as pointed out in the inspection report.

#### 8. <u>Starting of MD(Pharmacology) course at Mahatma Gandhi Medical College & Research Institute under Pondicherry University u/s 10A of the IMC Act, 1956.</u>

Read: The Council Inspector's report (December, 2007) on the physical and other teaching facilities available at Mahatma Gandhi Medical College and Research Institute,

Pondicherry under Pondicherry University for consideration of starting of MD(Pharmacology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (December, 2007) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of MD(Pharmacology) course at Mahatma Gandhi Medical College & Research Instt. Pondicherry under Pondicherry University u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2008-2009 restricting the number of admissions to 3 (three) students per year till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

#### 9. <u>Starting of MS(ENT) course at Govt. Medical College, Chandigarh under Panjab University u/s 10A of the IMC Act, 1956.</u>

Read: The Council Inspector's report (December, 2007) on the physical and other teaching facilities available at Govt. Medical College, Chandigarh under Panjab University for starting of M.S.(ENT) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (December, 2007) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of M.S.(ENT) course at Govt. Medical College, Chandigarh under Panjab University u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2008-2009 restricting the number of admission to 1(one) student per year till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

#### 10. <u>Starting of MD(Pathology) course at Mahatma Gandhi Medical College & Research Institute under Pondicherry University u/s 10A of the IMC Act, 1956.</u>

Read: The Council Inspector's report (December, 2007) on the physical and other teaching facilities available at Mahatma Gandhi Medical College & Research Institute, Pondicherry under Pondicherry University for consideration of starting of MD(Pathology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (December, 2007) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of MD(Pathology) course at Mahatma Gandhi Medical College & Research Institute, Pondicherry under Pondicherry University u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2008-2009 restricting the number of admissions to 3 (three) students per year till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

### 11. <u>Starting of M.D.(Radio-Diagnosis) course at Amrita School of Medicine, Kochi under Amrita Vishwa Vidya Peetham (Deemed University) u/s 10A of the IMC Act, 1956.</u>

Read: The Council Inspector's report (December, 2007) on the physical and other teaching facilities available at Amrita School of Medicine, Kochi, Kerala under Amrita Vishwa Vidya Peetham (Deemed University) for starting of M.D.(Radio-Diagnosis) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (December, 2007) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting MD (Radio-Diagnosis) course at Amrita School of Medicine, Kochi, Kerala under Amrita Vishwa Vidya Peetham (Deemed University) u/s 10A of the IMC Act, 1956, because of the following:-

- 1. Dr. M.D. Bhansali, Prof. & Head and Dr. P. K. Nazar, Assoc. Prof. do not possess recognized postgraduate qualification.
- 2. Promotion of Dr.Rajesh Kanan, Assoc. Prof. is not as per Regulations as he possesses experience of only 4 years 11 months as Assistant Professor.
- 3. Resultantly, teaching faculty complement is inadequate.

4. Other deficiencies as pointed out in the inspection report.

### 12. <u>Starting of M.D.(Obst. & Gynae.) course at Amrita School of Medicine, Kochi under Amrita Vishwa Vidya Peetham (Deemed University) u/s 10A of the IMC Act, 1956.</u>

Read: The Council Inspector's report (December, 2007) on the physical and other teaching facilities available at Amrita School of Medicine, Kochi, Kerala under Amrita Vishwa Vidya Peetham (Deemed University) for starting of M.D.(Obst. & Gynae.) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (December, 2007) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.D.(Obst. & Gynae.) course at Amrita School of Medicine, Kochi, Kerala under Amrita Vishwa Vidya Peetham (Deemed University) u/s 10A of the IMC Act, 1956, because of the following:-

- 1. The institute has made a MOU with Lakshmi Hospital, 6 k.m. away from the college for utilizing the clinical material for the students which is not acceptable as being contrary to the Regulations.
- 2. Clinical material available at the own hospital is grossly inadequate: Deliveries 278 per year, Caesarean Section 239 /year; MTP & abortions 112/year.
- 3. Other deficiencies as pointed out in the inspection report.

### 13. <u>Starting of M.D.(Anaesthesiology) course at Amrita School of Medicine, Kochi under Amrita Vishwa Vidya Peetham (Deemed University) u/s 10A of the IMC Act, 1956.</u>

Read: The Council Inspector's report (December, 2007) on the physical and other teaching facilities available at Amrita School of Medicine, Kochi, Kerala under Amrita Vishwa Vidya Peetham (Deemed University) for starting of M.D.(Anaesthesiology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (December, 2007) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of MD(Anaesthesiology) course at Amrita School of Medicine, Kochi, Kerala under Amrita Vishwa Vidya Peetham (Deemed University) u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2008-2009 restricting the number of admissions to 5 (five) students per year till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

#### 14. <u>Starting of MS(General Surgery) course at Katihar Medical College, Katihar under B.N. Mandal University u/s 10A of the IMC Act, 1956.</u>

Read: The Council Inspector's report (December, 2007) on the physical and other teaching facilities available at Katihar Medical College, Katihar under B.N. Mandal University for starting of MS(General Surgery) course u/s 10A of the IMC Act, 1956.

The Secretary informed the members of the Postgraduate Committee that an inspection of the institute was carried out by the Council Inspectors in June, 2007 for increase of seats from 60 to 100 in MBBS course.

The Postgraduate Committee observed that the Executive Committee at its meeting held on 13<sup>th</sup> & 14<sup>th</sup> June, 2007 wherein the members of the Adhoc Committee appointed by the Hon'ble Supreme Court were also present while considering the inspection report of the institute for increase of seats in Ist MBBS course from 60 to 100 had decided as under:-

"The members of the Adhoc Committee appointed by the Hon'ble Supreme Court and the Executive Committee of the Council considered the Council Inspectors report (05<sup>th</sup> & 06<sup>th</sup> June, 2007) and noted the following:-

- 1. The shortage of teaching staff required at present stage is as under:-
- (a) The shortage of teaching faculty is 16 % (i.e. 21 out of 131) as under:-
- (i) Professor :2 (Anatomy –1 & Radio-diagnosis –1)

(ii) Assoc. Prof. :11 (Physiology -1, Biochemistry -2, Community Medicine -1, General Medicine -1, TB & Chest -1, Dermatology -1, Psychiatry

-1, Obst. & Gynae. -1, Radio-diagnosis - 1 & Dentistry -1)

- (iii) Asst. Prof. :08 (Anatomy -1, Community Medicine -4, TB & Chest -1, Psychiatry -1 & Obst. & Gynae. -1)
- (b) The shortage of Residents is 14.5 % as under :-
- (i) Sr. Resident :09 (General Medicine -1, Paediatrics -1, Psychiatry -1, General Surgery -1, Orthopaedic -1, ENT -1, Ophthalmology -1, Obst.

& Gynae. -1 & Anaesthesia -1)

(ii) Jr. Resident :02 (ENT -1 & Dentistry -1)

2. Clinical Material is inadequate in terms of bed occupancy, number of deliveries and laboratory and radiological investigations as under:-

- The bed occupancy was 65% on the day of inspection.
- 3. Hostels: Accommodation is available only for 245 boys and girls against the requirement of 340 at this stage.
- 4. Accommodation is available only for 35 residents, which is inadequate against the requirement of 100 at this stage.
- 5. There are no units in TB & Chest, Skin & VD & Psychiatry, as there is no faculty in these departments.
- 6. There is overcrowding of beds in all departments
- 7. In O.P.D.: No facilities are provided for Bio-Medical waste. Space is inadequate in the OPD block. Each specialty is provided only 2 rooms and 1 small teaching area for 5 to 5 to 7 students. No Audio Visual aids and other teaching facilities are provided. There is no separate injection room for male and female patients. No needle destroyers are provided. In the Gynae. OPD, rusted instruments were kept in a manual sterilizer which was not in working order. No other autoclaved instruments or gloves were available.
- 8. Wards: There is overcrowding of beds in all wards. The roof of the 2<sup>nd</sup> floor of the Medical and allied wards is temporary and was found to be leaking in many places due to rains. There is no Central Oxygen and Central Suction anywhere in the Hospital. There is no Post-operative ward within or outside the OT complex. No ward is provided with duty doctor room, nurse duty room, pantry, examination/procedure room, teaching area and side laboratory. Nursing stations are placed in the corridors. Many wards are located in cubicles of 07 beds. There are no clinical demonstration areas in the wards. No audiovisual aids and other teaching facilities are provided.
- 9. There is no lecture theatre in the Hospital
- 10. Registration and Medical Record Section: Indoor registration is computerized but not cross linked with outdoor registration numbers.
- 11. There is no disaster trolley or crash cart.
- 12. Operation theatre unit: There are 9 operation theatres against the requirement of 10 at this stage. The air-conditioning is not working in most O.Ts. No O.T. is having central oxygen & nitrous oxide supply and suction.
- 13. Equipment for Radiological Department is inadequate. Only 03 static units (2 of 300 mA, 1 of 60mA) are available and 1 mobile unit (1 of 60 mA) are available.
- 14. CSSD: No bowl sterilizer and instrument washing machine are available in CSSD. Racks, trays and mixers are not available.
- 15. Nursing Staff is inadequate as under:-

Nursing Superintendent:02Deputy Nursing Superintendent:2Matron:NilAsstt. Nursing Superintendent2Nursing Sisters10

Staff nurses 90

- 16. RHTC, Hazipur is located in a rented leased private house with 4 rooms, which is not as per Regulations. Staff as prescribed under the Regulations is not available. At Barsoi Health Centre also staff as prescribed under the Regulations is not available.
- 17. In Anatomy Department: The research laboratory is ill equipped. Instruments/equipments to carryout PG research work are not available.
- 18. In Physiology Department: The research laboratory is ill equipped. Instruments/ equipments to carryout PG research work are not available.
- 19. Number of books in the departmental libraries are inadequate as under:- TB & Chest:20, Skin & V.D.:20, Psychiatry:20, Orthopaedics:68, Oto-Rhino-Laryngology:72, Ophthalmology: 54, Radio-Diagnosis:59 and Anaesthesia:56.
- 20. There is no ICCU.
- 21. Other deficiencies pointed out in the inspection report.

In view of above and Govt. of India letter dated 15.03.2005 issued after the directions of the Hon'ble Supreme Court in case of Mridul Dhar Vs. UOI & Ors. directing the Council to strictly adhere to the time schedule prescribed under the regulations, the members of the Adhoc Committee appointed by the Hon'ble Supreme Court and of the Executive Committee of the Council decided to return the application, recommending disapproval to the Central Govt. for increase of seats in 1<sup>st</sup> MBBS course from 60 to 100 at Katihar Medical College, Katihar for the academic session 2007-08."

In view of above, the Postgraduate Committee decided to carry out another inspection of the institute and defer the consideration of the matter till then.

#### 15. <u>Starting of DM(Gastroenterology) course at Moti Lal Nehru Medical College,</u> Allahabad under Allahabad University u/s 10A of the IMC Act, 1956.

Read: The Council Inspector's report (December, 2007) on the physical and other teaching facilities available at Moti Lal Nehru Medical College, Allahabad under Allahabad University for starting of DM(Gastroenterology) course u/s 10 A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (December, 2007) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of DM(Gastroenterology) course at Moti Lal Nehru Medical College, Allahabad under Allahabad University u/s 10A of the IMC Act, 1956, because of the following:-

- 1. Unit 1 has 40 beds which is not as per Regulations.
- 2. Bed occupancy is 70% which is inadequate.
- 3. Other deficiencies as pointed out in the inspection report.

## 16. <u>Starting of MD(Dermatology) course at Pondicherry Institute of Medical Sciences, Pondicherry under Pondicherry University u/s 10A of the IMC Act, 1956.</u>

Read: The Council Inspector's report (December, 2007) on the physical and other teaching facilities available at Pondicherry Institute of Medical Sciences, Pondicherry under Pondicherry University for starting of MD(Dermatology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (December, 2007) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of MD(Dermatology) course at Pondicherry Institute of Medical Sciences, Pondicherry under Pondicherry University u/s 10A of the IMC Act, 1956, because of the following:-

- 1. Average daily OPD is 27 which is inadequate.
- 2. There is no departmental research laboratory.
- 3. Punch grafting and suction technology are not available.
- 4. Resultantly, instrumentation is inadequate.
- 5. Other deficiencies as pointed out in the inspection report.

- 3. Other deficiencies as pointed out in the inspection report.

#### 46. Goa University – Recognition of MS (ENT) qualification in respect of students being trained at Goa Medical College, Panaji.

Read: The compliance verification report (December, 07) together with compliance and Council Inspector's (April, 2007) on the standard of examination and other teaching facilities available at Goa Medical College, Panaji under Goa University for purpose of recognition of MS (ENT) qualification granted by Goa University.

The Postgraduate Committee considered the compliance verification inspection report (December, 07) along with compliance and Council Inspector's report (April, 2007) and observed that the deficiencies pointed out vide the decision of the Postgraduate Committee taken at its meeting held on 06.06.2007 have not till been complied with as (1) Dr. Sandesh Chodankar, Asstt. Prof. & Dr. Carnegie De Sa, Lecturer do not possess requisite postgraduate qualification. Resultantly, teaching complement is incomplete in Unit-I.

In view of above, the Committee decided to reiterate its earlier decision taken at its meeting held on 06.06.2007 to recommend not to recognise MS (ENT) qualification granted by Goa University in respect of students being trained at Goa Medical College, Panaji and further decided to reiterate its decision to direct the institution authorities to henceforth stop admissions in M.S.(ENT) course from the ensuing academic session 2008-2009.

# 47. Osmania University, Andhra Pradesh University of Health Sciences, Vijayawada and N.T.R. University of Health Sciences, Vijayawada - Approval of Gandhi Medical College, Hyderabad for the award of M.D.(General Medicine) qualification.

The Postgraduate Committee considered the compliance verification report (December, 07) togetherwith compliance and Council inspector report (October, 2002) and decided not to approve Gandhi Medical College, Hyderabad for the award of M.D.(General Medicine) qualification earlier granted by Osmania University, Andhra Pradesh University of Health Sciences, Vijayawada & now by NTR University of Health Sciences, Vijayawada because of the following:-

- 1. Unit-I does not have Assoc. Prof.
- 2. Dr. Nagamani, Asst. Prof. in Unit IV does not possess recognized PG qualification.
- 3. Resultantly, teaching faculty complement is incomplete.
- 4. Other deficiencies as pointed out in the inspection report.

In view of above, the Committee further decided to direct the institution authorities to henceforth stop admissions in MD (General Medicine) course from the academic session 2008-2009.

## 48. West Bengal University of Health Sciences, Kolkata – Recognition of M.D/MS(Anatomy) qualification in respect of students being trained at R.G. Kar Medical College, Calcutta.

The Postgraduate Committee considered the compliance togetherwith Council inspector report (April, 2007) and decided to recommend that M.D/MS(Anatomy) qualification granted by West Bengal University of Health Sciences, Kolkata in respect of students being trained at R.G. Kar Medical College, Calcutta be recognized and included in the 1<sup>st</sup> Schedule to the I.M.C. Act,1956 restricting the number of admission to 4 (four) students per year prospectively i.e. from the academic year 2008-09.

The Committee further decided to direct the institution authorities to restrict the number of admissions from 2(two) to 1 (one) student for D. Ortho. course per year prospectively commensurate with number of available PG teachers.

## 56. <u>Madras University and The Tamilnadu Dr. M.G.R. Medical University, Chennai- Approval of Kilpauk Medical College, Chennai for the award of M.S.(Orthopaedics) & D.Ortho. qualifications.</u>

Read: The compliance verification report (December, 07) togetherwith compliance Council Inspector report (April, 2004) on the standard of examination and other teaching facilities available at Kilpauk Medical College, Chennai for purpose of approval of the college for the award of M.S.(Orthopaedics) & D.Ortho. qualifications earlier granted by Madras University and now by The Tamilnadu Dr. M.G.R. The Postgraduate Committee considered the compliance verification report (December, 07) togetherwith compliance Council Inspector report (April, 2004) and decided to recommend that Kilpauk Medical College, Chennai be approved for the award of M.S.(Orthopaedics) & D.Ortho. qualifications earlier granted by Madras University and now by The Tamilnadu Dr. M.G.R. Medical University, Chennai restricting the number of admissions to 5 (five) students per year.

The Committee further decided to direct the institution authorities to restrict the number of admissions from 8(eight) to 1 (one) student for D. Ortho. course per year commensurate with number of available PG teachers prospectively i.e. from the academic year 2008-2009...

### 58. <u>Increase of seats in MD(Obst. & Gynae.) course at Jawaharlal Nehru Medical College, Swangi, Wardha under Datta Meghe Institute of Medical Sciences</u> (Deemed University) u/s 10A of the IMC Act, 1956.

Read: The Council Inspectors report (December, 2007) on the physical and other teaching facilities available at J.N. Medical College, Swangi, Wardha for increase of seats in MD(Obst. & Gynae.) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (December, 2007) and decided to recommend to the Central Govt. to issue Letter of Permission for increase of seats in MD(Obst. & Gynae.) course at J.N. Medical College, Swangi, Wardha under Datta Meghe Institute of Medical Sciences (Deemed University) u/s 10A of the I.M.C. Act,1956 prospectively i.e. from the academic session 2008-2009 from 3 (three) to 5 (five) students per year till the first batch admitted against the increased number appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification for the additional increased intake at the time of first available examination as per the provision of Section 11(2) of the IMC Act,1956.

#### 59. <u>Starting of DM(Cardiology) course at Moti Lal Nehru Medical College,</u> <u>Allahabad – Permission of Central Govt. – Regarding.</u>

Read: The letter dated 13/12/2007 received from the Principal, Moti Lal Nehru Medical College, Allahabad for carrying out the inspection for starting of DM (Cardiology) course at Moti Lal Nehru Medical College, Allahabad.

The Postgraduate Committee considered the letter received from the Principal, Moti Lal Nehru Medical College, Allahabad and observed that Regulation 3.2 of the Qualifying Criteria in Part-I of the Scheme for permission of the Central Government for opening a New or Higher course of Study or Training (including a Postgraduate Course of Study or Training) in a Medical College/Institution reads as under:

"3.2 The permission letter regarding desirability and feasibility for opening a new or higher course in the medical college/institution has been obtained by the applicant from the respective State Government or the Union Territory administration"

In view of above, the Postgraduate Committee decided that as the institution has not submitted any Essentiality Certificate or permission letter regarding desirability and feasibility for opening of D.M. (Cardiology) course in the institution from the State Government, the qualifying criteria as required under the Regulations are not fulfilled and further decided to return the application to the Central Government recommending disapproval of the scheme. It was also decided that this decision may also be communicated to the Secretary, Medical Education, Govt. of U.P. for necessary action.
