- 4. Only 5 patients in casualty.
- 5. Only 1 CT & 2 MRI per day.
- 6. Dr. Risham Singla is not eligible as senior Resident.
- 7. Other deficiencies as pointed out in the assessment report.

The Postgraduate Committee considered the Council Assessor's report (10/01/2014) and decided to recommend to the Central Govt. to disapprove the scheme for Starting of MD(General Medicine) course at Govt. Medical College, Anantapur under Dr. NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 because of the following reasons:-

- 1. Facilities for blood component are not available.
- 2. Regular Dean was absent on day of assessment.
- 3. Dr. M. Bhimsenacharry, Asso. Prof. cannot be accepted as he has been promoted as Asso. Prof. with experience of only 2 y 1 m as Asst. Prof.
- Teaching experience of Dr. K.S.S. Venkateswara Rao, Professor & HOD could not be verified due to Nonavailability of experience certificates for certain periods as detailed in report.
- 5. Unit I & II have only 2 faculty; resultantly they cannot be considered as PG Units. Unit III & IV have only 1 faculty each.; resultantly, teaching complement is inadequate.
- 6. Shortage of faculty: (a) Asst. Prof.: 3.
- 7. Shortage of Senior Resident: 3.
- 8. Paramedical staff: 510 posts are vacant.
- OPD data is maintained manually; it is written incompletely, inappropriately in very poor quality books. OPD space is congested. Waiting area for patients is not available.
- 10. Bed occupancy is 46 %. Ward floor tiles are broken. Biomedical waste management is poorly managed. Registers for data entry are poorly maintained.
- 11. ICU is not available. In ICCU, round the clock medical officers are not available. Dialysis unit is non-functional.
- 12. Equipment like Echo, TMT, PFT, EEG, Endoscopy, Bronchoscopy, etc. are not available. Amongst available equipment, many are non-functional.
- 13. Ward side laboratory is non-functional. Procedural workload is grossly inadequate. Ascitic fluid 20, CSF 15 & Pleural fluid examination only 15 20 annually. Bone marrow examination is carried out may be once in 2-4 months.
- 14. Investigative workload, both radiological & laboratory, is grossly inadequate. Only 30 X-rays are taken daily. Special radiological investigations are not carried out.
- 15. In class rooms and demonstration rooms, chairs, black boards, etc. are not
- 16. There are no publications from the department in indexed journals in last 3 years.

- 17. Faculty office rooms are not defined and appear to be less used.
- 18. There are no speciality clinics run by the department.
- 19. Other deficiencies as pointed out in the assessment report.

The Postgraduate Committee considered the Council Assessor's report (11/01/2014) and decided to recommend to the Central Govt. to disapprove the scheme for Increase of seats in MS(OBG) course at Mediciti Institute of Medical Sciences, Ghanpur (A.P.) under Dr. NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 because of the following reasons:-

- 1. Gynaecology operative workload is very less daily only 1 major & 1 minor operation. Unitwise record is not maintained. O.T. facilities for Gynaecology are inadequate. Preoperative & postoperative rooms are very small. No proper space for Gynaecologist &Anesthesiologist in the O.T. Only 4-5 units of blood are issued to Gynaecology in a month. Total number of major operations has decreased during the period of last 3 years.
- 2. Bed occupancy on day of assessment is 58 %.

Read: the Council Assessor's report (21st Jan, 2014) on the physical and other teaching facilities available at Kasturba Medical College, Mangalore under Manipal University, Karnataka for Starting of MD(Psychiatry) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Assessor's report (21st Jan, 2014) and decided to recommend to the Central Govt. to disapprove the scheme for Starting of MD(Psychiatry) course at Kasturba Medical College, Mangalore under Manipal University, Karnataka u/s 10A of the IMC Act, 1956 because of the following reasons:-

- 1. There are 2 hospitals attached to the college of which one is government hospital. It appears that the data of clinical material pertain to combined data of both the hospitals; it is inadequate.
- 2. 40 beds of the only Unit are split between college hospital (30 beds) & Govt. Hospital (10 beds). Split Unit between two hospitals is not permissible. Beds at Govt. hospital cannot be considered as a fully fledged Unit of 30 beds with teaching faculty as defined in the Regulations is not available.
- 3. No new books on Psychiatry have been purchased for departmental library in last 3 years.
- 4. Other deficiencies as pointed out in the assessment report.

166. Starting of MD(Forensic Medicine) course at Govt. Medical College, Anantapur under Dr. NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956.

Read: the Council Assessor's report (11/01/2014) on the physical and other teaching facilities available at Govt. Medical College, Anantapur under Dr. NTR University of Health Sciences, Vijayawada for Starting of MD(Forensic Medicine) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Assessor's report (11/01/2014) and decided to recommend to the Central Govt. to disapprove the scheme for Starting of MD(Forensic Medicine) course at Govt. Medical College, Anantapur under Dr. NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 because of the following reasons:-

- 1. Promotion of Dr. B. Venkateswarulu, Professor & HOD is not as per regulation.
- 2. There is no Associate Professor.
- 3. Open mortuary with fly proofing is not available.
- 4. Other deficiencies as pointed out in the assessment report.

167. <u>Consideration of applications for Starting of various PG courses at Mandya Institute of Medical Sciences, Mandya.</u>

Read: the matter with regard to consideration of applications for Starting of various PG courses at Mandya Institute of Medical Sciences, Mandya along with legal opinion of the Law Officer dated 01/02/2014.

The Postgraduate Committee considered the matter with regard to consideration of applications for Starting of various PG courses at Mandya Institute of Medical Sciences, Mandya along with legal opinion of the Law Officer dated 01/02/2014, which is reproduced below:

"The file of Mandya Institute of Medical Sciences, Mandya, in respect of its application for the starting of various postgraduate courses has been referred for my opinion. I have perused the representation dated 23.01.2014 of the Director of the Institute wherein he states an application with fees was made to the Council office on 19.09.2011 and thereafter the Institute had written to the Council requesting for inspection for 2012-13 and 2013-14. However, as there was no response from the Council it had submitted fees once again on 10.10.2013 and has annexed receipt issued by the Council dated 29.10.2013 with it. The Institute is also relying upon section 10 (A) (5) of the IMC Act, 1956 pertaining to deemed approval in respect of its claim.

- 2. On perusal of file, it is noted that the applicant has submitted an application for starting of various PG courses to the Secretary, Medical Council of India on 27.05.2013. A letter dated 15.04.2013 by the Director of the Institute addressed to the Secretary, MCI is enclosed with it in which reference is made to the fees paid on 19.09.2011 with request to consider this as payment of fees for 2014-15 inspection. However, no application fees has been tendered with this application.
- 3. The application of the College was returned on 11.12.2013 with the remark that "Application fee is not submitted".
- 4. It is to be noted that in accordance with "The Opening of a New or Higher Course of Study or Training (including Postgraduate Course of Study or Training (including a Postgraduate Course of Study or Training) Regulations, 2000", the time for submission of application for PG Courses (broad specialty) is from 1 April to 31 May. Therefore, the applicant in accordance with the Regulations ought to have made application during such period, and not on 19.09.2011. However, the applicant has enclosed a document showing its receipt in the Council office on 19.09.2011 and on the file referred for my opinion there is no record as to how the matter was addressed.
- 4. From the above narration of facts, it appears to me that:

Firstly, the College claims to have made an application for starting of various PG courses on 2011-12 on 19.09.2011. The College has produced acknowledgement from the Council in this regard. The Accounts Officer has stated on 22.01.2014 that no such payment that the College claims to have made in 2001 has been received in the MCI Bank Account and has advised that applicant check it with the Zonal or Regional Office of the Bank for refund.

Secondly, fees for processing the application for the academic year 2014-15 was submitted by the College on 10.10.2013 and that has been accepted by the Council.

Thirdly, rejection Order dated 11.12.2013 has been sent to the applicant on the ground that "application fees is not submitted."

In view of this factual matrix that is primarily an administrative issue, I am of the opinion that the case of the applicant calls for re-look by the PG Committee, as equity for consideration is created in favour of applicant on the following grounds:-

Firstly, it has in its application dated 27.05.2013 annexed its letter dated 15.04.2013 wherein Council was informed of application made on 19.09.2011 and payment made with request to consider it for inspection for 2014-15.

Second, the application is rejected on 11.12.2013 on account of non-payment of fees whereas the applicant has paid as it claims once again fees on 10.10.2013 and has in its

favour a receipt issued by the Council. To me it appears from perusal of records that such rejection is without considering that the fees has been submitted on 10.10.2013 and is with Council. Further, no clarification has been offered till date to the applicant regarding the fees that it claims to have paid on 19.09.2011 and has requested for adjustment. However, the applicant cannot claim reliance on section 10 (A) (5) of the IMC Act, 1956 relating to deemed approval, for starting the course as a communication regarding rejection has been made.

In view of the above, this matter may be considered in accordance with the decision of the PG Committee on item 215 (Extract annexed) in its meeting held on 20-21 January 2014, as there is a claim for adjustment of fees paid in past year and full fees has been paid although after cut-off date and the representation for consideration has been made by the applicant.

In view of the legal opinion explained, the Postgraduate Committee decided that the application may be considered and the college may be assessed for the subjects applied for.

168. Starting of MD(Immuno Haematology & Blood Transfusion) course at Indira Gandhi Institute of Child Health, Bangalore under Rajiv Gandhi University of Health Sciences, Karnataka u/s 10A of the IMC Act, 1956.

Read: the Council Assessor's report (13th Jan, 2014) on the physical and other teaching facilities available at Indira Gandhi Institute of Child Health, Bangalore under Rajiv Gandhi University of Health Sciences, Karnataka for Starting of MD(Immuno Haematology & Blood Transfusion) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee decided to defer the matter for its next meeting.

169. <u>Increase of seats in MD(Paediatrics) course at Indira Gandhi Institute of Child</u> <u>Health, Bangalore under Rajiv Gandhi University of Health Sciences,</u> <u>Karnataka u/s 10A of the IMC Act, 1956.</u>

Read: the Council Assessor's report (13th Jan, 2014) on the physical and other teaching facilities available at Indira Gandhi Institute of Child Health, Bangalore under Rajiv Gandhi University of Health Sciences, Karnataka for Increase of seats in MD(Paediatrics) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee decided to defer the matter for its next meeting.

170. <u>Inspection of Bangabandhu Sheikh Mujib Medical University, Dhaka, Bangladesh.</u>

Read: the matter with regard to Inspection of Bangabandhu Sheikh Mujib Medical University, Dhaka, Bangladesh along with letter dated 17/01/2014 received from Dr. K.N. Siddiqui.

The Postgraduate Committee considered the matter with regard to Inspection of Bangabandhu Sheikh Mujib Medical University, Dhaka, Bangladesh along with letter dated 17/01/2014 received from Dr. K.N. Siddiqui and decided that a sub-committee of experts be constituted which will look into the eligibility conditions and syllabus of MD (Cardiology) and decide its equivalence (whether MD or DM). The matter be referred to the President for needful.

171. Guru Gobind Singh Indraprashta University, New Delhi - Recognition of MS (Orthopaedics) qualification against increased intake from 01 to 06 seats in respect of students being trained at Postgradaute Institute of Medical Education and Research, Dr. R.M.L. Hospital, New Delhi.

Read: the matter with regard to recognition of MS (Orthopaedics) qualification against increased intake from 01 to 06 seats in respect of students being trained at Postgradaute Institute of Medical Education and Research, Dr. R.M.L. Hospital, New Delhi under Guru Gobind Singh Indraprastha University, New Delhi.

The Postgraduate Committee considered the matter with regard to recognition of MS (Orthopaedics) qualification against increased intake from 01 to 06 seats in respect of students being trained at Postgradaute Institute of Medical Education and Research, Dr. R.M.L. Hospital, New Delhi under Guru Gobind Singh Indraprastha University, New Delhi and decided to verify the compliance with fresh assessment at the time of next examination.
