2. <u>Minutes of the last meeting of the Postgraduate Medical Education Committee</u> – action taken thereon.

The Postgraduate Medical Education Committee noted & approved the action taken on the minutes of the previous meeting of the Postgraduate Medical Education Committee.

3. <u>Starting of M.Ch. (Urology) course at VSS Medical College, Burla, Odisha under Sambalpur University, Burla u/s 10A of the IMC Act, 1956 for the academic year 2016-17.</u>

Read: the Council Assessor's Report (16/03/2016) on the physical and other teaching facilities available at VSS Medical College, Burla, Odisha under Sambalpur University, Burla for Starting of M.Ch. (Urology) course u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (16/03/2016) and noted the following:

- 1. There is no Assoc. Professor in the Unit; hence faculty complement is incomplete & it cannot be considered as PG Unit.
- 2. There are only 14 teaching beds against requirement of 20.
- 3. Dr. Sailendra Nayak, Professor was absent on day of assessment; hence his D.F. could not be verified.
- 4. Dr. Biswajit Mohapatra, Senior Resident does not possess 3 years experience as Resident in the department; hence not qualified to hold the post.
- 5. There are only 60 books in Departmental library.
- 6. MRI is not available.
- 7. No sanctioned post of Asst. Professor in the Department.
- 8. Other deficiencies as pointed out in the Assessment Report.

In view of the above, the Postgraduate Medical Education Committee decided to recommend to the Central Government not to grant letter of permission for Starting of M.Ch. (Urology) course at VSS Medical College, Burla, Odisha under Sambalpur University, Burla u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

4. Starting of M.Ch. (Endocrine Surgery) course at Amrita School of Medicine, Elamkara, Kochi, Kerala under Amrita Vishwa Vidyapeetham University (Deemed), Coimbatore u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

Read: the Council Assessor's Report (21st March 2016) on the physical and other teaching facilities available at Amrita School of Medicine, Elamkara, Kochi, Kerala under Amrita Vishwa Vidyapeetham University (Deemed), Coimbatore for Starting of M.Ch. (Endocrine Surgery) course u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (21st March 2016) and noted the following:

- 1. Teaching complement is incomplete.
- 2. Dr. Jimmy Mathews, Associate Professor possesses academic qualification in Plastic Surgery. He has total experience of 6 years 1 month in department of Plastic Surgery. Thus his experience in this department is

- only 2 years 3 months. No evidence of his receiving training in Endocrine Surgery is shown in the faculty table.
- 3. Dr. C. Gopal Krishnan Nair, Professor & HOD possesses qualification of M.S. No evidence of his receiving training in Endocrine Surgery is shown in the faculty table. He is shown as Professor w.e.f. 01/04/2002 till date; however no breakup of experience in this department is provided. His experience at Kottayam and Thrissur was in Surgery, which cannot be counted.
- 4. Dr. Mishra J.C. Babu, Assoc. Professor is shown as Asst. Professor from 17/08/2005 to 31/12/2010 and as Assoc. Professor thereafter; however no breakup of experience in this department is provided. No evidence of his receiving training in Endocrine Surgery is shown in the faculty table. All her experience as Asst. Professor at Kannur and Kochi is in General Surgery.
- 5. Dr. A.K. Revathy, Senior Resident does not possess 3 years experience as Resident in the department. Hence, not qualified to hold the post.
- 6. Details of daily operations are not provided.
- 7. Other deficiencies as pointed out in the Assessment Report.

In view of the above, the Postgraduate Medical Education Committee decided to recommend to the Central Government not to grant letter of permission for Starting of M.Ch. (Endocrine Surgery) course at Amrita School of Medicine, Elamkara, Kochi, Kerala under Amrita Vishwa Vidyapeetham University (Deemed), Coimbatore u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

5. Increase of seats in DM (Endocrinology) course at Topiwala National Medical College, Mumbai under Maharashtra University of Health Sciences, Nashik u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

Read: the Council Assessor's Report (21st March 2016) on the physical and other teaching facilities available at Topiwala National Medical College, Mumbai under Maharashtra University of Health Sciences, Nashik for Increase of seats in DM (Endocrinology) course u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (21st March 2016) and noted the following:

- 1. Details of Senior Resident are not provided in the faculty table.
- 2. Endocrinology OPD is run only twice a week; rest of days only specialty clinics are run.
- 3. Total OPD attendance has decreased from 35,360 in 2013 to 34,295 in 2015.
- 4. Bed occupancy on day of assessment is not provided.
- 5. Other deficiencies as pointed out in the Assessment Report.

In view of the above, the Postgraduate Medical Education Committee decided to recommend to the Central Government not to grant letter of permission for Increase of seats in DM (Endocrinology) course at Topiwala National Medical College, Mumbai under Maharashtra University of Health Sciences, Nashik u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

6. Starting of M.Ch. (Hepato Pancreato Billary Surgery) course at Christian Medical College, Vellore, Tamilnadu under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

Read: the Council Assessor's Report (21st March 2016) on the physical and other teaching facilities available at Christian Medical College, Vellore, Tamilnadu under The

Tamilnadu Dr. MGR Medical University, Chennai for Starting of M.Ch. (Hepato Pancreato Billary Surgery) course u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (21st March 2016) and noted the following:

- 1. Details of Senior Residents are not provided in the faculty table.
- 2. Evidence of 2 years training in the subject is not shown in respect of Dr. D.J. Sonbare & Dr. M.L. Rymbai, both Asst. Professor
- 3. Dr. Philip Joseph, Professor & HoD. Till 2010, he first worked as Asst. Professor in General Surgery, which cannot be recognized. Then he worked as Assoc. Professor and Professor from 2002 to 2010 in General Surgery and Hepato Billary Unit, both simultaneously. Then he shifted to Hepato Billary Surgery only in 2010. Hence, he is not eligible. During the period February, 2002 to January, 2004, he was working as Lecturer in Surgery and at the same time, he was undergoing special training in Australia, which is not feasible. Similarly, from April, 2004 to January, 2005, he was on training in London and the same time, he is shown working as Reader/ Assoc. Professor in this Institute. He could not be working at both the places. Hence, not eligible to hold the post of Professor.
- 4. Professor Fredrick L. Vyas is MS (Surgery), he has no special training in Hepato Pancreato Billary Surgery. His training was in Transplant Surgery, which cannot be considered. He shifted to Hepato Pancreato Billary Surgery department in December, 2010 prior to this his experience was in General Surgery and Hepato Pancreato Billary Unit.
- 5. Dr. Ravish Sanghi Raju, Assoc. Professor was on Fellowship for 2 months in 2008 and for 2 years 2 months in 2012-13 and 2013-14. During the same period he has been shown to be working in CMC, Vellore, which is not feasible. Prior to 2010, he was working in General Surgery, which cannot be counted. He was Asst. Professor for 1 year 1 month 20 days against the requirement of 2 years. Hence, his promotion is not as per Regulations.
- 6. Both the Asst. Professor are MS (General Surgery) with no special training in Hepato Pancreato Billary Surgery.
- 7. Other deficiencies as pointed out in the Assessment Report.

In view of the above, the Postgraduate Medical Education Committee decided to recommend to the Central Government not to grant letter of permission for Starting of M.Ch. (Hepato Pancreato Billary Surgery) course at Christian Medical College, Vellore, Tamilnadu under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

7. Starting of DM (Reproductive Medicine) course at Mahatma Gandhi Medical College and Hospital, Jaipur under Mahatma Gandhi University of Medical Science & Technology, Jaipur u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

Read: the Council Assessor's Report (21st March 2016) on the physical and other teaching facilities available at Mahatma Gandhi Medical College and Hospital, Jaipur under Mahatma Gandhi University of Medical Science & Technology, Jaipur for Starting of DM (Reproductive Medicine) course u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (21st March 2016) and noted the following:

- 1. No evidence of training for 2 years in Reproductive Medicine is provided in respect of Dr. Usha Shekhawat, Professor; Dr. Alka Gahlot, Professor & Dr. Manisha Chaudhary, Professor.
- 2. None of Senior Residents has experience of 3 years as Resident in the department; hence not qualified to hold the post.
- 3. Dr. Usha Sekhawat, Professor & HoD worked in OBG department in SMS Medical College, Jaipur. She has no Special Training of 2 years in Reproductive Medicine. Hence, not eligible.
- 4. Dr. Alka Gahlot, Professor was Assoc. Professor for 3 years and promoted on 06/04/2015 after the cut-off date without any publications. All her experience is in MGM College, Jaipur and this college is not having the department of Reproductive Medicine since 2007. Training, if any, was in 2015 and not at the time of appointment.
- 5. Dr. Monika Chaudhary is MS (OBG). She was Assoc. Professor for 3 years 2 months and promoted on 01/01/2016 after the cut-off date without any publications. She has no 2 years special training in Reproductive Medicine. Training, if any (ART), was in 2015 and not at the time of appointment. Hence, not eligible.
- 6. Dr. Jawahira Chishti, Asst. Professor is MS (OBG) without any special training in Reproductive Medicine. Hence, not eligible.
- 7. Both the Senior Residents have no 3 years experience in a Medical College as Junior Resident in Reproductive Medicine. Hence, not eligible.
- 8. Other deficiencies as pointed out in the Assessment Report.

In view of the above, the Postgraduate Medical Education Committee decided to recommend to the Central Government not to grant letter of permission for Starting of DM (Reproductive Medicine) course at Mahatma Gandhi Medical College and Hospital, Jaipur under Mahatma Gandhi University of Medical Science & Technology, Jaipur u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

8. <u>Starting of DM (Cardiology) course at M.K.C.G. Medical College, Brahmapur under Berhampur University, Berhampur u/s 10A of the IMC Act, 1956 for the academic year 2016-17.</u>

Read: the Council Assessor's Report (18/03/2016) on the physical and other teaching facilities available at M.K.C.G. Medical College, Brahmapur under Berhampur University, Berhampur for Starting of DM (Cardiology) course u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (18/03/2016) and noted the following:

- 1. MRI is not available.
- 2. Both the Senior Residents are MD (Medicine). No 3 years experience as Junior Resident in Cardiology in a medical college. Hence, not eligible.
- 3. Other deficiencies as pointed out in the Assessment Report.

In view of the above, the Postgraduate Medical Education Committee decided to recommend to the Central Government not to grant letter of permission for Starting of DM (Cardiology) course at M.K.C.G. Medical College, Brahmapur under Berhampur University, Berhampur u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

9. Increase of seats in DM (Cardiology) course at Indira Gandhi Medical College, Shimla under Himachal Pradesh University, Shimla u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

Read: the Council Assessor's Report (22/03/2016) on the physical and other teaching facilities available at Indira Gandhi Medical College, Shimla under Himachal

Pradesh University, Shimla for Increase of seats in DM (Cardiology) course u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (22/03/2016) and noted the following:

- 1. The only Unit has 33 beds, which is not as per Regulations.
- 2. Details of Senior Resident are not provided in the faculty table.
- 3. Data of Treadmill Test after July 2015 are not provided.
- 4. Departmental library has only 60 books. No new books have been added in last 3 years.
- 5. TMT machine is not functional.
- 6. Other deficiencies as pointed out in the Assessment Report.

In view of the above, the Postgraduate Medical Education Committee decided to recommend to the Central Government not to grant letter of permission for Increase of seats in DM (Cardiology) course at Indira Gandhi Medical College, Shimla under Himachal Pradesh University, Shimla u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

10. Starting of DM (Medical Gastroenterology) course at Smt. N.H.L. Municipal Medical College, Ahmedabad, Gujarat under Gujarat University, Ahmedabad u/s 10A of the IMC Act, 1956 for the academic year 2016-17 – consideration of compliance.

Read: the Council Assessor's Report (12/02/2016) and compliance dated 21/03/2016 submitted by the college authorities on the physical and other teaching facilities available at Smt. N.H.L. Municipal Medical College, Ahmedabad, Gujarat under Gujarat University, Ahmedabad for Starting of DM (Medical Gastroenterology) course u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (12/02/2016) and compliance dated 21/03/2016 submitted by the college authorities and decided to verify compliance by way of Assessment.

11. Increase of seats in DM (Cardiology) course at Smt. N.H.L. Municipal Medical College, Ahmedabad, Gujarat under Gujarat University, Ahmedabad u/s 10A of the IMC Act, 1956 for the academic year 2016-17 – consideration of compliance.

Read: the Council Assessor's Report (11/02/2016) and compliance dated 21/03/2016 submitted by the college authorities on the physical and other teaching facilities available at Smt. N.H.L. Municipal Medical College, Ahmedabad, Gujarat under Gujarat University, Ahmedabad for Increase of seats in DM (Cardiology) course u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (11/02/2016) and compliance dated 21/03/2016 submitted by the college authorities and decided to verify compliance by way of Assessment.

12. Approval of the minutes of the Monitoring Sub-Committee meeting held on 08/02/2016 – Reg.

Read: the minutes of the Monitoring Sub-Committee meeting held on 08/02/2016.

The Postgraduate Medical Education Committee perused the minutes of the Monitoring Sub-Committee meeting held on 08/02/2016 and observed as under pointwise:

- 1. Approved.
- 2. Approved. If 50-50 seat sharing has to be done then it has to be subject-wise. Otherwise it has no meaning because 50% non-clinical seats will be left for the Govt. quota. Hence, decision on this issue may be expedited.
- 3. Approved.
- 4. Approved. However, a copy of the Hon'ble Supreme Court order be obtained which say that there will be no seat sharing in super-specialities. Decision may be got perused with legal expert.
- 5. It is not clear whether admissions referred in the item are in post M.B.B.S. Diploma course or in general Health Education course. This be verified from the institute. It should also be verified whether the same course is run for medical & non-medical graduates in combined manner. Procedure for withdrawal u/s 19 can be initiated only for post M.B.B.S. Diploma course upon receipt of such information. It is also not clear whether this institute is a medical college or not. Clarification be obtained.
- 6. Approved. The roaster will apply from the date of notification. We have been approving 15% NRI admission without entrance examination in the previous years. The same yardstick should be followed here also till the Monitoring Committee prepares the roaster and gets it approved by the General Body. That will be applicable from the date of approval and not retrospectively.
- 7. Approved.
- 8. Both DO & DA be approved. In future they will admit only recognized number of seats.
- Approved.
- 10. Approved.
- 11. It is stated that admissions are in contravention of PG Medical Education Regulations; however it is not stated whether they are in contravention of A.P. Govt. Rules, particularly with regard to at least 70 % of the total seats be filled from minority candidates or not. As these Rules have been promulgated by A.P. Govt. subsequent to order of Hon'ble Supreme Court in Pai Foundation case, it also needs to be examined whether these admissions are in accordance with Hon'ble Supreme Court orders or not.

Referred back with above observations to obtain information as mentioned above. Legal opinion from Law Officer may also be obtained in the matter. The matter be resubmitted after taking appropriate decision thereafter.

- 14. The dates of Letters of MCI have not been shown in the minutes. They be filled as per record.

- 15. Decision of sub-committee after PG Committee referred back the item has not been recorded in the minutes.

- 16. Approved. Also, authorities of A.P. & Telangana Governments be directed not to issue any order which are in contravention of Regulations which being Statutory Regulations are mandatory & binding in character and required to be followed

- by all the authorities. Instead of writing same decision in item 11 & 13 the exact decision should be written.

The State Govt. be directed to abolish reservation of teachers quota with immediate effect as it is not permissible as per Postgraduate Medical Education Regulations, 2000 of MCI. All students admitted under this quota should be discharged with a copy to the State Govt., University and State Medical Council.

- 21. Approved. However, correction in MCI records that how many seats are permitted should be done. Continuation of recognition inspection be done and number of seats should be fixed.

- 36. Approved. Monitoring Sub-Committee to confirm that 18 NRI seats fall within the limit of 15%.

the same paragraph the institution says 2 seats have been permitted for MD (Nuclear Medicine).

The college authorities be asked to supply proof of granting LOP for DRM and MD (Nuclear Medicine), number of students year-wise who has passed out DRM and proof that the college authorities have discontinued the DRM course (got it deleted from the schedule).

- 4. Dr. Jayshree N., Asst. Professor possesses qualification of M.S. (O.G.). Her period of fellowship in Gynaecological Oncology of 2 years is shown from July 2005 to July 2005 which is not feasible.
- 5. Dr. Vineetha Murali & Dr. Reshu Agarwal, both Senior Residents, do not have 3 years experience as Resident in the subject in medical college; hence not qualified to hold the post.
- 6. Details of books purchased in last 3 years in Departmental Library are not provided.
- 7. Other deficiencies as pointed out in the Assessment Report.

In view of the above, the Postgraduate Medical Education Committee decided to recommend to the Central Government not to grant letter of permission for Starting of M.Ch. - 5. Both the Senior Residents are MD (General Medicine) without 3 years experience as Junior Resident in a Medical College in Gastroenterology.
- 6. Other deficiencies as pointed out in the Assessment Report.
