1. <u>Minutes of the last meeting of the Postgraduate Medical Education</u> <u>Committee – confirmation of.</u>

No objection/observation made by any member of the Postgraduate Medical Education Committee. The minutes of the last meeting confirmed.

2. <u>Minutes of the last meeting of the Postgraduate Medical Education</u> <u>Committee – action taken thereon.</u>

Action has been taken on the minutes of the last meetings dated 24.05.2016, 03.06.2016, 17.06.2016, 01.07.2016, 12.07.2016, 26.07.2016 & 09.08.2016. Minutes of the remaining meetings dated 30.08.2016, 07.09.2016, 16.09.2016, 22.09.2016, 29.09.2016, 05.10.2016 and 13.10.2016 are still not received from the Oversight Committee.

Action will be taken on receipt of the Minutes from the Oversight Committee.

3. <u>Dr. N.T.R. University of Health Sciences, Vijaywada. A.P - Recognition</u> of MD(General Medicine) qualification against increased intake from 04 to 06 seats in respect of students being trained at Medicity Institute of Medical Sciences, Ghanpur.

Read: the Compliance Verification Assessment Report (08/06/2016) along with the Council Assessor's Report (May, 2015 & 11.03.2016) and compliance dated 09/04/2016 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(General Medicine) qualification against increased intake from 04 to 06 seats at Medicity Institute of Medical Sciences, Ghanpur granted by Dr. N.T.R. University of Health Sciences, Vijaywada. A.P.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (08/06/2016) along with the Council Assessor's Report (May, 2015 & 11.03.2016) and compliance dated 09/04/2016 submitted by the college authorities and decided to recommend not to recognize MD(General Medicine) qualification against increased intake from 04 to 06 seats granted by Dr. N.T.R. University of Health Sciences, Vijaywada. A.P in respect of students being trained at Medicity Institute of Medical Sciences, Ghanpur because of the following facts:-

- 1. Deficiency of faculty: (a) Asst. Prof.: 4.
- 2. Shortage of Senior Resident: 1. Only 3 Senior Residents were present during assessment against requirement of 4.
- 3. Dr. Faraz Farishta has been promoted as Assoc. Prof. after cut-off date on 01/10/2015; however one of the publications cited in the list is a review article which cannot be considered; resultantly there is only 1 research publication to his credit against requirement of 2; hence his promotion is not as per Regulations & he cannot be considered. Deficiency remains as it is.
- 4. Only 2 faculty were present in Units I, II during assessment; hence they cannot be considered as PG Units.
- 5. Only 1 faculty in Unit III & IV each was present; hence they cannot be considered as teaching Unit.
- 6. There is no Senior Resident in Unit IV.
- 7. Resultantly none of the Units qualifies as PG Unit.
- 8. Bed Occupancy was 12% on day of assessment.
- 9. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. increased intake from 4 to 6 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."

In case, the college authorities desire to submit compliance, same should be received in this office preferably within four weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

4. Dr. NTR. University of Health Sciences, Vijayawada - Recognition of MS(OBG) qualification against increased intake from 03 to 04 seats a in respect of students being trained at Kamineni Institute of Medical Sciences, Narketpally.

Read: the Compliance Verification Assessment Report (14/06/2016) along with the Council Assessor's Report (May, 2015 & 29.02.2016) and compliance dated 16/04/2016 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MS(OBG) qualification against increased intake from 03 to 04 seats a at Kamineni Institute of Medical Sciences, Narketpally granted by Dr. NTR. University of Health Sciences, Vijayawada.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (14/06/2016) along with the Council Assessor's Report (May, 2015 & 29.02.2016) and compliance dated 16/04/2016 submitted by the college authorities and decided to recommend to the Central Government that MS(OBG) qualification against increased intake from 03 to 04 seats a granted by Dr. NTR. University of Health Sciences, Vijayawada in respect of students being trained at Kamineni Institute of Medical Sciences, Narketpally be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

5. Pondicherry University, Puducherry - Recognition of MD/MS(OBG) qualifications against increased intake from 2 to 3 seats in respect of students being trained at Pondicherry Institute of Medical Sciences, Pondicherry.

Read: the Compliance Verification Assessment Report (17/06/2016) along with the Council Assessor's Report (April, 2015 & 29.02.2016) and compliance dated 26/04/2016 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD/MS(OBG) qualifications against increased intake from 2 to 3 seats at Pondicherry Institute of Medical Sciences, Pondicherry granted by Pondicherry University, Puducherry.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (17/06/2016) along with the Council Assessor's Report (April, 2015 & 29.02.2016) and compliance dated 26/04/2016 submitted by the college authorities and decided to recommend not to recognize MD/MS(OBG) qualifications against increased intake from 2 to 3 seats granted by Pondicherry University, Puducherry in respect of students being trained at Pondicherry Institute of Medical Sciences, Pondicherry because of the following facts:-

- 1. Dr. Mary Daniel, Prof. & HOD has been promoted as Professor after 3 years and 3 months as Assoc. Prof. against the requirement of 4 years; however in the column of "Benefit of publications" in the faculty table, it is stated "No" implying Nil publications against requirement of 4; hence her promotion is not as per Regulations & she cannot be considered.
- 2. Dr. Sneha Badwe Dhodopkar, Asst.Prof. was absent on day of assessment.

- 3. The institute authorities told that she had gone for university work, but there is no letter of invitation from the university appointing her examiner on that day.
- 4. Dr. Tahmina S, Asst. Prof. was absent on the day of assessment.
- 5. Bed Occupancy was 61 % on day of assessment at 10 a.m.
- 6. Nil Major Operation was listed on day of assessment. Average of last 14 days is 0.28/day which is grossly inadequate.
- 7. Average of Minor Operations for last 14 days is 0.5/day which is grossly inadequate.
- 8. OPD attendance on day of assessment was only 98 which is inadequate.
- 9. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. increased intake from 2 to 3 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."

In case, the college authorities desire to submit compliance, same should be received in this office preferably within four weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. Himachal Pradesh University - Recognition of MD(Anaesthesia) qualification against increased intake from 02 to 05 seats in respect of students being trained at Dr. Rajendar Prasad Government Medical College, Tanda, H.P.

Read: the Compliance Verification Assessment Report (06/06/2016) along with the Council Assessor's Report (July, 2015) and compliance dated 28/03/2016 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Anaesthesia) qualification against increased intake from 02 to 05 seats at Dr. Rajendar Prasad Government Medical College, Tanda, H.P granted by Himachal Pradesh University.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (06/06/2016) along with the Council Assessor's Report (July, 2015) and compliance dated 28/03/2016 submitted by the college authorities and decided to recommend not to recognize MD(Anaesthesia) qualification against increased intake from 02 to 05 seats granted by Himachal Pradesh University in respect of students being trained at Dr. Rajendar Prasad Government Medical College, Tanda, H.P because of the following facts:-

1. Deficiency of faculty: Asst. Prof.: 1.

2. Promotion of Dr. Jai Singh, Professor, is not as per regulations. He was promoted on 30.03.2015 after the cut-off date. There are no publications to his credit mentioned in the faculty table.

- 3. Promotion of Dr. R.K. Verma, Professor, is not as per regulations. He was promoted on 05.12.2014 after the cut-off date without any publications.
- 4. Promotion of Dr. Bharti Gupta, Assoc.Prof. is not as per regulations. She was promoted on 10.03.2015 after the cut-off date without any publications.
- 5. Dr. Usha Chaudhary, Asst.Prof. is basically Medical Officer (Zonal Hospital at Dharamshala). She has been deployed only temporarily in the college as Asst.Prof., which cannot be accepted. There is no letter from Competent Authority deputing her for any training on the day of assessment (as communicated by the Dean).
- 6. Central O₂ and Central Suction are still not available. Deficiency remains as it is.
- 7. MRI was not functional on day of assessment.
- 8. Dean has refused to sign SAF Part II.
- 9. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. increased intake from 02 to 05 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. 7. Delhi University, Delhi - Recognition of MD(General Medicine) qualification against increased intake from 5 to 11 seats in respect of students being trained at Army Hospital Research & Referral, New Delhi.

Read: the Compliance Verification Assessment Report (06/06/2016) along with the Council Assessor's Report (April, 2015) and compliance dated 28/04/2016 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(General Medicine) qualification against increased intake from 5 to 11 seats at Army Hospital Research & Referral, New Delhi granted by Delhi University, Delhi.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (06/06/2016) along with the Council Assessor's Report (April, 2015) and compliance dated 28/04/2016 submitted by the college authorities and decided to recommend not to recognize MD(General Medicine) qualification against increased intake from 5 to 11 seats granted by Delhi University, Delhi in respect of students being trained at Army Hospital Research & Referral, New Delhi because of the following facts:-

1. As per regulations requirement for giving equated teaching designations in Army Hospital is as follows:-

- (i) Professor: 4 years, experience as Graded Specialist/Classified Specialist and holding rank of Advisor/Sr.Advisor.
- (ii) Assoc.Prof.: 5 years experience as Graded Specialist/Classified Specialist; the person must have worked in hospitals listed in the list approved for teaching hospitals of defence services.
- (iii) The following faculty members are not eligible to hold the teaching designations they have been given.
- Col.(Dr.) A.K.Sood, Professor : He was Graded/Classified Specialist for 2 years 11 months against the requirement of 4 years when he became Advisor. His period at PGI, Chandigarh cannot be counted in Medicine Department since he was DM(Gastroenterology) student during this period.
- 3. Col.(Dr.) Rajan Kapoor, Professor: He is not designated Advisor without which he cannot be given equated teaching designation of Professor. He is only Classified Specialist. Hence not eligible.
- 4. Lt. Col. M. Manrai, Assoc.Prof.: He is Graded/Classified Specialist for 2 years and 3 months against the requirement of 5 years. His period at PGI Chandigarh cannot be counted in Medicine Department. He was working as DM student in the subject of Gastroenterology at that time.
- 5. Resultantly, Unit-I & III do not have complete teaching complement and they cannot be considered as PG unit.
- 6. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. increased intake from 05 to 11 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

Read: the Compliance Verification Assessment Report (20/06/2016) along with the Council Assessor's Report (July, 2015) and compliance dated 03/04/2016 submitted by the college authorities on the standard of examination and other teaching facilities for Renewal of recognition of MD(General Medicine) qualification for 4 seats at Government Medical College, Thrissur granted by Kerala University of Health Sciences, Thrissur.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (20/06/2016) along with the Council Assessor's Report (July, 2015) and compliance dated 03/04/2016 submitted by the college authorities and decided to recommend not to renew the recognition of MD(General Medicine) qualification for 4 seats granted by Kerala University of

Health Sciences, Thrissur in respect of students being trained at Government Medical College, Thrissur because of the following facts:-

- 1. Dr. Vinu Thomas is promoted as Professor after cut-off date; however the column of "Benefit of publications" in the faculty table has been left blank implying NIL publications against requirement of 4; hence his promotion is not as per Regulations& he cannot be considered.
- 2. Dr. Usha Naga Devi is shown as Asst. Prof. in Unit M 2; however her academic qualification is shown as M.B;B.S.; hence not qualified to hold the post.
- 3. Resultantly faculty complement is incomplete in Unit M 2 & it cannot be considered as PG Unit.
- 4. Dr. Rosy Philip is promoted as Assoc. Prof. after cut-off date; however the column of "Benefit of publications" in the faculty table has been left blank implying NIL publications against requirement of 2; hence her promotion is not as per Regulations & she cannot be considered.
- 5. Dr. Shajit Sadanand is promoted as Assoc. Prof. after cut-off date; however the column of "Benefit of publications" in the faculty table has been left blank implying NIL publications against requirement of 2; hence his promotion is not as per Regulations & he cannot be considered.
- 6. Dr. Jijith Krishnan is shown as "Asst. Prof." in the column of "Designation" in the faculty table; however in the column of experience, it is shown as "Asso. Prof." w.e.f. 02/09/2013 till date. This discrepancy needs to be clarified.
- 7. There is no Senior Resident in Units M 4 & M 5.
- 8. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. 04 seats till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. This is also clarified in the letter of recognition granted u/s 11(2) of the IMC Act, 1956 issued for these seats, which reads as under:

9. <u>Kerala University of Health Sciences, Thrissur - Renewal of recognition</u> of MS(Orthopaedics) qualification for 3 seats and Recognition against increased intake from 03 to 09 seats in respect of students being trained at Government Medical College, Thrissur.

Read: the Compliance Verification Assessment Report (10/06/2016) along with the Council Assessor's Report (July, 2015) and compliance dated 03/04/2016 submitted by the college authorities on the standard of examination and other teaching facilities for Renewal of recognition of MS(Orthopaedics) qualification for 3 seats and Recognition against increased intake from 03 to 09 seats at Government Medical College, Thrissur granted by Kerala University of Health Sciences, Thrissur.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (10/06/2016) along with the Council Assessor's Report (July, 2015) and compliance dated 03/04/2016 submitted by the college authorities and decided to recommend not to renew the recognition of MS(Orthopaedics) qualification for 3 seats and not to recognize against increased intake from 03 to 09 seats granted by Kerala University of Health Sciences, Thrissur in respect of students being trained at Government Medical College, Thrissur because of the following facts:-

- 1. Dr. Tomsee Anil is promoted as Asso. Prof. after cut-off date; however the column of "Benefit of publications" in the faculty table has been left blank implying NIL publications against requirement of 2; hence his promotion is not as per Regulations & he cannot be considered.
- 2. Date of promotion as Asso. Prof. of Dr. C.V. Krishnakumar is not shown in the faculty table; hence it is not possible to verify whether his promotion is as per Regulations or not.
- 3. Promotion of Dr. M.K. Manoj, Asso. Prof. is not as per regulations. He was promoted after the cut-off date. However, one of his publications is in state journal, which cannot be considered.
- Dr. Chetan J. Wankede, Senior Resident in Unit I does not have any experience as Resident before appointment as Senior Resident; hence not qualified to hold the post. There is no other Senior Resident in the Unit.
- 5. Dr.Prabhakaran, Senior Resident in Unit II does not have any experience as Resident before appointment as Senior Resident; hence not qualified to hold the post.
- 6. Central Research Laboratory is not yet functional.
- 7. Investigative facilities like Nerve Conduction, EMG are not yet available.
- 8. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. 03 seats till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. Read: the Compliance Verification Assessment Report (10/06/2016) along with the Council Assessor's Report ((June, 2013 and July, 2015)) and compliance dated 03/04/2016 submitted by the college authorities on the standard of examination and other teaching facilities for Renewal of recognition of MS(General Surgery) qualification for 4 seats and Recognition against increase intake from 5 to 8 seats at Government Medical College, Thrissur granted by Kerala University of Health Sciences, Thrissur.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (10/06/2016) along with the Council Assessor's Report ((June, 2013 and July, 2015)) and compliance dated 03/04/2016 submitted by the college authorities and decided to recommend not to renew the recognition of MS(General Surgery) qualification for 4 seats and not to recognize against increase intake from 5 to 8 seats granted by Kerala University of Health Sciences, Thrissur in respect of students being trained at Government Medical College, Thrissur because of the following facts:-

- Dr. K.N. Further his academic qualification is shown as M.B;B.S. which is not adequate for being appointed as Lecturer. There is no other Sr.Resident in Unit-II.
- 2. Dr. P. Ajeesh, Senior Resident in Unit 3 does not have any experience as Resident before appointment as Senior Resident; hence not qualified to hold the post. No other Sr. Resident in the Unit.
- Promotion of Dr. Vishnu Kumar, Assoc.Prof. is not as per regulations. He was promoted after the cut-off date without any publications. Resultantly, Unit left with 2 Asst.Prof. only and it cannot be considered a PG Unit.
- 4. There are 2 O.T. Tables in 1 O.T. which is not as per norms.
- 5. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. 04 till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. 79. <u>Kerala University of Health Sciences, Thrissur/ Kerala University -</u> <u>Recognition of MS(Orthopaedics) qualification for 2 seats in respect of</u> <u>students being trained at Jubilee Mission Medical College & Research</u> <u>Institute, Kerala.</u>

Read: the Compliance Verification Assessment Report (23/09/2016) along with the Council Assessor's Report (July, 2015 & 10.03.2016) and compliance dated 25/04/2016 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MS(Orthopaedics) qualification for 2 seats at Jubilee Mission Medical College & Research Institute, Kerala granted by Kerala University of Health Sciences, Thrissur/ Kerala University.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (23/09/2016) along with the Council Assessor's Report (July, 2015 & 10.03.2016) and compliance dated 25/04/2016 submitted by the college authorities and decided to recommend not to recognize MS(Orthopaedics) qualification for 2 seats granted by Kerala University of Health Sciences, Thrissur/ Kerala University in respect of students being trained at Jubilee Mission Medical College & Research Institute, Kerala because of the following facts:-

- Deficiency of promotion of Dr. Girish Kumar as Professor being not as per Regulations remains as it is. Although he is promoted after cut-off date; he does not have 4 publications to his credit required as per Regulations. He cannot be considered as Assoc. Prof. unless appropriate order is issued by the institute & fresh joining report is provided with D.F. Hence he cannot be considered as faculty.
- 2. Resultantly there are only 2 faculty in Unit 2 & it cannot be considered as PG Unit.
- 3. OPD on day of assessment is only 78.
- 4. Other deficiencies as pointed out in the assessment report.

- 1. None of the faculty has 2 years special training in IHBT or PG degree in IHBT. Hence they are not eligible to hold the post they are occupying.
- 2. Coagulation Tests are still done in department of Pathology and not in IHBT Department.
- 3. Other deficiencies as pointed out in the assessment report.

- 1. Dr. Meenakshi Girish, Assoc. Prof. in Unit 2 was absent on day of assessment; resultantly there are only 2 faculty, both of whom are Asst. Prof. & the Unit cannot be considered as teaching Unit.
- 2. Institute has amended orders of Residency of Dr. Archana Jaiswal & Dr. Ashish Vaidya with retrospective effect so as to make them eligible for post of Senior Resident which is not permissible. Hence deficiency continues to remain as such.
- 3. Bed Occupancy is 50 % (i.e. 44 /90 beds) on day of assessment.
- 4. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. 02 seats till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. 1. PG degrees of Dr. C. Harihar, Professor & HOD and Dr. Y. Sanjay, Asso. Prof. are not recognized. 2. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. 01 seat after the first batch appeared in Examination till their recognition will be irregular/illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. - 3. Dr. G. Ravi Babu is promoted as Asso. Prof. after cut-off date; however in the column of "Benefit of publications" in the faculty table, it is stated "No" implying NIL publications against requirement of 4; hence her promotion is not as per Regulations & she cannot be considered.
- 4. Details of Senior Residents are not provided in the faculty table.
- 5. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. increased intake from 04 to 05 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. - 1. Although permission for conducting medico-legal post-mortems has been granted, police has not yet sent any dead body for medico-legal post-mortem as yet.
- Note initiated by the IGP shows that police may be permitted to refer dead bodies to the institute except in sensitive cases such as murder, rape cum murder, deaths within 7 years of marriage, etc. This would imply that material available at the institute for PG training would be extremely limited and inadequate.
- 3. Medico-legal workload of all parameters continues to remain NIL at this institute. Deficiency persists.
- 4. Other deficiencies as pointed out in the assessment report.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (26/09/2016) along with the Council Assessor's Report (June, 2014 & 01.04.2016) and compliance dated 09/06/2016 submitted by the college authorities and decided to recommend not to recognize MD(Pathalogy)qualification for 04 seats granted by Baba Farid University of Health Sciences, Faridkot in respect of students being trained at Adesh Institute of Medical Sciences & Research, Bhatinda because of the following facts:-

- 1. Deficiency of promotion of Dr. Vijay Suri not being as per Regulations remains as it is. He was promoted as Professor with experience of only 3 y against requirement of 4 y as per Regulations. Further in the column of "Benefit of publications", it is stated "No" implying Nil publications against requirement of 2 as per Regulations. When he was promoted as Professor on 23/10/2009, the criteria of 2 research publications was already notified in the Gazette of India; hence he could not have been promoted without any publications; hence his promotion is not as per Regulations & he cannot be considered.
- 2. Dr. R.K. Vijay, Professor does not have proper residence proof. There is no evidence in teaching register that he is regularly teaching students; hence it is doubtful that he is a regular employee of the college.
- 3. In previous assessment experience as Asst. Prof. of Dr. Kuldeep Singh was shown from 01/04/2007 to 19/08/2011 i.e. 4 y 4 m only at this institute against requirement of 5 y. When this deficiency has been pointed out, in the present assessment it is shown from 07/07/2006 to 17/02/2007 & from 01/04/2007 to 19/08/2011 to make total experience of 5 y so as to make him eligible. No satisfactory explanation is provided as to how the experience from 07/07/2006 to 17/02/2007 was not included in previous assessment.
- 4. Other deficiencies as pointed out in the assessment report.

- Dr. Ajay K. Khandal is promoted as Assoc. Prof. after cut-off date; however in the column of "Benefit of publications" in the faculty table, it is stated "No" implying Nil publications against requirement of 2; hence his promotion is not as per Regulations & he cannot be considered.
- 2. Promotion of Dr. G.Deepa, Assoc.Prof., is not as per regulations. She was Asst.Prof. for 4 years against the requirement of 5 years and promoted on 22.06.2016 after the cut-off date. She has no publications.
- 3. Other deficiencies as pointed out in the assessment report.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (23/09/2016) along with the Council Assessor's Report (June, 2015) and compliance dated 16/04/2016 submitted by the college authorities and decided to recommend to the Central Government that MD(Physiology) qualification against increased intake from 05 to 07 seats granted by Ranchi University in respect of students being trained at Rajendra Institute of Medical Sciences, Ranchi be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (23/09/2016) along with the Council Assessor's Report (May, 2015 & 04.03.2016) and compliance dated 26/04/2016 submitted by the college authorities and decided to recommend not to recognize MS(General Surgery) qualification against increased intake from 01 to 02 seats granted by West Bengal University of Health Sciences, Kolkata in respect of students being trained at Vivekananda Institute of Medical Sciences, Kolkata because of the following facts:-

- 1. Dr. Himadri Sengupta, Prof.&HoD, was not available on the day of assessment.
- 2. There are only 2 Units against requirement of 3 as per Regulations.

- 5. Dr. Abhyday Verma, Assoc. Prof. in Unit VI has been promoted as Assoc. Prof. after cut-off date; however out of 2 publications cited in the

list, 1 appears to be a review article and 2nd one is related with Paediatrics & not with General Medicine; resultantly there is NIL research publication in the subject against requirement of 2; hence his promotion is not as per Regulations & he cannot be considered.

- 8. Other deficiencies as pointed out in the assessment report.

In view of the above, the Postgraduate Medical Education Committee decided to recommend to the Central Government not to grant letter of permission for Increase of seats in MD (TB & Chest) course at Index Medical College, Hospital & Research Centre, Indore, Madhya Pradesh under Malwanchal University, Indore u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

119. Increase of seats in MD (Skin & VD) course at Index Medical College, Hospital & Research Centre, Indore, Madhya Pradesh under Malwanchal University, Indore U/s 10(A) of the IMC Act, 1956 for the academic year 2017-18.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (07/10/2016) and noted the following:

- 1. There are 2 Units which require total 6 faculty @ 3/Unit. However total only 4 faculty are available & present during assessment; thus there is deficiency of faculty: (a) Asst. Prof.: 2.
- 2. Unit II has only 2 faculty; hence it cannot be considered as PG Unit.
- 3. There is no Senior Resident in any Unit.
- 4. Promotion of Dr. Parikshit Sharma, Assoc.Prof. is not as per regulation. He was Asst.Prof. 4 year 2 months against the requirement of 5 years and he has no publications.

- 5. Although 2 Units are shown, all the available faculty is shown in Unit I in the faculty table; thus no faculty is shown for Unit II. It is not clear how a Unit runs in absence of faculty & Residents.
- 6. Procedures like Skin Grafting procedures, Nail Surgery are not done in the department.
- 7. There is no participation in National Leprosy Control Programme, HIV/AIDS Programme.
- 8. Other deficiencies as pointed out in the assessment report.

In view of the above, the Postgraduate Medical Education Committee decided to recommend to the Central Government not to grant letter of permission for Increase of seats in MD (Skin & VD) course at Index Medical College, Hospital & Research Centre, Indore, Madhya Pradesh under Malwanchal University, Indore u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

120. Increase of seats in MS (Orthopaedics) course at Index Medical College, Hospital & Research Centre, Indore, Madhya Pradesh under Malwanchal University, Indore U/s 10(A) of the IMC Act, 1956 for the academic year 2017-18.

Read: the Council Assessor's Report (07/10/2016) for Increase of seats in MS (Orthopaedics) course at Index Medical College, Hospital & Research Centre, Indore, Madhya Pradesh under Malwanchal University, Indore U/s 10(A) of the IMC Act, 1956 for the academic year 2017-18 in pursuance to the order dated 03/10/2016 passed by the Hon'ble Supreme Court of India in W.P.(C) No. 687/2016.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (07/10/2016) and noted the following:

- 1. At Item § 5 of Summary, it is stated that there are 4 Units with 120 beds. At Item §29 of Summary it is stated there are 5 Units with 150 beds. Faculty table gives only 4 units.
- 2. Dr. Vinay Tantuway is promoted as Professor after cut-off date; however in the column of "Benefit of publications" in the faculty table, it is stated "No" implying Nil publications against requirement of 4; hence his promotion is not as per Regulations & he cannot be considered.
- 3. Dr. Gaurav Sahu is shown as Senior Resident in Unit III at # 4 & also at # 5. At # 4, it shown that he has passed M.B;B.S. examination in 2007; at # 5 it is shown that he has passed M.B.B.S. examination in 2013. PAN numbers are also different. This discrepancy needs to be clarified.
- 4. Other deficiencies as pointed out in the assessment report.

In view of the above, the Postgraduate Medical Education Committee decided to recommend to the Central Government not to grant letter of permission for Increase of seats in MS (Orthopaedics) course at Index Medical College, Hospital & Research Centre, Indore, Madhya Pradesh under Malwanchal University, Indore u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

121. Increase of seats in MD (Radio-Diagnosis) course at Index Medical College, Hospital & Research Centre, Indore, Madhya Pradesh under Malwanchal University, Indore U/s 10(A) of the IMC Act, 1956 for the academic year 2017-18.

Read: the Council Assessor's Report (07/10/2016) for Increase of seats in MD (Radio-Diagnosis) course at Index Medical College, Hospital & Research Centre, Indore, Madhya Pradesh under Malwanchal University, Indore U/s 10(A) of the IMC Act, 1956 for the academic year 2017-18 in pursuance to the order dated 03/10/2016 passed by the Hon'ble Supreme Court of India in W.P.(C) No. 687/2016.

- 1. Faculty deficiency: Asst.Prof. -1 & Senior Residents: 3.
- 2. Promotion of Dr. Kumud Julka, Assoc.Prof. is not as per regulation. She was promoted on 23.02.2015 after the cut-off date. One of the 2 publications is not related to Radio-diagnosis.
- 3. Dr. Anoop Gupta, Asst.Prof. was absent on the day of assessment.
- 4. Space for faculty & office needs drastic improvement.
- 5. Other deficiencies as pointed out in the assessment report.

In view of the above, the Postgraduate Medical Education Committee decided to recommend to the Central Government not to grant letter of permission for Increase of seats in MD (Radio-Diagnosis) course at Index Medical College, Hospital & Research Centre, Indore, Madhya Pradesh under Malwanchal University, Indore u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

122. Increase of seats in MD (Pharmacology) course at Index Medical College, Hospital & Research Centre, Indore, Madhya Pradesh under Malwanchal University, Indore U/s 10(A) of the IMC Act, 1956 for the academic year 2017-18.

- Dr. Suraj Tripathi is promoted as Professor after cut-off date; however in the column of "Benefit of publications" in the faculty table, it is stated "No" implying Nil publications against requirement of 4; hence his promotion is not as per Regulations &he cannot be considered.
- Promotion of Dr. Prem Nyati, Prof. & Head, is not as per regulations. He was Assoc.Prof. 3 years against the requirement of 4 years, he has no publications.
- 4. Other deficiencies as pointed out in the assessment report.

In view of the above, the Postgraduate Medical Education Committee decided to recommend to the Central Government not to grant letter of permission for Increase of seats in MD (Pharmacology) course at Index Medical College, Hospital & Research Centre, Indore, Madhya Pradesh under Malwanchal University, Indore u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

123. Increase of seats in MD (Community Medicine) course at Index Medical College, Hospital & Research Centre, Indore, Madhya Pradesh under Malwanchal University, Indore U/s 10(A) of the IMC Act, 1956 for the academic year 2017-18.

Read: the Council Assessor's Report (07/10/2016) for Increase of seats in MD (Community Medicine) course at Index Medical College, Hospital & Research Centre, Indore, Madhya Pradesh under Malwanchal University, Indore U/s 10(A) of the IMC Act, 1956 for the academic year 2017-18 in pursuance to the order dated 03/10/2016 passed by the Hon'ble Supreme Court of India in W.P.(C) No. 687/2016.

- 1. Deficiency of faculty: (a) Asst. Prof.: 1.
- 2. Promotion of Dr. Jayshree Bute, Assoc. Prof. is not as per regulations. She was promoted in January, 2016 after the cut-off date and she was Assoc.Prof. for 3 years 5 months against the requirement of 4 years. Out of 4 publications quoted, one article has been published twice. Resultantly, only 3 publications against the requirement of 4.
- 3. RHTC: Cold chain equipment is not available.
- 4. Other deficiencies as pointed out in the assessment report.

In view of the above, the Postgraduate Medical Education Committee decided to recommend to the Central Government not to grant letter of permission for Increase of seats in MD (Community Medicine) course at Index Medical College, Hospital & Research Centre, Indore, Madhya Pradesh under Malwanchal University, Indore u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

124. Evaluation of answer book of MD/MS examination by E-checking – reg.

Read: the E-mail dated 27/09/2016 received from Ms. Shivangi Sharma, Advocate and associate of Sh. Manpreet Singh Longia, Standing Counsel of MCI in the Hon'ble High Court of Punjab & Haryana at Chandigarh and petition received in the case of D. Raj Bahadur Singh and other v/s Medical Council of India and ors in CWP No. 18429 of 2016 in the Hon'ble Punjab and Haryana High Court at Chandirgarh from the Asst. Registrar, Hon'ble High Court with regard to evaluation of answer book of MD/MS examination by e-checking.

The Postgraduate Committee considered the E-mail dated 27/09/2016 received from Ms. Shivangi Sharma, Advocate and associate of Sh. Manpreet Singh Longia, Standing Counsel of MCI in the Hon'ble High Court of Punjab & Haryana at Chandigarh and petition received in the case of D. Raj Bahadur Singh and other v/s Medical Council of India and ors in CWP No. 18429 of 2016 in the Hon'ble Punjab and Haryana High Court at Chandirgarh from the Asst. Registrar, Hon'ble High Court with regard to evaluation of answer book of MD/MS examination by e-checking mode.

The Committee after perusal of relevant provisions of Postgraduate Medical Education Regulations, 2000 noted that the Medical Council of India Regulations have not spelt out the modalities for evaluation. This aspect is left to the wisdom of the university authorities concerned.
