Read: the Council Assessor's Report (18/09/2017) for Increase of seats in MS (Otorhinolaryngology) course at Dr. B.R. Ambedkar Medical College & Hospital, Bangalore under Rajiv Gandhi University of Health Sciences, Karnataka U/s 10(A) of the IMC Act, 1956 for the academic year 2018-19.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (18/09/2017) and noted the following:

- 1. Promotion of Dr. M. Muniraju, Professor & HOD, is not as per regulation. He was promoted on 11.05.2017 after the cut off date. He has 3 publications against the required 4. The 4th one is quoted is a case report which cannot be considered.
- 2. Promotion of Dr.C.V. Srinivas, Professor, is not as per regulation. He was promoted on 11.05.2017 after the cut off date. He has only 2 publications against the requirement of 4.
- 3. There is a decrease in day care operation from 1728 in 2015 to 1450 in 2016.
- 4. On the day of assessment BERA was only 1 and average of 3 random days was also only one.
- 5. Total number of IPD patients has decreased from 1,777 in 2014 to 1,724 in 2016.
- 6. Range of Operative procedures is not adequate. Total workload in 3 years of Operations like Laryngectomy is only 01 and of Laryngo/Tracheoplasty; Angiofibroma; Maxillectomy is only 02.
- 7. Attendance at Specialty clinics like Cancer related clinic; otology related clinic is low: 2-4 cases/clinic.
- 8. Other deficiencies as pointed out in the Assessment Report.

In view of the above, the Postgraduate Medical Education Committee decided to recommend to the Central Government not to grant letter of permission for Increase of seats in MS(Otorhinolaryngology) course at Dr. B.R. Ambedkar Medical College & Hospital, Bangalore under Rajiv Gandhi University of Health Sciences, Karnataka u/s 10A of the IMC Act, 1956 for the academic year 2018-19.

- 2. On day of assessment, only 1 Senior Resident, Dr. Pankaj P. Sanghvi was present; however as he does not have 3 y experience as Resident in a teaching hospital before appointment as Senior Resident; he is not qualified to hold the post. Resultantly there is no eligible Senior Resident in the Unit.
- 3. Shortage of Residents: (a) Senior resident: 1; (b) Junior Resident: 1.
- 4. Only faculty member is part time.

- 5. Bed Occupancy on day of assessment was 35 %. Average Bed occupancy is 60 % which also is inadequate.
- 6. Specialty clinics like Clinic for Senile Disorder, Psycho motor clinic are not run.
- 7. Documentation is poor & no records of Specialty clinics and ECT are maintained.
- 8. Community Helpline is not available.
- 9. There is no participation in National Mental Health Programme.
- 10. OPD lacks proper facility for patient workup.
- 11. OPD and Ward had very few patients on assessment day.
- 12. Male & female wards are not properly arranged. They lack safety, security & sanitation.
- 13. Departmental library is not available. In Central library, there is only 1 journal. Latest journals available are upto December, 2016 only. No journals for the year 2017.
- 14. In the column "Stipend paid in Govt. Colleges by State Govt. to residents", it is stated as Rs. 32,000; Rs. 37,000 & Rs. 42,000 p.m. respectively to I/II/III year Residents which is not correct. Institute has proposed the same amount as stipend to Residents which implies that stipend paid to Residents will be less than that paid by State Govt. which is contrary to PG Regulations. Further, by showing that the same amount is paid by State Govt. to Residents is an attempt to mislead the Council.
- 15. Other deficiencies as pointed out in the Assessment Report.

- 3. There were only 2 deliveries and nil Caesarean Section on day of assessment.
- 4. ART is not available.
- 5. Total number of Operative deliveries has decreased from 32 in 2014 to 21 in 2016.
- 6. Total number of Caesarean Sections has decreased from 754 in 2014 to 704 in 2016.
- 7. The Patient's attendants were made to lie on the patient's beds and shown as patients, so the actual number of patients were only 32.
- 8. There are total of only 2-3 MTP's per month and 5 to 6 tubal ligation as per records sent to the government authorities.
- 9. Other deficiencies as pointed out in the Assessment Report.

In view of the above, the Postgraduate Medical Education Committee decided to recommend to the Central Government not to grant letter of permission for Increase of seats in MS(Obstetrics & Gynaecology) course at Rohilkhand Medical College & Hospital, Bareilly, Uttar Pradesh under Bareilly International University u/s 10A of the IMC Act, 1956 for the academic year 2018-19.

23. Inclusion of M.Ch. (Paediatric Orthopaedics) course in the regulations of the Council on Postgraduate Medical Education Regulations, 2000.

Read: the letter dated 12/09/2017 received from the Under Secretary, to the Government of India, Ministry of Health & Family Welfare, New Delhi with regard to Inclusion of M.Ch. (Paediatric Orthopaedics) course in the regulations of the Council on Postgraduate Medical Education Regulations, 2000.

The Postgraduate Medical Education Committee considered the letter dated 12/09/2017 received from the Under Secretary, to the Government of India, Ministry of Health & Family Welfare, New Delhi with regard to inclusion of MS (General Surgery) course as prior qualification for M.Ch.(Paediatric Orthopaedics).

In Postgraduate Medical Education Regulations, 2000 MS(General Surgery) is not a prescribed qualification for MS(Orthopaedics). Hence it cannot be considered as a Pre qualification for M.Ch. (Paediatrics Orthopaedics) which is a super-speciality of Orthopaedics. Hence, MS(Orthopaedics) will be the only Pre qualification for M.Ch. (Paediatrics Orthopaedics).

The minutes of the agenda items of this meeting are read out and confirmed in the meeting itself.
