The Postgraduate Medical Education Committee confirmed the minutes of the Postgraduate Medical Education Committee meeting held on 24/01/2018.

#### 2. <u>Minutes of the last meeting of the Postgraduate Medical Education</u> <u>Committee – action taken thereon.</u>

The Postgraduate Medical Education Committee noted the Action Taken Report on the minutes of the Postgraduate Medical Education Committee meeting held on 24/01/2018. The Postgraduate Committee noted that the number of seats against item no. 60 for recognition of DLO qualification at Darbhanga Medical College, Lehriasarai has not been mentioned in its decision taken at its meeting held on 24.01.2018. The decision be read corrected as under:-

"The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (27/11/2017) along with the Council Assessor's Report (May, 2014) and compliance dated 04/09/2017 submitted by the college authorities and decided to recommend to the Central Government that DLO for **8(Eight)** seats granted by LN Mithila University/Aryabhatta Knowledge University, Patna in respect of students being trained at Darbanga Medical College, Lehriasarai be recognized and included in the 1st Schedule to the I.M.C. Act, 1956."

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (04/01/2018) along with the Council Assessor's Report (June, 2017) and compliance dated 14/09/2017 submitted by the college authorities and decided to recommend to the Central Government that MD(Radio Diagnosis/Radiology) qualification against increased intake from 01 to 03 seats granted by Dr. NTR University of Health Sciences, Vijayawada, A.P. in respect of students being trained at Kurnool Medical College, Kurnool be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

#### 4. Dr. NTR University of Health Sciences, Vijayawada, A.P. - Recognition of MS(General Surgery) qualification against increased intake from 05 to 10 seats in respect of students being trained at Kurnool Medical College, Kurnool.

Read: the Compliance Verification Assessment Report (04/01/2018) along with the Council Assessor's Report (May, 2017) and compliance dated 14/09/2017 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MS(General Surgery) qualification against increased intake from 05 to 10 seats at Kurnool Medical College, Kurnool granted by Dr. NTR University of Health Sciences, Vijayawada, A.P..

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (04/01/2018) along with the Council Assessor's Report (May, 2017) and compliance dated 14/09/2017 submitted by the college authorities and decided to recommend not to recognize MS(General Surgery) qualification against increased intake from 05 to 10 seats granted by Dr. NTR University of Health Sciences, Vijayawada, A.P. in respect of students being trained at Kurnool Medical College, Kurnool because of the following facts:-

- 1. On the day of assessment bed occupancy was 62.9%
- 2. Dr.K Venkatesh, Prof, was not present on the day of assessment.
- 3. Dr. K Karimulla, Sr.Resident, Unit II, was not present on the day of assessment. There is no other Sr. Resident in unit-II.
- 4. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. increased intake from 05 to 10 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."

In case, the college authorities desire to submit compliance, same should be received in this office preferably within four weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

#### 5. <u>Maharashtra University of Health Sciences, Nashik - Renewal of</u> recognition of MD(General Medicine) qualification for 04 seats in respect of students being trained at A.C.P.M.Medical College, Dhule.

Read: the Compliance Verification Assessment Report (28/12/2017) along with the Council Assessor's Report (May, 2015 & 03.03.2016 & 23.09.2016 & 07.04.2017) and compliance dated 20/09/2017 submitted by the college authorities on the standard of examination and other teaching facilities for Renewal of recognition of MD(General Medicine) qualification for 04 seats at A.C.P.M.Medical College, Dhule granted by Maharashtra University of Health Sciences, Nashik.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (28/12/2017) along with the Council Assessor's Report (May, 2015 & 03.03.2016 & 23.09.2016, 07.04.2017) and compliance dated 20/09/2017 submitted by the college authorities and decided to recommend not to renew the recognition of MD(General Medicine) qualification for 04 seats granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at A.C.P.M.Medical College, Dhule because of the following facts:-

<sup>1.</sup> There is shortage of faculty: Asst.Prof.-3, Sr. Resident -3.

- 2. Dr. Dilip R Patil, Prof. & HoD was not available on the day of assessment. There is no conference attending certificate attached.
- 3. Dr. Prashant P More and Dr. Dipak A Khore, Asstt. Prof. are DNB from non-teaching. They have no 3 Years Experience as Jr. Resident in a medical college when appointed first as Sr. Resident & later as Asstt Prof. Hence not eligible.
- 4. Unit-I : only one Asstt. Prof present
- 5. Unit-II : only 2 faculty. No SR
- 6. Unit-III : No SR
- 7. Unit-IV : only 2 faculty. No SR
- 8. OPD was 80 on the day of assessment.
- 9. Bed occupancy was 51% on the day of assessment.
- 10. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. 4 seats till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. This is also clarified in the letter of recognition granted u/s 11(2) of the IMC Act, 1956 issued for these seats, which reads as under:

"...the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (10/01/2018) along with the Council Assessor's Report (June, 2017) and compliance dated 27/09/2017 submitted by the college authorities and decided to recommend to the Central Government that MD(Radio Diagnosis/Radiology) qualification against increased intake from 04 to 08 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at M S Ramaiah Medical College, Bangalore be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

#### 7. <u>West Bengal University of Health Sciences, Kolkata - Renewal of</u> recognition of MS(General Surgery) qualification for 4 seats in respect of students being trained at Command Hospital, Kolkata.

Read: the Compliance Verification Assessment Report (05/01/2018) along with the Council Assessor's Report (July, 2016) and compliance dated 31/01/2017 submitted by the college authorities on the standard of examination and other teaching facilities for Renewal of recognition of MS(General Surgery) qualification for 4 seats at Command Hospital, Kolkata granted by West Bengal University of Health Sciences, Kolkata.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (05/01/2018) along with the Council Assessor's Report (July, 2016) and compliance dated 31/01/2017 submitted by the college authorities and decided to recommend not to renew the recognition of MS(General Surgery) qualification for 4 seats granted by West Bengal University of Health Sciences, Kolkata in respect of students being trained at Command Hospital, Kolkata because of the following facts:-

- 1. Dr. Manish Sharma is shown Assoc Prof. in column of designation and Asstt Prof from June 2015 till date in column of experience.
- 2. Dr. SK Sengupta Assoc Prof : He was Asstt Prof only for 1 year 2 Months against the requirement of 4/5 yrs. Hence not eligible.
- 3. Only 2 units, each with 60 beds. Required unit 3. 60 Beds in each unit is not as per MCI regulations. Institutions having only PG courses have to fulfill requirement of 50 UG seats. Hence 3 units needed.
- 4. On the day of assessment clinical material of Surgery Deptt (OPD, IPD) not given.
- 5. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. 4 seats till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. This is also clarified in the letter of recognition granted u/s 11(2) of the IMC Act, 1956 issued for these seats, which reads as under:

"...the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

Read: the Compliance Verification Assessment Report (04/01/2018) along with the Council Assessor's Report (April, 2014 & 10.03.2017) and compliance dated 29/09/2017 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(General Medicine) qualification against increased intake from 14 to 22 seats at Maulana Azad Medical College, New Delhi granted by University of Delhi, Delhi.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (04/01/2018) along with the Council Assessor's Report (April, 2014 & 10.03.2017) and compliance dated 29/09/2017 submitted by the college authorities and decided to recommend not to recognize MD(General Medicine) qualification against increased intake from 14 to 22 seats granted by University of Delhi, Delhi in respect of students being trained at Maulana Azad Medical College, New Delhi because of the following facts:-

- 1. Deficiency of faculty: (a) Asst. Prof.: 9.
- 2. Unit-II : only 2 faculty and one of them not available
- 3. Unit-III : only 2 faculty available.
- 4. Unit-IV : only two faculty out of them only one was available.
- 5. Unit-V : only two faculty, out of them only one was available.
- 6. Unit-VI : only two faculty, out of them only 1 was available.
- 7. Unit-VII : only one faculty.
- 8. Unit-VIII : only one faculty who was not available.
- 9. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. intake from 14 to 22 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."

In case, the college authorities desire to submit compliance, same should be received in this office preferably within four weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

Note:- The faculty is inadequate even for 250 seats of MBBS. The matter may be brought to the notice of the President, MCI.

Read: the Compliance Verification Assessment Report (08/01/2018) along with the Council Assessor's Report (June, 2017) and compliance dated 19/07/2017 and 22/09/2017 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD (T.B & Chest) (Pulmonary Medicine) qualification for 1 seat at Geetanjali Medical College & Hospital, Udaipur granted by Geetanjali University (Deemed), Udaipur.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (08/01/2018) along with the Council Assessor's Report (June, 2017) and compliance dated 19/07/2017 and 22/09/2017 submitted by the college authorities and decided to recommend to the Central Government that MD (T.B & Chest) (Pulmonary Medicine) qualification for 1 seat granted by Geetanjali University (Deemed), Udaipur in respect of students being trained at Geetanjali Medical College & Hospital,Udaipur be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

# 10. West Bengal University of Health Sciences, Kolkata - Recognition of Recognition of MS(OBG) qualification against increased intake from 6 to 10 seats in respect of students being trained at Burdwan Medical College, Burdwan.

Read: the Compliance Verification Assessment Report (05/01/2018) along with the Council Assessor's Report (June, 2017) and compliance dated 22/09/2017 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of Recognition of MS(OBG) qualification against increased intake from 6 to 10 seats at Burdwan Medical College, Burdwan granted by West Bengal University of Health Sciences, Kolkata.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (05/01/2018) along with the Council Assessor's Report (June, 2017) and compliance dated 22/09/2017 submitted by the college authorities and decided to recommend to the Central Government that Recognition of MS(OBG) qualification against increased intake from 6 to 10 seats granted by West Bengal University of Health Sciences, Kolkata in respect of students being trained at Burdwan Medical College, Burdwan be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

#### 11. <u>Jiwaji University - Renewal of recognition of DA qualification for 07</u> seats in respect of students being trained at Gajra Raja Medical College, <u>Gwalior.</u>

Read: the Compliance Verification Assessment Report (04/01/2018) along with the Council Assessor's Report (June, 2017) and compliance dated 23/09/2017 submitted by the college authorities on the standard of examination and other teaching facilities for Renewal of recognition of DA qualification for 07 seats at Gajra Raja Medical College, Gwalior granted by Jiwaji University.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (04/01/2018) along with the Council Assessor's Report (June, 2017) and compliance dated 23/09/2017 submitted by the college authorities and decided to recommend not to renew the recognition of DA qualification for 07 seats granted by Jiwaji University in respect of students being trained at Gajra Raja Medical College, Gwalior because of the following facts:-

- 1. Faculty deficiency Asst. Prof. -1.
- 2. Promotion of Dr. D Kothari, Prof., is not as per regulations. He was promoted on 01-01-15 after the cutoff date without 4 required research publications.
- 3. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. 7seats till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. This is also clarified in the letter of recognition granted u/s 11(2) of the IMC Act, 1956 issued for these seats, which reads as under:

"...the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

In case, the college authorities desire to submit compliance, same should be received in this office preferably within four weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. 12. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. 4 seats till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (17/01/2018) along with the Council Assessor's Report (May, 2013, 14.07.2015 30.05.2016& 07.04.2017) and compliance dated 05/09/2017 submitted by the college authorities and decided to recommend not to recognize MD(Paediatrics) qualification against increased intake from 02(Two) to 03(Three) seats granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at Indira Gandhi Medical College & Hospital, Nagpur because of the following facts:-

- 1. Promotion of Dr. Hrishikesh Belsare, Assoc Prof., is not as per regulations. He was Asst.Prof. for 4 years 11 months against the requirement of 5 years. He has no publications.
- 2. Faculty table not signed by any faculty member.
- 3. There is no MRI in the institute.
- 4. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. intake from 02(Two) to 03(Three) seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. University of Health Sciences, Thrissur/ Kerala University in respect of students being trained at Govt. Medical College, Kozhikode, Calicut, Kerala because of the following facts:-

- 1. There is no Professor in the Deptt. All are Addl. Prof.
- 2. Dr. Raju K, Addl. Prof. He passed MS in 2007. He cannot be considered Asstt. Prof from 08-11-2004. Resultantly, he was Asstt. Prof for less than 4 yrs. Hence, his promotion is not as per regulations
- 3. Dr. Aneen N Kutty, Assoc Prof. He was Asstt Prof only for 7 months. Hence his promotion not as per regulations. Period prior to passing M.S cannot be considered.
- 4. Unit-II, has only two faculty. The remaining two Asstt Prof (Dr. Arun Prakash and Dr. Dhiyaneswaran) were Absent on inspection day
- 5. Promotion of Dr. M Thanveeruddin Sherule, Assoc., is not as per regulations. He was promoted on 01-09-16 after the cutoff date. He has no publication.
- 6. Dr. Jipin Gopi-SR unit-II not eligible, no 3 year experience as Jr. Resident in a teaching hospital when appointed SR. no other SR in unit-4.
- 7. Other deficiencies as pointed out in the assessment report.

Koirala Institute of Health Science, Nepal along with assessment report (04.09.2017) & Central Govt. letter dated 20.06.2005 and previous assessment report (September, 2005) with regard to recognition of MD(Pathology) qualification in repsect of B.P. Koirala Institute of Health Sciences, Dharan, Nepal granted by B.P. Koirala Institute of Health Sciences, Dharan, Nepal and decided to recommend not to recognize MD(Pathology) qualification granted by B.P. Koirala Institute of Health Sciences, Dharan, Nepal and being trained at B.P. Koirala Institute of Health Sciences, Dharan, Nepal because of the following facts:-

- 1. Promotion of Dr Smriti Karki-Prof is not as per regulations. She was promoted on 04-02-16 after the cut off date. She has no 4 publications as first or 2nd Author
- 2. Promotion of Dr. Paricha Upadhyaye-Prof. is not as per regulations. He was Asstt Prof only for 1-10 months against the requirement of 5 yrs. He is shown Prof in column of Desig. & Assoc. Prof. in column of exp.
- 3. Promotion of Dr. Anju Pardhan- Addl. Prof. is not as per regulations. She was Asstt Prof only for 3-2 months against the requirement of 5 yrs.
- 4. Promotion of Dr. Punam Paudyal-Assoc. Prof. is not as per regulations. She was Asstt Prof. only for 3 yrs 4M against the required 5 yrs.
- 5. PG Degree of Dr. Niharika Shah, Asstt. Prof. is not recognized.
- 6. Number of students admitted in different years is variable 2014-7 & 2016-6.
- 7. Other deficiencies as pointed out in the assessment report.
- Note: The Postgraduate Committee perused the legal opinion regarding recognition of these qualifications of a foreign country which is reproduced below:

"The querist - Medical Council of India as sought my opinion on the issue of conducting Compliance Verification Inspections towards recommending grant of recognition in the case of certain postgraduate medicine courses being conducted at the following medical colleges in Nepal:-

- 1. Dr. Laxman P Shrestha, Prof & HOD was not available on the day of assessment. There is no certificate attached that he had gone for duty assigned by Nepal Medical Council.
- Promotion of Dr. Arun K Sharma, Assoc. Prof. Unit-I is not as per regulations. He was Promoted on 16-09-14 after the cut off date. He has only 1 publication
- 3. Promotion of Dr. Sudha Basnet, Prof. Unit-II, is not as per regulations. She was promoted on 09-02-17 after the cut off date. She has no 4 publications as first or 2nd Author.
- 4. Promotion of Dr. Merina Shrestha, Assoc.Prof. is not as per regulations. She was promoted on 15-07-17. She has only one publication against the required two.

- 1. Promotion of Dr. Anand K. Sharma, Prof., is not as per regulation. He was promoted in 2015 after the cut off date without any publications..
- 2. Promotion of Dr. Meenu Choudhary, Assoc., is not as per regulations. She was promoted in 2014 after the cut off date without any publications.
- 3. Dr. Sangeeta Sitaula, shown Lecturer in column of Designation & teaching Asst. in column of experience.
- 4. Dr. Sugam Narain Joshi, Assoc.Prof., Unit-II; he was lecturer only for 2 years when promoted Assoc.Prof. in 2003. Hence, his promotion not as per regulations.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2006, September, 2013 & 16.05.2016) and compliance dated 04/02/2016 submitted by the college authorities and decided to recommend not to recognize MD/MS(OBG) qualification for 08 seats granted by Tribhuvan University in respect of students being trained at Institute of Medicine, Kathmandu because of the following facts:-

The Postgraduate Medical Education Committee considered the Council Assessor's Report (June, 2017) and compliance dated 22/09/2017 submitted by the college authorities and decided to recommend to the Central Government that the recognition of DGO qualification for 01 seat granted by Veer Narmad South Gujarat University in respect of students being trained at Surat Municipal Institute of Medical Education & Research, Surat be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

#### 31. <u>Ch. Charan Singh Universitiy - Recognition of MD(Forensic Medicine)</u> <u>qualification for 2 seats in respect of students being trained at Saraswati</u> <u>Institute of Medical Sciences, Hapur.</u>

#### 33. <u>Sanjay Gandhi Post Graduate Instt. of Medical Sciences (Statutory</u> <u>Autonomous), Lucknow - Recognition of MD(Immuno-Haematology &</u> <u>Blood Transfusion) in respect of students being trained at Sanjay Gandhi</u> <u>Postgraduate Institute of Medical Sciences, Lucknow.</u>

Read: the Compliance Verification Assessment Report (24/05/2015) along with the Council Assessor's Report (May, 2014) and compliance dated 30/10/2017 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Immuno-Haematology & Blood Transfusion) at Sanjay Gandhi Postgraduate Institute of Medical Sciences, Lucknow granted by Sanjay Gandhi Post Graduate Instt. of Medical Sciences (Statutory Autonomous), Lucknow.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (24/05/2015) along with the Council Assessor's Report (May, 2014) and compliance dated 30/10/2017 submitted by the college authorities and decided to recommend not to recognize MD(Immuno-Haematology & Blood Transfusion) granted by Sanjay Gandhi Post Graduate Instt. of Medical Sciences (Statutory Autonomous), Lucknow in respect of students being trained at Sanjay Gandhi Postgraduate Institute of Medical Sciences, Lucknow because of the following facts:-

- 1. Irregularity in promotions of Dr. Priti Ethence, Dr Anupam Verma, Dr Prashant Agarwal, Dr Atul Sonkar remains as it is. Contention of the institute that it is as per its promotion policy which is at par with AIIMS cannot be accepted as TEQ Regulations, being statutory regulations, are mandatory and binding in nature & are required to be followed by all authorities and will prevail.
- 2. Resultantly, deficiency of Assoc Prof -1, remains as it is.
- 3. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. increased intake from 2 to 3 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (23/03/2017) along with the Council Assessor's Report (08.12.2014) and compliance dated 28/10/2017 submitted by the college authorities and decided to recommend to the Central Government that MD/MS(Ophthalmology) qualification against increased intake from 04 to 05 seats granted by Kerala University of Health Sciences, Thrissur/ Kerala University in respect of students being trained at Govt. Medical College, Kozhikode, Calicut,Kerala be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (07/03/2017) along with the Council Assessor's Report (August, 2016) and compliance dated 14/12/2017 submitted by the college authorities and decided to recommend not to recognize M.Ch (Urology) qualification against increased intake from 1 to 2 seats granted by West Bengal University of Health Sciences, Kolkata in respect of students being trained at Nilratan Sircar Medical College, Kolkata because of the following facts:-

- It is wrong to say that notification making publications compulsory came after interview on 31-07-13. This notification was issued in 2009 and 4 year intervening period was given. Hence the notification was very much in existence on 19-03-2013. Hence, promotion of Dr Tapan Kumar Mondal Prof& HOD is not as per regulations. He was promoted on 01-08-13 after the cutoff date and he has no publications.
- 2. Deficiency of Dr. Tapas Kumar Majhi, stays as such. There is no revised promotion order, promoting him Professor from 15.09.2017 attached.
- 3. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. increased intake from 1 to 2 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."

In case, the college authorities desire to submit compliance, same should be received in this office preferably within four weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. #### 54. <u>Application requesting grant of PG Degree in the subject of M.D.</u> (Pharmacology) as a recognized medical qualification on or after 2013 at Dr. Shankarrao Chavan Govt. Medical College, Nanded, Maharashtra -Correction- reg.

The Postgraduate Medical Education Committee considered the letter dated 05/01/2018 received from the Dean, Dr. Shankarrao Chavan Govt. Medical College, Nanded, Maharashtra with regard to recognition of MD(Pharmacology) course at Dr. Shankarrao Chavan Govt. Medical College, Nanded, Maharashtra on or after 2013 and decided to recommend to the Central Government that MD(Pharmacology) qualification 2(Two) seats granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at Dr. Shankarrao Chavan Govt. Read: the E-mail dated 21/12/2017 received from the Central Government forwarding therewith the letter dated 20/12/2017 received from the Director of Medical Education, Bangalore, Karnataka for correction/corrigendum with regard to recognition of Post Graduate Degrees/Diplomas (MD/MS/Diplomas) obtained under Karnataka University Dharwad from Karnataka Institute of Medical Sciences, Hubli and Gulbarga University, Gulbarga from Vijaynagar Institute of Medical Sciences, Bellary.

The Postgraduate Medical Education Committee considered the E-mail dated 21/12/2017 received from the Central Government forwarding therewith the letter dated 20/12/2017 received from the Director of Medical Education, Bangalore, Karnataka for correction/corrigendum with regard to recognition of Degrees/Diplomas (MD/MS/Diplomas) Post Graduate obtained under Karnataka University Dharwad from Karnataka Institute of Medical Sciences, Hubli and Gulbarga University, Gulbarga from Vijaynagar Institute of Medical Sciences, Bellary and noted the earlier decision of the Postgraduate Committee taken at its meeting held on 28/08/2015 in respect of various postgraduate courses (which stood discontinued) at Government Medical Colleges in Madhya Pradesh and the relevant part of the decision is as under:-

After detailed discussions, the Postgraduate Medical Education Committee observed/ noted that the courses were started with the permission of state Govt. prior the 10(A) came into existence in 1992. However, Section 11(2) has been in existence ever since the IMC Act, 1956 came into existence and the college authorities were expected to apply for recognition when the first batch of students appeared in the examination. However, none of them did so. Now all these courses have been discontinued long back and it is not possible to conduct recognition inspection u/s 11(2) of the IMC Act, 1956 because the same is done at the time of examination and there is no examination possible. As per the existing MCI Regulations, there is no provision under which Postgraduate Medical Education

Committee/ MCI can recommend recognition without following the prescribed procedure.

Under the perculiar circumstances as explained above and keeping in view the fact that a large number of students have passed out and their diplomas remain unrecognized, the Central Govt., Ministry of Health & F.W. may take an appropriate view as it may deem fit in the matter."

The committee further noted that the Central Government had issued notification dated 12/11/2015 recognizing these postgraduate courses which had been discontinued in respect of Govt. Medical Colleges of Madhya Pradesh.

In view of above, the Committee decided that a larger number of students have passed out and their degrees and diplomas remain unrecognized, the Central Government, Ministry of Health & F.W., may take an appropriate view as it may deem fit in the matter of recognition of the following courses as well:-

The Committee also noted that DMRD course was started in 1977 and continued to till 2008. The course was re-started in 2011 and recognition assessment under section 11(2) of IMC Act was done for the first time in 2015.

In the matter of retrospective recognition (many years back) the PG Committee perused Govt. letter dated 09.03.2015. The BOG and later PG Committee had recommended recognition of DGO qualification of Goa Medical College retrospectively from the date of first examination when the first batch students appeared in examination vide letter dated 09.03.2015 mentioned above the Govt. asked MCI to confirm that they are satisfied with fulfillment of all required norms by the college during the period between first examination and the actual assessment (which was several years later because the college applied for recognition assessment late). Medical College, Burla with regard to correction of Date/Year of examination for first batch to 2000 for Recognition of MD(Forensic Medicine/Forensic Medicine & Toxicology) qualification for 02 seats in respect of students being trained at V.S.S Medical College, Burla, Sambalpur

The Postgraduate Medical Education Committee considered the letter dated 30/12/2017 received from the Principal, Amala Institute of Medical Sciences, Thrissur with regard to Recognition of DDVL qualification for 1 seat in respect of students being trained at Amala Institute of Medical Sciences, Thrissur granted by Kerala University of Health Sciences, Thrissur and noted that the said qualification is recognized and included in the 1<sup>st</sup> Schedule to the IMC Act, 1956 on or after 2016.

In the matter of retrospective recognition (many years back) the PG Committee perused Govt. letter dated 09.03.2015. The Postgraduate Medical Education Committee considered the letter dated 29/12/2017 received from the Dean, Dr. S.N. Medical College, Jodhpur with regard to Recognition of MD(Pharmacology) qualifications for 3 seats in respect of students being trained at Dr. S.N. Medical College, Jodhpur granted by Rajasthan University of Health Sciences, Jaipur and noted that the said qualification is recognized and included in the 1<sup>st</sup> Schedule to the IMC Act, 1956 on or after 2016.

In the matter of retrospective recognition (many years back) the PG Committee perused Govt. letter dated 09.03.2015. The BOG and later PG Committee had recommended recognition of DGO qualification of Goa Medical College retrospectively from the date of first examination when the first batch students appeared in examination vide letter dated 09.03.2015 mentioned above the Govt. asked MCI to confirm that they are satisfied with fulfillment of all required norms by the college during the period between first examination and the actual assessment (which was several years later because the college applied for recognition assessment late). #### 63. <u>Amendments in Postgraduate Medical Education Regulations, 2000 with</u> regard to lowering the minimum percentile for admissions in Postgraduate Courses and consideration for deletion of clause for Institutional reservations of 50% - Regarding.

Read: the D.O. letter dated 25/01/2018 received from the Joint Secretary, Government of India, Ministry of Health & Family Welfare, New Delhi with regard to Amendments in Postgraduate Medical Education Regulations, 2000 with regard to lowering the minimum percentile for admissions in Postgraduate Courses.

The Postgraduate Medical Education Committee discussed in detail the reference made by Govt. vide letter DO No. JS/MCI/NEET-SS/Misc, dated 25.01.2018 and observed that:-

As per the result of NEET declared by NBE this year total number of qualifying students (as per minimum qualifying criteria) is 71398. Total number of available PG seats (Broad specialities ) is as below:-

MD/MS: 24896 PG Diploma: 6052 Total: 30948

Out of these 6052 seats are in Pre and Para clinical departments for which there are few takers. So the number of qualifying students is roughly three times the number of available seats in clinical departments.

It will be pertinent to mention here that before last year the minimum qualifying criteria was minimum 50% marks in entrance test and no student could be admitted to any PG course who could not score minimum 50%

marks in entrance examination. The minimum passing score in MBBS and MD/MS is also 50%. With change of minimum qualifying criteria last year from percentage to percentile the percentage of marks scored by last qualifying candidate in NEET 2018-19 examination in different categories is as below:

General Category 26.7%. Physical Disabled (PWD) 25% SC/ST/OBC 23.4%

The Postgraduate Committee is of the considered opinion that any further lowering of minimum qualifying criteria will have a very adverse effect on the standard of medical education in the country. However, in view of the acute shortage of faculty in pre & para clinical departments & not many students opting for pre & paraclinical subjects, the minimum qualifying criteria may be lowered in these subjects only in an attempt to fill up the vacant seats.

#### 64. <u>Starting/ increase of seats in various postgraduate (Broad Speciality)</u> <u>courses for the academic year 2018-19 – hearing granted to medical</u> <u>colleges by the MOHFW – Review regarding.</u>

Read: the D.O. letter dated 30/01/2018 received from Sh. Arun Singhal, Joint Secretary, Government of India, Ministry of Health & Family Welfare, New Delhi with regard to starting/ increase of seats in various postgraduate (Broad Speciality) courses for the academic year 2018-19 where the Ministry of Health & Family Welfare, New Delhi granted hearing to the college authorities.

The Postgraduate Medical Education Committee considered the D.O. letter dated 30/01/2018 received from Sh. Arun Singhal, Joint Secretary, Government of India, Ministry of Health & Family Welfare, New Delhi with regard to starting/ increase of seats in various postgraduate (Broad Speciality) courses for the academic year 2018-19 where the Ministry of Health & Family Welfare, New Delhi had granted hearing to the college authorities and noted that the last date of submission of final recommendations by Medical Council of India to Central Government is already over as per the Time Schedule laid down by the Hon'ble Supreme Court.

In view of above, the Postgraduate Committee reiterated its earlier decision dated 14.11.2017 and 24.01.2018.

## 65. <u>Amendment in the Postgraduate Medical Education Regulations, 2000 –</u> <u>Regarding.</u>

Read: the matter with regard to amendment in the Postgraduate Medical Education Regulations, 2000 along with the E-mail dated 05/02/2018 received from the Ministry of Health & Family Welfare, New Delhi.

The Postgraduate Medical Education Committee noted that this is a referred back item from the Govt. The Ministry in consultation with Directorate General of Health Services (DGHS) has made some observations on the amendments in Postgraduate Medical Education Regulations, 2000 proposed by MCI. The PG Committee perused Govt. letter dated 8<sup>th</sup> February, 2018 and observed as below:-

1) The PG Committee agreed with the suggestion that three & two years for degree and diploma courses be replaced by four & three years respectively. The proposed amendment should read as below:-

The institution shall apply for recognition of the Postgraduate Medical Qualification to the Central Government through the affiliating University, when the first admitted batch shall be due to appear for the examination to be conducted by the affiliating university.

In the Event of deficiencies being found in the assessment, the institution shall be granted an opportunity to submit compliance within 30 days from the date of communication of deficiencies by the Council. Such an opportunity to comply with the deficiencies shall be availed by the Institute only twice. The Postgraduate Medical Education Committee on finding the compliance satisfactory shall convey the recommendation to recognize the course. In all other cases, the prior permission of the Central Government granted under sub-clause (1) shall be deemed to have lapsed after four and three years for postgraduate degree/postgraduate diploma courses respectively, further, in such cases; recommendation shall be made to the Central Government to include the qualifications in the first schedule of the Indian Medical Council Act, 1956 only in respect of first four batches of postgraduate degree courses and three batches of postgraduate diploma courses.

- 2) Observation at S. no.2, 3 already replied under agenda Item 63.
- 3) Observation no.4 that institution preference be reduced from 50% to 25%. The PG Committee reiterated its earlier decision which is based upon the advice of Addl. Attorney General of India. Recent judgments quoted are interim orders. The preference should be at the college level & not university level.
- 4) Observation at Sr.No.5 is not clear.
- 5) Regarding observation at Sr. No.VII that ICU/HDU beds should be included for counting of teaching beds, the PG Committee does not in favour their inclusion in the minimum general teaching beds, they are additional requirement and should stay as such. No change is required.
- 6) With regard to nomenclature of MD Radiotherapy, PG Committee reiterated its earlier decision that its nomenclature should be radiation oncology.
- 7) In the proposed amendment at 9(7) "Procedure for selection of candidates for postgraduate courses word rural areas have been inadvertently left out which should be inserted. The proposed amendment should read as below:

50% of the seats in Postgraduate diploma courses shall be reserved for Medical Officer in the Government service, who have served for at least three years in remote and / or difficult and /or Rural areas. After acquiring the postgraduate diploma the Medical Offices shall service for two more years in remote and /or difficult and /or rural areas as defined by State Government /Competent Authority from time to time.

# 66. <u>Prior qualification (entry level) for admission in super-speciality courses</u> <u>– regarding.</u>

Read: the matter with regard to prior qualification (entry level) for admission in super-speciality courses along with the letter dated 14/12/2017 received from the Oversight Committee and letter dated 29/01/2018 received from the Hony. Executive Director, National Board of Examination.

The Postgraduate Medical Education Committee reviewed the matter as referred back by the Oversight Committee and decided as under:-

Genetics claims front line position in faculty of health care sciences. The degree of DM in this field naturally claims the highest position. The question as to who is eligible to pursue this, may not have easy answer. Recent advances in this field and the research warrants a thorough knowledge of the subject. It is possible with sound knowledge of basic sciences like Anatomy, Physiology, and Biochemistry. The syllabus of these subjects in all the universities incorporate sizeable quantum of genetics. The branches under the field of Genetics include the following:-

- 1) Molecular and Cytogenetics : Anatomy, Physiology
- 2) Developmental Genetics : Anatomy, Physiology
- 3) Biochemical Genetics : Biochemistry
- 4) Cancer Genetics : Pathology and Microbiology
- 5) Immuno-Genetics : Pathology and Microbiology
- 6) Population Genetics : Community Medicine
- 7) Clinical Genetics : Medicine and Paediatrics
- 8) Genetic Counseling : Medicine and Paediatrics

It is ether clear from the above that postgraduates (MD) from any of these subjects can join the course of DM Medical Genetics. The course curriculum in DM Genetics, not being a core specialty, has an overlap input from multiple broad specialty subjects. The course curriculum during DM Medical Genetics entails study of all the subdivisions of Genetics. Candidate from any of the broad specialty who opts for DM Medical Genetics shall have to undertake enhancement of the knowledge as well as skill related to other subdivisions. It is also imperative that in the pre and paraclinical subject, the avenues for advancement of knowledge domain pertaining to particular branch be held open. It would not be advisable to restrict entry in to DM Medical Genetics to only broad specialty candidates from clinical subjects.

The increase is subject to the undertaking as prescribed in PG resolution (Item 67, 2(c) in its meeting held on 27.10.2017.
