1. Minutes of the last meeting of the Postgraduate Medical Education Committee – confirmation of.

The Postgraduate Medical Education Committee confirmed the minutes of the Postgraduate Medical Education Committee meeting held on 12.06.2018.

2. Minutes of the last meeting of the Postgraduate Medical Education Committee – action taken thereon.

The Postgraduate Medical Education Committee noted that the minutes of the Postgraduate Committee meeting dated 12.06.2018 have been forwarded to the Oversight Committee and the approval from there is still awaited.

3. **Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh- Recognition of MS(Orthopaedics) qualification for 02 seats in respect of students being trained at Bhaskar Medical College, Yenkapally.**

Read: the Assessment Report (11.05.2018) on the standard of examination and other teaching facilities available at Bhaskar Medical College, Yenkapally for purpose of Recognition of MS(Orthopaedics) qualification for 02 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh.

The Postgraduate Medical Education Committee considered the Assessment Report (11.05.2018) and decided to recommend to the Central Government that MS(Orthopaedics) qualification for 02 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at Bhaskar Medical College, Yenkapally be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

4. **Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh- Recognition of MD(Physiology) qualification for 02 seats in respect of students being trained at Bhaskar Medical College, Yenkapally.**

Read: the Assessment Report (12.05.2018) on the standard of examination and other teaching facilities available at Bhaskar Medical College, Yenkapally for purpose of Recognition of MD(Physiology) qualification for 02 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh.

The Postgraduate Medical Education Committee considered the Assessment Report (12.05.2018) and decided to recommend not to recognize MD(Physiology) qualification for 02 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at Bhaskar Medical College, Yenkapally because of the following facts:-

1. The college got first LOP to start MBBS course on 19.04.2005, Dr. B. Shruthi, Professor has been given teaching experience from 11.12.2003 when the college was not in existence and this is not permissible. Resultantly, she was Asst.Prof. for 3 years only and her promotion is not as per regulations. There is no other Assoc.Prof. in the Department.
2. Other deficiencies as pointed out in the assessment report

Admissions done (if any) against these seats i.e. 2(Two) after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."

In case, the college authorities desire to submit compliance, same should be received in this office within 30 days from the date of communication of the deficiencies by the Council as specified in the Gazette Notification dated 05.11.2018. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

5. **Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh- Recognition of MS(General Surgery) qualification for 04 seats in respect of students being trained at Bhaskar Medical College, Yenkapally.**

Read: the Assessment Report (12.05.2018) on the standard of examination and other teaching facilities available at Bhaskar Medical College, Yenkapally for purpose of Recognition of MS(General Surgery) qualification for 04 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh.

The Postgraduate Medical Education Committee considered the Assessment Report (12.05.2018) and decided to recommend to the Central Government that MS(General Surgery) qualification for 04 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at Bhaskar Medical College, Yenkapally be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

6. **Dr. NTR University of Health Sciences, Vijayawada, A.P. - Recognition of MD(Psychiatry) qualification against increased intake from 01 to 02 seats in respect of students being trained at Bhaskar Medical College, Yenkapally.**

Read: the Assessment Report (10.05.2018) on the standard of examination and other teaching facilities available at Bhaskar Medical College, Yenkapally for purpose of Recognition of MD(Psychiatry) qualification against increased intake from 01 to 02 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh.

The Postgraduate Medical Education Committee considered the Assessment Report (10.05.2018) and decided to recommend to the Central Government that MD(Psychiatry) qualification against increased intake from 01 to 02 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at Bhaskar Medical College, Yenkapally be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

7. **Punjab University, Chandigarh- Renewal of recognition of MD(Transfusion Medicine) qualification for 03 seats in respect of students being trained at Government Medical College, Chandigarh.**

Read: the Assessment Report (07.05.2018) on the standard of examination and other teaching facilities available at Government Medical College, Chandigarh for purpose of Renewal of recognition of MD(Transfusion Medicine) qualification for 03 seats granted by Punjab University, Chandigarh.

The Postgraduate Medical Education Committee considered the Assessment Report (07.05.2018) and decided to recommend not to renew the recognition MD(Transfusion Medicine) qualification for 03 seats granted by Punjab University, Chandigarh in respect of students being trained at Government Medical College, Chandigarh because of the following facts:-

1. Promotion of Dr. Ravneet Kaur, Professor is not as per Regulations. She was promoted on 6.2.2014 after the cut off date. She has no publications.
2. Dr. Gagandeep Kaul is promoted as Assoc.Prof. after cut off date on 29.4.2016. However, in the column "Benefit of publications" in the faculty table, it is stated "No" implying NIL publications against requirement of 2 as per Regulations; hence his promotion is not as per Regulations and he cannot be considered.
3. No faculty has MD (IHBT) or 2 years special training in IHBT. Hence not eligible to hold their post.
4. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. 3(Three) till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. This is also clarified in the letter of recognition granted u/s 11(2) of the IMC Act, 1956 issued for these seats, which reads as under:

"...the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. The Postgraduate Medical Education Committee considered the Assessment Report (14.05.2018) and decided to recommend not to renew the recognition of MD(Forensic Medicine/Forensic Medicine & Toxicology) qualification for 01 seat granted by Punjab University, Chandigarh in respect of students being trained at Government Medical College, Chandigarh because of the following facts:-

1. Promotion of Dr. Ajay Kumar, Assoc.Prof., is not as per regulations. He was promoted on 25.03.2015 after the cut off date and as per faculty table he has no publications.
2. Dr. Amandeep Singh is promoted as Assoc. Prof. with experience of only 1 y 2 m as Asst. Prof. against requirement of 5 y; hence his promotion is not as per Regulations & he cannot be considered.
3. Faculty table is not signed by any faculty.
4. Equipment are inadequate as detailed in the report.
5. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. 01(One) till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. This is also clarified in the letter of recognition granted u/s 11(2) of the IMC Act, 1956 issued for these seats, which reads as under:

10. JSS University, Mysore- Renewal of recognition of D Ortho qualification for 06 seats in respect of students being trained at J.S.S. Medical College, Mysore.

Read: the Assessment Report (07.05.2018) on the standard of examination and other teaching facilities available at J.S.S. Medical College, Mysore for purpose of Renewal of recognition of D Ortho qualification for 06 seats granted by JSS University, Mysore.

The Postgraduate Medical Education Committee considered the Assessment Report (07.05.2018) and decided to recommend to the Central Government that the recognition of D Ortho qualification for 06 seats granted by JSS University, Mysore in respect of students being trained at J.S.S. Medical College, Mysore be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

The Postgraduate Medical Education Committee considered the Assessment Report (15.05.2018) and decided to recommend not to renew the recognition of MS(General Surgery) qualification for 04 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at Maharajah Institute of Medical Sciences, Nellimarella because of the following facts:-

1. Promotion of Dr. B. Masthanaiah, Professor, is not as per regulations. He was Assoc.Prof. for only 1 year and 11 months against the requirement of 4 years. There is other Assoc.Prof. or Professor in Unit-IV.
2. Promotion of Dr. K. Srinivas Chakravarty, Assoc. Prof., is not as per regulations. He was promoted on 20.01.2017 after the cut off date without any publications. He was not available on the day of assessment. There is no other Assoc.Prof. in Unit-I. Resultantly, teaching complement is incomplete in Unit I.
3. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. 04(Four) till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. The Postgraduate Medical Education Committee considered the Assessment Report (10.05.2018) and decided to recommend not to renew the recognition of MD(General Medicine) qualification for 04 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at Medicit Institute of Medical Sciences, Ghanpur because of the following facts:-

1. The college has been permitted 150 UG seats in 2012 for which 5 units are required but available units are only 4.
2. Average bed occupancy of 3 days was 66%.
3. On the day of assessment MRI in the entire hospital were only 4 and CT Scan only 8, which are inadequate.
4. On the day of assessment and previous three days hospital admissions and admission in the Medicine Department has increased as compared to other days.

6. Speciality clinic in Cardiology and Neurology are being held. But other speciality clinics like Geriatrics, Endocrinology, Haematology, Gastroentrology, Nephrology are not being conducted by the department of Medicine.
7. During clinical/practical examination while assessing the long and short cases time taken was less; more time should have been taken to assess each candidate.
8. There were only 2 patients in ICCU on the day of assessment.

4. The computer data provided is highly inflated.
5. Bed Occupancy at 10 a.m. on day of assessment was 25 %. Bed occupancy in ICU was only 17%.
6. There was only 1 Major Operation on day of assessment. Average of randomly selected days is 1-2 which is inadequate.
7. Total MRI workload for the whole hospital on day of assessment was only 04 & CT Scan-8.
8. OPD area had very little patient population at 10 a.m. on the day of assessment.
9. There were only 2 patients in SICU on day of assessment.
10. Details of attendance at Specialty clinics like Cardio Vascular & Thoracic Surgery clinic, Surgical Gastroenterology clinic, Paediatric Surgery clinic, Surgical Oncology clinic are not provided.
11. Postgraduate examination had no timing format for the cases. One candidate was examined for more than one hour on short case while others were given very little time.
12. Other deficiencies as pointed out in the assessment report.

7. Central Research Laboratory is not available.
8. MRI workload of the whole hospital is only 2 on day of assessment.

4. Dr. Srikanth Naik is appointed as Asst. Prof. on 04/11/2017; however he does not have 1 y experience as Senior Resident required as per Regulations; hence he is not qualified to hold the post.
5. Dr. Poorna Chandra Reddy, Dr. K.Vishal, Dr. A Manikanteshwara Rao & Dr. M Anil Bala Raghavendra, all Sr. Residents have DNB qualification from non-teaching hospitals. They have no 3 years experience as Jr. Resident in a teaching hospital when appointed Sr. Resident. Hence they are not eligible.
6. Dr. K. Samira appointed as Asst.Prof. on 19.03.2018. However, she does not have 1 year experience as Sr. Resident required as per regulations.
