### **PUBLIC NOTICE**

**Sub: Filing of 1<sup>st</sup>/2<sup>nd</sup> Appeals under relevant sections [u/s 22(3), 28(5), 30(4), 35(5)] of NMC Act, 2019 and appeal fee thereof.**

This Commission has earlier issued public notices dated 28.12.2022 and 28.08.2023 (copy enclosed) prescribing therein steps/ procedure for filing 1<sup>st</sup>/ 2<sup>nd</sup> appeals before the National Medical Commission (NMC) under the NMC Act, 2019.

2. Despite these guidelines, it has been observed that many colleges/ appellants are still not following the due procedure for filing appeals under the aforesaid sections of NMC Act as per said public notices. A number of appeals received in this Commission are deficient on various counts; invoking wrong section of the NMC Act; non-submission of all documents as per checklist prescribed in the public notice, appeal submission to non-concerned authority etc. which make them liable to be rejected on technical grounds.

3. In this regard, it is reiterated that all concerned may go through before submitting any appeal to this commission against decision of any board.

4. **The Commission in its 13th Meeting has decided to adopt a uniform fee of Rs. 50,000/- in cases of appeals filed by colleges/ Institutions related to academic year 2024-25 onwards and Rs. 5,000/- in all cases of appeals filed by Individuals. This will revise the different amounts of appeal fee earlier applicable for appeals in matter of different type of applications.**

5. **Further, it has also been decided that all appeals against the orders of the Boards under the Commission shall henceforth be addressed to Secretary, NMC only.**

6. Therefore, all concerned colleges/ appellants are hereby informed that all appeals against the orders of Boards under the Commission as provided under different sections of NMC Act, 2019 may be preferred via **ONLINE MODE ONLY** through email at '**nmc\_appeal@nmc.org.in**' and addressed to "**Secretary, NMC**" within the stipulated time period as per the NMC Act. Appeals received through any other mode/channel or email address will be liable not to be considered.

Accordingly, all concerned colleges/ appellants are hereby again informed that all appeals (along with relevant documents), against the orders of Boards under the Commission as provided under aforesaid sections of NMC Act, 2019 may be preferred by Dean/Principal of the Medical College/ appellant to the Commission by **addressing to Chairman, NMC** via **EMAIL ONLY** at '**nmc\_appeal@nmc.org.in**' with the requisite documents as per the attached **checklist** (refer Annexure-I) and under the **stipulated time period** as per the NMC Act (refer Annexure-II).

3. All the communications must contain **the copy of duly filled checklist** and invariably bear the subject as under:

“1<sup>st</sup>/ 2<sup>nd</sup> appeal under section..... of NMC Act, 2019 against decision of ... (Name of the Board) ... regarding ..... (subject matter of the appeal) .....”

4. The above email is only for the purpose of submission of Appeals under aforesaid sections of the NMC Act, 2019 and therefore no cognizance of appeal related communication would be taken if not sent on the above email Id or addressed otherwise.

**Timelines prescribed under NMC Act, 2019 for filing of appeals to the Commission**

S.No.	Section	Provisions for filing appeals to NMC under the Act
1.	22 (3)	“Subject to the provision of section 28, a person who is aggrieved by <b><u>any decision of an Autonomous Board</u></b> may prefer an appeal to the Commission against such decision <b><u>within sixty days of the communication of such decision.</u></b> ”
2.	28 (5)	“Where a scheme is disapproved under sub-section (3), or where no decision is taken within six months of submitting a scheme under sub-section (1), the person concerned may prefer an appeal to the Commission for approval of the scheme <b><u>within fifteen days of such disapproval or, as the case may be, lapse of six months,</u></b> in such manner as may be specified by the regulations”  [Against the decision of <b>Medical Assessment and Rating Board (MARB)</b> ]
3.	30 (4)	“A medical practitioner or professional who is aggrieved by the decision of the <b><u>Ethics and Medical Registration Board</u></b> may prefer an appeal to the Commission <b><u>within sixty days</u></b> of communication of such decision”
4.	35 (5)	“Where the <b><u>Under-Graduate Medical Education Board or the Post-Graduate Medical Education Board,</u></b> as the case may be, decides not to grant recognition to a medical qualification, the University or the medical institution concerned may prefer an appeal to the Commission for grant of recognition <b><u>within sixty days</u></b> of the communication of such decision, in such manner as may be specified by the regulations”
